ABSTRACT

The 1997 fiscal year annual report on schools in the Illinois community college system focuses on student enrollment and completion. The demographic enrollment data reveals that slightly more than half the students are female, one third is of minority ethnicity, and 2 out of every 5 students are 31 years of age or older. Most of the instructional program areas experienced increased enrollments, the largest of which was the baccalaureate/transfer program. Over half of the students indicated they were enrolled in school with no intention of pursuing a degree, and intended only to complete a certificate or specific courses. Three-fourths of the students attended part-time, with the majority having only high school backgrounds. Eighty-two percent of student grade point averages were 2.01 or above. There was a slight decrease in the number of degrees and certificates awarded, and of those that did graduate, the majority were female non-minorities. More than half of the students under age 25 completed baccalaureate/transfer degrees. Across all age groups, the proportion of occupational graduates increased as age advanced. Appendices include enrollment data tables and completion data tables. (YKH)

## INTRODUCTION

The colleges in the Illinois community college system submit detailed student records twice during each fiscal year. Fall opening enrollment (E1) data for credit-generating students are recorded by the colleges at the end of the regular fall registration period, which is usually the 10th day of the term. Annual student enrollment and completion (A1) data are reported for all students who are officially enrolled at the college in credit coursework at any time during the fiscal year. An A1 record is also submitted for students who graduate, but are not officially enrolled during the year. Noncredit community education classes are not reported in these databases.

For many years, the Illinois Community College Board compiled a report on the fall enrollment records. These data provide a point-in-time or "snapshot" of fall term enrollment allowing year-to-year and institution-to-institution comparisons. Further, they are comparable to fall enrollment data in postsecondary institutions nationwide. However, the diversities of the community college system and its students were not fully captured in this report. This is because the age, attendance patterns, and goals of the community college student are unconventional. Students "stop in and out" of college according to their individual needs and may not always be enrolled at the beginning of a fall semester. The increase in module classes adds to the complexity of tabulating student enrollments at any given time. Additionally, with elevated emphasis on student outcomes and program effectiveness, analyses of student completions have become increasingly important. This variability is best captured in the annual enrollment data. Therefore, the analyses in this report have focused on annual enrollment and completion records in an effort to secure the most comprehensive and accurate information available.

This is the fifth year of publication for this report. This year's report is based on fiscal year 1997 annual enrollments and completions for credit-generating students as provided by the colleges at the close of the fiscal year. For comparison with past enrollments and completions, summary data for the four previous fiscal years (1993-1996) are also presented. Detailed tables comparing fiscal year 1996 and fiscal year 1997 headcount, full-time equivalent (FTE) enrollments, and graduates by college are included. FTE enrollments in this report are based on all credit hours attempted (including nonreimbursable credit hours). Supplementary enrollment and completion data for each community college will be available in the 1998 edition of *Data and Characteristics of the Illinois Public Community College System*.

The Illinois Community College Board is in the process of developing a *noncredit* enrollment database in order to document the magnitude to which Illinois community colleges serve individuals, business, industry, government, and labor. These noncredit enrollments, along with the the credit enrollment and completion information presently available, will facilitate a comprehensive portrayal of the Illinois community college system and the communities it serves.

## HIGHLIGHTS OF FISCAL YEAR 1997 ANNUAL REPORT

## Student Enrollments

- ▶ During fiscal year 1997, the 49 public community colleges in Illinois enrolled 677,314 students in instructional credit courses, 0.3 percent more than the previous year.
- ▶ The annual full-time equivalent (FTE) enrollment was 218,662, an increase of 0.5 percent since fiscal year 1996.
- ▶ The number of female students showed little change in fiscal year 1997. The number of male students, comprising approximately 45 percent of the student population, increased 0.7 percent.
- ▶ Minority (non-white) students accounted for one-third of those enrolled in community colleges. The proportion of minority students enrolled in the Illinois community college system increased slightly (1.2 percent). The number of Hispanic students increased 8.5 percent, while the black student population increased only 0.3 percent.
- ▶ The median age of community college students in Illinois was 27.5 during fiscal year 1997, slightly older than the previous year. The average age increased from 30.4 to 31.5 years.
- ▶ Statewide, occupational program enrollments declined 2.4 percent since last year. This is the fifth consecutive year in which a decline in occupational enrollments was exhibited.
- ▶ Three out of four students attended on a part-time basis during both the fall and spring semesters in fiscal year 1997.
- ▶ Annual Enrollment and Completion (A1) data indicate that Illinois community college students were enrolled for nearly 6,559,900 credit hours throughout fiscal year 1997 and earned nearly three-fourths of those hours.
- ▶ As in previous years, associate degree nursing (ADN) was the largest occupational program, enrolling 11,166 students in fiscal year 1997. ADN enrollments were down 9.0 percent from fiscal year 1996.
- ▶ Although 36 percent of the fiscal year 1997 student population was enrolled in the baccalaureate/transfer area, only 26 percent of all students indicated an intent to transfer. While 26 percent were enrolled in occupational programs, 31 percent of the students indicated that their intent was to improve present job skills or prepare for a job after community college.
- ▶ Half of the fiscal year 1997 students enrolled in Illinois community colleges indicated that they were not pursuing a degree, but attending only to complete one or several courses. Thirty-eight percent listed completion of an associate degree as their degree objective, while 11 percent desired to complete a certificate.
- ▶ Accumulated credit hours were available for 70 percent of the fiscal year 1997 student population. Of that percentage, 31 percent accumulated 30 or more college-level hours (sophomore level).
- ▶ Of those community college students (78 percent) from whom data were collected, 15 percent had already earned some type of collegiate certificate or degree. This includes 32,100 who earned a bachelors degree or higher.
- ▶ In fiscal year 1997, the Illinois community college system reported 15 percent of its students' high school percentile rank. Forty-nine percent of the students ranked in the upper half of their graduating class, while 5 percent were in the top ten percentile.
- ▶ Approximately 11 percent of the community college student population reported their ACT scores. Nearly 55 percent received a score of 19 or higher on the ACT exam.

## Student Completions

- ▶ More than 35,300 degrees and certificates were awarded to students at Illinois community colleges in fiscal year 1997, 1.2 percent less than in fiscal year 1996. Collegiate-level completions decreased 1.3 percent.
- ▶ Students successfully completed nearly 19,600 occupational degrees and certificates in Illinois community colleges during fiscal year 1997, a 3.6 percent decrease from the previous year.
- ▶ Nearly half of the occupational degrees and certificates awarded in fiscal year 1997 were associate in applied science degrees.
- ▶ Over 13,100 baccalaureate/transfer degrees were earned during the fiscal year, an increase of 3 percent since 1996, accounting for more than 37 percent of all completions.
- ▶ Throughout fiscal year 1997, colleges reported that nearly 1,900 adult education certificates were acquired by students in adult basic, adult secondary, and English as a Second Language programs, a 0.7 percent decrease over 1996. Most (92 percent) of these students completed the adult secondary education (GED) program. Colleges are encouraged to strengthen the reporting of completions in adult education.
- ▶ Females accounted for 62 percent of all completions during fiscal year 1997. A similar proportion was reflected in the baccalaureate/transfer and occupational program areas.
- ▶ The largest number (3,024) of male completers of a specific degree or certificate was in the associate in applied science (AAS) degree program. However, the majority of AAS graduates (67 percent) were female.
- ▶ The proportion of occupational graduates increased as age advanced.
- ▶ Sixteen percent of the students who were awarded degrees and certificates during fiscal year 1997 were less than 21 years of age. The age groups with the largest percentages of graduates were the 21 to 24 and the 31 to 39 year olds (28.7 and 19.1 percent, respectively).
- ▶ Minority students earned 24 percent of the collegiate-level degrees granted in the Illinois community college system during fiscal year 1997. Blacks achieved 13.1 percent, Hispanics earned 5.7 percent, and Asians earned 4.1 percent of these degrees.
- ▶ Minority students comprised 27 percent of occupational program completers. Blacks accounted for 15.4 percent, Hispanics comprised 6.4 percent, and Asians represented 4.5 percent of the total number of completers.
- ▶ Minorities comprised only 18 percent of the total graduates with baccalaureate/transfer degrees. Nine percent were black, 4.6 percent were Hispanic, and 3.5 percent were of Asian origin.
- ▶ Eleven percent of the students who successfully completed baccalaureate/transfer degrees in fiscal year 1997 indicated an intent to prepare for a job immediately after community college, *not* to prepare for transfer to a four-year institution.
- ▶ Twenty-one percent of the fiscal year 1997 AAS degree graduates had indicated their goal was to complete one or more courses or a certificate, *not* to earn an associate degree. This demonstrates that students sometimes alter their goals as they progress through the community college system.

FISCAL YEAR 1997 STUDENT ENROLLMENTS

**Student Enrollment by Community College**

Annual enrollment for fiscal year 1997 was 677,314, and FTE students totaled 218,662. Table 1 contains comparative enrollment data for the last five years. Both fiscal year 1997 total headcount enrollment and FTE enrollment increased slightly since fiscal year 1996. Headcount enrollments have decreased 6.5 percent since 1993, while FTE enrollments decreased 7.9 percent. 1992 was the peak year for enrollments in the last ten years. Fiscal year 1997 is the first year since that time in which headcount enrollments have shown growth.

Table A-1 in the appendix provides a comparison of fiscal year 1993 through fiscal year 1997 headcount enrollments for each community college. Of the 49 community colleges, 21 colleges experienced increases in headcount, while 22 exhibited decreases during the past year. Six colleges experienced little or no change (1.0 percent or less) over the last year. Table A-2 contains a comparison of FTE enrollments for the five-year period, indicating 21 colleges with increases, 16 with decreases, and 12 with little change.

**Male/Female Distribution**

The male/female distribution of students has fluctuated little in the past five years. Females comprised 55.5 percent of the student population in fiscal year 1997. The percentage of male students has averaged 44.6 percent over the past few years. (See Table A-3.)

**Ethnic Origin**

Both the proportion and number of minority student enrollments increased slightly from fiscal year 1996 to fiscal year 1997 (32.8 percent to 34.0 percent). In fiscal year 1997 no minority student groups experienced decreases in proportion, largely affected by a 1.7 percent decrease in the number of white students. The number of white enrollments decreased in each of the past five years, slightly more than 9 percent from fiscal year 1993 to fiscal year 1997. The Asian/Pacific Islander and American Indian/Alaskan groups remained unchanged proportionately, while the black and Nonresident Alien sectors slightly increased. Hispanic student representation has continued to increase over the past three years, placing the Hispanic ethnic group's proportion at only 1.2 percent less than that of the black student group. (See Table A-4.)

**Student Age**

The average age of the Illinois community college student was 31.5 years in fiscal year 1997, the oldest in the past five years. The median age was 27.5 years. Both mean and median age increased by approximately one year since 1996. Age data confirm that community colleges serve a broad cross-section of the population. Although the largest proportion of students (21.6 percent) was in the 17-20 year old category, this category experienced nearly a 5 percent decrease proportionately. The 21-24 age group experienced an increase in proportion (2.9 percent) as did the 40-55 age group (1.6 percent). The smallest proportion of students was in the 16 and under age group. This group has fluctuated in size during the five-year period, and in fiscal year 1997 represented only 0.5 percent of the student population. (See Table A-5.)

**Summary of Enrollments by Instructional Program Area**

The baccalaureate/transfer program is the largest instructional program offered in the Illinois community college system. Statewide, this program area has decreased 6.1 percent since fiscal year 1993. An examination of these data reveal that a large increase in the total number of baccalaureate/transfer students was experienced in both 1993 and 1994, followed by two years of level enrollments. From 1996 to 1997, data revealed a 15.1 percent decrease in the program area. Further study reveals that these large shifts in enrollments were due to the inclusion of adult education (specifically English As a Second Language) students in the baccalaureate/transfer programs at City Colleges of Chicago during fiscal years 1992 through 1996. Consequently, adult education enrollments experienced large decreases during these years. The second largest program, occupational, which showed a decrease of 2.4 percent from fiscal year 1996 to fiscal year 1997, decreased 11.8 percent over the five-year period. In the past year, enrollments also decreased in the vocational skills (12.1 percent) area, while an increase was experienced in general associate (3.5 percent). Although small in proportion to most of the other program areas, the general studies program enrollments increased nearly 38 percent in the past year. (See Table A-6a.) Upon review of instructional program area information excluding City Colleges of Chicago data, a brighter picture is revealed. All instructional program areas, with the exception of occupational (with a 2.8 percent decrease in fiscal year 1997 and 11.4 percent in the past five years), experienced increased enrollments in the past year. The largest program, baccalaureate/transfer, increased 1.1 percent in fiscal year 1997 and 1.9 percent over the five-year period. Vocational skills programs also experienced increases during fiscal year 1997, as well as over the past five years (0.3 percent and 8.8 percent, respectively). Both the general associate and general studies programs experienced increases in the past year (3.7 percent and 1.1 percent), but over the last five years student enrollments decreased substantially (9.9 percent and 33.5 percent). Adult education enrollment increased slightly more than 5 percent over both of these time periods (See Table A-6b).

It is important to note that, while occupational enrollments have decreased, the number of students enrolled in noncredit courses, many of which are suitable for updating professional skills in business and industry, increased. In fiscal year 1997, Illinois community colleges

served approximately 262,200 individuals through these noncredit courses. This represents an increase of 5.7 percent over fiscal year 1996, and an increase of almost 18 percent over two years ago. These numbers increased each year since fiscal year 1995, when annual noncredit enrollment data collection began.

Instructional Program Enrollments by Gender. During fiscal year 1997, females outnumbered males in all instructional areas; the English as a Second Language program contained the highest proportion of male students (49.1 percent). The highest proportion of females (58.7 percent) was enrolled in the baccalaureate/transfer program followed closely by the general associate (58.6 percent) and general studies certificate program (58.5 percent). (See Table A-7.)

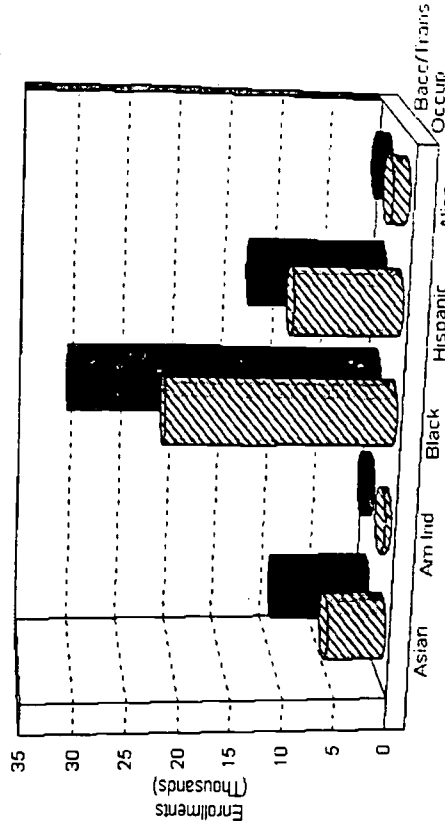


Fig. 1. Fiscal Year 1997 Minority Enrollments in Baccalaureate/Transfer and Occupational Programs

Instructional Program Enrollments by Racial/Ethnic Origin. Figure 1 illustrates the distribution of minorities in the two largest program areas, baccalaureate/transfer and occupational/career. An examination

of each racial/ethnic group's representation across program area in fiscal year 1997 indicates that the largest percentage of white (41.5 percent), American Indian (33.8 percent), Asian (32.9 percent), and black (30.7 percent) students were enrolled in baccalaureate/transfer programs. However, the Nonresident Alien, and white populations had nearly one-third of their enrollments in occupational programs. The



highest percentage of Hispanic (42.3 percent) students were enrolled in English as a Second Language programs. Nearly as many blacks (29.1 percent) were enrolled in adult basic and secondary programs as were enrolled in baccalaureate/transfer programs. Overall, minority students were represented the least in the vocational skills and baccalaureate/transfer areas (see Table A-8).

Instructional Program Enrollments by Age. During fiscal year 1997, 40.4 percent of community college students were under 25 years of age. Students in this age group were predominately (49.1 percent) enrolled in baccalaureate/transfer programs. The 25-39 year old age group comprised 34.1 percent of the total student population; 30.7 percent were enrolled in the occupational program area, while another 28.6 percent was enrolled in the baccalaureate/transfer program. More than one-fifth of Illinois' community college students were at least 40 years old. Nearly one-third of these "older" (40+) students were enrolled in the occupational programs, while another 22 percent were enrolled in baccalaureate/transfer programs. (See Table A-9.)

Largest Occupational Programs. An examination of those occupational curricula with at least 5,000 students enrolled during either of the last two years revealed, as in the past few years, that the associate degree nursing program was the largest program. However, enrollment in this program decreased 9 percent (or 1,103 students) since the previous year. In fact, all of the programs with at least 5,000 students experienced decreases in enrollments. Business Data Programming and Criminal Justice Technology, the next largest occupational programs, experienced small decreases of 2.1 percent and 3.2 percent, respectively. Child Care Provider/Assistant decreased the least (1.3 percent) of the programs in the group. Business Administration & Management enrollments lagged 3.3 percent below that of the previous year, while Accounting and Bookkeeping experienced a large decrease of 9 percent (see Table A-10.)

Instructional Program Enrollments by Intent. Intent data convey the primary goal that the student wants to achieve as a result of his/her studies. The intent data are self-reported by students when they initially enroll at the college. College staff are asked to require students to update this information periodically, providing a current intent as well as entry intent. An examination of the intent data across program areas

illustrates the diversity of interests and needs that community college students possess. Two goals combined to represent the aspirations of nearly 40 percent of community college students: 26.2 percent were preparing for transfer to a four-year institution and 17.6 percent were preparing for a job immediately after community college.

Examination of student intent by program area reveals interesting observations. With the exception of adult education and baccalaureate/transfer, less than half of the students in any program area were pursuing the particular goal most often associated with a given major. Only 55.8 percent of those students enrolled in baccalaureate/transfer programs indicated that they intend to transfer to a four-year institution. Less than two-thirds of those students in occupational programs had enrolled with an intent of preparing for a job after community college or to improve their present job skills. Fifty-nine percent of ABE/ASE and 79.4 percent of ESL students listed a desire to remedy basic skills deficiencies or to prepare for the GED test as their reason for attending. (See Table A-11.)

Instructional Program Enrollments by Degree Objective. Degree objective data are also self-reported and are designed to assist colleges in classifying students by curriculum or course enrollee category. The objective conveys the student's expected outcome from attending the community college. In fiscal year 1997, 61 percent of the students indicated that they were enrolled with no intention of pursuing a degree -- only to complete a certificate or one or several courses. A review of student objectives by program area reveals expected results: 61 percent of the baccalaureate/transfer students plan to complete an associate degree, while 33 percent are interested in completing one or several courses. Less than half (46.0 percent) of the occupational/career students indicated that they expected to complete an associate degree, while 35.5 percent listed that they expected only to complete one or several courses. Eighteen percent wanted to complete a certificate. These data illustrate the diversified needs of occupational students in the community college system. Many students complete an entire program, while others simply want to improve their current skills or obtain skills to enter a different career. Employers often do not require that a student earn a formal certificate or degree; only that they acquire the skills necessary to perform specific job duties. As expected, in the vocational, ABE/ASE, ESL, and general studies programs, the

vast majority (84.2, 78.2, 87.9, and 77.9 percent, respectively) of students planned only to complete one or several courses. (See Table A-12.)

**Enrollment Hours by Term and Type of Attendance**

Three out of every four students attended college on a part-time (less than 12 credit hours) basis during the fall and spring semesters of fiscal year 1997. Ninety-one percent of students attending the summer term were part-time (less than nine credit hours). In a pattern typical to higher education, more students attended Illinois community colleges in the fall semester (391,249) than in the spring semester (381,796). Nearly 206,300 students attended both the fall and spring semesters. (See Table A-13.)

**Highest Degree Earned by Students Prior to Attending Community College**

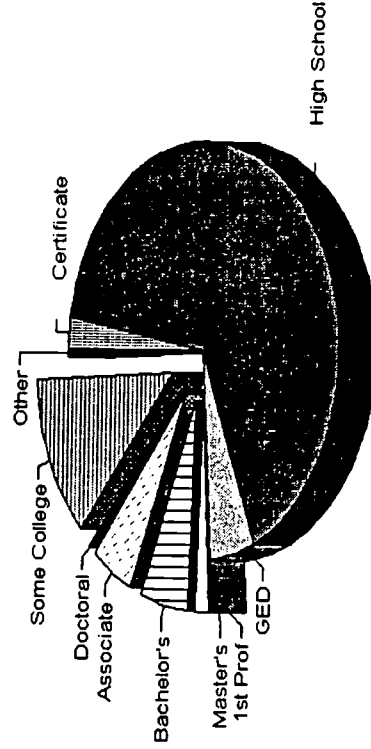


Fig. 2. Fiscal Year 1997 Headcount Enrollment by Prior Highest Degree Earned

The educational background of community college students is diverse. An examination of the degrees earned by students prior to their enrollment in community college confirms this diversity. Of the 78 percent of students who reported their previous degrees earned (excluding adult education students who would typically not possess earned degrees), 15 percent had earned a postsecondary certificate or degree. Nearly 13 percent had already earned degrees at or beyond the community college level. (See Table A-14.) Figure 2 illustrates the educational background of these fiscal year 1997 students.

**Attempted vs. Earned Credit Hours**

At all colleges and universities, there are students who, for a variety of reasons, are unable or unwilling to complete the requirements for the class in which they are enrolled. In 1997, Illinois community college students completed 4,850,435 credit hours, or 73.9 percent of their attempted hours. Overall, full-time students earned a higher percent of attempted hours than did part-time students. (See Table A-15.)

Of the 473,234 students (70 percent) for whom data were available, more than two-thirds had accumulated less than 30 college-level hours (freshman level). Nineteen percent had accumulated between 30 to 59 credit hours (sophomore status), and 13 percent earned 60 or more credits. (See Table A-16.)

**Grade Point Averages**

Cumulative grade point average data were available for 63 percent of the fiscal year 1997 enrollments. Eighty-two percent of the students had a grade point of 2.01 or above (minimum of a C average). Thirty-seven percent had achieved a grade point between 2.01 and 3.00 (C to B), while 45 percent were in the 3.01 to 4.00 (B to A) range. (See Table A-17.)

**High School Graduation Percentile Rank**

High school class rank was reported for 15 percent of the fiscal year 1997 community college students. Of this population, 5 percent were in the top tenth percentile of their graduating class, while 49 percent graduated in the top half of their class. (See Table A-18.)

**ACT Scores of Community College Students**

ACT score data were available for 11 percent of the students. Fifty-five percent of the students received a 19 or higher on the ACT exam. A minimum of 18 on the ACT exam is normally required for acceptance into many colleges or universities. For those fiscal year 1997 students from whom data were gathered, the average ACT score was 17.8. The median score was 18. (See Table A-19.)

FISCAL YEAR 1997 COMPLETIONS

**Degrees and Certificates Awarded by Community College**

The number of degrees and certificates awarded to Illinois community college students in fiscal year 1997 totaled 35,332. Table 2 contains comparative completion data for the last five years. The number of degrees and certificates awarded decreased by 1.2 percent over fiscal year 1996. Compared to fiscal year 1993, total fiscal year 1997 completions decreased by 10.1 percent. An examination of completions by program area reveals an overall collegiate program decrease (1.3 percent) since 1996. Noncollegiate-level completions remained stable in fiscal year 1997, following a substantial increase (6.2 percent) the previous year.

Table B-1 in the appendix provides a comparison of fiscal year 1993 through fiscal year 1997 duplicated completions for each community college. Of the 49 colleges, 22 experienced increases in degree and certificate awards, while 25 exhibited decreases in the past year. Two colleges experienced little or no change.

**Degrees and Certificates Awarded by Program Categories**  
Of the 35,332 completions during fiscal year 1997, more than half (55.4 percent) were occupational degrees or certificates. Baccalaureate/transfer degrees accounted for more than 37 percent of all the completions. Among these baccalaureate/transfer degrees, the associate in arts degree was most commonly awarded (58.7 percent). More than one-third (37.5 percent) of the baccalaureate/transfer degrees bestowed were associate in science degrees. The proportion of AA and AS degrees granted has changed very little in the past five years. The total number of transfer degrees awarded increased 3 percent since fiscal year 1996.

An examination of the occupational degrees and certificates awarded in fiscal year 1997 reveals that 47 percent (9,213) were associate in applied science degrees. Thirty-one percent of the completions were for certificates of less than one year. After a slight increase in 1995, the total number of occupational completions have decreased in the last two years. Compared to 1993, occupational completions decreased nearly 12 percent. Short-term certificates (less than one year) experienced the largest decrease (16.2 percent), while associate in applied science degrees and certificates of one year or more decreased 9.8 and 9.0 percent, respectively. Although small in proportion, vocational skills decreased 40.6 percent in the five-year period. However, it is important to note that, while the number of occupational and vocational graduates has decreased, the number of students served through noncredit offerings, including business and industry training, has increased.

Comparison of adult basic and adult secondary education certificate completions over the past few years illustrates the outside influences on the program. Historically, the number of completions in the adult education program has fluctuated due much to the problematic nature of reporting adult education graduates and inconsistencies in data reporting. The Illinois Community College Board is seeking alternate methods of data collection in order to improve adult education completion information. (See Table B-2.)

### Summary of Graduates by Degree Categories

Gender of Graduates by Degree Category. During fiscal year 1997, six out of ten degrees and certificates were earned by females. Excluding the lone female who completed an associate in fine arts degree, the specific degree attained by the highest proportion of females was the associate in applied science degree (67 percent). Although small in number (31), associate in engineering science — a new degree program in the Illinois community college system — had the highest proportion of male graduates (83.8 percent). The associate in applied science was the specific degree program with the largest number of male graduates (3,024). The male/female distribution within the baccalaureate/transfer degree and occupational degree and certificate areas reflects the overall proportion. (See Table B-3.)

Racial/Ethnic Origin of Graduates by Degree Category. Approximately 24 percent of all degrees and certificates in fiscal year 1997 were awarded to minority (non-white) students. An examination of the collegiate-level graduates reveals nearly the same proportion of minority students. Eighteen percent of all fiscal year 1997 baccalaureate/transfer degrees were earned by minority students, the majority of which were associate in arts designations (61.4 percent), while 36.6 percent were associate in science degrees. This is 1 percent more than the previous year's overall proportion of minority baccalaureate/transfer completers. A larger number of minority graduates was found in the occupational area (5,275) than in the baccalaureate/transfer area (2,321). More than twice as many black students completed collegiate-level programs than did Hispanic students in fiscal year 1997. Comparisons indicate more

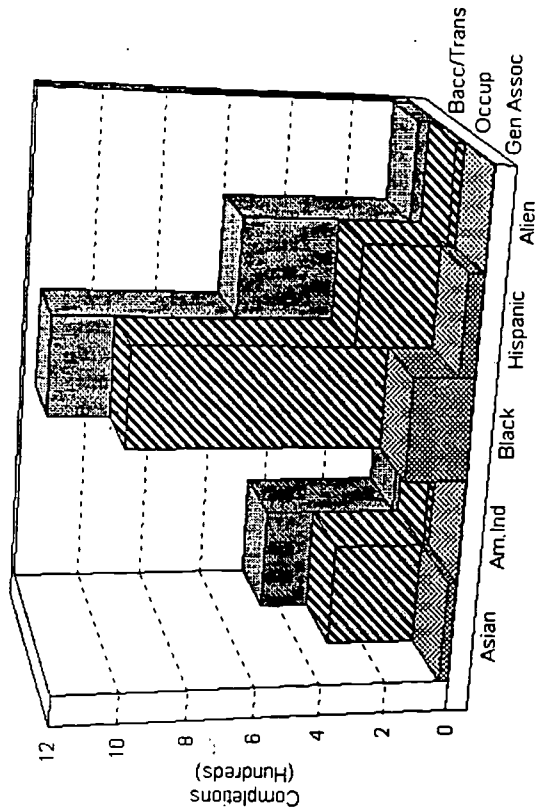


Fig. 3. Fiscal Year 1997 Associate Degrees Earned by Minority Students

college-level degrees than certificates were awarded to minorities. (See Table B-4). Figure 3 illustrates the distribution of minority students who successfully completed degree programs in the Illinois community college system during fiscal year 1997.

Age of Graduates by Degree Category. Sixteen percent of the completers were in the under 21 year old age group. These graduates were predominately (54.5 percent) in baccalaureate/transfer programs. The 21-24 age group accounted for 29 percent of the total graduates, while the 25-30 and 31-39 age groups each accounted for nearly 20 percent. More than half of the students under age 25 completed baccalaureate/transfer degrees. Approximately three-fourths of the 31-39 year olds earned occupational degrees and certificates. In fact, across all age groups, the proportion of occupational graduates increased as age advanced. The largest number (803 or 42.5 percent) of reported precollegiate-level graduates were under 21 years of age. (See Table B-5.)

Intent of Graduates by Degree Category. These self-reported data convey the primary goal that the student wants to achieve as a result of his/her studies. The community colleges examine current intent versus student intent at the time of initial enrollment at the college. In these analyses, current intent (when available) was analyzed to reflect the changing needs and desires of the community college student.

More than 70 percent of those students who attained a baccalaureate/transfer degree indicated that they wished to prepare for transfer to a four-year institution. Twelve percent of these successful students indicated a desire to prepare for a job immediately after community college -- an intent that would most often be associated with seeking an occupational degree or certificate. Likewise, only 66 percent of those students who attained an occupational degree or certificate indicated that they were preparing for a job immediately after completing community college or improving present job skills. Seventeen percent of these occupational graduates indicated that they sought preparation for transfer to a four-year institution. However, pursuing an occupational degree does not preclude a student from transferring. In fact, more than half of these occupational completers who indicated a desire to transfer were Health Professions and Related Sciences and Business Management and Administrative Services graduates. A review of the collegiate completers' intent revealed that, although 58 percent of the adult secondary education graduates had intended to improve their basic skills or prepare for the GED, 13 percent plan to proceed toward a new job after college. (See Table B-6.)

Degree Objective of Graduates by Degree Category. The self-reported degree objective conveys the student's expected outcome from attending the community college, and one would expect them to mirror the completion patterns of those students. Eighty-five percent of those students who earned baccalaureate/transfer degrees in fiscal year 1997 indicated that they enrolled with a desire to complete an associate degree. Eleven percent indicated that they wanted to complete only one or several courses. Eighty-four percent of the occupational students who earned an associate in applied science degree had listed completing an associate degree as their objective. Seventeen percent of the collegiate-level students who set out to complete a certificate went

beyond their expectations and earned an associate degree. Nearly 80 percent of the adult education completers indicated that they only expected to complete one or several courses. The remaining graduates identified a desire to complete an associate degree (12.7 percent) or certificate (8.2 percent). (See Table B-7.)

### SUMMARY

An examination of fiscal year 1997 demographic enrollment data reveals that there is not a "typical" community college student; slightly more than half of the students are female, one-third is of minority ethnicity, and two out of every five students are 31 years of age or older.

Based on fiscal year 1997 data, community college enrollments have increased slightly since the previous year, while the number of graduates decreased slightly. Coupled with the growing number of students served through noncredit courses, which provide training for personal, business, and industry skills, these data indicate that the Illinois community college system successfully educates an expanding number of students and makes a substantial contribution to training a competent workforce armed with skills that have prepared them for further education, new jobs, or career advancement.

The Illinois community college system prepares analyses on an extensive array of information pertaining to students' educational experiences. In addition to enrollment and completion data, information is collected on student migration between community colleges and universities (shared data), follow-up of occupational program graduates and coursetakers, program review, minority student studies, and persistence and transfer rate studies. These studies, along with a comprehensive state strategic plan which promotes student access and opportunity and encourages partnerships in education, government, and business, enable the Illinois community college system to carry out its mission to provide high-quality, accessible, cost-effective educational opportunities for the individuals and communities across the state.
