ABSTRACT

The report describes activities and achievements of the Attention Deficit Disorder (ADD) Teacher Inservice Project. The inservice program was developed using a formal process to identify the critical issues related to ADD awareness, assessment, and intervention. Program content was designed to address critical issues identified in the research literature. Comprehensive training materials were developed for each of the following modules: (1) characteristics, assessment, and management of ADD--an overview; (2) the school and ADD; (3) educational identification and assessment of ADD; (4) medical issues and medication management of ADD; (5) understanding behavior; and (6) specific classroom interventions for ADD. Training materials developed include presenter scripts, comprehensive participant handouts, audio-visual materials (slides, overheads, video tape), and evaluation materials. The 22-hour program was targeted primarily toward regular and special education teachers, as well as administrators, counselors, school nurses and related personnel. Dissemination was accomplished through direct training and adoption of a training of trainers model. The project has provided over 1,500 hours of direct training to more than 5,300 teachers and other personnel. The program was disseminated systematically across Arkansas and 352 individuals have been trained as inservice trainers, including participants from 13 different states. (Author/DB)

## **ABSTRACT**

The goal of the Attention Deficit Disorder (ADD) Teacher Inservice Project was to develop, evaluate, and disseminate a comprehensive ADD teacher inservice program. The program was developed using a formal process to identify the critical issues related to ADD awareness, assessment, and intervention. The program content was designed to address the critical issues and is based on the research literature. Comprehensive training materials were developed for each module, including fully-referenced training manual, presenter script, comprehensive participant handouts, audio-visual materials (slides, overheads, video tape), and evaluation materials (pre-post test, evaluation form). The developed inservice program consists of 22 hours of inservice material contained in six modules. The program was targeted primarily towards regular and special education teachers, as well as administrators, counselors, school nurses and related personnel. A systematic evaluation plan was used to modify program content. Dissemination was accomplished through direct training and adoption of a training of trainers model. To date, the project had provided over 1500 hours of direct training to over 5,300 teachers and related school personnel. The program was disseminated systematically across the state of Arkansas and participants from 13 different states have been trained. Three hundred and fifty-two individuals have been trained as inservice trainers and provided with a complete set of the training program materials.

## **PROJECT REVIEW**

The project accomplished the original objectives within the proposed timeline (see Appendix A). The core staff met approximately weekly throughout the course of the project to assess the progress toward the purpose and objectives. The accomplishment of each of the objectives is summarized below.

### **Phase I: Develop, pilot and evaluate an ADD inservice curriculum and training format (Objectives I-III)**

The development of the core inservice modules (Modules 1, 2, 4, 5, & 6) was completed in Year 2, and the evaluation module (3) was completed in Year 4. The inservice content consists of 16 hours of inservice material contained in the five core modules covering the critical issues in ADD awareness and intervention, targeted towards the general education audience. An additional 6 hour module was developed to train evaluators in the educational identification and assessment of ADD (Module 3). A summary of the inservice content is detailed below.

**Module 1: Characteristics, Assessment, and Management of ADD: An Overview (4 hours).** Module 1 is designed to increase awareness of the issues related to the characteristics, assessment, and management of ADD. This module is a prerequisite to all other inservice modules. Topics include: Characteristics of ADD (Brief History, Primary Features, Other Characteristics, Other Problems Associated with ADD, Causes), Assessment of ADD, and Management of ADD.

**Module 2: The School and ADD (2 hours).** Module 2 is designed to address the critical issues of accessing services for children with ADD within the school system, emphasizing Section 504 and IDEA. Topics include: Legal Rights of Children with ADD, Educational Identification, Evaluation and Intervention Obligations, and A Response Model for ADD.

**Module 3: Educational Identification and Assessment of ADD (6 hours).** Module 3 provides an in-depth look at the issues of identification and assessment of ADD from an educational perspective. This module is designed for those involved in the evaluation of children with ADD. Topics include: Standards of Practice in the Assessment of ADD, Overview of Assessment Methods, Issues in Interpreting and Integrating Assessment Data, and Building an Assessment Model.

**Module 4: Medical Issues and Medication Management of ADD (2 hours).** Module 4 provides a review of what educators need to know about medical issues and medication management of ADD. Topics include: Medication Intervention (Classes of Medications, Pharmacology of Stimulants, Medication Management, Medication Titration, Adverse Reactions and Side Effects, Contraindications to Stimulant Use, Use of Nonstimulants, and Long-Term Issues),

Rationale for Non-Medication Management, The Role of the Teacher and School Nurse in Medication Management, and Case Studies.

**Module 5: Understanding Behavior (2 hours).** Module 5 provides a review of the principles that underlie the classroom interventions presented in Module 6. Topics include: A Behavioral Approach to Understanding Behavior, The Role of Antecedent Events, The Role of Consequences, and The Role of Modeling.

**Module 6: Specific Classroom Interventions for ADD (6 hours).** Module 6 provides an in-depth look at the description, advantages, limitations, and implementation of specific classroom interventions for children with ADD. This module is designed primarily for elementary level regular and special education classrooms. Topics include: Antecedent Interventions (Classroom Environment, Effective Communication Strategies), Contingency Management Interventions (Selective Use of Attention, Home-Based Reinforcement Program, Classroom-Based Reinforcement Program, Withdrawing Teacher Attention, Reprimands, Response Cost, Time Out), and Developing an Intervention Plan.

The piloting of the core inservice modules took place in both a rural and urban area at the end of Year 1. Evaluation of the pilot training was completed during the early months of Year 2. The core modules were revised based upon evaluation feedback. The modules were again piloted during Year 2. Module 3 was piloted and evaluated during Year 4, and revisions were made based upon feedback.

**Phase II: Development, piloting and evaluation of a program for training ADD inservice trainers (Objectives IV - VI)**

The development, piloting and evaluation of a program for training ADD inservice trainers was begun in Year 2 and completed during the first of half of Year 3. Comprehensive training materials were developed for each module, including a fully-referenced training manual, presenter script, comprehensive participant handouts, audio-visual materials (slides, overheads, video tape), and evaluation materials (pre-post test, evaluation form).

Evaluation of the training of inservice trainers was monitored. The inservice trainers were required to send all completed evaluation materials to the project staff, where these results were tabulated and recorded, and feedback was provided to the trainer. Consultation was also provided to the trainers as needed. The median evaluation rating across all trainers for each of the modules is provided in the table below.

**Phase III: Training, evaluation, and consultation to ADD inservice trainers, production of a video, and dissemination of the ADD inservice program (Objectives VII-XI).**

**Training, evaluation and consultation to ADD inservice trainers (Objectives VII-IX).** The project has trained 352 trainers in the core curriculum (Modules 1, 2, 4, 5, & 6). There were 189 trainers within the state of Arkansas, representing each of the 15 educational cooperatives, and the three central Arkansas school districts (representing all of Arkansas), approximately 150 trainers within the state of Florida, and 13 trainers representing the following states such as: Florida, Idaho, Illinois, Louisiana, New Hampshire, North Dakota, Ohio, Oklahoma, Pennsylvania, Rhode Island, Texas, and Virginia (see Appendix D). These trainers were provided with comprehensive training materials for each of the modules; audio-visual training materials (slide sets, overheads, and video) were provided or made accessible to all trainers.

In addition, training in Module 4 (Medical Issues and Medication Management of ADD) was provided to school nurses and interested inservice trainers. Approximately 85% of the trainers had received training in Module 4 at the completion of this project.

The project staff monitored the dissemination of the inservices provided by the trained trainers and provided consultation and feedback throughout the course of the project. The project also served as a clearinghouse for statewide ADD inservice training by arranging trainers to provide the inservice for schools, school districts, and educational service cooperatives that requested the training. The project recorded inservice activities (see Appendix B), attendance (see Appendix C), and evaluation results. Ongoing feedback was provided to trainers through summarization of evaluation results.

Due to the demand for inservices beyond the timeline of the project, arrangements were made with the Arkansas Special Education Resource Center (ASERC) to serve as a clearinghouse for the project, effective September 1, 1997. ASERC is funded by the Arkansas Department of Education, Special Education and includes among their personnel, four trained inservice trainers. These trainers will be available to provide training or coordination of services for those school districts requesting training, and provide support to those trainers who wish to remain active in the future.

**ADD inservice program video (Objective X).** In Year 4, the project developed and produced a video of selected interventions demonstrated in a series of classroom vignettes, featuring classroom teachers implementing selected interventions within a classroom setting. To determine which interventions to include in the video, the project staff developed and distributed a survey to all active trainers asking them to select interventions they would most like included. Based upon this feedback, the video was produced demonstrating the most requested interventions. The video was distributed to active trainers during Year 4 to be used as a teaching aid with Modules 5 & 6.

**Dissemination of ADD inservice program (Objective XI).** The final three years of the project were focused primarily on the implementation and evaluation of a systematic dissemination plan. The dissemination plan included broad dissemination to regular and special education teachers and other non-teacher groups (see Table 2) through a training of trainers model.

The dissemination plan included the provision of the complete inservice program and training of trainers session in each region of the state of Arkansas, each year of dissemination (Years 3, 4, & 5). The training was directly marketed to the groups listed in Table 2.

Module 3 (Educational Identification and Evaluation of ADD) training was provided during Year 4 and was targeted towards each of the groups listed in Table 2 that had a role in evaluation. By the final year of the project, inservice training was open to all interested educators and related personnel through a series of four day inservices consisting of all the modules and a training of trainers workshop.

The trained trainers and the project staff also cooperatively provided ongoing training through the staff development activities of the state educational service cooperatives and through invited inservices. The project staff was responsible for the marketing of the inservice program and assisting in the scheduling.

School nurses received training in Modules 1 and 4 during Year 4 through a cooperative effort of the Arkansas Department of Education and UAMS College of Nursing. This inservice was well attended by school nurses statewide. Future recruitment of school nurses was handled by the project staff through direct marketing of scheduled inservice dates. School nurses were also allowed to train in the additional modules.

Regional and national marketing of the inservice project took place during Year 5 through direct marketing to the state education directors. Representatives from the following states were trained: Idaho, Louisiana, New Hampshire, North Dakota, Ohio, Oklahoma, Pennsylvania, Rhode Island, Texas, and Virginia. The Florida Department of Education contracted for training of 150 trainers, representing the state of Florida.

To date, the project has provided over 1500 hours of inservice training to over 5,300 teachers and school personnel (see Appendices B & C). Training has been provided systematically across the state of Arkansas, through a combined effort of the project staff and trained trainers.

In addition, a web page was also created during Year 5 of the project. This web page featured brief articles related to facts about ADD, facts about medication, and various classroom interventions discussed during the inservice. Information concerning the inservice content, curriculum, and project staff was also included in this web page. An e-mail address was made available for questions to the project staff.

### **PRODUCTS DEVELOPED**

1. A bibliography containing over 1500 articles, chapters, books, and training materials related to attention deficit disorder was produced during Year 1 of the project and updated during subsequent years.
2. Complete training materials for each inservice module, which include a fully-referenced training manual, presenter script, comprehensive participant handouts, audio-visual aides (slides, overheads, and video), and evaluation materials (pre-post test and evaluation form). These materials include approximately 639 pages of printed materials and 656 presentation slides (or overheads), and a 20 minute video.
