ABSTRACT

The guide provides a quick reference to the database, servi : , and additional resources of the ERIC System that may be of use in adult Miglish-as-a-Second-Language (ESL) literacy work. It first explains the role of the National Clearinghouse for ESL Literacy Education, then describes the ERIC database and the kinds of adult ESL literacy materials contained in it, outlines a strategy for planning a database search, lists common descriptors used in the database for adult ESL concepts, and lists points of access to the ERIC system, including electronic mail and World Wide Web addresses, print resources, services for obtaining print copies of materials, and ACCESS ERIC, the agency that coordinates the ERIC system's outreach, dissemination, and marketing functions and provides general reference and referral services. ERIC Database and Adult ESL Literacy Materials

At the center of the ERIC system is the ERIC database. The world's largest education database, it contains over 950,000 bibliographic records and full-text documents related to education, including such materials as conference proceedings, research reports, and curriculum guides—many on topics in adult ESL literacy and instruction.

The database can be searched any number of ways, through various interfaces. You can search it at libraries and other educational institutions, on-line via CD-ROMs, or via on-line public access catalogs. You can also access the database via the Internet (See "ERIC on the World Wide Web" below). Keep in mind that different search mechanisms will have different features and limitations, such as the extent of the database available for searching or the variety of criteria to be used f searching. These differences will greatly affect the success of your search, whether you are new to searching the ERIC database, or you are an experienced user desiring a highly specific search.

Planning a Search Strategy

Define the topic in your own words.

I want to locate curriculum units on citizenship for adults learning English as a second language.

Divide the topic into its major components. These components will generally be the key words or concepts that you will use to construct your search.

citizenship, adults, ESL, curricula

Use the Thesaurus of ERIC Descriptors to locate subject descriptors that best represent the components of your topic. The Thesaurus of ERIC Descriptors lists all the terms used by the ERIC system to describe and index each of the abstracts of the documents and journals in the database. The search interfaces do not require use of ERIC descriptors only. Some interfaces provide pull-down menu choices for the field to be searched (author, title words, journal name, etc.) Use of ERIC descriptors may simply help refine your search and accurately target each step in the search process.

Relevant ERIC descriptors: citizenship education, adult, education, adult programs, English (Second Language), limited English speaking, non English speaking, curriculum guides

Combine your components in a search strategy to extract the documents that you need. All search interfaces for the ERIC database are based on Boolean logic. Boolean logic allows you to combine multiple concepts in a way that will retrieve a specific set of documents from the database. It employs three primary operator terms that enable you to define the way in which the terms or concepts are combined: "and", "or", and "not." Using "and" to join your terms ("adult education and English as a Second Language and reading skills") will result in a set of documents in which each individual document contains all the terms. Using "or" to join your terms ("adult education or English as a Second Language or reading skills") will result in a set of documents in which each document contains at least one of the terms, but not necessarily all. In general, using "and" restricts the results and using "or" broadens them. Using "not" eliminates terms or concepts you specifically don't want included.

Refine your search, if necessary. Too many documents in your results? You can also limit the search by specifying a publication type such as research report or curriculum guide, narrowing the dates of publication, or reducing the descriptors that you use. Too few documents? Add more descriptors or descriptive terms for each concept in your topic.

Following are some of the most common descriptors used when searching for materials about adult ESL literacy and instruction. These terms can be combined and used with other topic terms to expand or limit your search to materials relevant to adult ESL literacy instruction. They are not an exhaustive list of descriptors, but they can get you started in your search for ERIC documents about adult ESL.

Common Adult ESL Descriptors for Concepts:

adult basic education adult education adult literacy adult programs literacy education migrant adult education adult learning English (second language) limited English speaking non English speaking second language instruction second language learning vocational English (second language)

When you have extracted the documents that you want, you will be provided with an abstract for each document. This abstract will contain reference information about the document (title, author, sponsor, publication data, ordering information, length, etc.), a brief description of the document's contents, and a list of the ERIC descriptors assigned to it. You can use this abstract to decide if you want to view the document in its full-text version.
