ABSTRACT

This Kids Count publication is the first to examine statewide trends in the well-being of Montana's children. The statistical portrait is based on 13 indicators of well-being: (1) low birthweight rate; (2) infant mortality rate; (3) child death rate; (4) teen violent death rate; (5) percent of public school enrollment in Chapter 1 programs; (6) percent of public school enrollment in special education; (7) percent of population younger than 16 years in out-of-home placements; (8) child abuse and neglect rates; (9) child poverty rate; (10) percent of public school enrollment in free/reduced meals; (11) percent of all births to single teens; (12) percent of youths in alcohol/drug treatment; and (13) juvenile crime as a percent of the population. The bulk of the data book presents the findings on the well-being indicators and notes trends from the mid-1980s when data are available. The data book indicates that Montana's infant mortality is the lowest among neighboring states. However, births to single teens and the percent of children living in poverty are increasing. The data book also contains data notes and sources and acknowledgements. The county profile book presents statistical profiles arranged by county for each of Montana's counties, as well as information on demographics, parental employment, single parent families, percent of children with limited English proficiency, welfare program participation, school enrollment, and family risk. 

Introduction

Montana KIDS COUNT is a project begun in January, 1993, funded by a four-year grant to Healthy Mothers, Healthy Babies, the Montana Coalition from the Annie E. Casey Foundation. The purpose of the KIDS COUNT Project is to profile the condition of children in Montana through:

- Improving the collection and use of data on the condition of children and issuing a Montana KIDS COUNT Data Report annually.
- Increasing the awareness of policy makers, care providers, and the general public of the status of Montana's children and creating a demand for action.
- Developing a partnership with state and community leaders to activate Montana citizens to improve the well-being of Montana's children.

Montana ranks forty-fourth nationally in population, yet is the fourth largest state in the United States. The ruralness and sparseness of the population in Montana has influenced the distribution of health care and social services and has greatly increased the challenges in service delivery and

access. Montana's children are vulnerable to these inequities. Because Montana lacks a centralized repository of data about children, readily available and reliable information is lacking. The KIDS COUNT Project's goal is to provide a strong foundation of data about the status of Montana's children and families.

Montana's KIDS COUNT Project is a collaborative effort of the following: Healthy Mothers, Healthy Babies – The Montana Coalition and the State of Montana including the Governor's Office, Department of Family Services, Department of Health and Environmental Sciences, Department of Corrections and Human Services, Department of Social and Rehabilitation Services, Office of Public Instruction, Montana State University, Governor's Office of Indian Affairs and Montana Legislature. Private organizations participating include The Montana Hunger Coalition, Montana Children's Alliance, Mental Health Association of Montana, Montana Council of Families and the Montana Council for Maternal and Child Health.



Overview

Montana's 1994 KIDS COUNT Data Book provides a core of material essential to understand the well being of children in this Big Sky State. Sponsored with the generous support of the Annie E. Casey Foundation, this book attempts to provide in a single place important facts upon which policies and programs impacting children's issues can be based.


The indicators in this collection have been selected in consultation with experts and program administrators in Montana. Attempts were made to provide data which will be comparable to that available for neighboring states. Where possible, trends over several years are included to show those areas which are improving as well as those which exhibit decline.

The following general guidelines dictated the selection of indicators of children's health and welfare:

- Child experts widely regard the evidence to meaningfully signify health or policy concerns.

- The indicator is understood by the public.
- Policy makers generally consider the information to be of significance.
- The evidence can be obtained with relative ease.
- There are prevention and intervention techniques known to be associated with the measure.

Montana is a large state with a small population—under a million residents. Accordingly, rates or trends based on small numbers must be interpreted with caution. In no case can substantive conclusions be drawn from incidence of less than five. In this regard, the next issue of the Montana KIDS COUNT Data Book will present several trends based on five-year averages and will be invaluable for defining the health and welfare of Montana's infants, children, and youths in future reports.

What We Can Do

Do we cherish our children enough? How can one shake a baby to the point of intra-cranial bleeding? How can we purchase cigarettes and alcohol for ourselves and feed our children junk food morning, noon and night? Why do we start an automobile prior to fastening our seat belts? We cannot continue to pay vast amounts of money to repair the results of a dysfunctional society and not address prevention.

It is time to cherish our children by providing a safe and nurturing environment that will lead to maximizing the potential of every child.

The fact is that a healthy newborn starts with the mother's

pregnancy. A healthy, concerned, caring mother is capable of bearing healthy babies. Certainly some congenital conditions result in birth problems, but these are minimized when good prenatal care and a healthy mother are involved.

As a society, we need to hold the line on resources expended to care for a self-indulgent, lazy, and uncaring adult population and put our resources to work on raising one generation of healthy babies followed by another and another. Putting money into appropriate prevention makes more sense at this time of diminished resources than any other effort. We cannot afford to do otherwise!

Health

Protecting the health of Montana's children is a task of monumental proportions. From the cradle on, illnesses, accidents and acts of violence claim many young lives each year.

State agencies and private organizations are accepting the challenge of defining the scope of these risks and spearheading efforts to reduce the dangers as much as possible.

Infant mortality, for instance, is a widely used indicator reflecting the health status of pregnant women and infants. The infant mortality rate in Montana in 1991 was 7.1, lower than the U.S. average and lower than neighboring states. This decrease in infant mortality coincides with the efforts of Montana's Initiative for the Abatement of Mortality in Infants (MIAMI).

Low birthweight is a leading cause of infant morbidity and mortality. Low birthweight rates in Montana have shown virtually no improvement over the past 15 years.


Beyond the obvious toll which these circum-

stances impose on families and Montana's future generations in terms of emotional distress, there are other consequences.... a low birthweight baby costs a minimum of \$610 per day and can produce \$70,000 in hospital costs alone. A very low birthweight infant may require lifetime care with costs which can exceed \$400,000.

Over the past three years, Montana has experienced an increase in child accidental deaths. Fires and motor vehicle accidents claimed most. And, since poverty and child death are intertwined, the State continues to be in a vulnerable position.


Violent teen deaths in Montana are lower than the national average, but many other states have recently seen an alarming increase. The answer to this problem seems to lie in a coalition of efforts in the home, the school, and law enforcement.

As Montana citizens, we need to increase our efforts to make our part of the world safer, more secure and less dangerous to our children.

It is expensive not to provide comprehensive maternity care. In 1988, \$4.2 million, or one-half of the total Montana Medicaid budget of \$8.3 million, was spent on only 4 percent of the births. A majority of those babies were of low birthweight which could have been prevented with regular prenatal care. Medicaid pays an average of \$19.48 for each prenatal visit; comparing that cost to neonatal intensive care costs of \$610-\$2,000 per day makes it apparent that money used for prevention is well spent.

' LOW BIRTHWEIGHT BIRTHS

The rate of infant death is accepted throughout the world as measuring a society's overall health status and a nation's health and well being. Gains have been made in ensuring the survival of infants and improving the quality of their lives. However, the U.S. continues to have one of the highest rates of infant mortality (9.9 deaths per 1,000 live births in 1988), ranking 19th behind other industrialized countries such as Singapore, Hong Kong and Spain.

The high U.S. infant mortality rate is due largely to low birthweight (LBW, 5lbs. 8 oz. or less) babies being born too soon or too small.

The Institute of Medicine in their 1985 landmark study, Preventing Low Birthweight, concluded that every dollar spent on comprehensive prenatal care services to high-risk, low income women saved \$3.38 in expenses in newborn intensive care units (NICUs). Their analysis did not consider long-term health care costs and other life-long financial burdens.

The high U.S. infant mortality rate is due largely to low birthweight (LBW, 5lbs. 8 oz. or less) babies being born too soon or too small. LBW is the major reason Montana infants die in their first year, with inadequate prenatal care identified as the leading cause of LBW. Many Montana women lack appropriate, affordable, accessible and acceptable prenatal care due to lack of access to physicians and nurse midwives. The closing of rural hospitals and obstetrical services has made access to care even more difficult. 24


Montana's Initiative for the Abatement of Mortality in Infants (MIAMI), passed by the 1989 legislature, provides for public education on the need for early and continuous prenatal care through the BABY YOUR BABY Program. It provides care coordination services needed to ensure optimal pregnancy outcome and reduce infant mortality. In the local MIAMI Projects, pregnant women are screened for medical and/or psychological risk of preterm labor or low birthweight; assisted to access medical prenatal care, optimally during the first trimester of pregnancy; educated about signs and symptoms of preterm labor; educated and assessed regarding use of alcohol, tobacco and other drugs; assessed for nutritional status and risk; and referred to WIC, other agencies and programs for services, treatment, and other assistance. MIAMI has documented improved outcomes and decreased health care costs.

A low birthweight baby costs a minimum of \$610 per day and may be hospitalized 7 to 20 days on average. A very low birthweight (VLBW, less than 3 lbs. 3 oz.) survivor (one who eventually goes home) averages \$31,000 to \$71,000 in hospital costs alone. VLBW infants are more likely to have problems requiring lifetime care, which average \$415,588.

The incidence of low birthweight is decreasing in Montana. Approximately 1/2 of the counties experienced a decrease in low birthweight. However, approximately 1/2 experienced either an increase or no change in their low birth weight incidence. Continued efforts are necessary to reach the goal of no more than 5 low birthweight and 1 very low birthweight births per 1,000 live births, in order to meet the National Year 2000 objectives.

INFANT MORTALITY

Infant mortality (IM) is a widely used indicator reflecting the health status of pregnant women and infants. IM is the number of deaths of infants from birth to age one year per 1,000 live births. The United States ranks 19th in the world in IM, compared to 6th in the 1950s. The Montana IMR for 1991 was 7.1.

The Montana Infant Mortality Rate for 1991 was 7.1. A close look at IM in Montana may help focus attention on problem areas. IM has two components; neonatal mortality and post-neonatal mortality. The neonatal mortality rate is the rate of deaths from birth to age twenty-eight days per 1,000 live-born infants while the post-neonatal mortality rate is the number of deaths from age twenty-eight days to one year per 1,000 live births.

The neonatal mortality rate results primarily from prematurity (and complications of prematurity), birth defects and problems associated with other compli-

cations of pregnancy. Neonatal mortality is affected strongly by maternal health problems, socioeconomic problems and access to medical care. IM in Montana declined from 1970 through 1990. Most of this improvement came from reducing neonatal mortality. Montana benefitted from this trend and in the 1980s could proudly point to a neo-natal rate that was among the best in the nation. By 1989, Montana's neonatal mortality rate was 5.6, but no longer among the top ten states. Indeed, most of the neighboring mountain states did better by the end of the 1980s. In 1990, Montana experienced 6.1 babies under 5 pounds 8 ounces per 100 babies born. This rate is high and should be no more than 5.0. During the 1980s, a number of events occurred in Montana which may have limited access to medical care. Several communities in Montana, including Plains and Superior, lost physicians capable of providing obstetrical care.

The number of prenatal medical visits that the pregnant woman completes correlates with low

birth weight and neonatal mortality rates. The highest neonatal mortality is among the babies whose mothers had the fewest prenatal visits. A baby who is born three to four months early and weighs 1½ to 3 pounds requires extensive neonatal intensive care services which can easily exceed \$100,000. It is easy to justify resources for relatively inexpensive prenatal preventative care, which in many cases may make expensive neonatal intensive care unnecessary.

The post-neonatal mortality rate reflecting deaths from age twenty-eight days to one year remained high in Montana throughout the last twenty years. Ongoing studies indicate that Montana has some special problems that are compounded by poverty and limited access to care. In Montana the Native American population is the group that suffers from higher rates of infant deaths, especially in the post-neonatal period. This is thought to be largely related to poverty and social factors.

While Montana's infant mortality rate compares favorably to its neighbors (page 11), deaths among infants account for more than half of all deaths of children under age 14.

CHILD DEATH

Over the past three years Montana has had an increase in the child death rate. In 1990 we were ranked 18th nationally (latest available data). However, we are significantly better than our neighbors (National KIDS COUNT Data Book).

A nagging omen continues to haunt the state. According to the 1994 National KIDS COUNT Data Book, Montana ranks 37th nationally in child death rate (ages 1-14). Children in poverty, since poverty and child death are intertwined, Montana is in a vulnerable position. With regard to child poverty, Montana is worse than all its neighbors. Poor children die at a rate significantly greater than that for financially secure children. (Peds, Sept. 1991)

In 1991 accidents claimed more than half of the child deaths: 57.9% in the 1-4 year age range and 52.6% among the 5-14 year olds. Fires and motor



vehicle accidents claimed the bulk of the children dying in these age groups. These are, for the most part, preventable.

Our emphasis, then, needs to be placed on prevention. Recent studies reveal less than 50% of our 2 year old population is properly immunized, whereas virtually every child entering school is current on his or her immunizations. We are all aware that \$1.00 spent to immunize a child saves \$10.00 in treatment of vaccine preventable diseases.

Many children who are Early Preventive Screening Diagnosis and Treatment (EPSDT) Program eligible are not receiving services that are readily available at little or no cost to the parent. As of 9/30/92, Montana EPSDT population totaled 43,443. Of that number, 6,810 or 16% had received well-child screens (Medicaid paid only).

If Montana is to reduce child death, preventative action must take place.

While roughly 70 percent of reported violent teen deaths are due to accidents, nearly one fourth are suicides.

TEEN VIOLENT DEATH

If you compare Montana statistics about violent teen deaths with statistics from other western states the first impression is that this state has a relatively good record—only 0.09 deaths as a percentage of the population.

The overwhelming number of teen violent deaths occur when the victim has lacked adult supervision.

So, many Montana parents are doing something

right. But, that is hardly an excuse for complacency. We have seen statistics about other states suddenly increase... Colorado and Kansas are up by 17%....Michigan is up an alarming 131%. How do we prevent that from happening here?


The answer lies in a combination of activities involving school authorities, parents, and law enforcement agencies. Another important part of the solution is early intervention.

We have talked to hundreds of teen-agers and parents, and have listened to their regrets and heart

aches. These teens are often belligerent, challenging, uncooperative and without respect for adult moral and ethical guidance.

Some of the movies, TV shows and music of this generation do not contribute to the restoration of basic family tranquility. So, if and until this occurs, the only practical solutions lie in the area of parent-police-teacher involvement in the rescue of our youth from the problems facing many young Montanans.

Education

In conjunction with communities and parents, schools provide an opportunity for students to achieve and find a role in society. Providing those opportunities is an investment in the future.


But some children require special programs or additional support in order to achieve.

Programs have been developed to serve the specific needs of students who may need academic assistance. Since the mid-1960s a program known as Title I or Chapter 1 has been federally-funded to help raise the academic level of students who have demonstrated below average achievement, and live in areas which have been impacted by low-income factors. Special education programs have been designed to provide additional

educational services for students with identified disabilities.


Other student support is given for additional language skills programs, counseling, or activities to provide productive after-school activities.

But it costs more to provide these special programs and additional opportunities for students. As educational resources decline and student enrollment increases (an 8% enrollment increase from 1990 to 1994), the additional higher cost programs are difficult for school districts to maintain. Students who need support to promote achievement, may find the additional opportunities for assistance becoming fewer and fewer.

percent of enrollment in public school, 1992




CHAPTER I

Chapter 1 is a federally funded supplemental education program designed to aid students who have demonstrated below average achievement, usually in reading, math, or language arts. Funds available to individual school districts are dependent on low income information provided by U.S. Census Bureau poverty figures, payments under Aid to Families with Dependent Children (AFDC), numbers of foster children supported by public funds, and numbers of children residing in private, local institutions for neglected and delinquent youth. Although the funding formula is generated primarily by low-income data, students are selected for services on the basis of objective educationally related criteria.

Participation figures reflect fluctuations in available funding. Since overall funding for Chapter 1 in Montana has continued to rise, the statewide trend is that more eligible children will be served. Again, because low income factors rather than educationally related factors generate the funding, there may not be increased services in some counties and districts. This does not necessarily mean that more children statewide are eligible each year, but it does indicate that more children statewide are served each year. The total funding for Chapter 1 in Montana has increased from \$13 million in 1991 to nearly \$23 million in 1994. This upward trend may not continue, depending upon what funding levels are approved by the U.S. Congress.

in public school, 1992




SPECIAL EDUCATION

The number of children needing special education identified by Montana public schools has grown significantly in recent years. The special education identification rate

measures the percentage of all students who have disabilities. The increase in the special education child count is primarily a function of the increase in identification rate. The growth of over 1,867

students between December 1, 1987, and December 1, 1992, represents a 12% increase. Montana public school enrollment during that same time period rose only 3%.



The vast majority of Montana children with disabilities receive most of their education in a general education setting. Of all the disability categories, learning disabilities stand out as the most common. Over 50% of all children with disabilities have a learning disability as their dominant disability. Three disability groups: learning disability (9,201 children), speech/language impairment (3,725 children), and cognitive delay (1,123 children) represent over 80% of all children receiving special education services in Montana. Other areas of disability in the special education child count include emotional disturbance, hearing impairment, visual impairment, multiple impairment, deafness, deaf/blindness, and other health impairments.

Security

There's no place like home???


For a growing number of Montana children, the warmth, support, and security of a normal home environment seems to be lacking. In 1992, Montana ranked second highest in the nation for increased reports of child maltreatment. Child abuse and neglect related to high divorce rates, increases in alcohol and drug abuse, mothers with HIV (AIDS) infection, and the crushing weight of economic factors are pushing Montana families into poverty.

Out-of-home placement, a court-mandated action removing a child from parental care and assigning him or her to a foster family, is a partial solution. But such actions sometimes create a new set of problems — serious emotional and behavioral situations for the child, the difficulty in finding and retaining quali-

fied foster parents and even occasions of abuse by foster parents.

The good news is that behavioral scientists now know what to do to prevent child abuse through high quality prevention programs. The Montana Legislature in 1993 adopted the State's first Family Policy Act, with new guidelines for the Department of Family Services', "Partnership to Strengthen Families" project.

Child & youth security in Montana, 1990 & 1992




In two recent years, reported child abuse among Montana children and youths has increased noticeably, while foster care levels are essentially unchanged.

Strategies are now being developed to shore up fragile families rather than waiting for crisis situations to require intervention. It is cheaper to fund programs that prevent family problems than to pay for expensive programs to care for and treat seriously troubled children.

Montana now is on the march toward preventing childhood neglect and abuse rather than treating the aftermath.

OUT-OF-HOME PLACEMENTS

"Out-of-home placement" refers to the movement of a child or youth from his/her home into foster care. Typically, this occurs after a judge finds evidence of child abuse and/or neglect and determines that placement is needed to protect the child. Removal of a child from his/her own home is a traumatic experience. Separation from one's family, even an abusive one, can cause psychological damage. Placements are used only when leaving the child in his/her own home would place that child at high risk of foster care have harm.


Increasing numbers of children entering foster care have serious emotional and behavior problems or physical disabilities. Foster family care is the most commonly used and least expensive form of foster care. In this arrangement, the child lives with an ordinary family in an ordinary home. All licensed foster parents receive basic training but some receive special training and learn to care for very troubled children, providing therapeutic foster family care. Specialized foster homes



provide care to seriously ill or disabled children. In group foster care, the child lives in a large house called a group home, with several other children of about the same age. Care is typically provided for by paid staff working round-the-clock shifts. Group care is commonly used for adolescents. Therapeutic group care occurs in group homes for youths with serious behavioral and emotional problems. For purposes of compiling statistics and calculating state budgets, children and youths placed in residential treatment centers and certain hospital and institutional settings are defined as being in foster care.

Increasing numbers of children entering foster care have serious emotional and behavioral problems or physical disabilities. Such conditions make foster parenting increasingly demanding and stressful. Foster parents need extensive training and supportive services to help them cope with their demanding responsibilities and to help curb the growing problem of abuse of foster children by foster parents.

CHILD ABUSE & NEGLECT

In 1874, a New England doctor examined an eight year old girl suffering from severe bruises, broken bones and malnutrition. At that time there were no laws to protect children from parental mistreatment. The New York Society for the Prevention of Cruelty to Animals convinced a judge that the child was a member of the animal kingdom and therefore protected by laws against animal cruelty.

It's hard to believe that nearly a hundred more years would pass before Dr. C. Henry Kempe first identified the "Battered Child Syndrome." In retrospect, we can see that the decision of the New York judge and Dr. Kempe's diagnosis were events that radically changed the history of our culture's relationship to children and families. There is strong reason to believe that the decade of the 90s also will be considered a redefining era. After years of treating the aftermath of abuse, there is now knowledge and technology to prevent it.

A powerful constellation of social and economic factors pushed an unprecedented number of Montana children into poverty during the past decade. Since poverty is the highest risk factor for abuse and neglect, it comes as no surprise that, in 1992, Montana ranked second highest in the nation for increased reports of child maltreatment.

Child abuse hurts. Academic achievement is often chronically delayed. Mal-

treated children suffer from low self-esteem, lack of trust, and poor relationships with adults and peers. Some children die.

Child abuse and neglect hurt everyone. Most of our major social problems have roots in child abuse and other severe inadequacies of childrearing. A recent study of three Eastern Montana counties found that 43 percent of youths adjudicated as delinquent had records of substantiated child abuse or neglect.

The good news is we now know what to do to prevent child abuse. The U.S. Advisory Board on Child Abuse and Neglect concluded that child maltreatment increases each year "in part because the nation has again delayed implementing what is known to work." Research repeatedly shows impressive success in preventing child abuse and neglect through high-quality prevention programs.

The 1993 Montana Legislature adopted Montana's first Family Policy Act. This legislation, new guidelines contained within the Department of Family Services budget, and the Department's new "Partnership to Strengthen Families Project" set a new course. They recognize that in most circumstances children do best when community care and concern is directed toward shoring up fragile families early on, rather than waiting for bad to turn to worse. They view the family as the child's best resource and set out strategies for marshalling community support to its aid.

The Vision

All children deserve to have a secure future, be free from hunger, and grow up in an economically stable family.

Schools Well-Being

Montana has its share — more than its share — of hungry children. So why doesn't Montana do something about it? Montana is trying. not kept pace.

In the eighties, nearly 30,000 Montana kids lived below the poverty level. By the nineties, this number increased to over 40,000. It was the second highest rate of increase in child poverty among the fifty states.

And, sadly, the biggest percentage of hungry kids were under age five: one out of every four.

As the nation and Montana embark on welfare reform measures in the near future, the plight of children in poverty needs to be addressed specifically or the situation may well become worse.

Montana has in place a "Free and Reduced Price" meal program in the schools. And, while the number of students eligible to participate in the program contin-


ues to increase, the number of students actually participating has not kept pace.

There appears to be a bias, not just in Montana, but throughout the nation, against families who take part in the program and this stigma is one of the greatest barriers to utilization of this activity.

There are proposed solutions to this paradox and, during the next legislative year, the Child Nutrition Act will be up for renewal in Congress.

During these deliberations a number of new ideas will be advanced to make the program easier to access and maintain.

Hungry children do not fare well in school nor does their plight bode well for future generations in the State.



POVERTY

During the 80s, Montana experienced the second highest rate of increase in child poverty among the 50 states. Between 1980 and 1990, the number of children living below the poverty line increased 44.2% to 43,237 children, meaning that about one fifth (21%) of all Montana children live in poverty. By county, the range in child poverty rates varies from 7.8% to 42.8%. In 16 counties more than 25% of the children live in poverty.


Two groups of Montanans are more likely to live in poverty: children under 5 (26% of all children) and families headed by females (48% with children under age 18).

During the 80s,

Montana experienced the second highest rate of increase in child poverty among the 50 states.

For families headed by females in Montana in urban counties, the rate is more than 52% whereas rural counties have a rate of 44%.

Poverty for female-headed families with children under 5 is most dramatic: almost 7 out of 10 (69.3%) for the State as a whole, with urban county rates of more than 73% and rural county rates of more than 66%.




In 1991 Montana exhibited a greater level of poverty among its children & youths than did its neighbors. Source: 1994 National Kids Count Data Book

Increased poverty rates are due to several factors. First, volatile employment, influenced by diminished extractive resources and closed mills; along with new jobs being generated in the low-wage service sector. These jobs frequently do not generate incomes sufficient to meet the needs of housing, clothing, transportation, and child care. Second are high rates of divorce and separation. Mothers and children disproportionately suffer when family dissolution occurs. Single-parent, female-headed households are most vulnerable to poverty, face the most demands for dependent child care, and have the lowest wage rates, most intermittent employment rates, and the fewest assets to draw on. Lack of financial support by absent fathers adds to the problem. Third is lack of affordable housing. Poor Montana families use, on average, more than 60% of their disposable income for housing (rent + utilities).

AFDC (Aid to Families With Dependent Children) is the major public program addressing needs of children in poverty. The degree to which children in poverty benefit from AFDC varies considerably among Montana counties, with an average of about 30% statewide. In urban counties, 42% of poor children receive benefits, while in rural counties only 19% do. These differences may signify that Montana children in poverty are not equally benefitting from poverty reduction programs.

FREE MEALS PROGRAM

Free and Reduced Price Meals (FRPM) are funded by the federal Child Nutrition Act and include school lunch and school breakfast. Participation in FRPM is an indicator of the financial health of a community. Nearly 33,000 Montana children participated in FRPM in 1992, up 1.2% from 1990. The number of eligible families is expected to continue to increase. Prejudice against participating families is one of the greatest barriers to under utilization. Only 6% of all eligible students participate — leaving many children hungry at school, unable to learn. The Child Nutrition Act is scheduled for renewal in the 1994 Congress. Proposed changes will eliminate the Reduced category, leaving only a Free category with expanded financial eligibility guidelines.

Application forms are available at participating schools



and in some WIC, AFDC offices, food banks, and other locations. The school is the approving authority with approval based only on income and family size. The Reduced Price breakfast is 30 cents and Reduced Price lunch is 40 cents. Students receive complete meals—breakfast, lunch or both. Parents often misunderstand and assume that if a brown bag lunch is sent from home, the student is entitled to free milk. Students are required to take a complete meal and the school must document the number of meals served; any deviation puts reimbursement funds in jeopardy. Schools must ensure the privacy of students and families, meaning students must not be identified in any obvious way; no lists, no special colored tickets, and no special lines for FRPM students. Current lists of FRPM students must be on file with the School Food Authority. An appeal process enables parents to appeal the decision of the School Food Authority if they feel their application has not been processed properly.

Social Behavior

The social behavior of Montana's younger population continues to be characterized by a series of inter-related behaviors which are not amenable to easy solutions.

Events such as juvenile crime, adolescent alcohol and drug use, and high rates of teenage pregnancies define the problem.

Some of the findings are encouraging. Such as the fact that 95% of Montana youth are never involved in the juvenile court system. While the rest of the nation is experiencing a significant increase in violent youth crimes, the State of Montana has witnessed an increase of only 6% from 1990 to 1992.

The number of teen pregnancies in Montana also has begun to increase after what appeared to be a reversal in teen pregnancies during the 1980s.


As the number of babies born out of wedlock

in Montana continues to rise, there is a growing concern about the future risks to the children of unwed teen mothers.

Along with these factors, there is also an apparent increase in adolescent alcohol and drug use. It is a well-documented fact that alcohol and drugs alter human physiology, change moods, impair cognition and induce high-risk behaviors.

As the nation approaches issues of health care reform, there are limited resources to deal with the behavioral difficulties facing youth today.

Community-based efforts in prevention and treatment involving families and agencies, such as teen parent programs, job skills programs, alternative schools, community health services, and family and youth mental health services, can offer many answers.



BIRTHS TO TEENS

In 1992, 12% of all live births in Montana were to teenagers. This percentage of births is below the national average; however, a high percentage of Montana teen pregnancies result in live births.

From 1980 to 1988, teen pregnancies and live births decreased and abortion rates increased slightly. However, since 1989 the trend has changed: the total number of teen pregnancies has increased; the number of live births has risen; and out-of-wedlock babies have escalated from 49% in 1983 to 71% in 1991.

In 1992, 12% of all live births in Montana were to teenagers. with the local school districts to provide education for pregnant girls and young mothers with babies. The girl may attend classes in the regular high school or alternative school and attend parenting classes, as well as having access to day care and counseling services. The Florence Crittenton Home in Helena is the only treatment-oriented licensed maternity home in the State offering services for seriously troubled pregnant teenagers.

Nationally, 53.1% of pregnant teens receive early prenatal care, compared to 76% of all other mothers. Because access to health care in Montana is a problem, there is even more concern about prenatal care for teenage mothers. The younger the mother, the greater the likelihood that she and her baby will experience health complications as a result of late entry into prenatal care, poor nutrition, and lifestyle factors.



Studies of pregnant and parenting teens reveal several interesting findings:

- Marrying after conception actually lowers the likelihood that a teenager will return to school after childbearing.
- Adolescent mothers who reside with their families during the first five years after the birth of their child are more likely to graduate from high school, to be employed and not to be welfare dependent.
- Young women who bore a child while in high school were identified as having lower academic abilities and educational expectations than their classmates as early as the ninth grade.

- 50.5% of parenting teens had repeated a grade.
- Teen mothers are less likely to finish high school and are three times more likely to remain in a single-parent family.
- While more teenage mothers than ever before are graduating from high school, only 1/2 of the women who have their first child at age 17 or younger will have graduated by age 30.
- Many teen mothers believe they lack the ability or opportunity for a college education and/or a career.
- Women attending a special school for pregnant and parenting teens did substantially better in later life than those attending regular school programs and those who dropped out.
- Teens who expect to continue their education are less likely to become teen mothers. This is true regardless of race or socioeconomic background. Even among high risk students, a smaller proportion of those who aspire to go to college become mothers before they graduate.



ALCOHOL & DRUG TREATMENT

In approaching issues of health-care reform, limited resources are available to deal with the difficulties which youth face today.

The focus of treatment delivery has shifted to the community and family, with an emphasis on the least restrictive placement.

Adolescence, as a period of transition, is growing longer with each generation as psychological development is taking longer to complete. Stresses increase with the increased number of blended families, socio-economic and educational concerns.

It is a well-documented fact that alcohol and drugs alter human physiology, including mood changes, impaired cognition and behavior. Chemical use also results in youth engaging in high-risk behaviors. The person is less likely to make



wise or well thought out decisions, control impulses, and solve problems readily. There is a higher incidence of rape, sexual abuse, unwanted pregnancy, sexually transmitted diseases, TB and HIV/AIDS among young drug and alcohol users.

The onset of chemical use is occurring at a younger age. Adolescents are at the greatest risk for chemical dependency which is a medical diagnosis of a primary, progressive, chronic, and fatal disease. The earlier the onset of the chemical use, the more rapid the progression.


Chemical dependency in youth is a reality. Many treatment approaches do not provide the necessary intensity of family involvement to treat the youth as part of a system instead of merely as an isolated person. Community-based efforts in prevention and treatment that involve family and agencies working together to find common ground and address the need of our youth are needed.

JUVENILE CRIME

Montana's system for dealing with juvenile crime is a thorough, efficient, and lengthy procedure with many built-in safeguards to make certain that justice is served.

Over the past several years, the State has seen very little change in youth court activity. While the rest of the nation is experiencing a significant increase in violent youth crime, Montana has witnessed a decrease of about 10%.

The most common door to the juvenile system is through a law enforcement agency. It's important to note that approximately 95% of Montana youths are never referred to youth court. Of the estimated 5,000 young people referred last year, almost 70% were referred only once; 60% of all referrals were between the ages of 15 and 17 and 30% between the ages of 12 and 14.

Recent analysis of all youth court activity from 1990 to 1992 indicates a total increase of about 300 referrals over the past two years or approximately a 6% increase.

The most common door to the juvenile justice system is through a law enforcement agency. Only 10% of the possible offenders are referred by school authorities, other courts or parents.

The Youth Court Probation Office conducts the preliminary inquiry. Almost 25% of the cases are dismissed due to lack of evidence or simply because the probation officer felt the family would be able to deal with the problem.

About 10% of the cases are referred to the County Attorney to file a petition alleging the youth is delinquent and in need of supervision but, more commonly, the officer may proceed with the case and handle it informally.

In this situation, the youth may be placed on probation and a contractual arrangement is signed by the youth, parents or guardians, and the probation officer prescribes specific conditions which must be followed for a set period of time.

Over 90% of young people placed on probation are handled in this manner.

If the case is referred to the County Attorney various steps are followed which lead to eventual disposition which are designed to benefit the youth while protecting society.

Factors which are considered in determining "high risk" juvenile criminal activity are age at first contact with the system, seriousness of offense, prior criminal history and frequency of illegal behavior.

Conclusions & Implications

Montana's infant mortality rate is the lowest among the neighboring states. Since the infant mortality rate is the most sensitive indicator of a population's social welfare, this is heartening news indeed!

At the same time, several findings in this report are cause for concern. Births to single teens and the percent of children living in poverty are both on the increase in Montana. These two conditions are likely to be interrelated and part of a network of disadvantage in which infants and children experience lasting deprivation and harm.

The initiatives undertaken by the Annie E. Casey Foundation and Montana's Healthy Mothers, Healthy Babies are of considerable value in defining the problems that the State's young citizens confront. It is important to define and continue to monitor the problems with future KIDS

COUNT Data Books. It follows that this information be utilized to develop and to strengthen prevention and intervention programs.


The size of the State represents a challenge. Each of three of Montana's 56 counties exceeds the total area of the state of Connecticut. And, it is daunting to coordinate programs to involve a relatively small and widely dispersed population.

At the same time, there are special opportunities in Montana that may represent advantages for improving the health and welfare of infants, children, and youths. Most of the representatives of our public and private organizations know each other. Moreover, recent initiatives in the State have involved substantial voluntary cooperation among these leaders. This bodes well for the future.




1992 High Risk Family Formation Index





1992 High Risk Family Formation Index






1992 High Risk Family Formation Index




