ABSTRACT

To assess some of the major attributes and activities of the 19,176 students it served in the fall of 1998, Cuyahoga Community College (CCC) in Ohio conducted this study of enrollment trends and student characteristics. Major results included: (1) the fall headcount was CCC's lowest since 1973 and a 28% decline from fall 1993; (2) losses were not spread uniformly among student demographic groups (for example, losses were greater among full-time students (-12.9%) than part-time students (-7.1%); losses were lower among continuing students (-8.4%) than they were among returning students (-22.2%); (3) nearly 2/3 of the new high school graduates are interested in taking courses for transfer purposes, while new students who are older or transferring from another college are pursuing a wide variety of educational goals; (4) the student body is two-thirds female, one-third male; (5) average student age is 29.6, with 55% of students over 24; (6) 87% of CCC's students are from Cuyahoga County; (7) two-thirds of the students are white, one-third are other races and ethnicity; (8) part-time students composed two-thirds of the enrollment; (9) 36% of CCC's students have achieved sophomore rank; (10) almost half of the students attend only daytime classes, while 26% attend in the evenings; and (11) 37% are enrolled in transfer programs, 23% in health care, and 20% in business, with the remaining 20% in other courses of study or undecided. Appended are tables illustrating enrollment comparisons between fall 1997 and 1998, full-time equivalent totals by program, postsecondary enrollment options, and data detail. (EMH)

PREFACE

The Fall 1998 Enrollment Trends and Student Characteristics Report has been developed in order to give the constituents of Cuyahoga Community College information on the students served by the College. It is intended to put the current enrollment experience in the context of the College's enrollment history and describe some of the major characteristics of students that influence the academic and student services offered and future marketing efforts.

It is hoped that this information will generate additional questions that can be addressed in future reports, either as separate research studies or as enhancements to future editions of this report.

In making the transition from the quarter calendar system to the semester calendar system, it is not appropriate to directly compare enrollment levels, particularly FTE enrollment, although comparisons of demographic characteristics can be made to determine where changes in enrollment patterns have occurred.

HIGHLIGHTS

- Cuyahoga Community College is serving 19,176 credit students in the Fall of 1998. This is 1,896 or 9.0% fewer than in the Fall of 1997 when enrollments were 21,072. These students are taking 154,238 credit hours of instruction, generating 10,283 FTEs (full-time equivalents, a standard measure of instruction).
- The experience of the other colleges/universities in Northeast Ohio that also changed to semester calendars this year was mixed. Universities generally did not experience the impact on enrollment that the two-year colleges did with Cleveland State increasing in headcount by 3.8% and Baldwin Wallace essentially remaining stable. Lorain County Community College decreased in headcount by 2.1%.
- This is the lowest Fall headcount enrollment for Tri-C since 1973 and a 28% decline since the Fall 1993 peak
- New high school graduates increased by 2.5% and new students who have been out of high school for a year or more increased by 14.9%. It appears that the majority of the new students who had been out of school for a year or more were still fairly recent high school graduates since the 15-19 age group was the only age cohort that did not decline this year.
- Losses were not spread uniformly among student demographic groups. For example, losses were greater among full-time students (-12.9%) than part-time students (-7.1%); losses were lower among continuing students (-8.4%) than they were among returning (-22.2%).
- Nearly 2/3 of the new high school graduates are interested in taking courses for transfer purposes (either with or without completing a degree) while students new to the College who are older or transferring from another college are pursuing a wide variety of educational goals.

FALL 1998**

Introduction

Cuyahoga Community College is serving 19,176 credit students as of the first census date in the Fall of 1998. This is 1,896 or 9.0% fewer than in the Fall of 1997 when enrollments were 21,072. These students are taking 154,238 credit hours of instruction, generating 10,283 FTEs (full-time equivalents, a standard measure of instruction). Note that this is the first experience under the semester calendar and so a direct comparison in FTE on a term-by-term basis to the Fall of 1997 is not applicable.

Other colleges in the area which changed from a quarter calendar to a semester calendar had a mixed experience:

The student body may be characterized as follows:

- 2/3 female, 1/3 male
- Average age 29.6 (55% over the age of 24)
- 87% from Cuyahoga County
- 2/3 white, 1/3 other races and ethnicity
- 2/3 attend part-time, 1/3 attend full-time
- 36% have achieved sophomore rank (accumulated 45 or more credit hours)

- 25% students new to the college
- 54% continuing enrollment (enrolled in the previous Spring or Summer)
- 21% students returning after stopping out for a period of time
- 331 of the students are participants in the Postsecondary Enrollment Options program with North Olmsted having by far the highest participation with 55 students and Strongsville second with 23 students. (see Appendix C)
- 17% of the students have transferred in an average of 8.0 credit hours.
- Time of Attendance
 - 47% attend only daytime classes (prior to 4:00)
 - 26% attend only evening classes
 - 13% attend both day and evening
 - 4% attend only weekend classes
 - 6% attend both evening and weekend classes
 - 4% attend some combination of day/evening/weekend classes
- High School Attended
 - 14% Cleveland Public Schools
 - 30% Suburban Schools
 - 8% Private/parochial
 - 11% Other Ohio
 - 5% Other US
 - 5% Foreign
 - 6% GED
 - 20% Missing Data
- Programs of interest upon entering the college:
 - 37% Transfer programs including AA/AS
 - 23% Health careers
 - 20% Business programs
 - 9% Other programs
 - 8% Undecided careers
 - 3% Missing/undeclared

Comparison to Fall 1997

Generally, the decline was experienced across all demographic categories of students with the following exceptions (See Appendix A):

- Students aged 15-19 essentially remained even, increasing by a minimal 37 students
- New students increased by 4.1%: 2.5% in new high school graduates and 14.9% in new students who have been out of high school more than a year.

Areas that declined at a rate greater than the 9% average include:

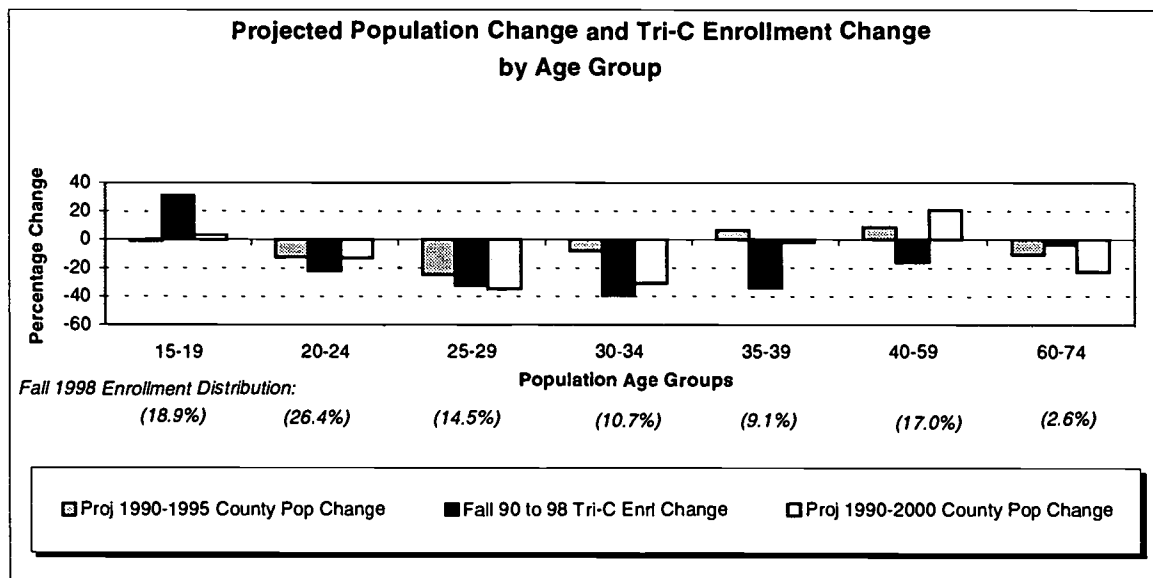
- Students aged 25-39 declined by 15%
- Full-time students declined by 13%
- Students who have achieved sophomore rank declined by 14%
- Returning students declined by 22%

As noted earlier, due to the change to a semester calendar, it is not appropriate to compare FTE counts to the prior year on a term-by-term basis. However, the FTE generated by discipline for this Fall is available in Appendix B.

Enrollment Trends¹

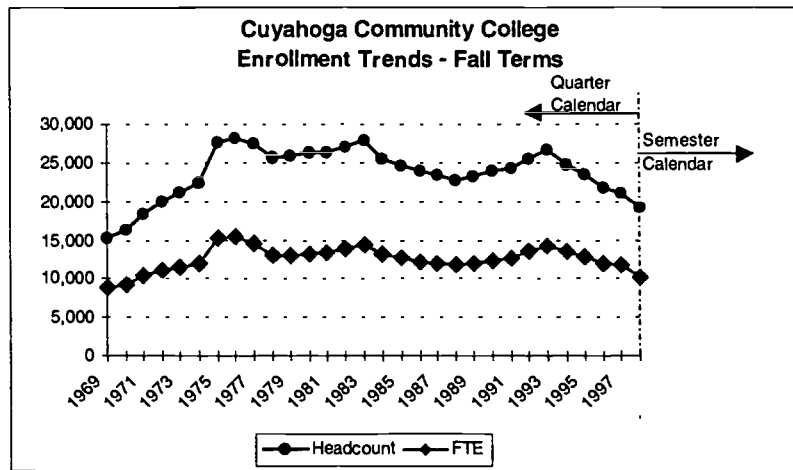
Since 1975, credit headcount enrollments have averaged 24,849--peaking at or near 28,000 in 1976 and 1983 and dipping to 19,176 this year. This is the lowest Fall headcount enrollment since 1971 and a 28% decline since the Fall 1993 peak.

In some cases, the enrollment decline may be related to substantial declines in particular age groups of the population base. In several instances, however, the decrease in enrollment is greater than the population decline. Note particularly the 20-24, 30-34, 35-39, and 40-59 age groups.

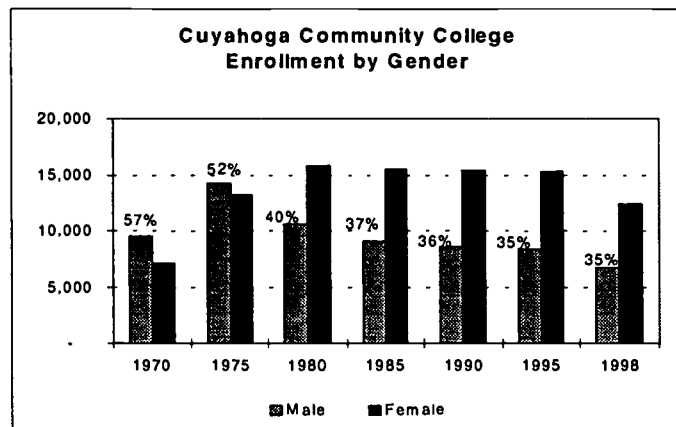


There is less variation in FTE enrollments due to the impact of the mix of full-time and part-time students. Since 1975, FTE has average 13,042.

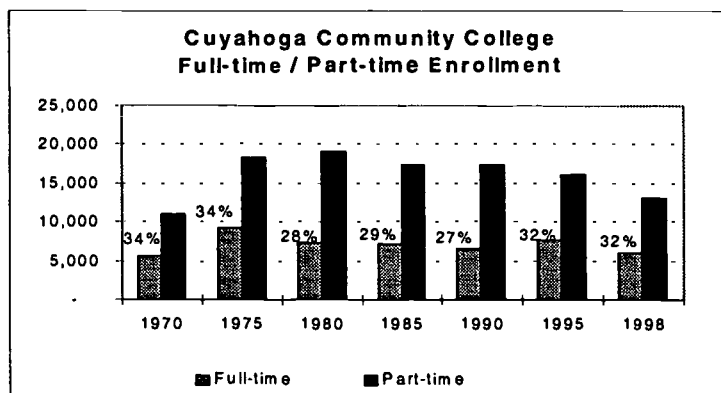
¹ All figures in this section are based on students' campus of registration. All other figures in this report are based on campus of attendance: the campus at which a student actually took his or her courses. Because some students take courses at more than one campus, campus of attendance enrollments may be higher than campus of registration.



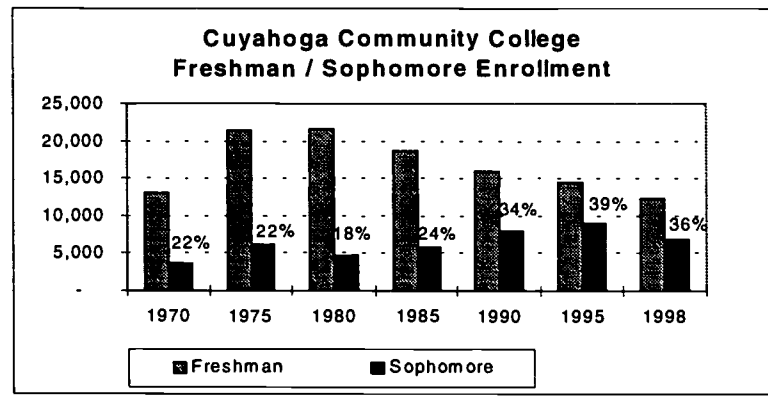
The number of men attending CCC peaked in the mid-1970s at over 14,000. However, their proportion of the total student body has steadily declined over the years--from 65% of total students in 1965 to 52% in 1975 to 37% in 1985. Currently, there are 6,735 men enrolled, a number reflective of the first decade of the college. Men now comprise 35% of the total student body.



The full-time and part-time proportions have remained fairly constant over the years with 2/3 of the student body attending on a part-time basis and 1/3 attending on a full-time basis.



Although the number and percentage of students achieving sophomore rank have declined since last year, the long-term trend shows an increasing rate. In the 1970s, 22% of the student body had achieved sophomore rank. By 1980, that had dropped to 18%, but has increased substantially since that time--to 24% in 1985, 34% in 1990, and 37% today.



New Students

In the Fall of 1998, 25% or 4,885 students are attending the College for the first time. This is a 4.1% increase in new students from the Fall of 1997.

New high school graduates attending Tri-C this fall comprise 10% of the total student body. They vary from the general student body in the following ways:

- More are men: 43% are male, compared to the college average of 35%
- More attend full-time: 72% compared to the college average of 32%
- Fewer are of a minority racial /ethnic background: 28% compared to a College average of 35%
- Time of Attendance
 - 76% attend only daytime classes (higher than 47% average)
 - 6% attend only evening classes (lower than 26% average)
- High School Attended
 - 12% Cleveland Public Schools
 - 56% Suburban Schools
 - 10% Private/Parochial
 - 14% Other Ohio
 - 2% Other US
 - 1% Foreign
 - 5% GED
 - 1 Missing Data
- Programs of interest are:
 - 42% Transfer programs including AA and AS (higher than 34% average)
 - 20% Health Careers

- 18% Business programs
- 9% Other programs
- 8% Undecided careers
- 3% Missing/Undeclared

Students are asked to indicate their educational goal on their application for admission. Nearly 2/3 of the new high school graduates are interested in taking courses for transfer purposes. Overall, their goals are:

- 37% are pursuing a transfer associate degree
- 28% are taking courses to transfer, but are not pursuing a degree
- 16% are interested in pursuing a technical associate degree
- 12% are interested in courses for skill development, certificates, personal interest, or other purposes
- 7% did not respond to the question

Nine percent of the student body (1,733) are **students entering CCC for the first time after being out of high school for awhile**. They differ from the general student body in the following ways:

- More are men (40% compared to College average of 35%)
- More attend on a full-time basis: 37% compared to a College average of 32%
- More are from minority racial or ethnic backgrounds: 41% compared to a College average of 35%
- Time of Attendance - all are similar to college-wide patterns:
 - 51% attend only daytime classes
 - 28% attend only evening classes
 - 7% attend both day and evening classes
 - 5% attend only weekend classes
 - 9% attend some other combination of day/evening/weekend
- High School Attended
 - 16% Cleveland Public Schools
 - 28% Suburban Schools
 - 4% Private/Parochial
 - 12% Other Ohio
 - 8% Other US
 - 12% Foreign
 - 10% GED
 - 11% Missing Data
- Programs of interest are all similar to the college-wide average
 - 37% Transfer programs including AA and AS
 - 23% Business programs
 - 18% Health Careers
 - 10% Other programs
 - 6% Undecided careers
 - 6% Missing/undeclared

All new students are asked to indicate their educational goal on their application for admission. Students who have been out of high school for longer than a year are coming to Tri-C for a variety of reasons:

- 27% are pursuing a transfer associate degree
- 22% are interested in pursuing a technical associate degree
- 13% are taking selected courses for career or job skills
- 10% are taking courses to transfer, but are not pursuing a degree
- 7% are interested in courses for personal interest
- 12% are interested in certificates or other short-term purposes
- 9% did not respond to the question

Transfer students are coming from approximately 315 different colleges and universities. Students are classified as new transfer students if they are new to CCC and if they have indicated attendance at a previous college. They may or may not be interested in transferring credit. There are 1,216 students who are new transfer students, 6% of the total student body.

On average, they are transferring in 9.9 credit hours. While 78% of these students have no transfer credits posted on their record, 10% have been credited with up to 24 transfer credits, 7% have from 25 to 60 transfer credits, and 5% have over 60 credit hours transferred in.

They differ from the general student body in the following ways:

- They are slightly younger. Average age is 28.7. Nearly one-half (46%) are under the age of 25.
- More are men: 44% compared to a college average of 35%
- More are from outside of Cuyahoga County: 27% from other counties compared to a college average of 13%
- Only 8% have enough credit hours to be ranked as sophomores
- Time of Attendance generally follows college-wide patterns:

- 41% attend only daytime classes
- 34% attend only evening classes
- 11% attend both day and evening classes
- 5% attend only weekend classes
- 9% attend some other combination of day/evening/weekend
- High School Attended
 - 8% Cleveland Public Schools
 - 25% Suburban Schools
 - 11% Private/Parochial
 - 25% Other Ohio
 - 16% Other US
 - 10% Foreign
 - 3% GED
 - 2% Missing Data
- Programs of interest also follow college-wide patterns:
 - 42% Transfer including AA and AS
 - 21% Health careers
 - 22% Business programs
 - 5% Other programs
 - 4% Undecided careers
 - 6% Missing/undeclared

Transfer students, like other students entering the College for the first time, indicate their educational goal on their application for admission. Transfer students, like other adult students, are attending Tri-C for a variety of reasons:

- 23% are pursuing a transfer associate degree
- 19% are taking courses to transfer, but are not pursuing a degree
- 18% are interested in pursuing a technical associate degree
- 13% are taking selected courses for career or job skills
- 11% are interested in certificates or other short-term purposes
- 8% are interested in courses for personal interest
- 8% did not respond to the question

Returning Students

There are 4,022 students who are returning to CCC after having stopped out for a period of time, a decrease of 22.2% from the Fall of 1997. This is 21% of the student body. They have accumulated on average 43 credit hours, with 20% transferring an average of 8.6 credit hours from another college.

Returning students differ from the general student population in the following ways:

- They are older: Average age is 32.7, nearly 3/4 (71%) are over the age of 24.
- More are of a minority racial/ethnic background: 41% compared to a College average of 35%

- A large majority (91%) are from Cuyahoga County.
- More attend on a part-time basis: 84% compared to the average of 68%
- Time of Attendance
 - 39% attend only daytime classes (lower than 47% average)
 - 37% attend only evening classes (higher than 26% average)
 - 8% attend both day and evening classes (lower than 13% average)
 - 7% attend only on weekends
 - 9% attend some other combination of day/evening/weekend
- High School Attended
 - 15% Cleveland Public Schools
 - 26% Suburban Schools
 - 7% Private/Parochial
 - 8% Other Ohio
 - 4% Other US
 - 2% Foreign
 - 6% GED
 - 33% Missing Data
- Students who stopped out for longer than 2 years must reapply for admission. The program of interest indicated on either the original application or the updated application is:
 - 37% Transfer programs including AA and AS
 - 21% Health careers
 - 19% Business programs (lower than 21% college average)
 - 10% Other programs
 - 9% Undecided careers
 - 4% Missing/undeclared

Continuing Students

Of the total student body, 54% are continuing students (10,269), having been in attendance the immediately preceding Spring or Summer terms. This is a decline of 8.4% from the Fall of 1997. They have accumulated on average 59 credit hours with 22% of the students transferring in an average of 10.3 credits from another college. Over one-half of the students (51%) have accumulated 45 or more credit hours and have achieved sophomore rank.

Since continuing students are the largest component of the student body, for the most part they have greatly influenced and will reflect the characteristics of the general student body. There is no area in which they differ substantially, except as noted above.

Enrollment by Gender

Females

Nearly two-thirds (12,408 or 65%) of all students who attend CCC are female. Because females comprise such a large proportion of the student body, the characteristics of the total student body are reflective of the characteristics of the female student population. On average, they are taking 7.9 credit hours and have accumulated 44.1 credit hours including transfer hours where appropriate.

- Time of Attendance is consistent with the college average:
 - 47% attend only in the day
 - 26% attend only in the evening
 - 13% attend both day and evening classes
 - 4% attend only weekend classes
 - 10% attend some other combination of day/evening/weekend
- Program of interest upon entry to the college is generally consistent with the college average:
 - 37% Transfer programs including AA/AS
 - 27% Health Careers
 - 19% Business Programs
 - 8% Other Programs
 - 7% Undecided Careers
 - 2% Missing/undeclared

Males

The 6,735 male students attending CCC comprise over 1/3 of the total student body (35%). On average, they are taking 8.4 credit hours and have accumulated 36.5 credit hours including transfer hours where appropriate.

Male students differ from the general student body characteristics in the following ways:

- They are younger. Average age is 28.4: 52% are under the age of 25.
- Fewer are minorities: 30% are of minority racial or ethnic backgrounds compared to 35% college-wide.
- More attend on a full-time basis: 36% compared to the College average of 32%
- A greater proportion are new students (31%) compared to the college-wide average of 25%.
- Fewer have accumulated enough credit hours to achieve sophomore rank (30%) compared to the college average of 36%.
- Time of Attendance generally reflects the college average:
 - 49% attend only daytime classes
 - 26% attend only evening classes
 - 13% attend both day and evening classes

- 3% attend only weekend classes
- 9% attend some other combination of day/evening/weekend classes
- High School Attended
 - 10% Cleveland Public Schools
 - 33% Suburban Schools
 - 8% Private/Parochial
 - 12% Other Ohio
 - 5% Other US
 - 7% Foreign
 - 6% GED
 - 19% Missing Data
- Program of interest upon entry to the college:
 - 39% Transfer including AA and AS
 - 15% Health Careers (lower than 23% college average)
 - 23% Business programs
 - 11% Other programs (higher than 8% college average)
 - 9% Undecided careers
 - 3% Missing/undeclared

Full-time and Part-time Enrollments

Part-time Students

Over two-thirds (13,086 or 68%) of all students attend CCC on a part-time basis (take fewer than 12 credit hours). The average number of credit hours taken by a part-time student is 5.6. On average, part-time students have accumulated 47.5 credit hours either through transfer credit or at CCC. Twenty percent of part-time students transfer in an average of 10.0 credit hours from another college or university.

Part-time student characteristics differ from the general student body in the following ways:

- They are older: Average age is 32.3; 67% are 25 years of age or older
- A larger proportion have achieved sophomore rank: 40% compared to a college average of 36%
- A larger proportion are students returning after stopping out for a period of time (26% compared to the 21% college average)
- Time of Attendance
 - 39% attend only in the day (lower than 47% average)
 - 36% attend only in the evening (higher than 26% average)
 - 10% attend both day and evening classes
 - 6% attend only weekend classes
 - 9% attend some other combination of day/evening/weekend
- High School Attended
 - 12% Cleveland Public Schools
 - 27% Suburban Schools

- 8% Private/Parochial
- 11% Other Ohio
- 6% Other US
- 4% Foreign
- 6% GED
- 26% Missing Data
- Program of interest upon entry to the college:
 - 37% Transfer programs including AA and AS
 - 23% Health careers
 - 20% Business programs
 - 8% Other programs
 - 9% Undecided careers
 - 3% Missing/undeclared

Full-time Students

A full-time student is one who takes 12 or more credit hours. The 6,090 students attending CCC on a full-time basis comprise nearly 1/3 of the total student body. On average, they are taking 13.2 credit hours and have accumulated 28.2 credit hours, including transfer hours where appropriate. Eleven percent of full-time students transfer in an average of 3.6 credit hours from other colleges.

Full-time students differ from the general student body in the following ways:

- They are younger: Average age is 23.9, 72% are under the age of 25
- More are minorities: 40% are of minority racial or ethnic backgrounds compared to 35% college-wide
- A greater proportion are new high school graduates (23%) and fewer are students returning after stopping out for a period of time (11%) compared to college average of 10% and 21% respectively.
- Fewer have achieved enough credit hours to be ranked as sophomores (25% compared to 36% college-wide)
- Time of Attendance
 - 65% attend only daytime classes (much higher than 47% average)
 - 19% attend both day and evening classes (higher than 13% average)
 - 3% attend only evening classes (much lower than 26% average)
 - 13% attend some other combination of day/evening/weekend classes
- High School Attended
 - 17% Cleveland Public Schools
 - 37% Suburban Schools (higher than 30% average)
 - 9% Private/Parochial
 - 12% Other Ohio
 - 4% Other US
 - 8% Foreign
 - 8% GED
 - 5% Missing Data

- Program of interest upon entry to the college:
 - 39% Transfer programs including AA and AS (higher than 34% average)
 - 23% Health careers
 - 22% Business programs
 - 9% Other programs
 - 6% Undecided careers (lower than 14% average)
 - 1% Missing/undeclared

Minority Students

The 6,606 students from minority racial and ethnic backgrounds make up 34% of the total student body. At 29.9, minorities reflect the average of the College as a whole. Sixteen percent of minority students transfer in an average of 6.1 credit hours from another college or university. Minority students differ from the general student body in the following ways:

- More are women: 70% are female, compared to 65% college-wide
- Nearly all are from Cuyahoga County (93%)
- A greater proportion attend on a full-time basis (37%) compared to the college average of 32%
- Time of attendance
 - 52% attend only daytime classes (higher than college average of 47%)
 - 22% attend only evening classes (lower than college average of 26%)
 - 10% attend both day and evening classes
 - 4% attend only weekend classes
 - 12% attend some other combination of day/evening/weekend
- High School Attended
 - 31% Cleveland Public Schools
 - 19% Suburban Schools
 - 4% Private/parochial
 - 4% Other Ohio
 - 6% Other US
 - 7% Foreign
 - 9% GED
 - 20% Missing Data
- Program of interest upon entry:
 - 38% Transfer including AA and AS
 - 24% Health careers
 - 23% Business programs
 - 10% Other programs
 - 3% Undecided careers (lower than 8% average)
 - 2% Missing/undeclared

Time of Attendance

Day Students

Students who attend only daytime classes comprise nearly one-half (47%) of the total student body. When combined with the students who attend daytime classes as well as evening and/or weekend, nearly 2/3 of all students (65%) are on campus at some point during the daytime hours (prior to 4:00). Students who attend only daytime classes differ from the general student body in the following ways:

- They are younger. Average age is 27.5: (57% are under the age of 25)
- More attend on a full-time basis (44% compared to 32% for the total college)
- More are from minority ethnic and racial backgrounds: 38% compared to a 34% college average
- More are new from high school (16%) and fewer are returning after "stopping out" for a period of time (17%) compared to a college average of 10% and 21% respectively
- Fewer have accumulated enough credit hours to be classified as sophomores, 30% compared to 36% for the College as a whole.

Evening Students

Over one-fourth of the total student body (26%) attend classes only in the evening (after 4:00). When combined with those students who also take classes at some other time (day and/or weekend) the proportion of students taking at least one evening class increases to 46%.

Students who attend only evening classes differ from the general student body in the following ways:

- Fewer are of a minority racial or ethnic background: 29% compared to 34% for the college as a whole
- They are older. Average age is 33.5 (74% are over the age of 24)
- Nearly all attend on a part-time basis (96%).
- More are students returning after stopping out for a period of time 30% and fewer are new from high school (2%) compared to the college-wide average of 21% and 10% respectively

Weekend Students

Students who attend classes only on the weekend are a much smaller proportion of the student body, 4%. However, when combined with students who also take classes at other times including day and/or evening, the proportion of students who take at least one weekend class increases to 14% of the student body.

Students who take classes only on the weekend differ from the general student body in the following ways:

- Fewer are men: 29% compared to a college average of 35%
- They are older. Average age is 37.4 (85% are over the age of 24)
- Nearly all students attend on a part-time basis
- Fewer students are continuing (43%) or new from high school (2%), while more are students returning after stopping out for a period of time (36%) compared to the college average of 54% continuing, 10% new from high school, and 21% returning.

Campus of Attendance

Individual campus reports based on campus of attendance are available from the Office of Institutional Planning and Evaluation. Data by campus of attendance may reflect duplicated counts since students may attend more than one location. Each campus has experienced a decline in the number of students attending compared to last Fall:
