ABSTRACT

This report, provides statistical data on the salaries of faculty and selected administrators in Oklahoma. Highlights pertaining to the 1997-98 academic year include the following: (1) the average salary for all full-time faculty, equated to a 9-10 month basis in Oklahoma state-supported colleges and universities, was \$45,189; (2) average salaries increased \$1,652 at four-year universities and \$1,368 at two-year colleges; (3) the rank of professor at the comprehensive universities showed the greatest dollar increase over 1996-97--10.2%; (4) total full-time faculty was 4,133; (5) full-time salaries on a 9-10 month basis ranged from \$4,784 to 144,200, and on an 11-12 month basis from \$12,000 to \$150,840; and (6) the average fringe benefits paid for faculty in a 9-10 month contract basis were \$10,955, and for faculty on an 11-12 month basis, \$13,929. Overall, the above statistics represent an increase from the 1996-97 academic year. Comprehensive universities' average salary in Oklahoma is now 90% of the national average, compared with 83% in 1987-88. (Contains 17 tables and 11 figures.) (AS)

## HIGHLIGHTS

For the purposes of this report, the term “comprehensive universities” includes OU and OSU; the term “four-year universities” includes the ten regional universities (UCO, ECU, NSU, SEOSU, SWOSU, Cameron, Langston, NWOSU, Panhandle, and USAO). “Constituent agencies” refer to the OU Health Sciences Center, the OU Law Center, the OSU Agriculture Experiment Station, the OSU Agriculture Extension Division, the OSU College of Veterinary Medicine, the OSU College of Osteopathic Medicine and Surgery, and the OSU Technical Branches at Oklahoma City and Okmulgee.

**Average Salary:** The average salary for all full-time faculty equated to a 9-10 month basis in Oklahoma state supported colleges and universities, excluding the constituent agencies, is \$45,189 for the year 1997-98 (Table 1). This is an increase of \$2,138 or 5.0% above 1996-97.

**Increase by Type of Institution:** Average salaries increased \$3,080 at the universities, \$1,652 at the four-year universities, and \$1,368 at the two-year colleges. These salaries represent increases of 6.1%, 4.1%, and 3.8%, respectively, over 1996-97.

**Increase by Rank:** Among the three categories of institutions, the rank of professor at the comprehensive universities showed the greatest dollar increase over 1996-97--\$6,535 or 10.2%. All other percent changes in salaries range from an increase of \$1,094 or 3.5% for instructors at the four-year universities, to an increase of \$2,157 or 5.1% for associate professors at the four-year universities (see figure 2).

**Total Faculty:** Total full-time faculty in 1997-98 is 4,133, an increase of 40 or 1.0% over 1996-97 (Figure 1).

**Salary Range:** Full-time salaries on a 9-10 month basis in the 25 institutions in 1997-98 range from a minimum of \$4,784, a decrease of 49.4% from 1996-97, to a maximum of \$144,200, an increase of \$7,784 or 5.7% over the previous year (Table 9). On an 11-12 month basis, full-time salaries range from a minimum of \$12,000, a decrease of 48.9% from 1996-97, to a maximum of \$150,840, an increase of 9.0%. These data exclude salaries for deans and other administrative personnel.

**Increase in Benefits:** The average fringe benefits paid for faculty on a 9-10 month contract basis for 1997-98 are \$10,955, an increase over 1996-97 of \$161, or 1.5% (Table 5); for faculty on an 11-12 month contract basis, the increase in benefits is \$13,929, an increase of \$827 or 6.3% (Table 7).

**Oklahoma Average Salaries Compared to National:** Comprehensive universities average salary is now 90% of the national average, compared to 83% in 1987-88. There is a slight decline in relative averages at the other two tiers of institutions.

**NOTE:** The changes in average salaries are only partially related to salary increase action by governing boards. Other factors, such as resignations and retirements, can have an impact as well, particularly if new junior faculty are hired at lower salaries to replace departing senior faculty.

## TABLE 1

Table 1 presents the 1997-98 average salaries on a 9-10 month basis paid all full-time faculty by rank and by all 25 colleges and universities in The Oklahoma State System of Higher Education. These data include salaries of full-time faculty employed on a 9-10 month contract basis and full-time faculty employed on an 11-12 month contract basis with salaries equated to 9-10 months. Table 1 also includes the number of full-time faculty by rank and by institution.

The average salary on a 9-10 month basis paid in the 25 institutions in 1997-98 is \$45,189. This represents an increase over 1996-97 of \$2,138 or 5.0%. The average for comprehensive universities is \$53,613, for four-year universities, \$42,039, and for two-year colleges, \$37,255. These salaries represent increases over 1996-97 of 6.1%, 4.1%, and 3.8%, respectively. The 1997-98 median of all institutions' average salaries is \$36,907.

Salaries at UCO are higher than the comprehensive university average salaries for both associate and assistant professors. Average salaries for instructors are highest at the two-year colleges, and lowest at the comprehensive universities.

Faculty distribution by rank may influence the salary averages of the various faculty ranks within an institution. Table 1 shows a smaller proportion of faculty in the upper two ranks (professor and associate professor) at four-year universities than at the comprehensive universities. The comprehensive universities' average salary for all ranks is 27.5% higher than the average salary of all ranks for four-year universities. By rank, the comprehensive universities' average salary exceeds the four-year universities' average salary in the rank of professor by 36.1%, associate professor by 8.6%, and assistant professor by 2.9%. However, in the rank of instructor, the four-year universities' average salary exceeds the comprehensive universities' average salary by 28.5%.

The total number of full-time faculty reported in the 25 institutions in 1997-98 is 4,133—1,525 at comprehensive universities, 1,640 at four-year universities, and 968 at two-year colleges.

These totals compare to 1,501 at comprehensive universities, 1,631 at four-year universities, and 961 at two-year colleges in 1996-97. The total for all institutions was 4,093 in that year.



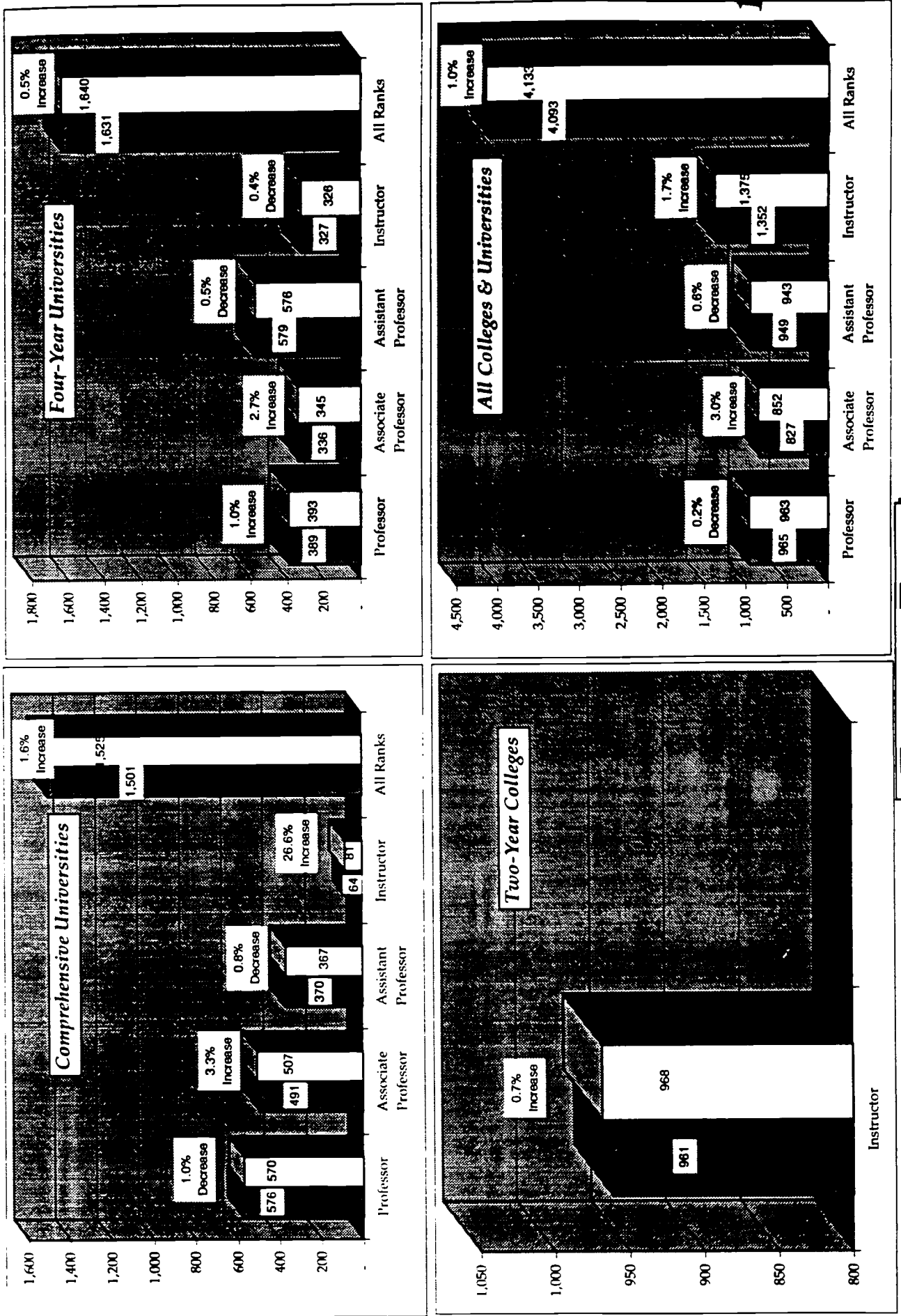

1996-97 TO 1997-98**



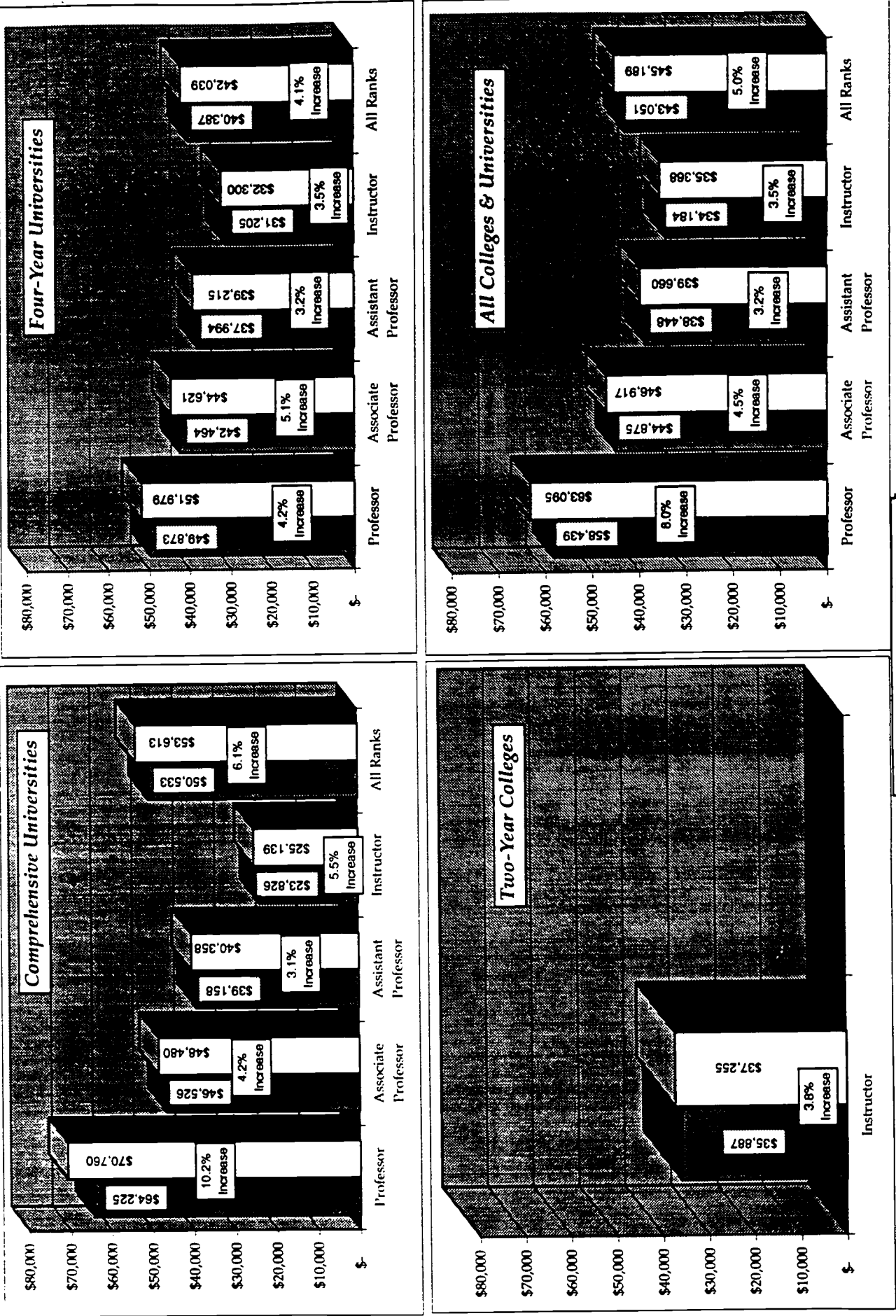

Table 2 presents the 9-10 month average salaries of all full-time faculty members for the three years, 1995-96 through 1997-98, from which salary trends by institution and by rank may be analyzed.

Certain factors may influence salary averages so that they do not accurately indicate long-term salary trends. For example: a senior full professor receiving a top salary could retire and at the same time an associate professor be promoted to full professor at the bottom of the salary scale for full professors. The net result, with respect to individual faculty still employed, would be that at least one person would be receiving more salary than in the previous year. Yet, the effect upon the average salary for full professors at the institution would show a decline. The average salary for an entire institution could be affected in the same manner. Another factor causing the same effect could occur as a result of hiring new faculty to meet the demands of expanding enrollment, new faculty members would be hired at a salary level below the institution's salary average.

Analyses of the data contained in Table 2 may be made in a variety of meaningful ways. No attempt is made here to provide an exhaustive analysis; however, certain observations are noted. The dollar increases in average salaries are not the same between different ranks in the same institution. For example, changes for 1995-96 to 1997-98 show the University of Oklahoma increased the average of all ranks \$4,017, while Oklahoma State University increased \$6,704. At Oklahoma State University, the salary increase for the rank of professor was \$12,459; the increase for associate professors was \$4,215; the increase for assistant professor was \$3,332; and the increase for instructor was \$926. (It should be noted that OSU had 12 fewer professors, 5 additional associate professors, 14 fewer assistant professors, and 3 more instructors for a net loss of 18 faculty.) At the University of Oklahoma, where total faculty showed a gain of 42 with increases at every level, comparable salary figures were increases of \$7,954, \$3,312, \$2,153, and \$5,998 for professors, associate professors, assistant professors and instructors, respectively. Such differences may result from factors suggested above or could also result from salary administration policy and faculty qualifications. Although Table 2 does not provide specific reasons for observed salary averages and comparisons, the three-year trend of institutions' average salaries by rank may provide helpful data.

### TABLE 3

Table 3 presents the average salaries of all full-time faculty members equated to a 9-10 month basis for the three years, 1995-96 through 1997-98, classified by rank and by type of institution.

Dollar increases in average annual salaries of all ranks in 1997-98 over 1996-97 are greatest for the comprehensive universities, next for four-year universities, and least for two-year colleges. The increased averages of all ranks by type of institution in 1997-98 over 1996-97 were \$3,080, \$1,652, and \$1,368 for comprehensive universities, four-year universities, and two-year colleges, respectively. The average salary at comprehensive universities was \$10,146 greater than the average at four-year universities in 1996-97, and \$11,574 greater in 1997-98. The average salary at four-year universities was \$4,500 greater than the average at two-year colleges in 1996-97, and \$4,784 greater in 1997-98.

Averages by rank show that comprehensive universities' faculty receive higher salaries than four-year universities' faculty in the ranks of professor, associate professor and assistant professor in 1997-98. Instructors at two-year colleges receive higher average salaries than instructors at both comprehensive universities and four-year universities.

Over the three-year period, the percentage increase in average salaries for all ranks was largest for comprehensive university faculty, while faculty at four-year universities showed the smallest percentage increase.

The annual increases in average salaries for 1996-97 and 1997-98 for comprehensive universities have been 4.5% and 6.1% with an average of 5.4%. The four-year universities experienced increases of 3.8% in 1996-97 and 4.1% in 1997-98, with an average of 4.0%. The two-year colleges experienced a 4.5% increase in 1996-97 and a 3.8% increase in 1997-98.

Table 4 presents the average salaries and the number of full-time faculty employed on a 9-10 month basis only. Faculty who are employed on an 11-12 month basis are not included in this table. Individual faculty members included in Table 4 may or may not be employed by separate contract for summer teaching. The criterion for inclusion in Table 4 is that the basic contract is for a regular 9-10 month academic year. Whereas many interpretations may be made from data in Table 4 alone, depth may be gained by comparing the data with those contained in Tables 1 and 6.

The average salary paid in the 25 institutions in 1997-98 to 9-10 month employed faculty is \$44,736. This represents an increase over 1996-97 of \$2,349 or 5.5%. As is true with other consolidated data in this report, the comprehensive universities exert heavy influence on this average, as they claim more than one-third of the faculty and their average is 25.2% higher than that of the four-year universities. Likewise, within the two-year tier, Tulsa Community College employs one quarter of the total faculty and shows an average salary over 12% above the mean. This influence is indicated by observing that the average salary for the comprehensive universities is \$52,723, the average salary for four-year universities is \$42,112, and the average salary for two-year colleges is \$37,403. The 1997-98 median of all institutions' average salaries is \$36,899.

Table 4 reveals that the comprehensive universities report a lower average salary for the ranks of professor and associate professor employed on a 9-10 month contract when compared to the average shown in Table 1. The data for the comprehensive universities reflect a higher average monthly rate of pay for 11-12 month contract faculty than average monthly salary rates for 9-10 month contract faculty, with the exception of the rank of assistant professor. Unlike the comprehensive universities, the data for four-year universities and two-year colleges reflect a higher average monthly salary rate of pay for 11-12 month contract faculty than average monthly salary rates for 9-10 month contract faculty at all ranks.

The number of full-time faculty employed on a 9-10 month contract in 1997-98 is 3,718. This number represents 90.0% of the total full-time faculty in the 25 institutions. In 1996-97, the number was 3,654 or 89.3% of the total. In 1997-98, four-year universities employ 94.3% of their full-time faculty on a 9-10 month basis. The two-year colleges employ 89.6% on a 9-10 month basis. The two comprehensive universities combined employ 85.5% of their full-time faculty on a 9-10 month basis.

1996-97 TO 1997-98

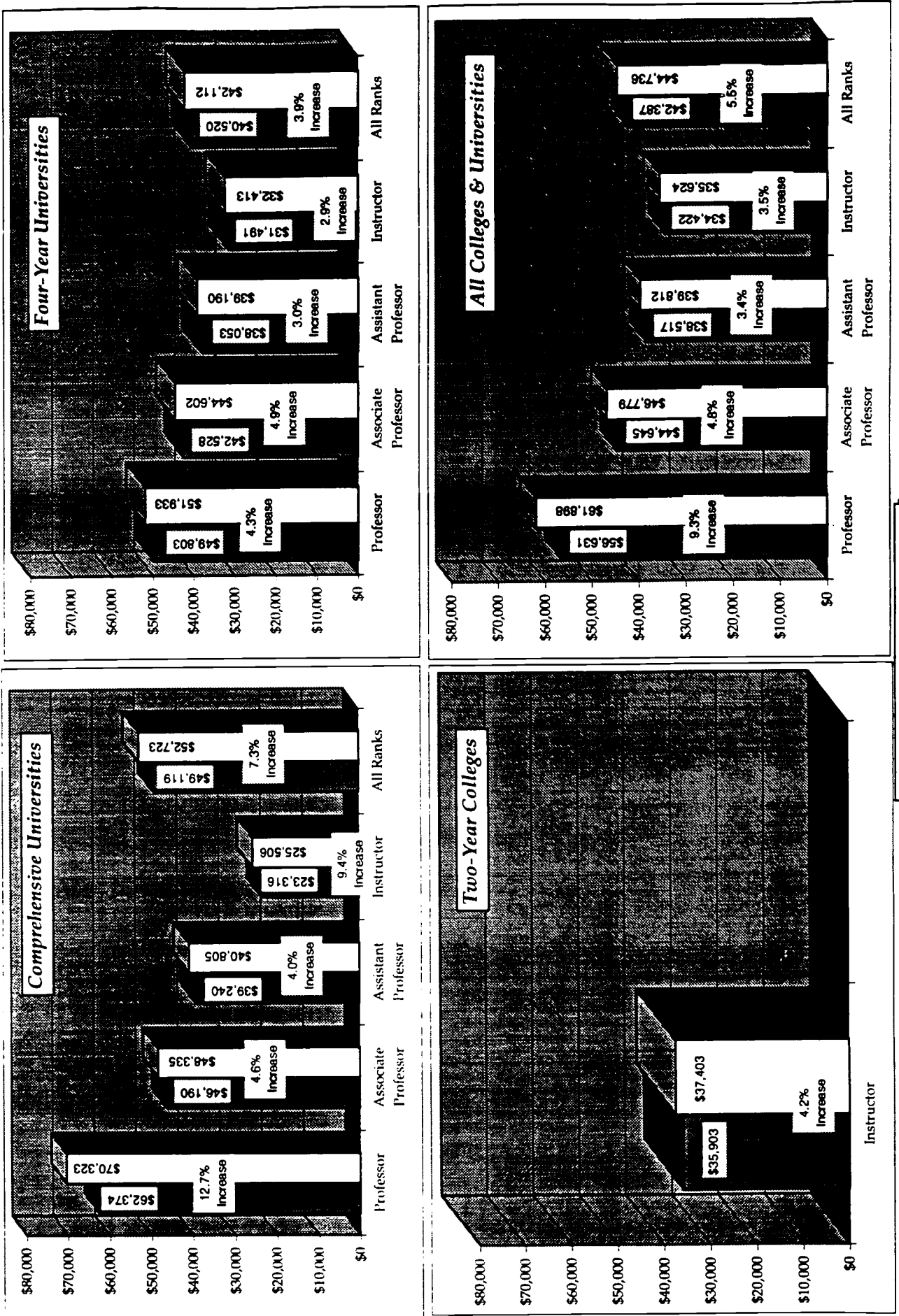

## TABLE 5

Table 5 presents the average fringe benefits on a 9-10 month basis paid to or on behalf of all 9-10 month full-time faculty by all 25 colleges and universities in The Oklahoma State System of Higher Education. The average fringe benefits paid for 1997-98 are \$11,084, an increase over 1996-97 of \$289 or 2.7%.

Fringe benefits as a percent of average salaries may be computed from the data in Tables 4 and 5. For all institutions, 1997-98 fringe benefits are 24.8% of the average salary; in 1996-97, the figure was 25.5%. For the comprehensive universities, four-year universities, and two-year colleges, the fringe benefits for 1997-98 as a percent of average salaries are 24.4%, 25.7%, and 23.7%, respectively. Comparative percentages for 1996-97 were 26.2%, 25.6%, and 23.6%, respectively.

Retirement plan payments are the largest fringe benefit for all institutions combined. 1997-98 payments comprise 45.6% of the average total fringe benefits for the State System, an increase over 44.2% in 1996-97. For the comprehensive universities, four-year universities, and two-year colleges, retirement plan payments are 51.2%, 45.5%, and 33.4%, respectively, of the total average fringe benefits. Comparable 1996-97 figures were 50.7%, 43.2%, and 31.9%, respectively.

Social security taxes are the second largest fringe benefit paid by institutions and are required by law, as are unemployment compensation and worker's compensation payments.

Medical and life insurance benefits are provided by all institutions and 22 institutions provide other fringe benefits not specifically identified.

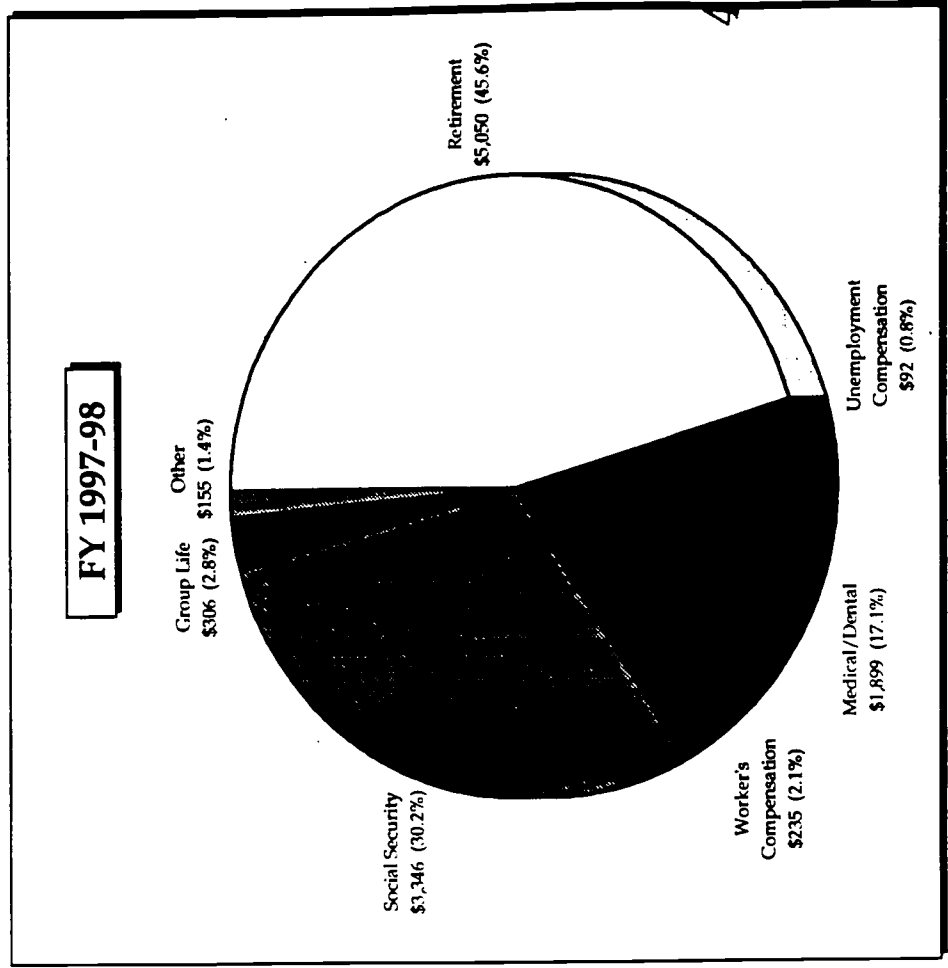
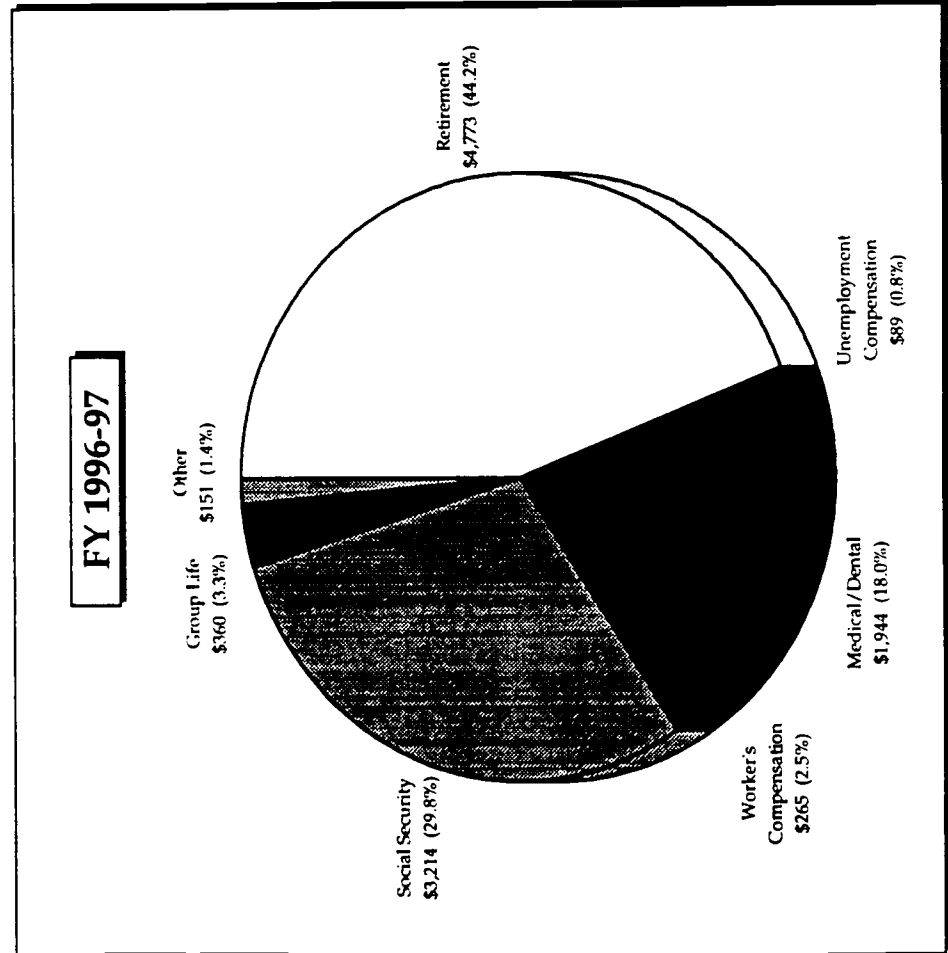

## TABLE 6

Table 6 presents the average salaries and the number of full-time faculty employed in the 25 institutions on an 11-12 month basis only.

The average salary paid in the 25 institutions in 1997-98 to 11-12 month employed faculty is \$60,197, an increase over 1996-97 of \$822 or 1.4%. The average 11-12 month salary for comprehensive universities is \$71,943; the average for four-year universities is \$49,893; and the average for two-year colleges is \$43,983. The 1997-98 median of the average salaries for 23 institutions reporting 11-12 month full-time faculty is \$45,337.

The number of full-time faculty employed on an 11-12 month contract basis is 415 or 10.0% of the total full-time faculty in the 25 institutions. In 1996-97, the number was 439 or 10.7%. The percent of faculty employed on an 11-12 month basis is 14.5% at comprehensive universities; 5.7% at four-year universities, and 10.4% at two-year colleges. The number of full-time faculty employed on an 11-12 month basis varies by institution. For example, the University of Central Oklahoma employs no faculty on an 11-12 month basis, while more than one-fourth of Langston University's faculty (33 out of 117) are employed on an 11-12 month basis.



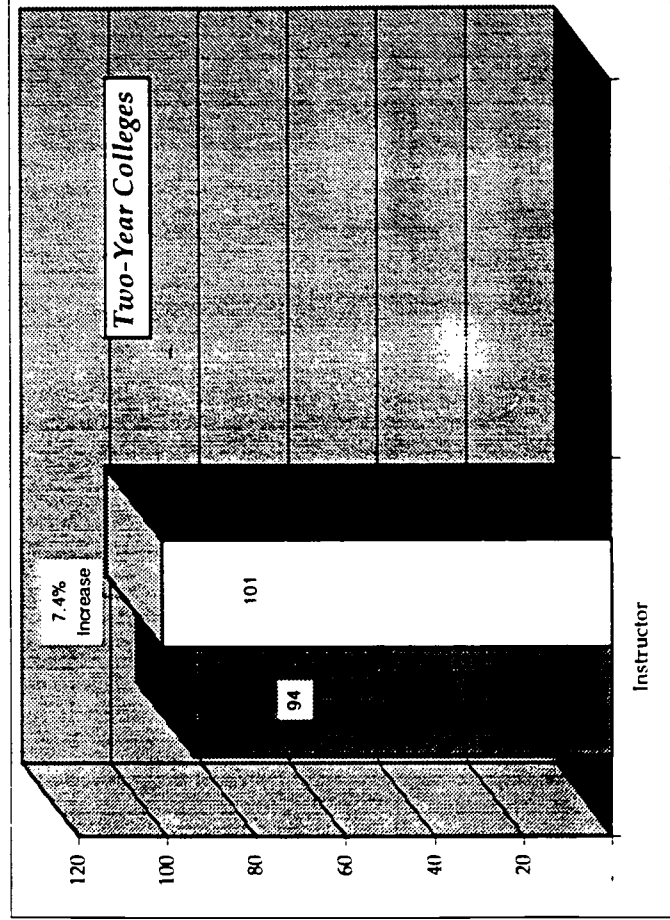
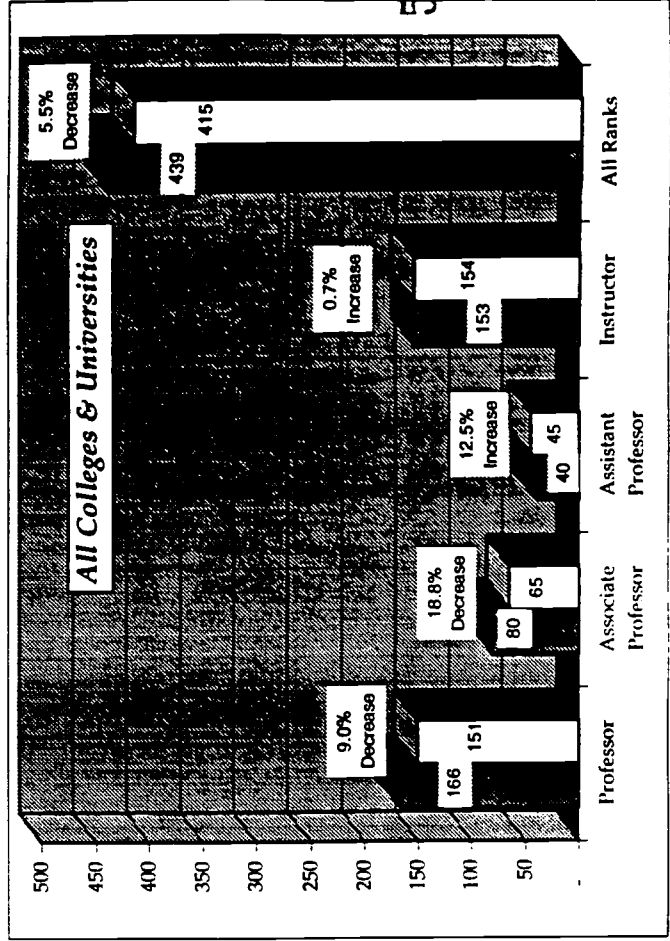
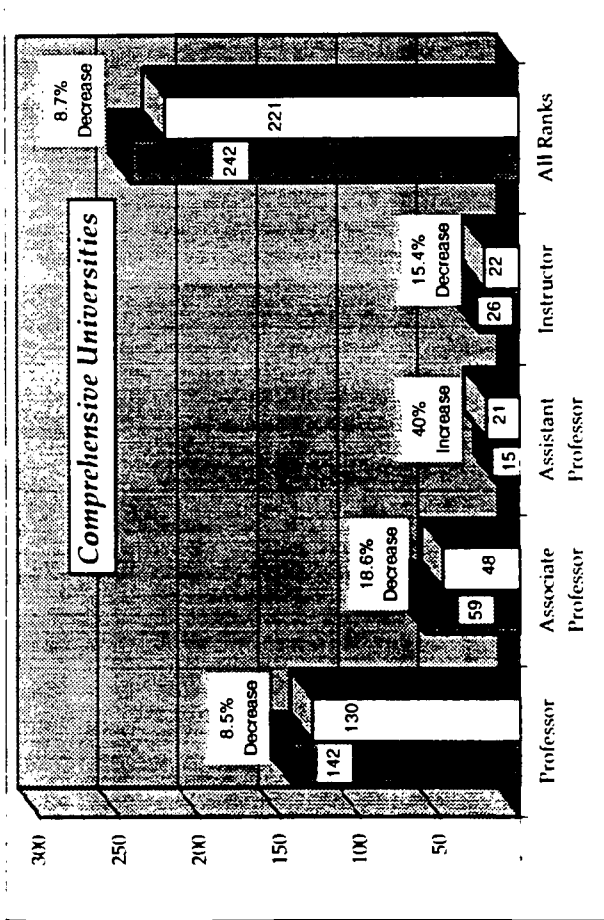
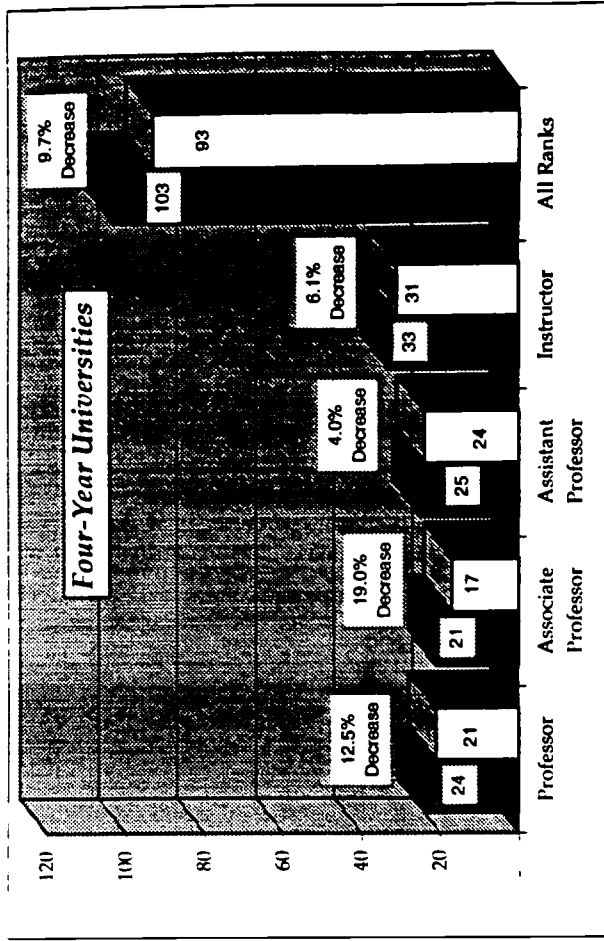

1996-97 TO 1997-98**

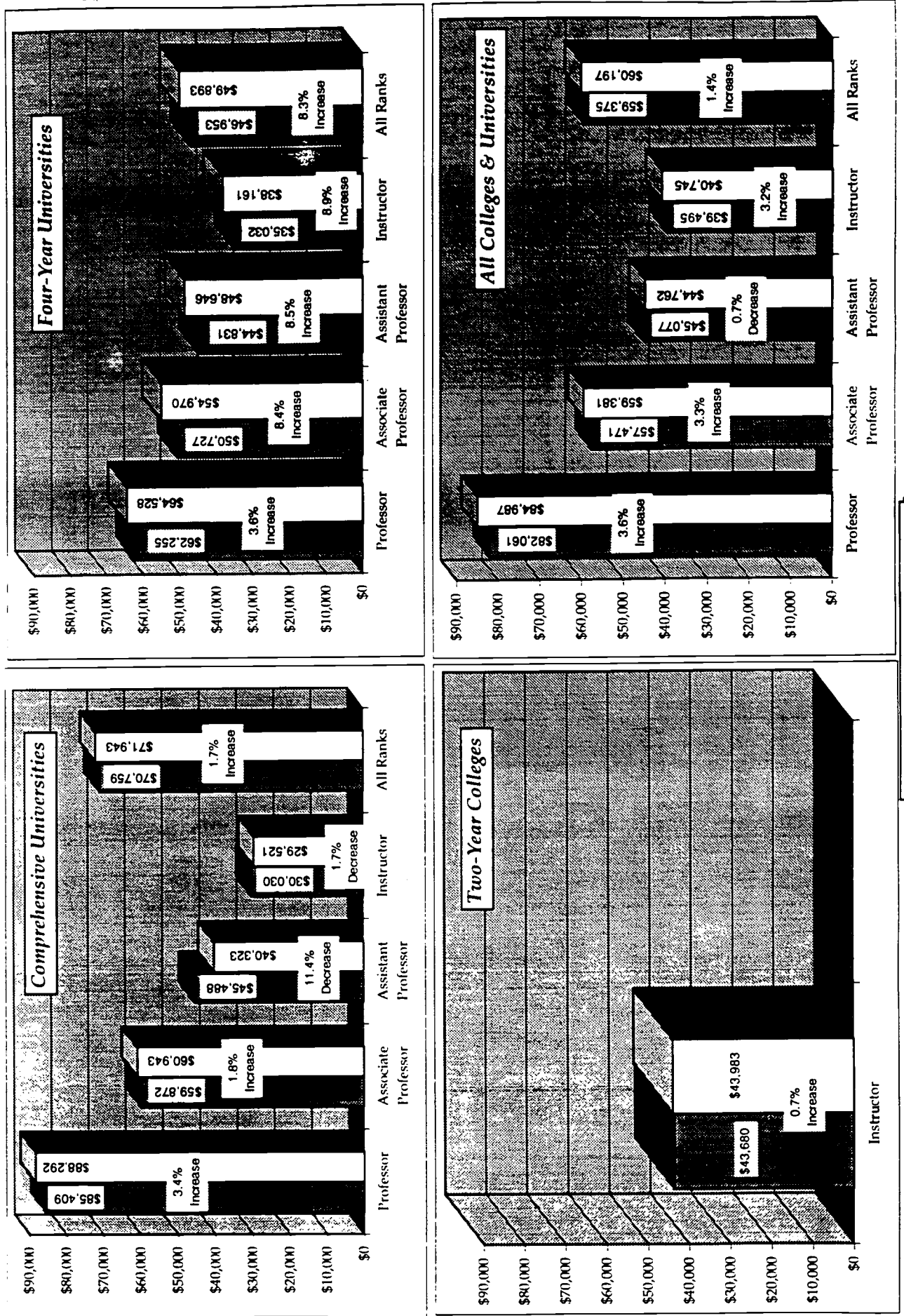

## Table 7

Table 7 presents the 1997-98 average fringe benefits on an 11-12 month basis to or on behalf of all 11-12 month full-time faculty by all 25 institutions in The Oklahoma State System of Higher Education. The average fringe benefit paid for 1997-98 is \$14,188 and represents an increase of \$538 or 3.9%.

Fringe benefits as a percent of average salaries may be computed from the data in Tables 6 and 7. For all institutions, 1997-98 fringe benefits are 23.6% of the average salary, an increase from 23.0% in 1996-97. For the comprehensive universities, four-year universities, and two-year colleges, the fringe benefits as a percent of average salaries are 22.9%, 26.9%, and 22.6%, respectively. Comparable 1996-97 figures were 22.5%, 25.3%, and 22.2%, respectively.

Retirement plan payments are the largest fringe benefit for all institutions combined. Such payments comprise 51.7% of the average total fringe benefits for the State System for 1997-98 as compared with 49.0% for 1996-97. For the comprehensive universities, four-year universities, and two-year colleges, the payments are 56.4%, 50.9%, and 35.4%, respectively, of the total average fringe benefits. Comparable figures for 1996-97 were 53.5%, 45.8%, and 34.1% respectively.

Social security taxes are the second largest fringe benefit paid by institutions and are required by law, as are unemployment compensation and worker's compensation payments.

Medical and life insurance benefits are provided by all 23 institutions reporting 11-12 month full-time faculty. Nineteen institutions provide other fringe benefits not specifically identified.

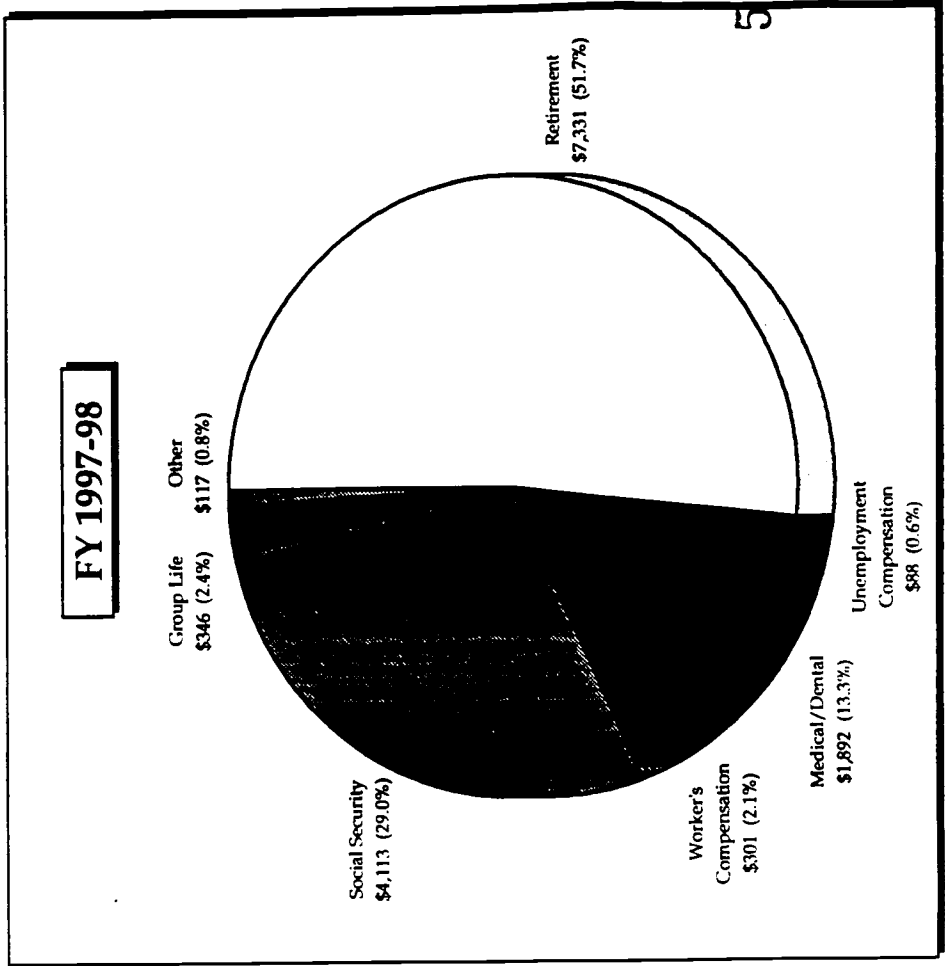
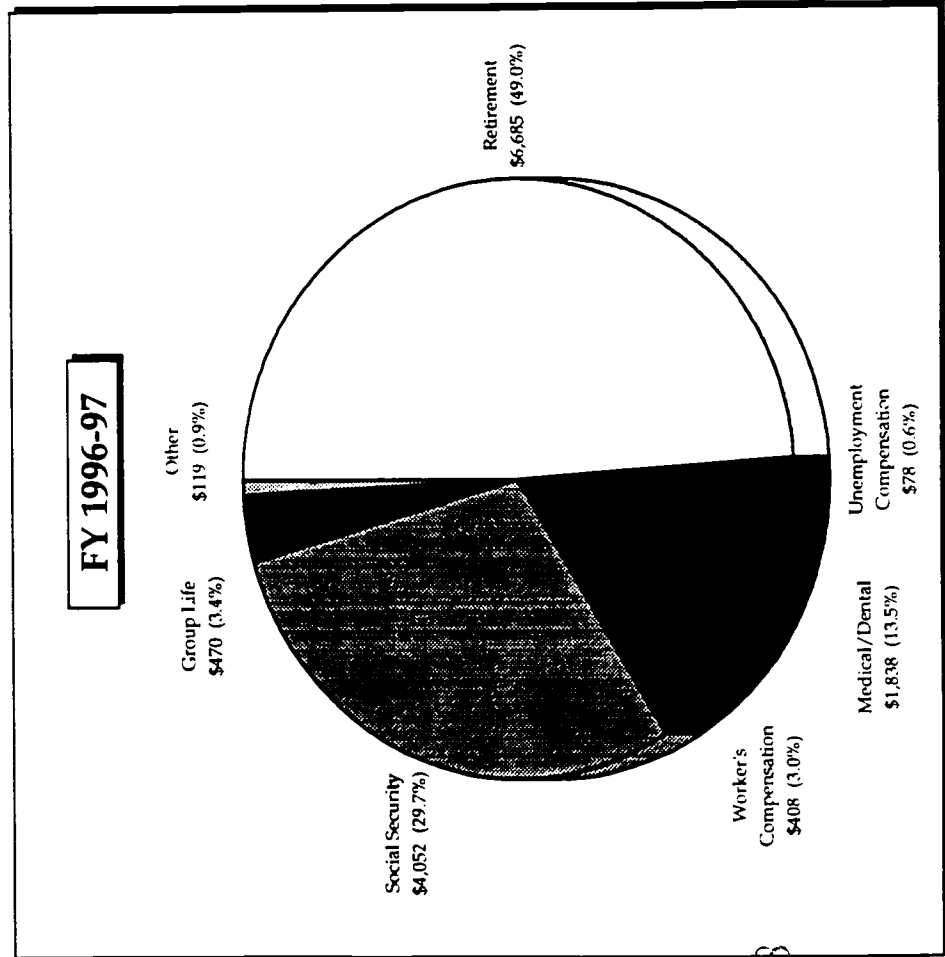

## TABLE 8

Table 8 presents the 1997-98 average total compensation paid to those full-time faculty on both 9-10 month and 11-12 month contracts by all 25 institutions in The Oklahoma State System of Higher Education.

Average total compensation for 9-10 month faculty in 1997-98 is \$55,691, compared with \$53,182 in 1996-97, and represents an increase of \$2,509 or 4.7%. The 1997-98 average for comprehensive universities is \$65,242, for four-year universities, \$52,841, and for two-year colleges, \$46,578. The median of the average total compensation for all 25 institutions reporting is \$48,217.

Average total compensation for 11-12 month faculty in 1997-98 is \$74,127 compared with \$73,025 in 1996-97, and represents an increase of \$1,102 or 1.5%. The 1997-98 average for comprehensive universities is \$88,005, for four-year universities, \$63,341, and for two-year colleges, \$53,901. The median of the average total compensation for the 23 institutions reporting 11-12 month faculty is \$56,219.

NOTE: At Cameron University, 11-12 month average salaries are lower than 9-10 month average salaries because the only faculty paid on an 11-12 month contract at this institution are instructors, who are normally paid at a lower rate than other higher ranking faculty. Oklahoma Panhandle State University and Redlands Community College also have lower 11-12 month average salaries, due to the very small number of faculty on 11-12 month contract at both of those institutions.



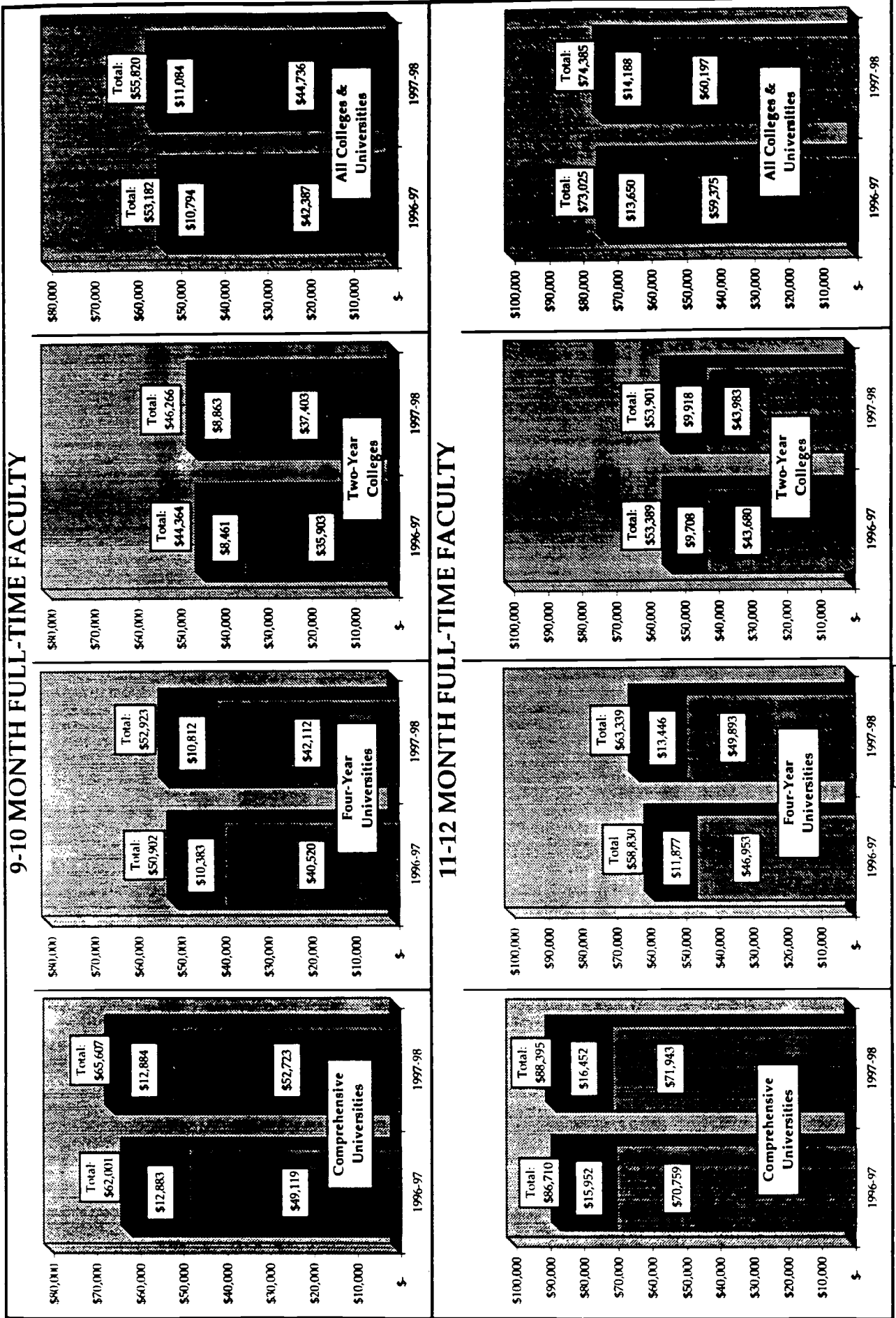

## TABLE 9

Table 9 presents the highest and lowest salaries paid academic deans and full-time faculty classified both by contract period and by type of institution. The number of individuals and the number of institutions in each classification are also presented.

The average (mean) salaries for academic deans employed on an 11-12 month contract basis in 1997-98 for the three classifications of institutions are: comprehensive universities, \$122,385; four-year universities, \$69,264; and two-year colleges, \$56,663. For 1996-97 the average salaries were \$113,251, \$65,661, and \$54,644, respectively. Average salaries for academic deans increased over 1996-97 by 8.1% at comprehensive universities, by 5.5% at four-year universities, and by 3.7% at the two-year colleges.

The highest salary paid academic deans in the 25 institutions on an 11-12 month contract basis in 1997-98 is \$182,760 for comprehensive universities, \$112,800 for four-year universities, and \$65,000 for two-year colleges. The highest salary for these categories in 1996-97 was \$156,480, \$98,508, and \$63,875 for the comprehensive universities, four-year universities, and two-year colleges, respectively. The 1997-98 lowest salary for academic deans is \$57,500 for comprehensive universities, \$49,350 for four-year universities, and \$43,000 for two-year colleges. The lowest salary for these categories in 1996-97 was \$85,722, \$43,087, and \$43,593, respectively.

For full-time faculty on 9-10 month contracts in the state system, the highest salary paid in 1997-98 is \$144,200, up from \$136,416 in 1996-97. The lowest salary is \$4,784, a decrease from \$9,450 in 1996-97.

For 1997-98, the highest salary for a full-time faculty member employed on a 9-10 month contract basis by a four-year university is \$63,496, an increase from \$59,800 in 1996-97. The lowest salary for a full-time faculty member employed on a 9-10 month contract basis by a four-year university in 1997-98 is \$24,000, compared to \$23,000 in 1996-97. For two-year colleges, the 1997-98 high is \$62,107, compared to \$59,150 for 1996-97. Finally, the 1997-98 low two-year college salary is \$24,250, compared to \$15,789 in 1996-97.

The highest salary paid an 11-12 month contract full-time faculty member in the 25 institutions in 1997-98 is \$150,840, compared to \$138,420 in 1996-97. The lowest salary in 1997-98 is \$12,000, compared to \$23,472 in 1996-97. For 1997-98, the highest salary for a full-time faculty member employed on an 11-12 month contract basis by a comprehensive university is \$150,840, compared to \$138,420 in 1996-97; the lowest salary in 1997-98 is unchanged at \$23,472. For 1997-98, the highest salary for a full-time faculty member employed on an 11-12 month contract basis by a four-year university is \$81,360, compared to \$79,044 in 1996-97; the lowest salary in 1997-98 is \$12,000, compared to \$24,000 in 1996-97. For 1997-98, the highest salary for a full-time faculty member employed on an 11-12 month contract basis by a two-year college is \$66,892, compared to \$63,706 in 1996-97; the lowest salary is \$23,235, a decrease from \$25,990 in 1996-97. These data exclude academic deans.

## TABLE 10

Table 10 presents income earned by full-time faculty members from activities that are specifically authorized by the institution in addition to primary employment duties. Income from summer-term employment for faculty employed on a 9-10 month contract basis is excluded from Table 10. These data are presented as "actual" for the completed year of 1996-97 and "estimated" for the current year, 1997-98.

The "estimated" average mean income in the 25 institutions from extra teaching assignments and approved noninstitutional employment for 1997-98 is \$2,354 for those faculty members earning such income. The "actual" figure for 1996-97 was \$2,358. In 1997-98, the median of the "estimated" averages is \$2,100; in 1996-97, the median of the "actual" averages was \$2,440. In 1997-98, the highest "estimated" average income from extra assignments is \$6,201; in 1996-97, the highest "actual" average was \$4,842.

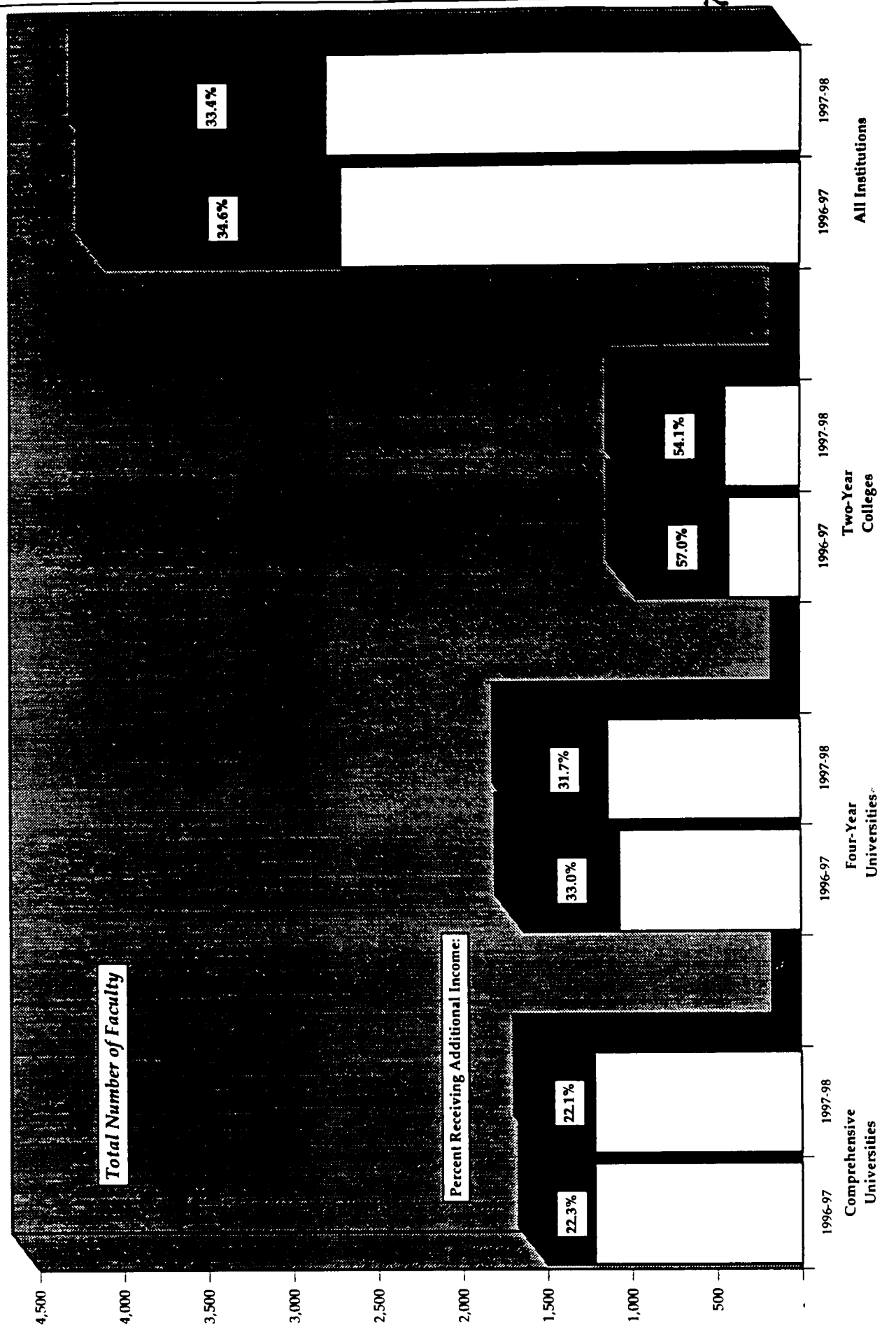

## TABLE 11

Table 11 presents 1997-98 salary data for selected administrative positions on an 11-12 month employment period by type of institution. The positions selected for inclusion are those most commonly staffed at higher education institutions. The average amount of fringe benefits is also included in the table. In some institutions, one individual may hold two or more administrative titles. In these instances, the salary has been reported under that heading most commonly associated with the highest salary.

Comprehensive university presidents salaries average \$184,500 in 1997-98, compared to \$157,197 in 1996-97. Fringe benefits for the two presidents average \$34,848.

Four-year university presidents receive an average salary of \$125,745 in 1997-98, an increase of 14.6% over the 1996-97 average salary of \$109,741. The highest salary for a four-year university president in 1997-98 is \$158,000, compared to \$140,000 in 1996-97. Fringe benefits average \$25,057 or 19.9% of the average salary.

Two-year college presidents receive an average salary of \$95,361 in 1997-98, an increase of 4.6% over the 1996-97 average salary of \$91,178. The highest salary for a two-year college president in 1997-98 is \$118,627, compared to \$112,978 in 1996-97. Fringe benefits average \$25,632 or 26.9% of the average salary.

College and university vice presidents' salary information includes those positions surveyed in the Administrative Compensation Survey from the College and University Personnel Association (CUPA). These positions surveyed at the Vice President level are: Chief Academic Officer, Chief Business Officer, Chief Development Officer, and Chief Student Affairs Officer.

## TABLES 12, 13, and 14

Tables 12, 13, and 14 present average salaries and fringe benefits of eight constituent agencies in the state higher education system. Each of the constituent agencies is unique with respect to average salary rates or professional classification. Consequently, salary data for each of the eight agencies are presented separately.

The University of Oklahoma Health Sciences Center average salaries are presented on an 11-12 month contract basis. **The College of Medicine** 1997-98 average salary is \$66,338, an increase of 1.7% from 1996-97. **The College of Dentistry** 1997-98 average salary is \$60,184, an increase of 4.5% from 1996-97. **The College of Nursing** 1997-98 average salary is \$39,898. **The College of Public Health** 1997-98 average salary is \$62,529, an increase of 6.2% over 1996-97. **The College of Allied Health** 1997-98 average salary is \$50,248, an increase of 4.8% over 1996-97. **The Graduate College** 1997-98 average salary is \$52,909. **The College of Pharmacy** 1997-98 average salary is \$63,721, an increase of 7.9% over 1996-97. **The Tulsa Branch Medical School** 1997-98 average salary is \$85,960, a decrease of 2.0% from 1996-97.

The University of Oklahoma Law Center full-time faculty average salary on a 9-10 month equivalent contract basis for 1997-98 is \$81,629, a 9.9% increase over 1996-97.

**88** The Oklahoma State University College of Veterinary Medicine full-time faculty average salary on an 11-12 month contract basis for 1997-98 of \$73,513 is an increase of 1.0% over 1996-97.

The Oklahoma State University College of Osteopathic Medicine full-time faculty average salary on an 11-12 month contract basis for 1997-98 of \$92,882 is an increase of 3.6% over 1996-97.

The Oklahoma State University Agricultural Experiment Station full-time faculty average salary on an 11-12 month contract basis for 1997-98 of \$69,181 is an increase of 4.3% over 1996-97.

The Oklahoma State University Agricultural Extension Division full-time faculty average salary on an 11-12 month contract basis for 1997-98 of \$65,640 is an increase of 4.7% over 1996-97.

The Oklahoma State University Technical Branch Okmulgee full-time faculty average salary on an 11-12 month contract basis for 1997-98 of \$40,413 is an increase of 9.5% from 1996-97.

The Oklahoma State University Technical Branch Oklahoma City full-time faculty average salary on a 9-10 month contract basis for 1997-98 of \$34,638 is an increase of 6.6% over 1996-97.

## **TABLES 15 and 16**

Tables 15 and 16 illustrate the number and average salaries of new full-time faculty hired in 1997-98, as well as the number and average salaries of full-time faculty terminations in 1996-97. A total of 272 faculty retired, resigned, or were terminated, while an additional 297 faculty were hired, a net gain of 25 new faculty. "Terminated Faculty" on Table 16 includes faculty who departed for any of the noted reasons (retired or resigned).

When comparing average salaries of new faculty hires to faculty terminations, new faculty salaries were 2.5% higher at the comprehensive universities, 9.1% lower at four-year universities, and 14.2% lower at two-year colleges. The system average is 4.8% less for new hires compared to terminated faculty. The average salaries of new hires are lower primarily because most new faculty are hired at a lower academic rank (i.e., assistant professor or instructor).

It is significant that the average salary of new hires is higher at all ranks of both comprehensive universities than the average salary of each rank as a whole (Table 15 vs. Table 1). At the regional universities, newcomers' average salaries are lower than the average salaries for the ranks of assistant professor and instructor, as a whole, but are higher for professors and associate professors.

## TABLE 17

Table 17 illustrates average salaries by rank and by tier of Oklahoma institutions compared to national averages.

Oklahoma has made significant strides in bringing faculty salaries up to the national average. With the exception of Oklahoma's instructor salaries, which already exceed the national average, salaries of all other ranks are now no more than 9 percentage points below the national average. Oklahoma professors salaries are at 92.8% of the national average (\$63,095 compared to \$68,018), associate professors are 91.7% of the national average (\$46,917 compared to \$51,181), and assistant professors are 93.5% of the national average (\$39,660 compared to \$42,402). Oklahoma instructors salaries exceed the national average, \$35,368 compared to \$32,359.

Professors at Oklahoma's comprehensive universities have seen the largest 10-year growth in average salary, 65.2%, when compared to other ranks and other tiers. Nationally, professor salaries at comprehensive universities grew only 47.1%, by comparison. Not surprisingly, Oklahoma instructors at comprehensive universities have seen the smallest 10-year increase, 34.2%, and are 77.4% of the national average (\$25,139 compared to \$32,478).

Overall, average salaries of all ranks have increased 46.4% over the 10-year period compared to 44.2% nationally, bringing Oklahoma average faculty salaries up to 84.3% of the national average.

Figure 11 shows the annual percentage increases in average faculty salaries in Oklahoma and the nation over a 10-year period for each tier of institutions. Comprehensive universities have made the most progress, with percentage increases surpassing the national average in 7 out of the 10 years. Overall, Oklahoma's average annual increase outpaced the nation, 3.9% compared to 3.7%.

Figure 12 shows annual percentage increases in faculty salaries in Oklahoma and the nation over a 10-year period by faculty rank. Professors received the largest average annual increase, 4.8%, compared to 3.7% nationally. Average annual increases for associate professors, assistant professors, and instructors were 3.7%, 3.4%, and 3.3%, respectively.

**OKLAHOMA COMPARED TO NATIONAL INSTITUTIONS**

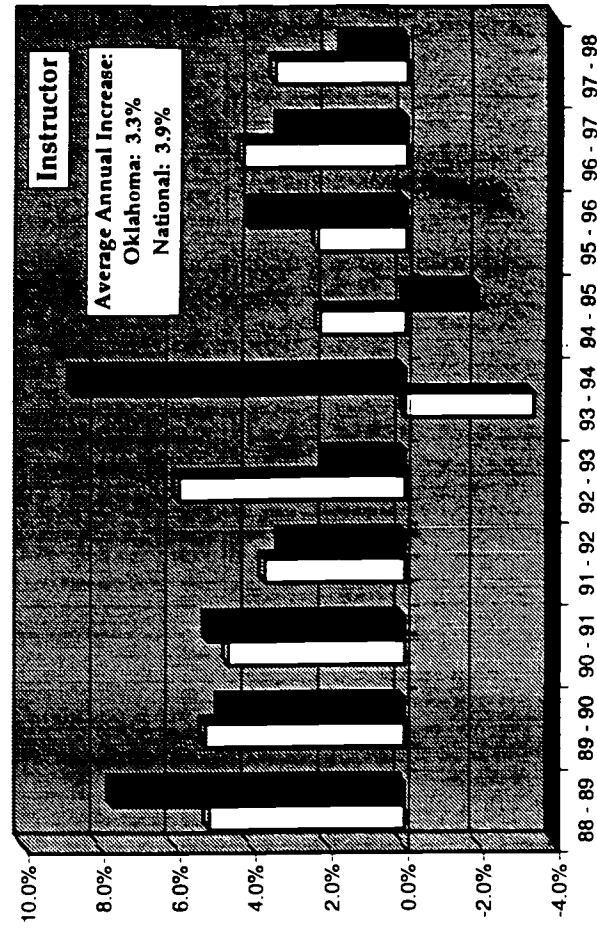
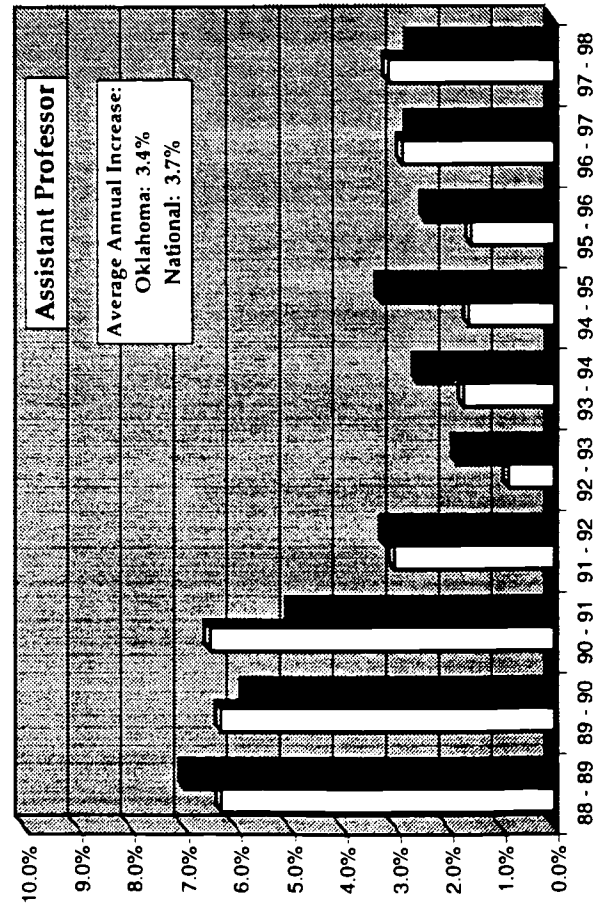
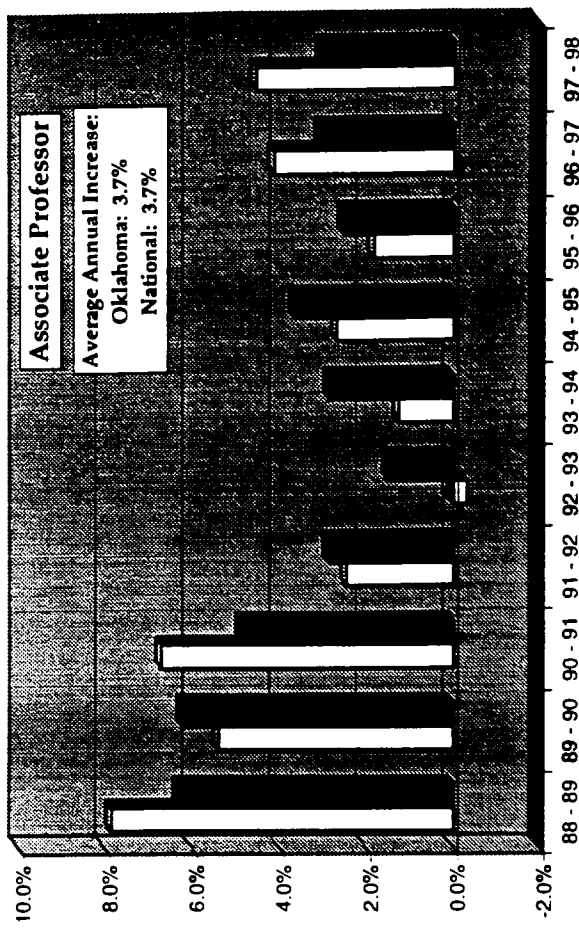
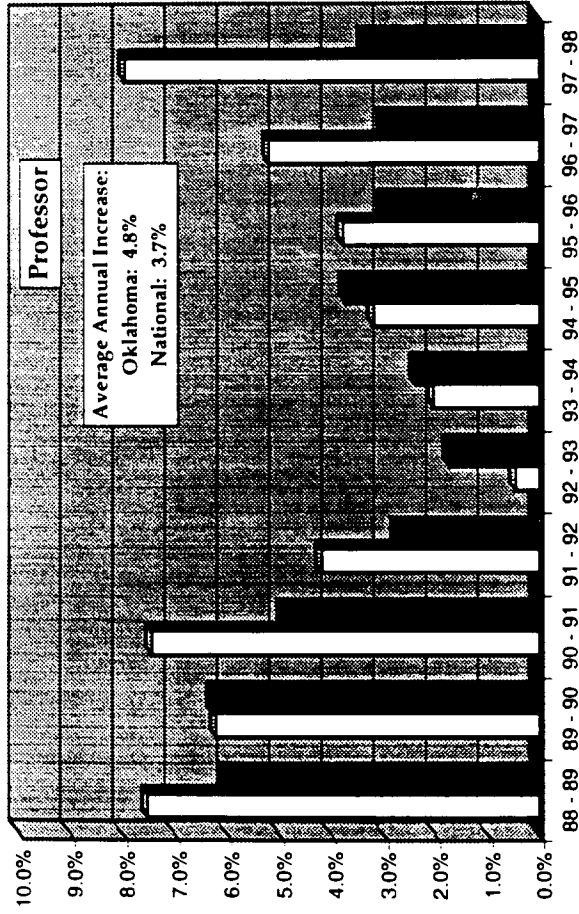
