ABSTRACT

The Youth Risk Behavior Survey (YRBS) was administered in a stratified random sample to South Dakota public schools including Bureau of Indian Affairs schools; private schools were not included. The six priority health-risk behaviors assessed in the YRBS are: (1) intentional and unintentional injuries; (2) tobacco use; (3) alcohol and other drug use; (4) sexual behaviors that result in HIV infection, other sexually transmitted diseases, and unintended pregnancy; (5) dietary behaviors; and (6) physical activity. A description of sampling strategy, description of sample, weighting of responses, and rationale for each question are provided. Results are presented for each of the six health risk behaviors along with the related national health objectives for the year 2000. Results are summarized for years 1991, 1993, 1994, and 1997. In addition to presenting the overall results for each question, a separate breakdown is provided for each grade level. Data is provided in graphs showing percentage of responses to each question by year and by grade. (Contains 41 references.) (EMK)

Description of the Youth Risk Behavior Survey

The Youth Risk Behavior Survey (YRBS) is a questionnaire consisting of 98 items that assess the six priority health-risk behaviors that result in the greatest amount of morbidity, mortality, and social problems among youth. The YRBS was developed cooperatively by the Centers for Disease Control and Prevention (CDC), and state and local departments of education. The six priority health-risk behaviors assessed in the YRBS are intentional and unintentional injuries; tobacco use; alcohol and other drug use; sexual behaviors that result in HIV infection, other sexually transmitted diseases (STDs), and unintended pregnancy; dietary behaviors; and physical activity.

These six priority health-risk behaviors were selected for inclusion in the survey because, among persons aged 5-24 years, approximately 72% of all deaths are due to only four causes: motor vehicle crashes (30%), other unintentional injuries (12%), homicide (19%), and suicide (11%). In addition, each year, an estimated 1 million teenaged girls become pregnant and 86% of all STD cases occur among 15 - 29 year olds. Further, one out of every five persons diagnosed with AIDS in the U.S. is 20 to 29 years old. Given the 8 to 10 year incubation period between HIV infection and AIDS diagnosis, many of those 20 to 29 year-olds with AIDS may have been infected as adolescents. A limited number of behaviors usually established during youth contribute substantially to these causes of mortality and morbidity. These behaviors include carrying a weapon; physical fighting; attempted suicide; drinking or using drugs while operating a motor vehicle; lack of seatbelt use while riding in a motor vehicle; lack of helmet use while riding a bicycle or motorcycle; and unprotected sexual intercourse that results in unintended pregnancies and sexually-transmitted diseases, including HIV infection.

Among adults aged 25 and over in the U.S., 67% of deaths are due to only three causes: diseases of the heart (35%), cancer (25%), and stroke (7%). A limited number of behaviors, often established during youth, contribute to these health problems which generally do not result in mortality and morbidity until adulthood. These behaviors include the use of tobacco; excessive consumption of fat, calories, and sodium; insufficient consumption of fiber; and insufficient physical activity.

Description of the Sample Selection Process

All public, private, and Bureau of Indian Affairs (BIA) schools in South Dakota containing any students in grades 9, 10, 11, or 12 were eligible to be selected for inclusion in the sample. Ungraded and out-of-school programs were excluded. Schools were stratified on the basis of type of control (public, private, BIA), region (East River, West River), and size of enrollment. Systematic sampling with probabilities proportional to size of enrollment with a random start was used to select 25 schools to participate in the survey.

Each participating school submitted a list of all classes with students in grades 9, 10, 11, or 12 which met during a given class period (e.g., 2nd period). Systematic equal probability sampling with a random start was used to select classes to participate in the survey.

Description of the Survey Administration in the Classroom

Prior to the administration of the survey, a letter was sent to the parents of the students in each of the selected classes, which informed them about the nature of the survey. The letter also contained a form that the parents could return to request that



their child not participate in the survey. The instructions read to the students and printed on the survey stated that completing the survey is voluntary, and even though their parents had given permission for them to do the survey, they could make their own decision at that time as to whether or not to participate.

Description of the Strategies to Ensure the Privacy of Responses

The survey administration process was designed to maximize the confidentiality of each student's responses. Two strategies were utilized to achieve the greatest possible privacy for the students' responses. The first strategy consisted of distributing three versions of the questionnaire in each classroom. Each version had a different ordering of the questions. Therefore, even if someone was to see another person's responses, the onlooker would not know which questions were being answered. The second strategy for ensuring privacy consisted of having the students seal their sense-mark answer sheets into a standard-size business envelope, and then having them seal the questionnaire and the sealed business envelope into a large manila envelope.



Characteristics of the Sample

Completed surveys were received from 21 of the 25 sampled schools for a school response rate of 84%. Usable questionnaires were received from 1,604 of the 1,998 sampled students for a student response rate of 80%. The overall response rate was (84% * 88%) = 67%.

The 1,604 respondents were comprised of 789 females (49%) and 814 males (51%). The grade level breakdown of the respondents was 461 ninth grade (29%), 389 tenth grade (24%), 364 eleventh grade (23%), and 382 twelfth grade (24%). Eight of the respondents (0.5%) did not indicate their grade level. The race/ethnicity breakdown of the respondents was 1,491 White (93%), 46 Native American (3%), 12 Hispanic (0.7%), 11 Black (0.7%), 17 Asian or Pacific Islander (1%), and 21 Other (1%). Six of the respondents (0.4%) did not indicate their race/ethnicity.

Weighting of the Responses

A weighting procedure was performed to reduce bias by compensating for differing patterns of nonresponse and to reflect the likelihood of sampling each student. The weighted results contained in this report can be used to make inferences concerning the priority health-risk behaviors of all high school students in grades 9 through 12 in public, private, and BIA schools in South Dakota.

Organization of this Report

The following seven pages provide a summary of each of the six priority health-risk behaviors, and a summary of perceptions concerning HIV/AIDS. The remainder of the report provides the summary results for each of the survey questions, along with the related National Health Objectives for the Year 2000, and the rationale for each question. In addition to reporting the overall results for each question, a separate breakdown is provided for grade level. Since the majority of the 1997 questions were also included in the 1991, 1993, and 1995 surveys, the results are also summarized by year.




Summary of Behaviors that Result in Intentional and Unintentional Injuries

The chart below summarizes the reported risk behaviors that result in intentional and unintentional injuries, and the reported instances of sexual harassment. Fourteen percent of the respondents always wore a seatbelt when riding in a car. Only 1% of the respondents always used a helmet when riding a bicycle. Fifty percent of the respondents, during the past 30 days, rode in an automobile that was driven by someone who had been drinking alcohol. During the past 30 days, 31% of the respondents had driven an automobile when they had been drinking alcohol.

Nineteen percent of the respondents had carried a weapon during the past 30 days. Thirty-one percent of the respondents reported that they had been in a physical fight during the past 12 months. Thirty-three percent of the respondents were ever touched, grabbed, or pinched in a sexual way without their consent during school-related times. Forty-seven percent of the respondents had others make unwanted sexual comments, jokes, gestures or looks during school-related times. Suicide was seriously considered by 27% of the respondents during the past 12 months. Eleven percent of the respondents reported actually attempting suicide during the past 12 months.

Summary of Tobacco Use


The reported risk behaviors associated with tobacco use are summarized in the chart below. Seventy-five percent of the respondents have tried cigarette smoking. Twenty-six percent of the respondents had smoked a whole cigarette prior to age 13. Forty-four percent of the respondents smoked a cigarette during the past 30 days. Thirty-nine percent of the respondents reported that they have tried to quit smoking.

Eighteen percent of the respondents reported using smokeless tobacco, i.e., chewing tobacco or snuff, during the past 30 days.

Of respondents who smoked cigarettes during the past 30 days, 28% usually bought their cigarettes in a store. Of respondents who purchased cigarettes in a store during the past 30 days, 61% were ever asked to show proof of age.

Summary of Alcohol and Other Drug Use


The chart below summarizes the reported risk behaviors associated with the use of alcohol and other drugs. Lifetime alcohol use was reported by 83% of the respondents. Thirty-one percent of the respondents had drank alcohol prior to age 13. Over half of the respondents (60%) reported having at least one alcoholic drink during the past 30 days. Forty-five percent of the respondents had 5 or more alcoholic drinks in a row during the past 30 days.

Marijuana was used at least once by 35% of the respondents. Twenty percent of the respondents used marijuana during the past 30 days.

Cocaine use was reported by 9% of the respondents. Fifteen percent of the respondents reported using other illegal drugs. Illegal drugs were injected by 3% of the respondents. Three percent of the respondents reported using steroid pills or shots without a doctor's prescription. Eighteen percent of the respondents sniffed glue or inhaled sprays from cans during their lifetime.

Summary of Sexual Behaviors that Result in HIV Infection, Other Sexually Transmitted Diseases, and Unintended Pregnancy


The chart below summarizes the reported sexual risk behaviors. Forty-one percent of the respondents reported having had sexual intercourse. Five percent of the respondents reported having had sexual intercourse prior to age 13. Fourteen percent of the respondents reported having had sexual intercourse with four or more people during their life.

Of the respondents who reported having had sexual intercourse, 35% used alcohol or other drugs prior to last sexual intercourse, and 54% reported condom use during last sexual intercourse.

Three percent of the respondents reported that they had become pregnant or had gotten someone pregnant. Nine percent of respondents were ever forced to have sexual intercourse on a date.


Summary of Dietary Behaviors

The reported risk behaviors associated with dietary excesses and imbalances are summarized in the chart below. Fifty-two percent of the respondents reported that they were the right weight. Forty-six percent reported that they were trying to lose weight. Six percent of the respondents had vomited or took laxatives to lose weight or to keep from gaining weight during the past 30 days. Seven percent of the respondents took diet pills to lose weight or to keep from gaining weight during the past 30 days.

Regarding the foods they had eaten the previous day, 62% had eaten fruit and 26% had eaten green salad. Over half of the respondents had eaten foods such as hamburgers and hot dogs (59%), french fries and potato chips (56%), and cookies, doughnuts, pie or cake (61%) on the previous day. Sixty percent of the respondents had eaten breakfast the previous day.

Summary of Physical Activity


The chart below summarizes the reported risk behaviors associated with physical inactivity. Regarding the amount of physical activity in which they engaged, 60% of the respondents reported participating in strenuous exercise during the past 7 days. Forty-seven percent of the respondents reported engaging in stretching exercises during the past 7 days, and 47% of the respondents reported that they participated in exercises to strengthen or tone their muscles.

Twenty-five percent of the respondents walked or rode a bicycle for at least 30 minutes on three or more of the past seven days. Thirty-two percent of the respondents had at least one day of physical education class per week at school. Twenty-eight percent of the respondents reported spending at least 20 minutes actually exercising or playing sports during an average physical education class.

Participation on school sports teams during the past 12 months was reported by 52% of the respondents, and 44% reported participating on a sports team run by organizations outside of school.

Percentage of Respondents Who:






Summary of Perceptions Concerning AIDS/HIV

The respondents' perceptions regarding HIV/AIDS are summarized in the chart below. Ninety-three percent of the respondents reported being taught about HIV/AIDS at school. Fifty-four percent reported talking with their family about AIDS/HIV.

Related National Health Objective for the Year 2000:

Increase use of occupant protection systems, such as safety belts, inflatable safety restraints, and child safety seats, to at least 85% of motor vehicle occupants.

Question:

5. How often do you wear a seat belt when riding in a car driven by someone else?


Rationale:

This question measures the frequency with which students wear seat belts when riding in a motor vehicle. Seat belt use is estimated to reduce motor vehicle fatalities by 40% to 50% and serious injuries by 45% to 55%. Increasing the use of automobile safety restraint systems to 85% could save an estimated 10,000 American lives per year.²

Behaviors that Result in Intentional and Unintentional Injuries

Related National Health Objective for the Year 2000:

Increase use of helmets to at least 80% of motorcyclists and at least 50% of bicyclists.

Questions:

- 6. During the past 12 months, how many times did you ride a motorcycle?
- 7. When you rode a motorcycle during the past 12 months, how often did you wear a helmet?
- 8. During the past 12 months, how many times did you ride a bicycle?
- 9. When you rode a bicycle during the past 12 months, how often did you wear a helmet?


Rationale:

These questions measure the frequency of helmet use while riding motorcycles and bicycles. Head injury is the leading cause of death in motorcycle and bicycle crashes.³ Unhelmeted motorcyclists are two times more likely to incur a fatal head injury and three times more likely to incur a nonfatal head injury than helmeted riders.⁴ In addition, the risk of head injury for unhelmeted bicyclists is more than 6 1/2 times greater than for helmeted riders.⁵




Percentage of respondents who rode a motorcycle one or more times during the past 12 months = 34%

Of the respondents who rode a motorcycle during the past twelve months, the percentage who always wore a motorcycle helmet = 26%







Percentage of respondents who rode a bicycle one or more times during the past 12 months = 79%

Responses by Year






Question 9

Behaviors that Result in Intentional and Unintentional Injuries

Related National Health Objectives for the Year 2000:

Reduce deaths among people aged 15-24 caused by alcohol-related motor vehicle crashes to no more than 18 per 100,000 people.

Reduce deaths among youth aged 15-24 caused by motor vehicle crashes to no more than 33 per 100,000 people.

Questions:

- 10. During the past 30 days, how many times did you ride in a car or other vehicle driven by someone who had been drinking alcohol?
- 11. During the past 30 days, how many times did you drive a car or other vehicle when you had been drinking alcohol?


Rationale:

These questions measure the frequency with which students ride as a passenger or driver in a motor vehicle operated under the influence of alcohol or drugs. Motor vehicle crash injuries, more than half of which involve alcohol, are the leading cause of death among youth aged 15-24 in the United States. Alcohol-related traffic crashes cause serious injury and permanent disability and rank as the leading cause of spinal cord injury among adolescents and young adults.

Results: The results for Questions 10 and 11 are summarized on page 18.




Percentage of respondents who during the past 30 days rode one or more times in a car or other vehicle driven by someone who had been drinking alcohol = 50%

Behaviors that Result in Intentional and Unintentional Injuries

Related National Health Objective for the Year 2000:

Reduce by 20% the incidence of weapon-carrying by adolescents aged 14-17.

Questions:

- 12. During the past 30 days, on how many days did you carry a weapon such as a gun, knife, or club?
- 13. During the past 30 days, on how many days did you carry a gun?


Rationale:

These questions measure violence-related behaviors. Approximately nine out of ten homicide victims in the United States are killed with a weapon of some type, such as a gun, knife, or club. Homicide is the second leading cause of death among all youth aged 15-24 and is the leading cause of death among black youth aged 15-24. During adolescence, homicide rates increase 15 times, from a negligible rate of 0.9 per 100,000 at age 10 to 13.9 per 100,000 by age 20. The immediate accessibility of a firearm or other lethal weapon often is the factor that turns a violent altercation into a lethal event. Firearm-related suicides, which tripled between 1950 and 1980, account for 60% of adolescent and young adult suicides. Unintentional firearm-related fatalities also are a critical problem among children and young adults in the United States.




Percentage of respondents who carried a weapon such as a gun, knife, or club on one or more of the past 30 days = 19%

Reduce by 20% the incidence of physical fighting among adolescents aged 14-17.

Questions:

- 14. During the past 30 days, on how many days did you carry a weapon such as a gun, knife, or club on school property?
- 15. During the past 30 days, how many days did you not go to school because you felt you would be unsafe at school or on your way to or from school?
- 16. During the past 12 months, how many times has someone threatened or injured you with a weapon such as a gun, knife, or club on school property?
- 17. During the past 12 months, how many times has someone stolen or deliberately damaged your property such as your car, clothing, or books on school property?
- 18. During the past 12 months, how many times were you in a physical fight?
- 19. During the past 12 months, how many times were you in a physical fight in which you were injured and had to be treated by a doctor or nurse?
- 20. During the past 12 months, how many times were you in a physical fight on school property?
- 21. The last time you were in a physical fight, with whom did you fight?

- 23. During your whole school life, has anyone (this includes students, teachers, other school employees, and anyone else) ever made sexual comments, jokes, gestures, or looks when you did not want them to?


Rationale:

These questions measure the frequency and severity of physical fights and the persons with whom students fight. Homicide is the second leading cause of death among all youth aged 15-24 and is the leading cause of death among black youth aged 15-24.⁷ Nonfatal violence (i.e., fighting) often precedes fatal violence among young persons.¹⁴




Percentage of respondents who carried a weapon such as a gun, knife, or club on school property on one or more of the past 30 days = 8%




Question 15

Percentage of respondents who did not go to school on one or more of the past 30 days because they felt they would be unsafe at school or on their way to or from school = 3%






Percentage of respondents who have been threatened or injured with a weapon such as a gun, knife, or club on school property one or more times during the past 12 months = 5%





Percentage of respondents who had property such as a car, clothing, or books, stolen or deliberately damaged on school property one or more times during the past 12 months=31%






Percentage of respondents who were in a physical fight one or more times during the past 12 months = 31%


Percentage of respondents who were injured in a physical fight and had to be treated by a doctor or nurse one or more times during the past 12 months = 2%




Percentage of respondents who were in a physical fight on school property one or more times during the past 12 months = 11%








Percentage of respondents who, during their whole school life, had been touched, grabbed, or pinched in a sexual way by anyone when they didn't want them to = 33%

Behaviors that Result in Intentional and Unintentional Injuries

Related National Health Objective for the Year 2000:

Reduce by 15% the incidence of injurious suicide attempts among adolescents aged 14-17.

Questions:

- 24. During the past 12 months, did you ever seriously consider attempting suicide?
- 25. During the past 12 months, did you make a plan about how you would attempt suicide?
- 26. During the past 12 months, how many times did you actually attempt suicide?
- 27. If you attempted suicide during the past 12 months, did any attempt result in an injury, poisoning, or overdose that had to be treated by a doctor or nurse?


Rationale:

These questions measure attempted suicides and the seriousness of those attempts. Suicide is the third leading cause of death among youth aged 15-24 and the second leading cause of death among white males aged 15-24.⁷ The suicide rate for persons aged 15-24 has tripled since 1950.¹²




Percentage of respondents who ever seriously considered attempting suicide during the past 12 months = 27%


Percentage of respondents who made a plan about how they would attempt suicide during the past 12 months = 21%




Percentage of respondents who actually attempted suicide one or more times during the past 12 months = 11%


Rationale:

These questions measure smoking experimentation, current smoking patterns, age of initiation, and attempts to quit smoking cigarettes. Tobacco use is the single most important preventable cause of death in the United States, ^{15,16} accounting for more than one of every five deaths. ¹⁷ Smoking causes heart disease; cancers of the lung, larynx, mouth, esophagus, and bladder; stroke; and chronic obstructive pulmonary disease. If 29% of the 70 million children now living in the United States smoke cigarettes as adults, then at least 5 million of them will die of smoking-related diseases. ¹⁶ In addition, smoking is related to poor academic performance and the use of alcohol and other drugs. ¹⁸ Over one million teenagers begin smoking each year. ¹²




Percentage of respondents who ever tried cigarette smoking, even one or two puffs = 75%



Percentage of respondents who smoked a whole cigarette for the first time prior to age 13 = 26%




Percentage of respondents who smoked cigarettes on one or more of the past 30 days = 44%

Percentage of respondents who smoked 2 or more cigarettes per day on the days they smoked = 32%












Percentage of respondents who smoked cigarettes on school property on one or more of the past 30 days = 19%



This question measures smokeless tobacco use. Oral cancer occurs more frequently among smokeless tobacco users than nonusers and may be 50 times as frequent among long-term snuff users. Smokeless tobacco can lead to the development of oral leukoplakia and gingival recession and can cause addiction to nicotine. Between 1970 and 1986, the prevalence of snuff use increased 15 times and chewing tobacco use increased four times among men aged 17-19.



Related National Health Objectives for the Year 2000:


These questions measure frequency of alcohol use, age of initiation of drinking, and heavy drinking. Alcohol is a major contributing factor in approximately half of all homicides, suicides, and motor vehicle crashes, which are the leading causes of death and disability among young people. Heavy drinking among youth has been linked conclusively to physical fights, destroyed property, academic and job problems, and trouble with law enforcement authorities.




Percentage of respondents who had their first drink of alcohol other than a few sips prior to age 13 = 31%














Percentage of respondents who had at least one drink of alcohol on one or more of the past 30 days = 60%







In addition to morbidity and mortality due to injury, drug abuse is related to early unwanted pregnancy, school failure, delinquency, and transmission of sexually transmitted diseases (STD), including human immunodeficiency virus (HIV) infection. Despite improvements in recent years, illicit drug use is greater among high school students and other young adults in America than in any other industrialized nation in the world. ²¹




Percentage of respondents who tried marijuana for the first time prior to age 13 = 6%





Percentage of respondents who used marijuana one or more times during their life = 35%






Percentage of respondents who used marijuana one or more times during the past 30 days = 20%





Percentage of respondents who used marijuana on school property one or more times during the past 30 days = 5%






Percentage of respondents who tried any form of cocaine including powder, crack, or freebase, for the first time prior to age 13 = 1%





Percentage of respondents who used any form of cocaine, including powder, crack, or freebase, one or more times during their life = 9%






Percentage of respondents who had used any form of cocaine including powder, crack, or freebase; one or more times during the past 30 days = 4%







Percentage of respondents who had taken steroid pills or shots without a doctor's prescription, one or more times during their life = 3%










Percentage of respondents who ever used a needle to inject any illegal drug into their body one or more times during their life = 3%



AIDS is the 7th leading cause of years of potential life lost before age 65 in the United States²⁶ and is the 6th leading cause of death for youth aged 15-24.⁷ Of the 12 million new cases of STD per year, 86% are among people aged 15-29.²⁷ STD may result in infertility, adverse effects on pregnancy outcome and maternal and child health, and facilitation of HIV transmission.²⁸




Percentage of respondents who had been taught about AIDS/HIV infection in school = 93%














Of respondents who had sexual intercourse, the percentage who used or whose partner used a condom during last sexual intercourse = 54%






Percentage of respondents who ever had sexual intercourse = 41%


Percentage of respondents who had sexual intercourse for the first time prior to age 13 = 5%




Percentage of respondents who had sexual intercourse with four or more people during their life = 14%





Percentage of respondents who had sexual intercourse with four or more people during the past 3 months = 2%






Of respondents who had sexual intercourse, the percentage who drank alcohol or used drugs before last sexual intercourse = 35%


Rationale:

More than one million teenage girls in the United States become pregnant each year, just over 400,000 teenagers obtain abortions, and nearly 470,000 give birth.²³ One third of all unintended pregnancies occur among teenagers, and 75% of teenage pregnancies occur among adolescents who are not using contraception.²⁴ The United States leads all other Western developed countries in rates of adolescent pregnancy, abortion, and childbearing.²⁵




Of respondents who had sexual intercourse, the percentage who used or whose partner used birth control pills to prevent pregnancy during last sexual intercourse = 16%

Dietary Behaviors

Related National Health Objectives for the Year 2000:

Reduce overweight to a prevalence of no more than 20% among people aged 20 and older and no more than 15% among adolescents aged 12-19.

Increase to at least 50% the proportion of overweight people aged 12 and older who have adopted sound dietary practices combined with regular physical activity to attain an appropriate body weight.

Rationale:

These questions measure self-perception of and efforts to modify body weight, including behaviors that may lead to eating disorders and other health problems. Obesity and extreme obesity appear to be increasing by as much as 39% and 64%, respectively, among adolescents aged 12-17.²⁹ Obesity acquired during childhood or adolescence may persist into adulthood, increasing later risk for chronic conditions such as diabetes, heart disease, high blood pressure, stroke, some types of cancer, and gall bladder disease.³⁰ In addition, children and adolescents often experience social and psychological stress related to obesity.³¹ Obesity in adolescence has been related to depression, problems in family relations, and poor school performance.³² Overemphasis on thinness during adolescence may contribute to eating disorders, such as anorexia nervosa and bulimia.^{33,34} Adolescent females represent a high-risk population for the development of these two health problems and compose 90% to 95% of all patients with eating disorders.³⁵






Percentage of respondents who think of themselves as about the right weight = 52%







Percentage of respondents who dieted to lose weight or to keep from gaining weight during the past 30 days = 30%

Dietary Behaviors

Because lifetime dietary patterns are established during youth, adolescents should be encouraged to choose nutritious foods and to develop healthy eating habits.






Percentage of respondents who ate fruit one or more times yesterday = 62%




Percentage of respondents who ate green salad one or more times yesterday = 26%


Percentage of respondents who ate cooked vegetables one or more times yesterday = 45%






Percentage of respondents who ate hamburger, hot dogs, or sausage one or more times yesterday = 59%










Percentage of respondents who ate cookies, doughnuts, pie, or cake one or more times yesterday = 61%

Physical Activity

Related National Health Objectives for the Year 2000:

Increase to at least 30% the proportion of people aged 6 and older who engage regularly, preferably daily, in light to moderate physical activity for at least 30 minutes per day.

Increase to at least 20% the proportion of people aged 18 and older and to at least 75% the proportion of children and adolescents aged 6-17 who engage in vigorous physical activity that promotes the development and maintenance of cardiorespiratory fitness 3 or more days per week for 20 or more minutes per occasion.

Increase to at least 40% the proportion of people aged 6 and older who regularly perform physical activities that enhance and maintain muscular strength, muscular endurance, and flexibility.

Increase to at least 50% the proportion of children and adolescents in 1st through 12th grade who participate in daily school physical education.

Increase to at least 50% the proportion of school physical education class time that students spend being physically active, preferably engaged in lifetime physical activities.

Regular physical activity increases life expectancy³⁷ and is associated with good mental health and self-esteem.³⁸ Additionally, regular physical activity can assist in the prevention and management of coronary heart disease, hypertension, diabetes, osteoporosis, obesity, and mental health problems.³⁹ School physical education programs can have a significant positive effect on the health-related fitness of children.^{40,41}














Percentage of respondents who went to physical education class one or more days in an average school week = 32%

Percentage of respondents who spend more than 20 minutes actually exercising or playing sports during an average physical education class = 28%








Percentage of respondents who played on one or more sports teams run by their school, not including PE classes, during the past 12 months = 52%







