ABSTRACT

This directory of higher education in Illinois includes information on the Illinois Board of Higher Education, state public colleges and universities, independent institutions, and other state agencies and educational organizations. The section on the Illinois Board of Higher Education lists board members and staff, and includes an organization chart. The section on public institutions lists board members and key executives for the state's nine state universities, the Illinois Community College Board, and each of the state's community colleges. The section on independent institutions provides the names, addresses, and presidents of not-for-profit colleges and universities and for-profit institutions. The section on other state agencies and educational organizations provides contact information and lists key personnel of eight other state agencies and educational organizations, including the State Board of Education, the Illinois Student Assistance Commission, and the State Universities Civil Service System. The directory concludes with maps keyed to indicate the geographic location of both public and independent institutions in the state. (DB)

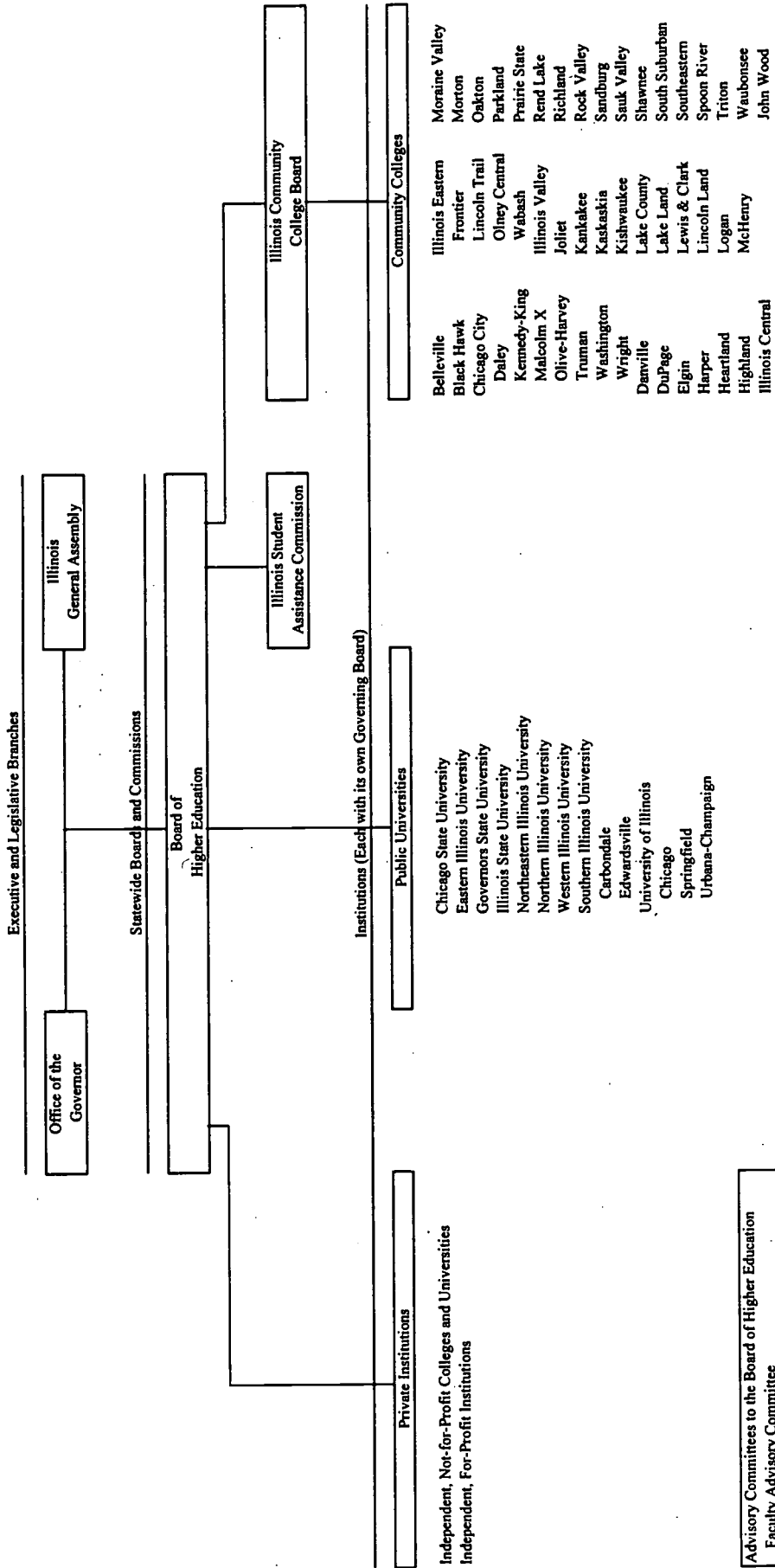

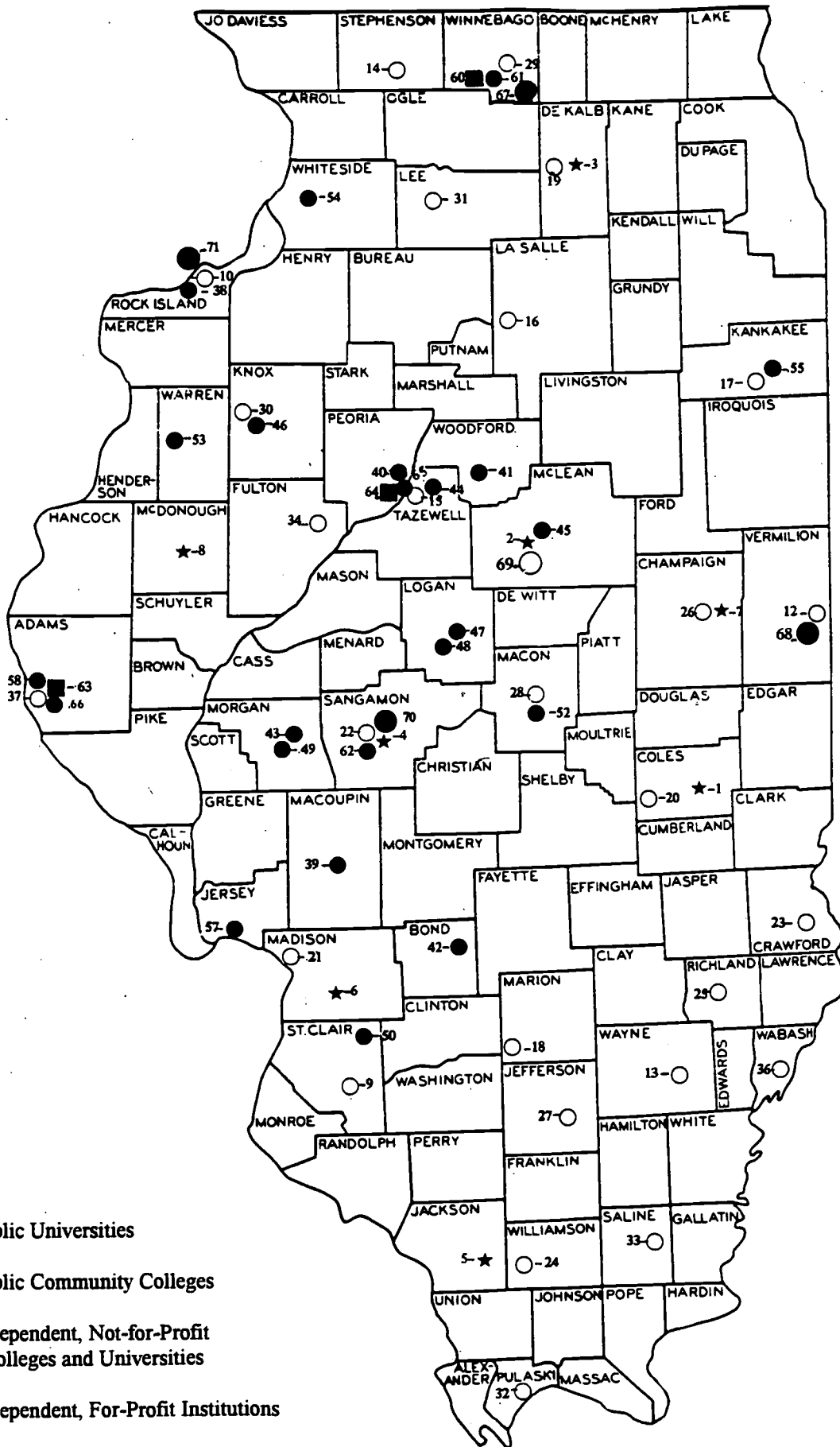
