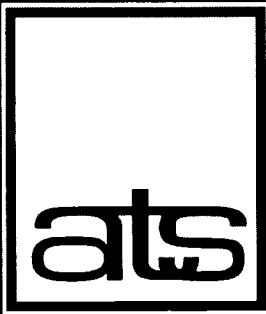

Preface

Catalog VI is designed as a supplement to the resources available to students preparing for graduate and post-graduate programs in the seminaries of North America.

The current edition is an update of *Catalog "V"* which was prepared in 1998. The Association of Theological Schools joined in that effort. Prior editions reflect the commitment of the Office of Financial Aid for Studies of the Presbyterian Church (U.S.A.) to support their students and others with a catalog of loans, grants, and scholarships. *Catalog VI* marks a new direction in the preparation of these resources. For the first time, they are available on a CD.

Post-freshman students are eligible for financial support based on academic merit or financial need. Merit scholarships are awarded to undergraduate and graduate students in the amount of \$1,000; Financial Assistance scholarships are awarded to undergraduate and graduate students in amounts ranging from \$500 to \$1,500. Applicants must be post-freshman undergraduates currently enrolled in an accredited degree granting program, or graduate students who plan to continue their academic pursuits in the fall of the grant year. All applicants must demonstrate exceptional academic achievement/or financial need.

The Rome Prize: Predoctoral Fellowships

Deadline: November 15

Applicants for the Rome Prize Predoctoral Fellowships at the School of Classical Studies must be U.S. citizens who have completed all course work for the Ph.D. at the time of application. Some of the fellowships also require completion of at least one year's work on the dissertation before application. The fields of award are: (a) School of Fine Arts—Architecture, Design Arts, Historic Preservation and Conservation, Landscape Architecture, Literature, Musical Composition, and Visual Arts; (b) School of Classical Studies—Classical Studies and Archaeology, History of Art, Modern Italian Studies, and Post-Classical Humanistic Studies. Each Rome Prize recipient is provided with a stipend of up to \$12,000, room and board, and a study at the Academy's facility in Rome in which to pursue independent work. Terms of appointment range from six months to two years.

These grants are intended to stimulate cooperative research among scholars in several institutions, with a focus on a clearly identified research project. Grants can provide funds for networking and communication. They may also be used for interdisciplinary work with scholars outside the field of religion, especially when such work shows promise of continuing beyond the year funded. In addition, grants may be used to support small research conferences. Conference proposals will be considered only if they are designed primarily to advance research. Scholars in small institutions, departments, or programs without research support, and scholars who are institutionally unaffiliated are especially encouraged to apply. A group must apply through an AAR member designated as the project director; not all participants need to hold AAR membership. Awards range from \$500 to \$5,000.
