ABSTRACT

This document presents the Strategic Plan and Academic Development Plan for Kapi'olani Community College (KCC) (Hawaii). The goals maintain or add to current practices and directions. The Academic Development Plan should be used as a point of reference, as a planning document, as leverage for initiatives. KCC has as its mission to broaden access to postsecondary education in Hawaii by providing open-door opportunities for students to enter quality educational programs. In addition to its liberal arts transfer mission, KCC offers the state's only programs in Health Sciences and Legal Education and the only community college Nursing programs on O'ahu. The College's long-range planning process is part of a comprehensive approach which seeks to integrate academic program planning and budgeting through a participatory process involving faculty, staff, and students. Among the planned or anticipated changes are improvements in educational technology and networked communications and new models of delivery, which provide more flexibility in course offering and in responding to the changing needs of businesses and students. This report also shows some indicators of program demand, efficiency, and outcomes, which have been used as the basis for strategic decision-making. (JA)

We are honored to present you with the Kapi'olani Community College Strategic Plan 1997-2007, a single document whose genesis is the culmination of a collaboration that spanned two years, involved almost 800 people and underwent eleven revisions. The foundation for the Strategic Plan was laid in 1995-1996 by the over 700 faculty, staff and students who participated in the Retreat to the Future activities. Using their original dreams and wishes, the Strategic Planning Council, consisting of 32 faculty, 7 staff, 4 students and 16 members of the community, worked together over a period of four months to develop the specific goals and performance objectives that form the Plan. Attached is a list of the participants.

The Strategic Planning Council met three times (January, February and March 1997). Four different subgroups met separately during those months to formulate the goals and objectives in four areas: Provide access, quality, service; Champion diversity; Acquire and manage resources; and Function as a system. Two draft versions of the report, the first and the sixth, were circulated to members of the Strategic Planning Council for their input and suggestions. College administrators received, in addition, the seventh and eighth drafts.

The process allowed for broad-based participation and ownership by all segments of the College and the community. We are especially grateful for the participation of two groups often missing from college planning: students and community members. The success of this two-year collaboration speaks to the tangible benefits of an inclusive process and of shared governance in planning.

We are confident that the Strategic Plan charts meaningful directions for KCC's future-directions that will result in quality educational experiences for faculty, staff, and students.

The College has also developed a successful Food Service and Hospitality Education program and an innovative Business Education program.

KCC focuses on the following cross-curricular initiatives, which serve to integrate course content, infuse skills and provide cohesive learning contexts:

This document presents KCC's Strategic Plan for 1997-2007. It is designed to build upon the College's existing strengths, initiatives and commitment to excellence. The goals in this document maintain, enhance or add to current practices and directions.

Goal A

Provide Access, Quality, and Service

1. Increase Access.

- 1.1. Incorporate the appropriate uses of information technology into instructional programs and services to students, including making the resources of the college available 24 hours a day to the students and the community.
- 1.2. Use the technological capabilities to deliver and promote appropriate distance learning.
 - 1.2.1. Develop and market on-line courses in academic areas uniquely available from the College or in one of its areas of expertise.
 - 1.2.2. Partner with publishers to gain access to course materials.
 - 1.2.3. Provide library support for distance learning.

1.1.3. Invite Hawaiian, Pacific Island and Asian experts and artists to the campus.

1.1.4. Formalize exchange protocols with institutions of higher education in Polynesia, Micronesia, Melanesia, Australia and Asia.

7. *Hire a development expert to network, recruit and maintain donors and seek contracts.*

8. *Develop international and multicultural educational packages.*
9. *Develop and provide resources for a comprehensive marketing plan for KCC.*
10. *Initiate year-round schedules for selected programs and activities.*
11. *Establish an alumni association.*
12. *Establish new student fees to support electronic enrollment services.*
13. *Broker international programs.*

1. *Play An Active Role In Streamlining Academic Procedures.*

- 1.1. Streamline student transfer procedures.
- 1.2. Establish technology-based models for registration and enrollment.
- 1.3. Develop close collaboration between the UH Manoa Academic Procedures Committee and the CC Registrars Ad-Hoc Committee.
- 1.4. Develop KCC-specific placement test norms on systemwide tests.
- 1.5. Participate in the development of systemwide databases.

2. *Participate In Systemwide Instructional Initiatives.*

- 2.2. Collaborate on systemwide articulation efforts.
