ABSTRACT

The 2000-2001 Fact Book provides information about the general background, finance, students, faculty, and programs of Austin Community College (ACC) (Texas). Highlights for fall 2000 (unless otherwise noted) include: (1) data for course enrollment show that 6,915 students were enrolled in arts and humanities, 10,400 in communications, 17,630 in math and science, and 18,717 in social and behavioral sciences; (2) total estimated expenditures for fiscal year 2001 is \$93,860,794; (3) in spring 2000, ACC's service area was 64% White, 24.2% Hispanic, 8% black, and 3% "other"; (4) there were 25,856 students enrolled in credit programs; (5) the largest student age group was 19-21 (31%), followed by 25-30 (17%); the smallest age group was age 65 and over (0.2%); (6) in fall 2000, approximately 54% of ACC's students were female; 64% of ACC's students were white, 21% Hispanic, 7% black, and 6% Asian; (7) 25% of ACC's students were full time; (8) ACC's staff, in fall 2000, was 58% female and 66% white; and (9) in 1999-2000, 24,920 students participated in one or more of ACC's 3,618 continuing education programs. Type

Public two-year community college

Sponsorship and Control

Austin Community College (ACC) is governed by a nine-member Board of Trustees. The Board is elected by the ACC District, which includes Austin Independent School District (AISD), Leander Independent School District (LISD), and Manor Independent School District (MISD). Members serve staggered six-year terms.

Enrollment

25,856 college-credit students consisting of 11,812 (45.7%) males and 14,044 (54.3%) females; 6,453 (25.0%) full-time and 19,403 (75.0%) part-time students; and 18,358 (71.0%) students from the ACC taxing district

Teaching Faculty

393 (28.3%) full-time and 996 (71.7%) adjunct

Library

115,567 volumes, 1,974 subscriptions

Finances

Fiscal Year 2000-01 Operating Budget: \$93,860,794

Revenues: 60.9% local, 39.2% state

Expenditures: 59.2% instructional and academic support, 17.1% institutional support, 10.2% plant operations, 7.6% students services, 3.7% debt service, 1.6% scholarships, and 0.6% public service

Campuses

Six campuses including Rio Grande (1975), Riverside (1984), Northridge (1989), Pinnacle (1990), Cypress Creek (1991), and Eastview (1999), as well as Highland Business Center (1988) and Downtown Center (2000). Classes are also offered at over 40 locations within the ACC service area.

Mission of the College

Austin Community College is an educational institution committed to challenging the human mind to explore new ideas and seek new opportunities. The College mission is to provide a wide range of high quality educational services that meet the needs of our willing partners in learning, both those who seek our services and those whom we must seek out.

Austin Community College operates on the belief that open access to quality postsecondary educational experiences are vital in a rapidly changing democratic society. Therefore, the College exists to provide such educational opportunities to all the people of the Austin Community College service area. Hence, Austin Community College maintains an "open door" admissions policy, offers a comprehensive variety of postsecondary educational programs, and actively seeks to eliminate barriers in the educational process.

A. Types of Programs

Austin Community College offers the following types of programs, services, and instruction to fulfill its mission and to satisfy state law for public junior and community colleges:

- [a] Vocational and technical programs of varying lengths leading to certificates or degrees.
- [b] Freshman- and sophomore-level academic courses leading to an associate degree or serving as the base of a baccalaureate degree program at a four-year institution.
- [c] Continuing adult education for academic, occupational, professional, and cultural enhancement.
- [d] Special instructional programs and tutorial service to assist underprepared students and others who wish special assistance to achieve their educational goals.
- [e] A continuing program of counseling and advising designed to assist students in achieving their individual educational and occupational goals.
- [f] A program of technology, library, media, and testing services to support instruction.
- [g] Contracted instructional programs and services for area employers that promote economic development.

B. Intended Results

- [1] The basic result to be produced by the College, in conjunction with other community sectors, is that all service-area adults legally qualified for College services have the postsecondary and higher education they need and can use for productive, successful lives. How close the local community is to this goal is a central accountability indicator for the College. However, declaration of this goal is not a guarantee of particular services, program admissions, or resource allocations; these are decided through the program-review, admissions, and budget processes.
- [2] Accredited preparation shall be provided for as many career areas and university-transfer options within the mission of the College as is feasible. Emphasis shall be placed on providing postsecondary education (including needed preparation) to people who are educationally disadvantaged or are not well-served by other colleges, and on preparation for family-wage careers (either directly or after further higher education).
- [3] In addition to mastery of the specific subject-area knowledge and skills needed to meet their education-related goals, students completing College programs shall have the general skills needed for success in employment and higher education: these include dependability, effective communication,

gathering and critically assessing information, problem-solving, teamwork, leadership, and a focus on producing results of high quality.

- [4] The College shall organize its activities so as to produce as high a level of overall value for the community as possible, and shall avoid procedures that waste the money or time of students or staff.
- [5] The College shall create a good place to work, to learn, and to otherwise experience the higher-education process.

The Austin Community College Board of Trustees adopted this policy on February 13, 1973, and amended it on March 4, 1974, September 2, 1975, January 18, 1982, September 24, 1984, February 3, 1997, and May 1, 2000.

Statement of Values and Ideals

The ACC district will fulfill its mission to the extent of its fiscal and legal capacity in support of the following ideals:

Quality: Emphasis on teaching; High educational standards; A faculty and staff dedicated to the success of all students; An environment conducive to personal excellence and growth for all students; Assurance of broad acceptance of transfer courses by four-year institutions; Relevance to employment needs of vocational/ technical courses; A plan for educational excellence that includes identification of at-risk students

Flexibility: Adapting to our community during times of rapid social and technological change; Developing an open curriculum that accommodates rapid change; Designing instructional methodologies and providing technological equipment relevant to a changing society; Ensuring continued professional competence of faculty and staff at all levels

Accessibility: An open door for all those who wish to attend; Assessment of entering student academic abilities; A determination to actively seek out those who may benefit from a community college education; The belief that every individual should have the opportunity to pursue a higher education; A tuition/fee structure that promotes accessibility; Creative ways to provide services to the community

Diversity: Understanding our world as one large, complex community; Fostering a genuine appreciation of a multi-cultural community; Promoting a genuine belief in the dignity, equality and value of every person

The Austin Community College Board of Trustees adopted this policy on March 4, 1974 and amended it on November 13, 1989 and May 1, 2000.

Historical Profile

Austin Community College (ACC) was established in December 1972 by voters of the Austin Independent School District. In the fall of 1973, ACC registered 2,363 students. Classes began on September 17, 1973. The AISD Board of Trustees served as ACC's Board of Trustees, and the College shared the district's boundaries.

In December 1978, ACC was accredited by the Commission on Colleges of the Southern Association of Colleges and Schools (SACS) to award associate degrees. ACC's enrollment had increased to 13,481 students.

On March 1, 1982, the Board, following the guidelines of the Texas Education Code, established its own governing Board of Trustees, consisting of nine elected members. Accreditation was reaffirmed by SACS in 1983 and 1993.

With its purchase of the Austin Country Club in January 1983, ACC acquired its first real estate. Situated at 5712 East Riverside Drive, the property is now ACC's Riverside Campus. ACC's Board of Trustees held its first election in the spring of that year.

On November 5, 1985, 83 percent of the citizens of the Leander Independent School District voted to become part of the ACC district.

Following the passage of the 1985 General Appropriations Act, which stated that "it is the intent of the Legislature that all public junior colleges receiving state appropriations shall initiate procedures necessary to secure ad valorem revenues sufficient to supplement the funding of the district by August 31, 1987," ACC held a successful tax base election. The measure approved a maximum of 5 cents per \$100 assessed property valuation.

On November 3, 1998, 70 percent of Manor Independent School District citizens voted to join the ACC district.

The College maintains six campuses in addition to the Highland Business Center, which houses the administrative offices and a business training center. The campuses are Rio Grande (1975), Riverside (1984), Northridge (1989), Pinnacle (1990), Cypress Creek (1991), and Eastview (1999). The newest addition is the Downtown Center which opened April 2000.

Lillian Davis, Chair

Place 1: Term ends in 2002

Lillian Davis was elected to the Board of Trustees in 1996, and currently serves as the Chair of the Board. She has also served as Secretary of the Board. Davis has been an employee of IBM for 26 years with management assignments in human resources, technical education, quality, and administration. She has a BS in Education, an MA in Speech, and a PhD in Communication from the University of Texas at Austin. Her dissertation was on interpersonal bargaining. She volunteers in many community organizations, primarily related to education.

Beverly Silas, Vice-Chair

Place 6: Term ends in 2004

Beverly Silas was elected to the Board of Trustees in 1998, and currently serves as the Vice-Chair of the Board. Silas was employed with Southwestern Bell for over thirty-one years, and is experienced as a Board member and volunteer in many organizations, which led to a Governor's Award as an Outstanding Texas Volunteer in 1993. Her current and recent activities are as varied as: Leadership Texas; Leadership Austin; Vice-Chair of the Downtown Austin Alliance Board of Directors; Capital Area Workforce Development Board; Camp Fire Boys and Girls; Southwest Texas Conference of the United Methodist Church Emmaus Board of Directors; and the Professional Women of Southwestern Bell. Ms. Silas is also past National President of The NETWORK, an organization to bring together African-American employees of SBC Communications, Inc. Ms. Silas serves on the Management Advisory Committee at ACC. Beverly is a graduate of Huston-Tillotson College with a Bachelor's degree in Public Management.

John Worley, Secretary

Place 8: Term ends in 2006

John Worley was elected to the Board of Trustees in 1994, and currently serves as the Secretary of the Board. Worley, who earned his law degree from the University of Texas at Austin, also holds a PhD in Philosophy. He has taught at UT-Austin, Texas Technological University, San Antonio College, and ACC. He has extensive experience in trial court and appellate litigation in state and federal court and currently is an assistant Attorney General for the State of Texas. Worley also serves on the board of the Austin Area Urban League.

Beverly Watts Davis

Place 4: Term ends in 2004

Beverly Watts Davis was elected to the Board of Trustees in 1992 and has served as Vice-Chair and Chair. Davis brings to the Board strong experience in program development, community mobilization, and the generation of grant and external resources. She currently directs the United Way Fighting Back project, which promotes healthy lifestyles for urban youth. She serves on seven National and State Boards and served on six local Community Boards. In 1997, she was selected by the Attorney General of the United States as the Volunteer of the Year, and has been selected by the Governor of Texas as a "Yellow Rose of Texas" for her civic and volunteer contributions. She has also received numerous other local, state, and national awards for her community service.

A principal in Austin Analysis, a public policy newsletter and research company, Kaplan has served on numerous community and professional boards including the Capital Metro and the Downtown Austin Alliance Board of Directors. He received his BA in Political Science from the Brooklyn College, City University of New York.

Barbara Mink

Place 7: Term ends in 2006

Dr. Barbara Mink was elected to the Board of Trustees in 2000. She is currently Dean of the Human and Organization Development (HOD) Graduate Program at the Fielding Institute in Santa Barbara, CA. Since 1978, she has also been a faculty member in the HOD Graduate Program in the areas of organizational theories, management and leadership systems, and learning and motivation.

Prior to becoming Dean of the HOD Program, Barbara was also a Senior Consultant with SCG, Inc., a woman-owned international consulting firm based in Austin, Texas. As such, Dr. Mink did over twenty-five years of consulting in the area of design and implementation of organizational change. She has worked with clients in the fields of manufacturing, health care, education, government, communications technology, and banking.

Dr. Mink's honors include being elected to Pi Mu Epsilon (mathematics honorary) and the Board of Directors of the Human Resource Planning Society. She has been listed in Outstanding Educators of America: Who's Who in American Women, and Who's Who in the South and Southwest. She has for several years won poetry and creative writing awards in Texas writing competitions.

Della May Moore

Place 2: Term ends in 2002

Della May Moore was elected to the Board of Trustees in 1982 and has served as Chair and Vice-Chair of the Board. Moore brings strong experience in education and administrative issues to the Board. Ms. Moore is Director of Bilingual/English As A Second Language Education for the Austin Independent School District where she has also held positions as Director of Communication, Principal, and Instructional Coordinator. Additionally, she has an extensive background in professional and community leadership with organizations such as the Hispanic Chamber of Commerce, Texas Elementary Principals, and Supervisors Association and the Austin Project. Ms. Moore is often invited to present at national and state conferences and has received numerous awards. Since 1996, Ms. Moore served as Texas State Chair for the American Association of Community College Trustees and was elected to the National Board of Directors for ACCT in 1998.

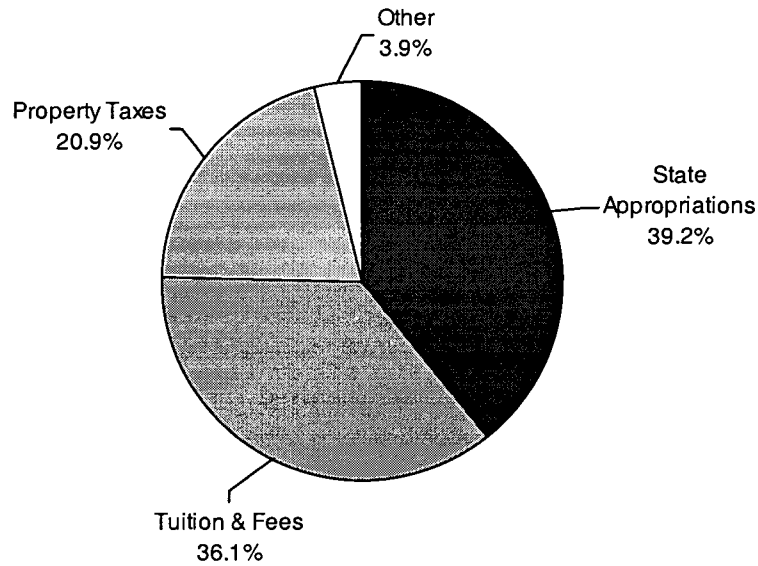

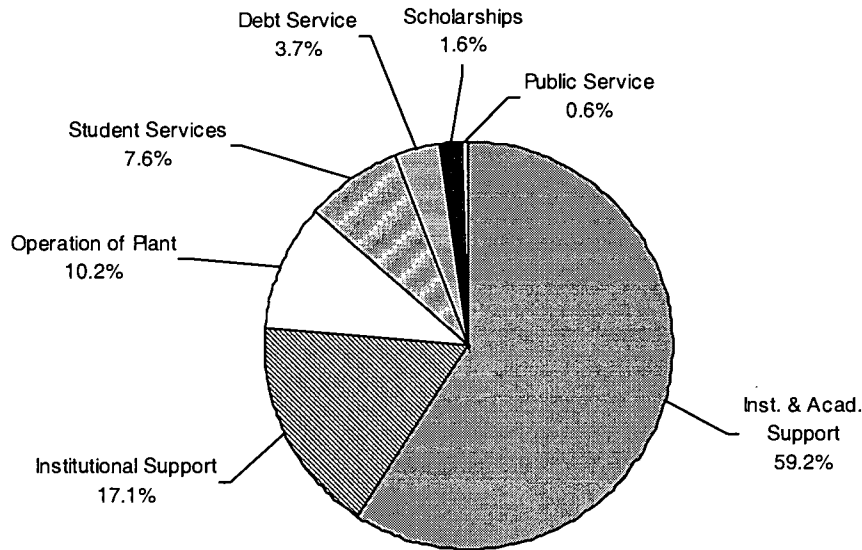

Review of Austin Community College Revenue and Expenditures

Austin Community College receives its funds from three primary sources of revenue: state funding, property taxes, and student tuition and fees. Federal grants account for a small percentage of revenue, and those funds can only be used for specific purposes as defined in the grant guidelines.

Tuition and fees are set by the Board of Trustees. Unlike state reimbursement, tuition and fee income may be spent for any College purpose, including retirement of revenue bonds, which could be used for limited construction purposes.

The College budgets according to these categories:

- **General Administration and Student Services** - government of the institution; executive direction and control; business and fiscal management; admissions and registration; other student services, including counseling, placement services, and student financial aid.
- **General Institutional Expense** - expenses of a general nature that benefit the entire institution and are not related solely to any specific program or division (cost of catalogs, bulletins, convocations, lectures, etc.).
- **Staff Benefits** - costs toward benefit programs for employees such as insurance programs, workers compensation, and unemployment compensation.
- **Resident Instruction** - there are two classifications: General Academic Courses and Vocational-Technical Courses. Costs include departmental operating expenses, instructional administration, salaries, wages, supplies, travel, equipment, and operating expenses.
- **Learning Resource Services** - costs for salaries, wages, other operating costs, books, periodicals, binding costs and equipment of separately organized libraries.
- **Extension and Public Service** - all costs of activities designed to serve the general public to include community service programs, instructional salaries and wages, supplies, equipment and departmental operating expenses.
- **Physical Plant Maintenance and Operations** - includes salaries and wages, custodial and maintenance personnel, cost of utilities, cost of supplies and equipment for custodial and maintenance personnel, minor repairs and renovations, parking areas and security, and the cost of operating expenses to carry out the duties of physical plant administration. Planning and general services must be funded from local funds.
- **Special Items** - cost of items not included in any other elements such as reserve accounts, contact hour adjustments, tuition shortfall, reserve for contingency, and retirement of Bond Debt.
- **Major Repairs and Rehabilitation of Buildings** - includes expenses to provide major repairs, rehabilitation, and renovations of existing buildings and facilities, salaries, wages, and the cost of materials for such items.

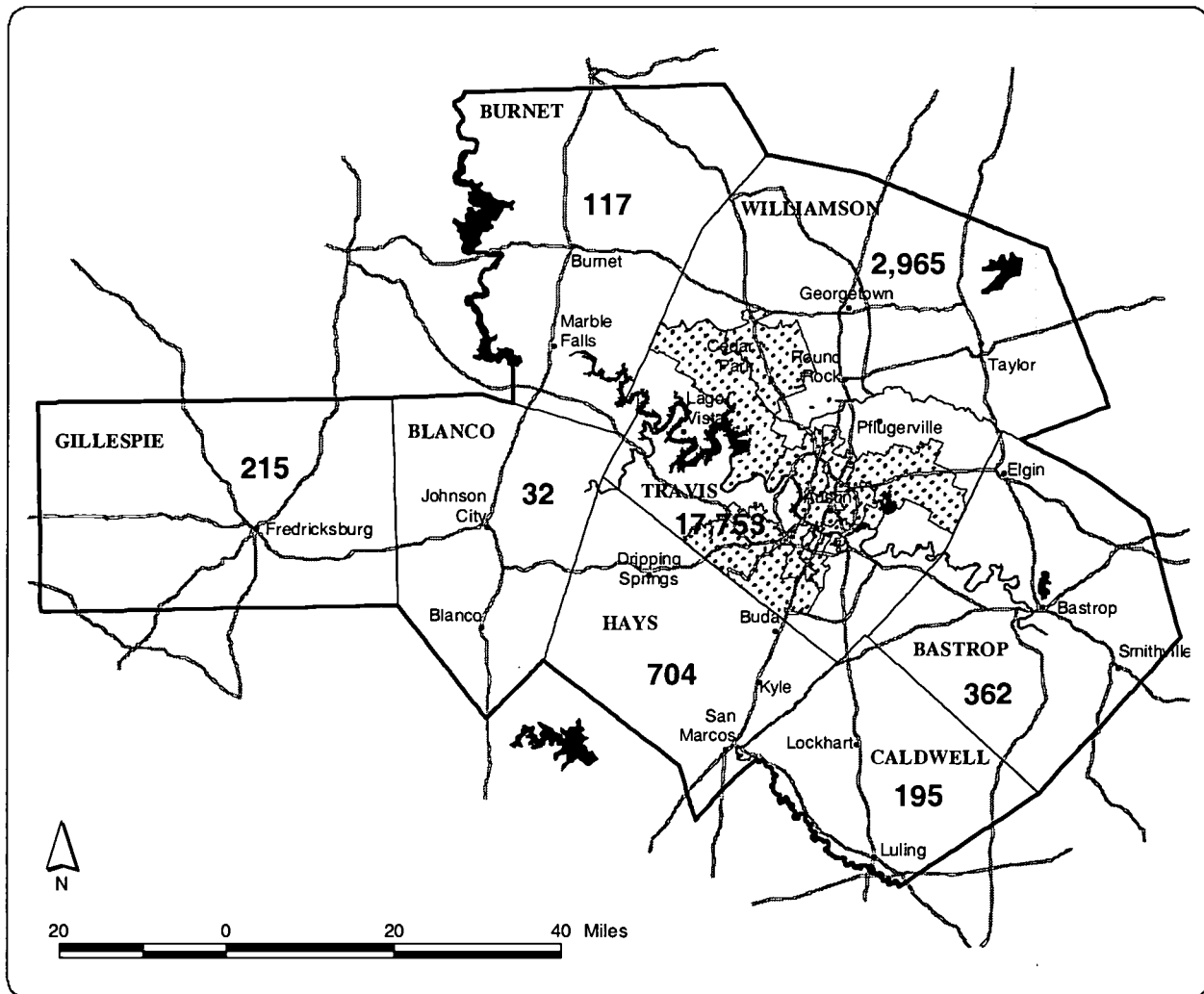

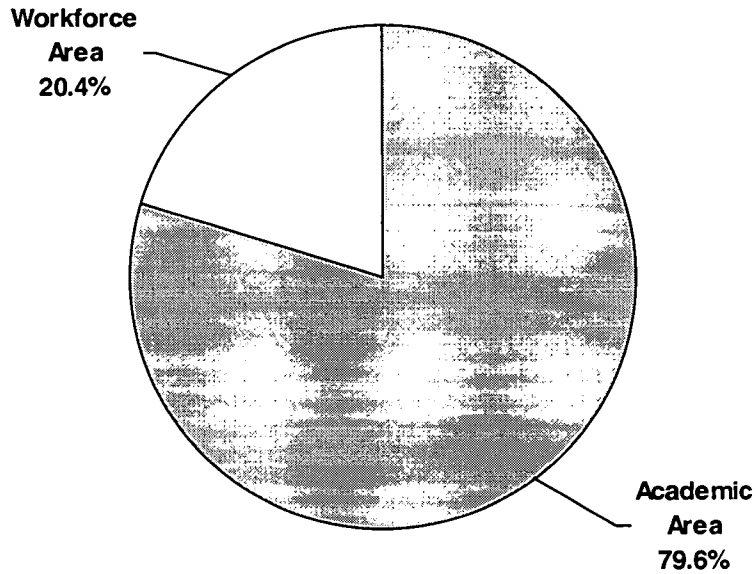

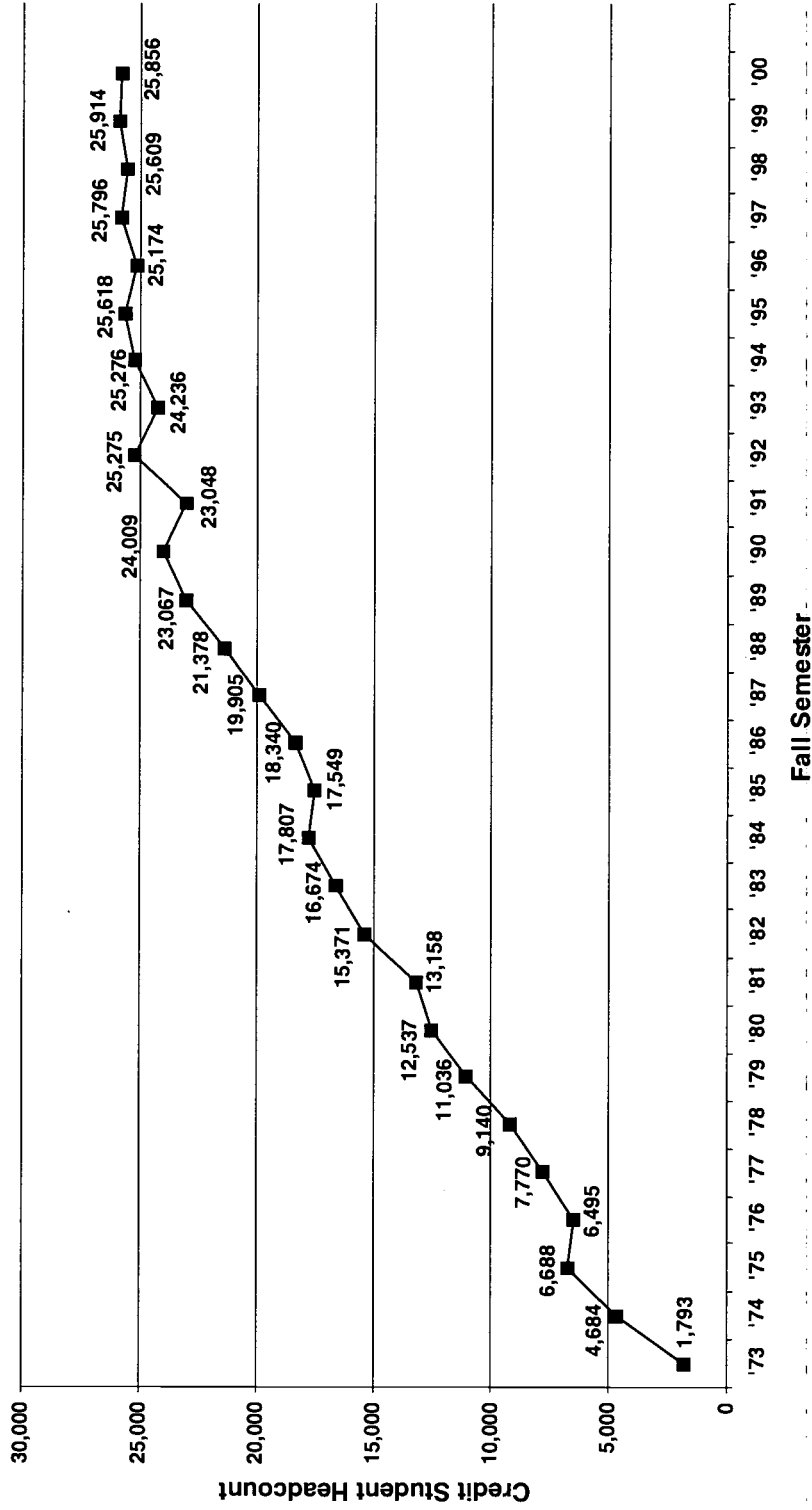

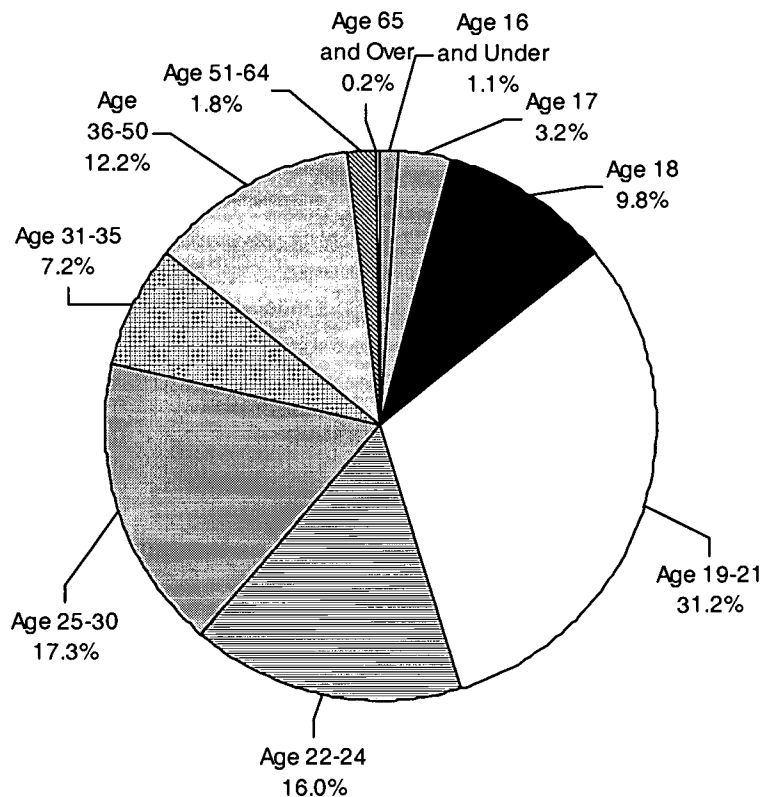
**Credit Student Headcount

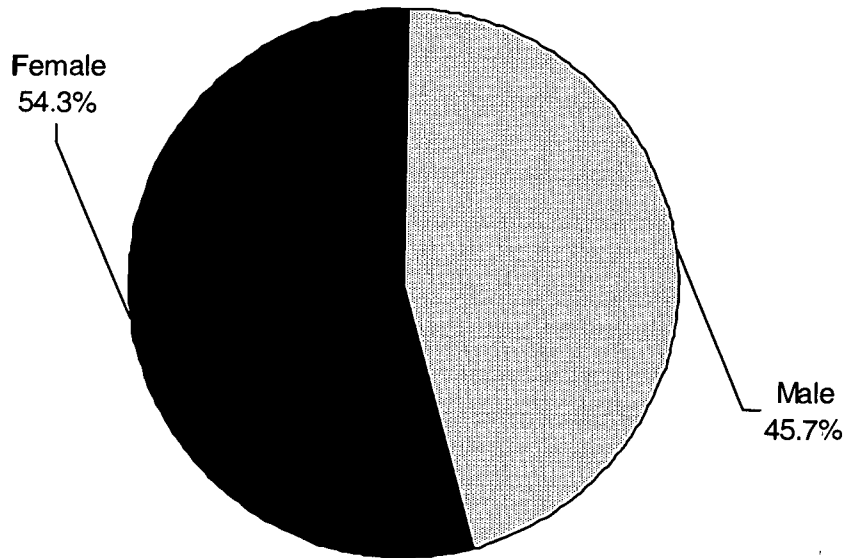

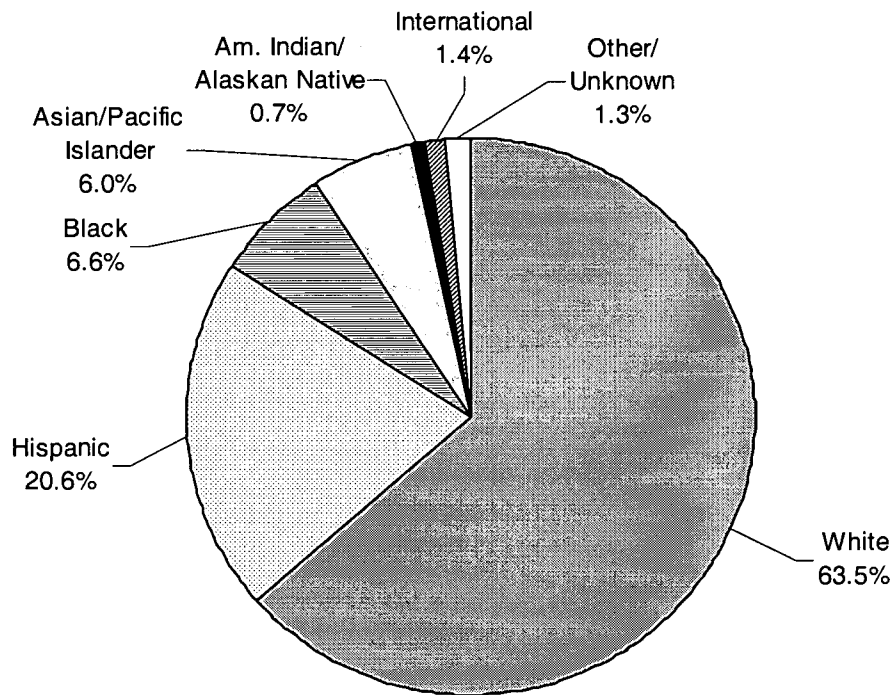

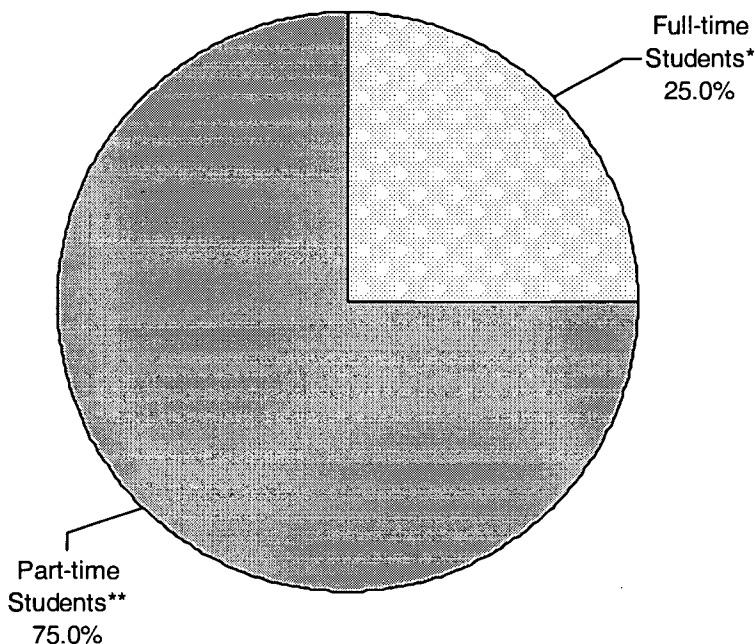

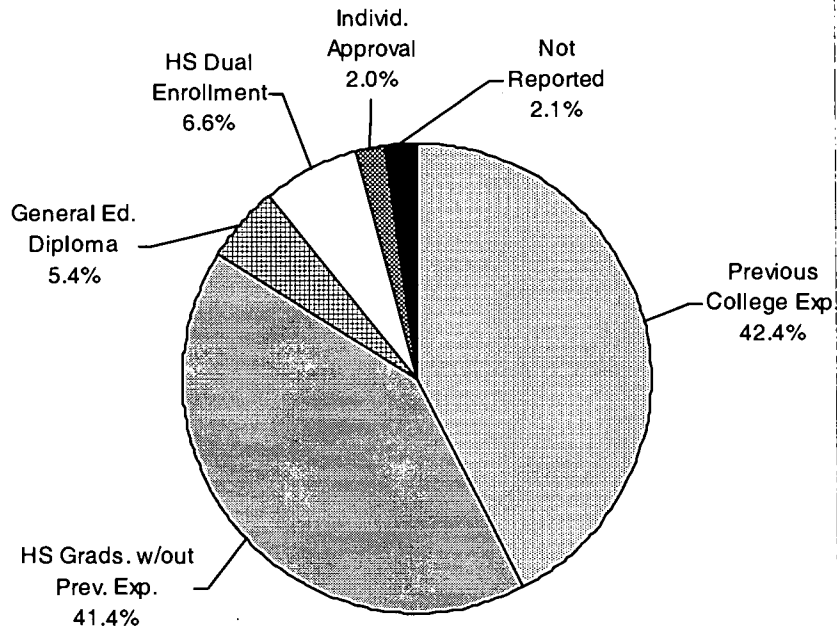

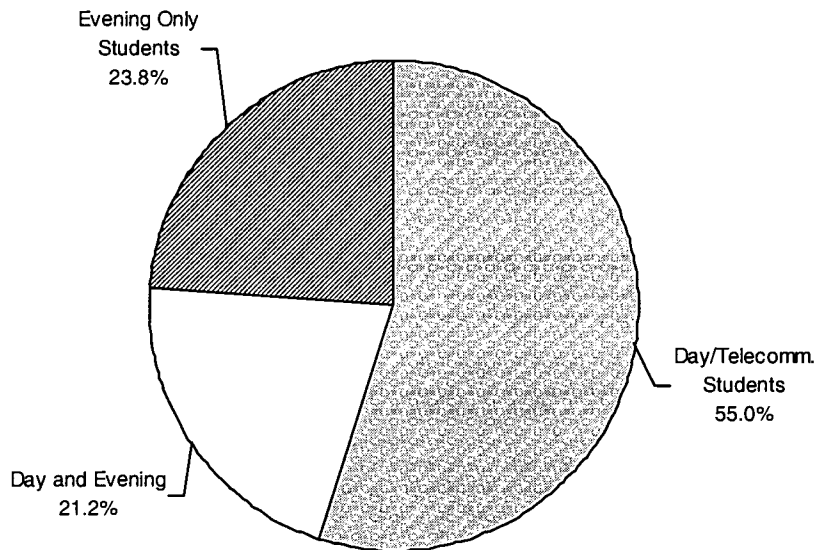

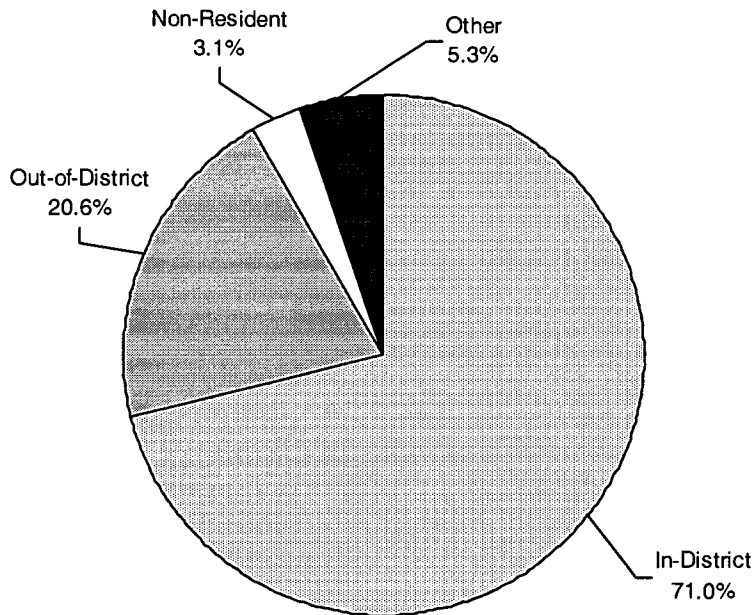

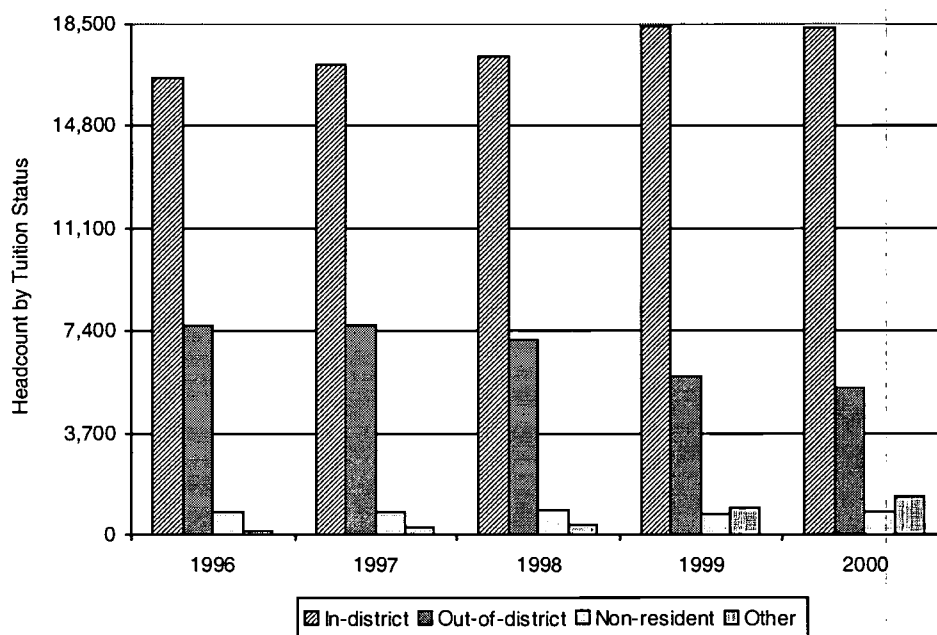

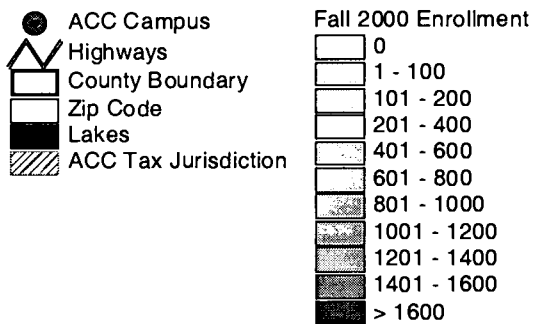

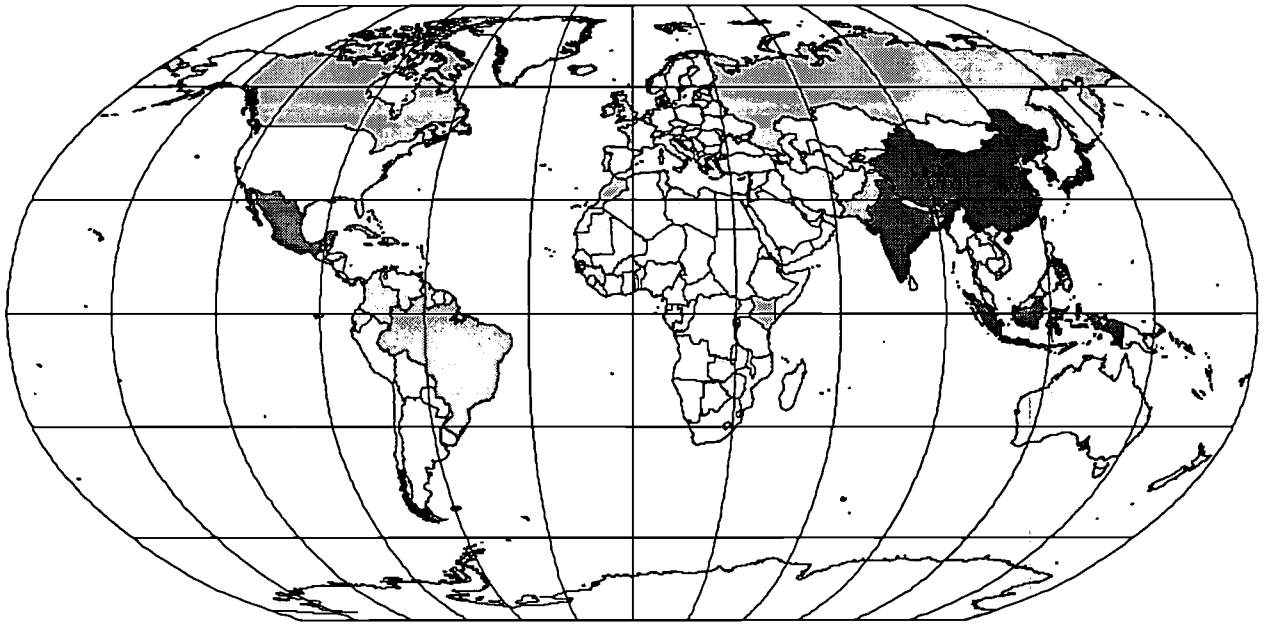

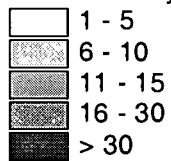

International Students by Country



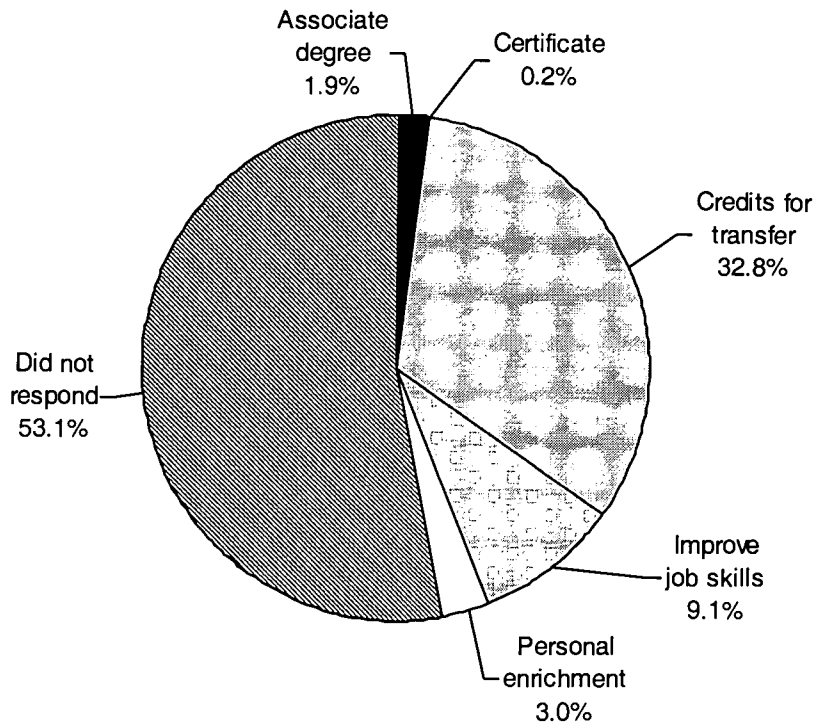

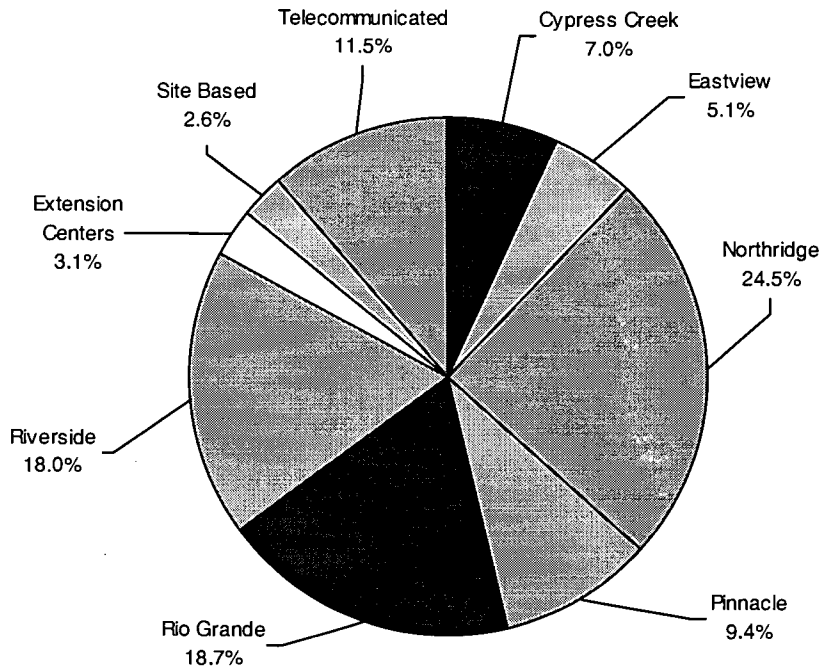

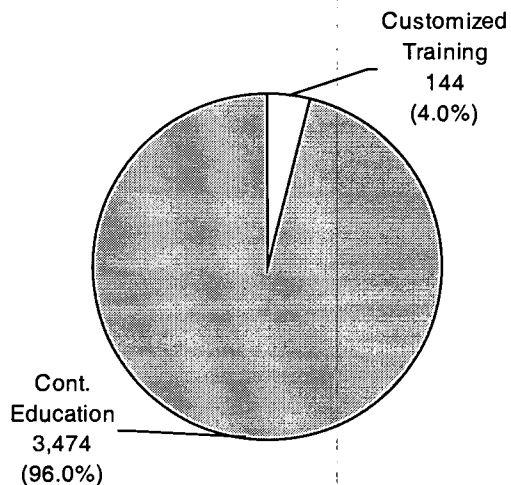
- Customized Training provides customized contract training and education, and job profiling and assessment services to individual organizations to improve job performance and productivity of their employees.

Adult Education

Austin Community College has served as the prime sponsor of the Adult Education Program of Travis County Co-op since September 1973. The program is funded annually and evaluated by the Texas Education Agency (TEA). The federal portion of the funding is provided by the U.S. Department of Education through TEA. The state portion of the funding is provided by the State of Texas. Local funding is also provided by Austin Community College. A coordinating committee, comprised of public school superintendents and their representatives, human services agency representatives, members of the business community, and student representatives, serves as an advisory committee in accordance with TEA guidelines.

Programs

The Adult Education Program includes the following components.

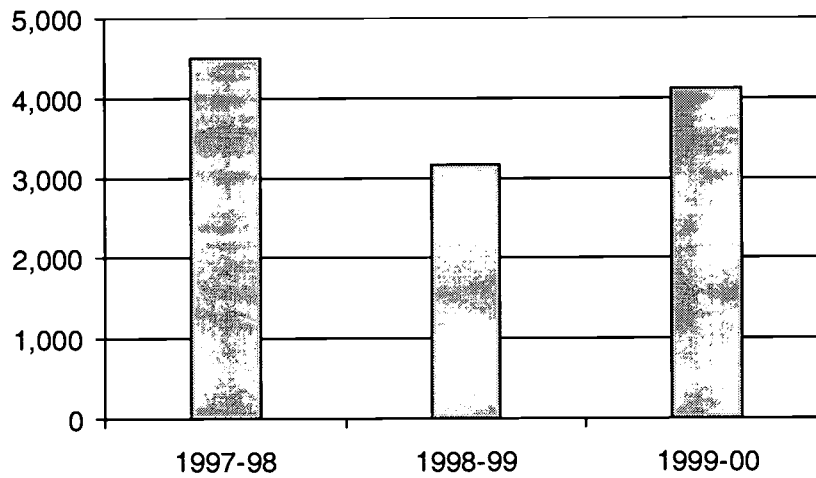
1. *Adult Basic Education (ABE)* programs are for adults whose reading, writing, and arithmetic skills are below the ninth-grade level. These classes, which consist of both self-paced and group instruction, are also part of the entry component of adult secondary or GED preparation.
2. *General Education Development (GED)* classes are for adults whose high school education was interrupted. These classes cover five areas: writing, social studies, science, reading, and math. GED classes are designed to assist students to prepare for the GED Test and offer life and job readiness skills.
3. *English-as-a-Second Language (ESL)* classes are for adults whose native language is not English.

The following programs are specially funded through adult education and are designed for special populations.

1. The *Adult Education for Correctional Institutions* program provides adult basic education and GED preparation classes for inmates of city and county correctional facilities.
2. The *Adult Education Even Start Family Literacy* program provides the nation's low income families with a unified family literacy program that integrates early childhood education, adult literacy or basic education, and parenting education.

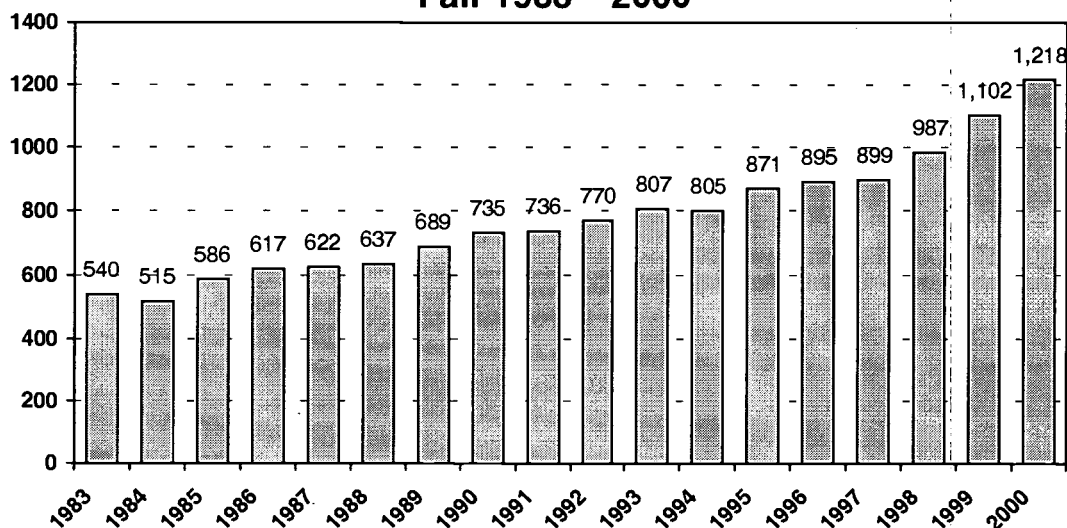

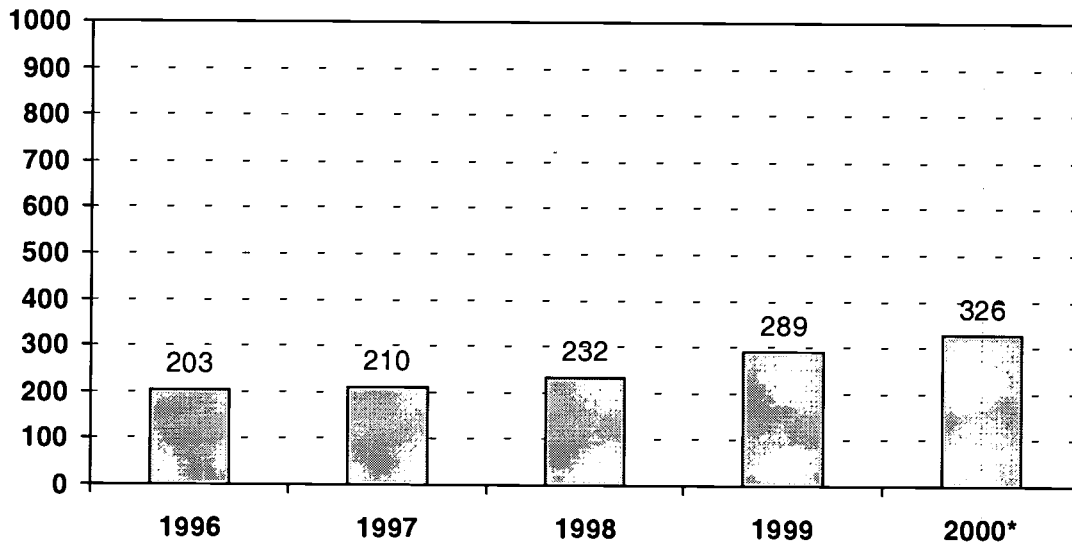

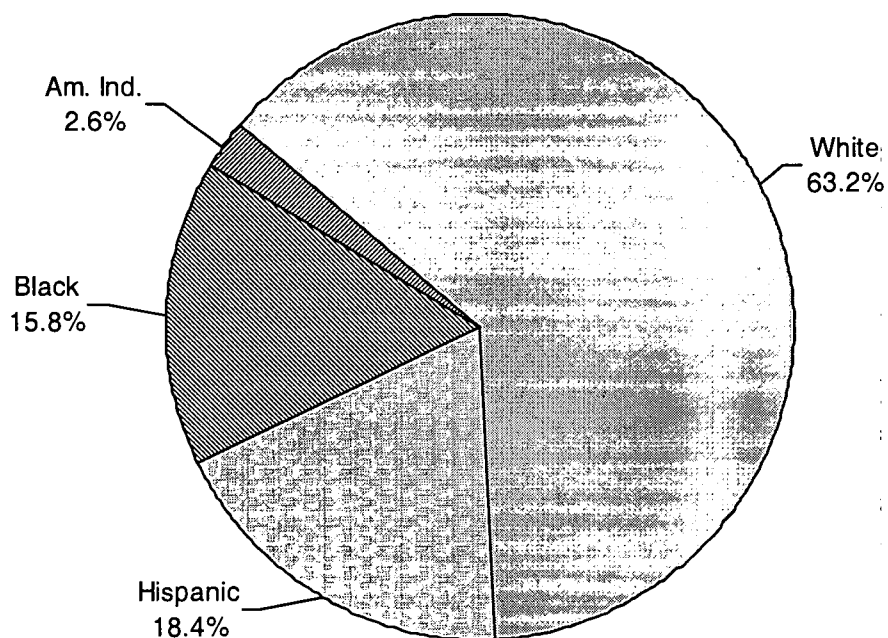

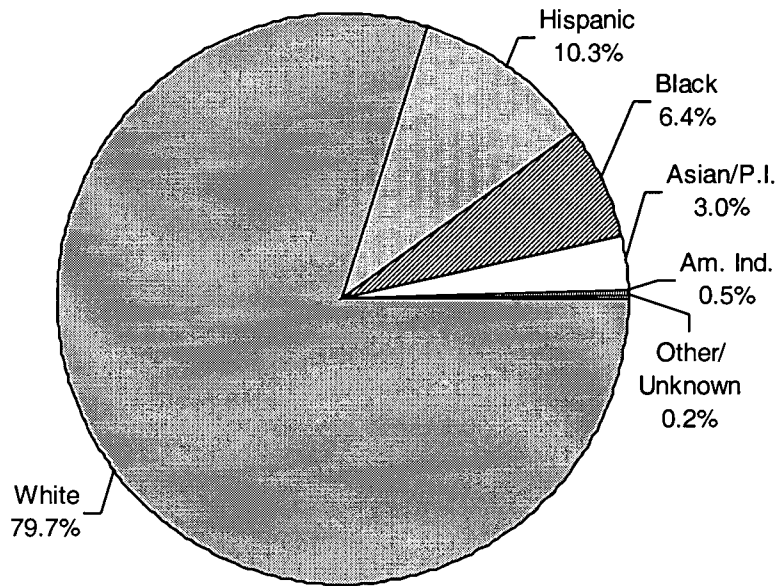

Fall 2000**



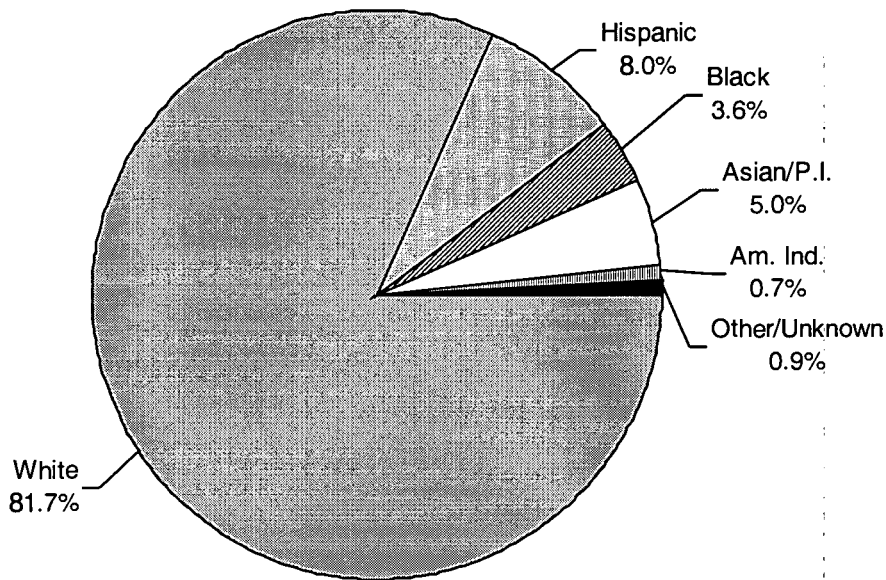

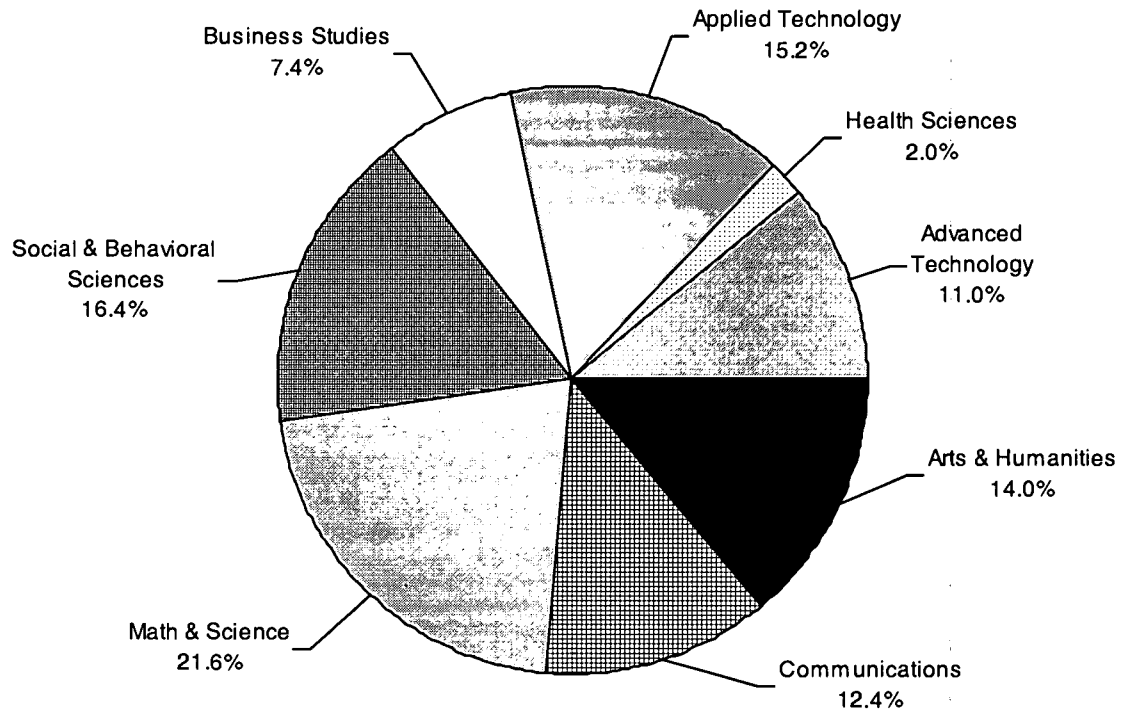

Fall 2000**



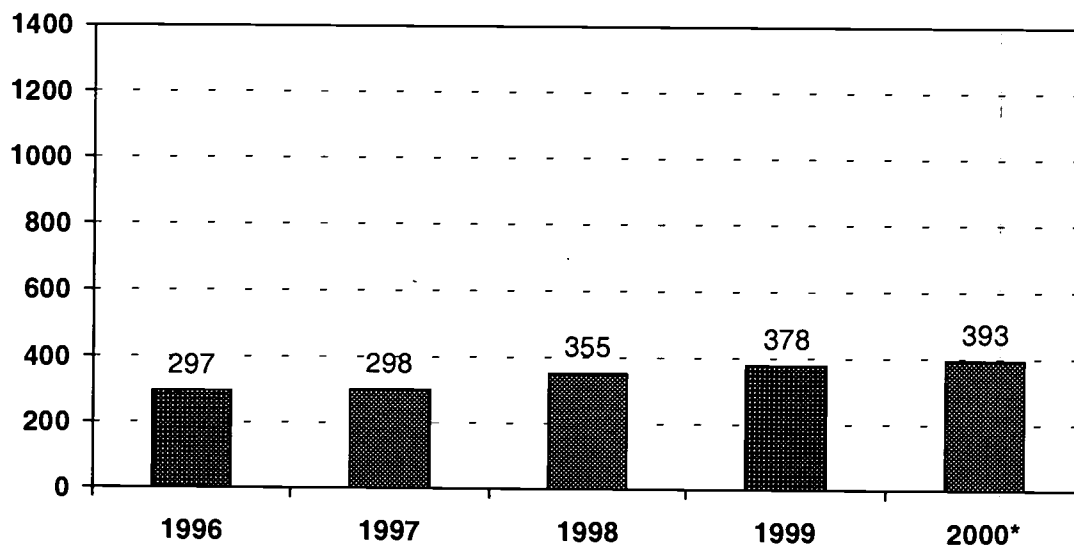

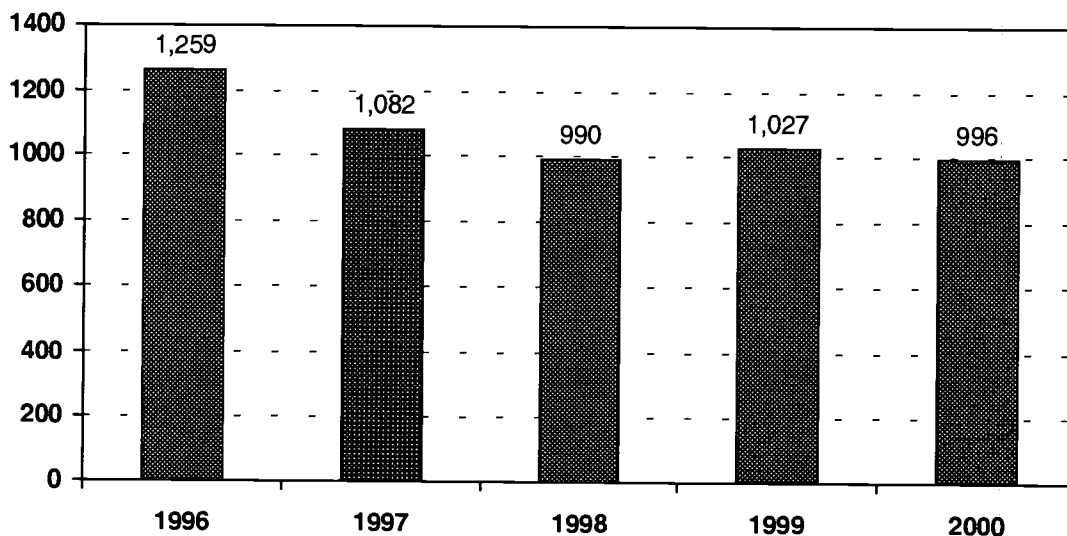

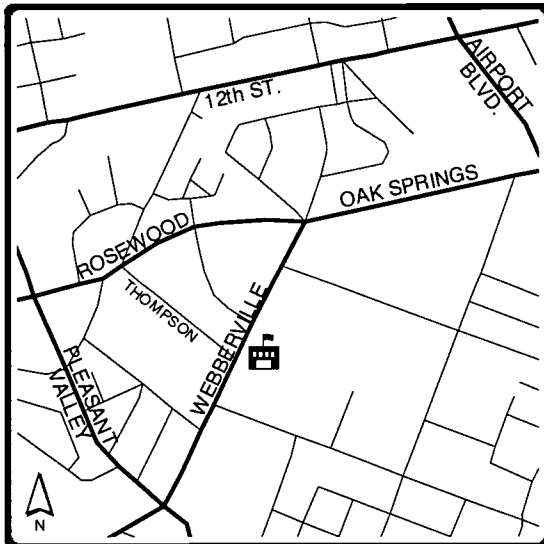
Maps of Full-time Facilities

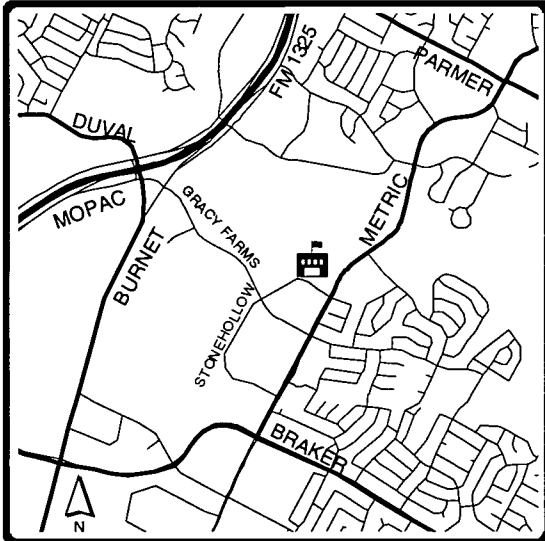

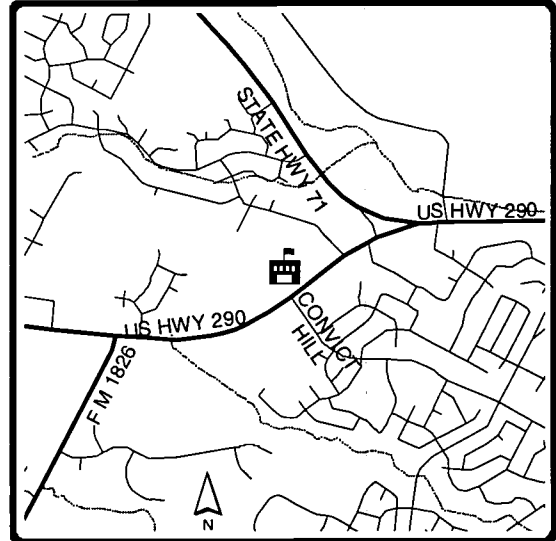

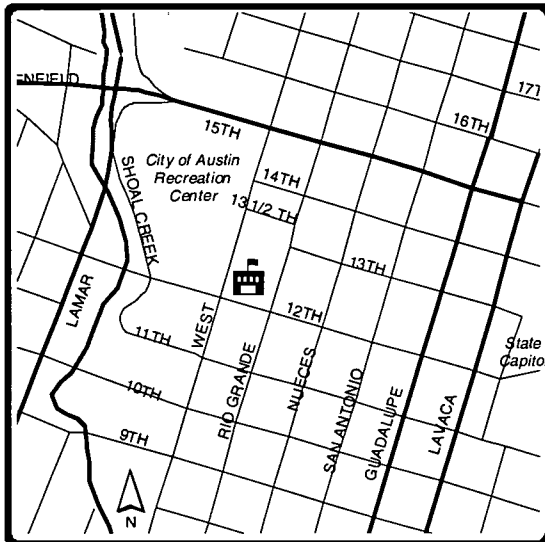
**Maps of Full-time Facilities

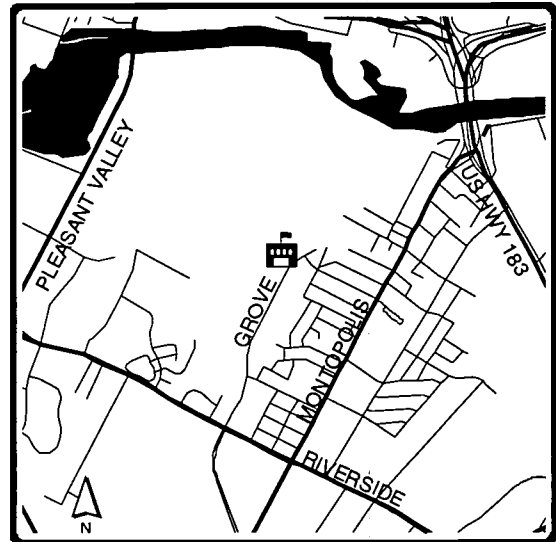

Glossary

ACADEMIC YEAR - runs from the first day of the fall semester through the last day of the summer session of the following year. For example, academic year 2000 began August 25, 1999 and ended August 22, 2000.

ADMINISTRATIVE PERSONNEL - include staffing table employees that are exempt from receiving over-time pay, are paid on a monthly basis, and are considered upper-management.

ADJUNCT FACULTY - include those instructors in college credit and certificate programs who are appointed on a course-by-course basis.

ASSOCIATE OF APPLIED SCIENCE (A.A.S.) - degree awarded to students who successfully complete the prescribed courses in any of the occupational-technical programs.

ASSOCIATE OF ARTS (A.A.) - degree awarded to students who complete at least 60 semester credit hours that include 6 hours of English, 6 hours of American government, 6 hours of U.S. history, 8 hours of a single foreign language, and the prescribed courses listed in one of the areas of concentration.

ASSOCIATE OF SCIENCE (A.S.) - awarded to students who complete at least 60 hour semester credit hours that include 6 hours of English, 6 hours of American government, 6 hours of U.S. history, 6-8 hours of science, and the prescribed courses listed in one of the areas of concentration.

CERTIFICATE - awarded to students who complete one of the approved certificate programs.

CERTIFIED DATA - data that is reported to the Texas Higher Education Coordinating Board and verified by ACC as an accurate reflection of student, course, and/or faculty information.

CLASSIFIED PERSONNEL - include staffing table employees that are not exempt from receiving overtime pay and are paid on a bi-weekly basis.

COLLEGE CREDIT COURSES - courses for which credits can be earned that apply toward a community college degree and that may be transferred to other institutions of higher education. College credit courses are approved by the Texas Higher Education Coordinating Board.

CONTACT HOUR - an instructional unit of time in which a student has contact with an instructor; includes both lecture and laboratory time.

CBM REPORTS - Coordinating Board Management reports that are mandatorily submitted to the Texas Higher Education Coordinating Board and are the basis for state reimbursement.

DAY AND EVENING STUDENTS - students enrolled in courses that begin both before and after 5:30 P.M.

DAY ONLY STUDENTS - students enrolled only in courses that begin before 5:30 P.M.

DUPLICATED ENROLLMENT - occurs when a person is counted more than one time. For example, a student who attends several courses at one campus and one or more courses at a second campus is counted twice, once at each campus.

EVENING ONLY STUDENTS - students enrolled only in courses that begin after 5:30 P.M.

EXTENSION CENTERS - locations other than campuses that are staffed, have regular posted hours, and offer credit courses on a regular basis (every semester).

FISCAL YEAR - runs from September 1 through August 31 of the following year. For example, fiscal year 2000 began September 1, 1999 and ended August 31, 2000.

FULL-TIME STUDENT EQUIVALENT (FTSE) - the total semester hours divided by 12, which is considered to be a full-time course load.

FULL-TIME FACULTY - include instructors in college credit programs as well as counselors and librarians who are employed by the college and are included in the staffing table.

FULL-TIME STUDENT - a student who is enrolled in 12 or more semester credit hours in the fall or spring semesters.

GRANT POSITIONS - include college employees whose salaries are funded by government or private agency grants and contracts.

HEADCOUNT ENROLLMENT - the total number of persons enrolled. This number may be duplicated or unduplicated (See: *Duplicated Enrollment*).

PART-TIME STUDENT - a student who is enrolled for less than 12 semester credit hours in the fall or spring semesters.

PROFESSIONAL/TECHNICAL PERSONNEL - include staffing table employees that are exempt from over-time pay and are paid on a monthly basis.

SITE BASED INSTRUCTION - includes various credit and non-credit classes and training offered for businesses, government entities, high schools, correctional institutions, and community groups.

STAFFING TABLE - includes non-grant employees who are eligible for benefits and accrue leave.

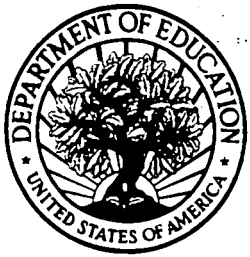
TELECOMMUNICATED INSTRUCTION - includes distance education courses delivered to individuals and informal groups by synchronous or asynchronous methods. Instruction formats include Instructional Television (ITV), Personal Computer with Modem (PCM), Print-Based using a textbook (PRN), Directed Learning (DIR), and Interactive Video Class (IVC).

TEXAS HIGHER EDUCATION COORDINATING BOARD (THECB) - a statutory 18-member board appointed by the Governor. It is responsible for statewide planning and policy-making to assure quality and efficiency in Texas higher education. The Board's primary areas of responsibility are financial planning, senior colleges and universities, community colleges and continuing education, health affairs, student services, and campus planning.
