#### ABSTRACT

The purpose of this report is to describe characteristics of students enrolled at Miami-Dade Community College (MDCC) (Florida) campuses and centers during the fall 2000 term and to highlight enrollment changes. Campus and center enrollment includes any student taking a course at that location, while college-wide data give an unduplicated count of students for the term. Findings include: (1) fall term 2000 credit enrollment was 47,637, a 1.6% increase from fall 1999. Notable increases occurred for females (+859 students), full-time students (+464), former students (+1,017), and students with a matriculation code of "Upgrade Skills" (+1,599), suggesting that current students are taking additional courses and that former students are returning for job upgrade; (2) ethnic proportions changed very little: 64% Hispanic; 22% Black non-Hispanic; and 13% White non-Hispanic; (3) most credit enrollees were continuing students (66%) pursuing an Associate in Arts degree (64%); (4) fall term 2000 Postsecondary Adult Vocational (PSAV) Student enrollment was 3,246, an 18% increase from fall 1999; and (5) Continuing Workforce Education (Supplemental) enrollment was 10,210, an increase of 27%, the highest enrollment of any non-credit category. #### College-Wide Results

#### **Credit Students (Table 1)**

- Fall Term 2000 credit enrollment was 47,637, a 1.6% increase from last Fall.
- Notable increases occurred for:
  - Females (+ 859 students). The female/male proportion was 60%/40%.
  - Full-time students (+ 464). The full-time/part-time proportion was 31%/69%.
  - Former students (+ 1,017). These students were 10% of the Fall enrollment.
  - Students with a matriculation code of 'Upgrade Skills' (+ 1,599). These students were 6% of the Fall enrollment.

These changes suggest that current students are taking additional courses, and that former students are returning for job upgrade.

Ethnic proportions were little changed: 64% Hispanic; 22% black non-Hispanic; and 13% white non-Hispanic. Most credit enrollees were continuing students (66%) pursuing an Associate in Arts degree (64%).

The biggest absolute increase in student enrollment occurred at the InterAmerican Campus (+ 574 students, or + 14%), while the biggest proportional gain was for the Entrepreneurial Education Center, which almost doubled its enrollment (+ 317 students or + 90%).

#### **Credit Students: Five Year Trends (Table 2)**

This is the first credit enrollment growth in five years. Credit load has also increased, so that total credits surpass those in either of the past two years.



#### Postsecondary Adult Vocational (PSAV) Students (Table 5)

- Fall Term 2000 PSAV enrollment was 3,246, an 18% increase from last Fall.
- Notable increases occurred for:
  - Blacks and Hispanics. Whites were only 9% of PSAV enrollment.
  - Females (+ 344 students). The female/male proportion was 62%/38%.
- Mean age also increased to 36.24.
- Continuing Workforce Education (Supplemental) enrollment was 10,210 for Fall Term 2000, an increase of 27%. This is the highest enrollment of any non-credit category. The increase was primarily for:
  - Hispanics (+ 1,606), who were 65% of the enrollment.
  - Females (+ 1,719), who were 61% of the enrollment.
  - These are our oldest students with a mean age of 37.25.
- Adult Basic enrollment more than doubled for Fall Term 2000, and reached 2,169 students. The increase was primarily for:
  - Hispanics (+ 1,124), who were 79% of the enrollment.
  - Older students. Mean age increased to 30.81.
- **GED Prep** enrollment also more than doubled for Fall Term 2000, and reached 960 students. The **increase** was primarily for Hispanics. **Average age** decreased again to 24.62, making these the **youngest students** at the College.
- Vocational Prep enrollment grew by 50% in Fall Term 2000 to 1,722 students. These students have a profile similar to PSAV students, but are younger (mean age of 31.52).

#### Non-Credit Students: Five Year Trends (Table 7)

Non-credit enrollment has shown a generally **increasing trend** across the past five Fall terms, with a drop in 1999 when VSI courses were phased out of the PSAV category. Adding all of the non-credit categories together yields 18,307 students for Fall Term 2000, an increase of 5,194 students from 1995.


