ABSTRACT

This report updates preliminary information from a 1998-1999 report, "The Civic Education of American Youth: From State Policies to School District Practices," relating to civics standards and assessments. The report states that the information found on its tables and charts was obtained from the Internet and from telephone interviews with specialists in state departments of education. Some of the data contradict information found in the earlier report. The report identifies which states have: (1) implementation dates of state standards with civic content; (2) presentation of civics content in state standards; (3) district requirements for implementation of standards; (4) existence and arrangement of testing of civics topics; and (5) state certification requirements to teach civics topics. The report provides a basic summary of civic standards and assessments for each state. (BT)

Background & Introduction

In 1998-1999 the Center for Civic Education commissioned a policy research project from the Lyndon B. Johnson School of Public Affairs in Texas. The report, entitled *The Civic Education of American Youth: from state policies to school district practices*, investigates a range of issues dealing with state requirements and programs in civic education. A year has elapsed since then, and states have still been working on the problem of civic education.

A need to update information about those states who were in the development stages of implementing standards or assessments bore this report. Originally, this research dealt with only those states that the LBJ project had reported as missing standards or assessments (either because they were being developed or because the state had decided against developing them). However, once that information was obtained and a chart format had been developed to document the data, it only made sense to continue the research and update all of the information relating to civics standards and assessments.

The internet was a great resource in this project because many states' standards were available for download from states' Departments of Education websites. The Center's Washington, D.C. office currently houses a library of each states' civics-related standards (with the exceptions of Iowa, which does not plan on creating standards, and Indiana, whose standards are not yet in draft form). The information found on the tables and charts in this report was obtained both from the internet and from telephone interviews with specialists in the Departments of Education in the states. Some of this data contradicts information found in the LBJ report. This could be due in part from inaccurate information given by either the contacts made by the LBJ report or by the contacts made during this research. Oversimplification in order to categorize data may have also contributed to discrepancies. For that reason, these charts have a "note-taking"-like feel to them: to convey as much information as possible.

Hopefully this research will accurately inform the *National Campaign to Promote Civic Education* about the status of civic education in the states and allow it to decide the next course of action.

Kevs for interpretation: Due to the varying language describing certificates, licenses, and endorsements across the various states, this chart will treat a certificate, a license, and an endorsement in the same way ("Certificate" will be the blanket term used). Often where an endorsement is required in order to teach there is no difference between that endorsement and a certificate or license in that endorsement area. In the case that more specific endorsements are available to a Social Studies certificate, a note will be made. An "X" in a column indicates that a certificate in that field is required in order to teach a class in that field. A " \checkmark " in a column indicates that a certificate for that field is not a requirement to teach in that field. In many cases this is because a comprehensive Social Studies overlaps with other specific certificates. An "X" will always be used to indicate the existence of a comprehensive Social Studies certificate if stand-alone components exist, and a " \checkmark " will be used to designate stand-alone certificates that would be subsumed by the comprehensive Social Studies. In the case that at the middle school/ junior high level there is an option to either be certified in a subject area or hold a general middle school or elementary school certificate, a " \checkmark " will be marked under comprehensive Social Studies. The "General" chart will only be marked if the certificate in question is only for general education, without the option for specialization. This chart will not attempt to define what grades are considered Middle or Junior High, but will use the guidelines set by each state.

Perhaps the most important thing to note about the differences between the LBJ Table 2.3 and this Table 2.3 is the more recent timetable. This indicates fluidity and willingness to revise on the part of the states. The oldest set of standards evaluated by the LBJ report was implemented in 1992. That state, Maryland, has revised its standards and implemented a new set in 1999. The oldest standards evaluated by this report date to 1995. Of those five states, one (Ohio) is writing a more formal set of standards for 2001. Several states, such as Massachusetts and North Carolina, are bound to revise and re-implement after a given amount of time. Updates to this report will be always necessary. There are a few instances where the information in the two charts are different only by a year. These discrepancies may be due to confusion about school years. One contact might say 1995 while another might say 1996 for the same school year.

Table 2.4: Presentation of Civics Content in State Standards

A modification was made to the first column under "Types of Presentation...". Because many states have adopted a strand-based system for their standards, it was necessary to change "Explicit section..." to "Explicit section or strand...". A strand is not the same as a section, if only for formatting reasons, but the value of that field is whether "civics" is explicit, not whether it is a strand or a section. Many footnotes were eliminated.

Table 2.5: District Requirements for Implementation of Standards

Each state determines how centralized its education system will be. In some states the Department of Education sets policy that must be followed by each school district within the state. In other states the Department can only suggest or present models. A field was added to this chart, "Mandated by assssment" to accommodate those states which were hesitant to claim that their standards were state-mandated, even though an assessment on those standards was state-mandated.

Table 2.7: Existence and Arrangement of Testing of Civics Topics

A couple of fields were added to this chart to more accurately describe each state's assessment policies. Types of assessment vary tremendously. Some states will have one state assessment that has multiple parts for each subject. Others will have stand-alone subject assessments. Others will have end-of-course exams. Still others will have standardized tests or graduation exit exams. Sometimes these exit exams are subject specific, sometimes they are comprehensive. It is very important to note that states may have different forms of assessment for different grade levels. The updated Table 2.7 attempts clarification by specifying: "within a comprehensive assessment," "within a graduation exam," "within a standardized exam." Unfortunately, grade-specific information is not found on this table. Because many states had detailed plans about their future assessments, those states were classified under the categories that fit the future assessments, and marked by brackets.



Table 2.9: State Certification Requirements to Teach Civics Topics

This table documents the different types of licenses or certificates or endorsements available in different states for social studies teachers. The information was gathered by calling each state's Department of Education and speaking to a certification representative. A few categories were added to break up the general nature of the LBJ table. Many states offer a "Political Science" certificate, which may describe a more civics-oriented training than "Various History/ Social Studies" or "Other."

UNDERSTANDING THE CHARTS

The chart format was developed after researching a few of the states and deciding what kind of information was relevant to many states and would give a descriptive view of the standards and assessments in those states.

Definition of a few fields:

Draft or Final?

Although a simple question, it was found that contacts in many states were hesitant to say that their standards were in final form because even a final form can be revised. Consequently, "Final" simply means that the standards have been implemented. "Draft" indicates that the version found in the library at the CCE, D.C. office has not been implemented.

Mandated or Recommended: As has already been remarked, many states did not want to classify their standards as mandated or recommended. This occurred mainly with states that had assessments because if the state mandated assessment tested those standards, then essentially the standards were mandated even though the state considered itself to be "local control."

Does a curriculum framework exist: Some states have developed suggested curriculum

frameworks to accompany the standards. In some cases, the standards were the framework or part of the framework.

Developed by the state: This field seeks to describe how well the assessment will be tied to

the standards. In most cases the assessment is developed by the

state, excepting where standardized tests are used.

"High Stakes" for building: The question asked to contacts if they were unsure of what the

> phase meant was "are reported scores tied to school accreditation, accountability, or funding?" No state reported that scores were



tied to funding, though a few described state control over a poorly performing school. Most "yes"s mean accountability.

Performance indicators/descriptors: Many states have developed performance standards to accompany a set of content standards. However, this field sought to determine which states had developed a means of determining how well students were achieving standards. The most informative set of indicators was leveled. For example, to meet xyz standard:

A basic student would be able to . . . A proficient student would be able to . . . Few states had these. Of those that did, most were in a very general, non-standard specific format.
