ABSTRACT

This executive summary reports on the number of students not reading on grade level in all second and third grades throughout Louisiana. The report notes the provisions of the legislation that requires such data be generated, and discusses selection of the Developmental Reading Assessment (DRA) as the uniform assessment instrument to be implemented statewide in the Fall of 1998. The report then presents a summary of the findings of the Fall 1998 administration of the DRA, noting that: (1) 43.64% of the second graders were reading on or above grade level; (2) 65.52% of the third graders assessed were reading on or above grade level; and (3) 54.49% of the second and third graders were reading on or above grade level. A table listing second and third grade reading ability by parish is attached. (RS)

Introduction and Background

This report is submitted in compliance with R.S. 17:181 (House Bill 2444 --Act 450) enacted during the 1997 Regular Legislative Session. This law directed that the State Board of Elementary and Secondary Education (BESE), in cooperation with the Department of Education and all public schools, report on the number of students not reading on grade level in all second and third grades throughout the State.

The Legislature, BESE, and the SDE are committed to improving the reading and mathematics abilities of all students in Louisiana, with a primary emphasis on early intervention. In this regard, the Legislature in 1997 appropriated 30 million dollars for a K-3 Reading and Mathematics Initiative, and in the 1998 Legislative Session 20 million dollars was allocated for the same purpose. The target population for this initiative are those students who are at risk of experiencing difficulty in reading and/or math in kindergarten through third grade.

Specifically, R.S. 17:181 included the following provisions:

- *each governing authority shall implement at each elementary school a reading program that is designed to teach students to read on grade level by not later than the end of first grade;*
- *the program shall include but not be limited to a phonics component;*
- *each second and third grade teacher shall report the number of students not reading on grade level;*
- *the data for each school and for each school system, and for the state as a whole, shall be*

reported in the school progress profile.

The legislation did **not** address how the students were to be assessed or which instrument(s) were to be used. However, specific time lines for reporting results of the assessment were established in the legislation, as follows:

- Within the first 30 days of the opening of school, teachers will report the number of students who cannot read at grade level to the principal and system superintendent;
- Within 60 days of the opening of school, the information will be forwarded to the State Superintendent and the State Board of Elementary and Secondary Education;
- Within 90 days of the opening of school, the information will be compiled and reported to the House Committee on Education and Senate Committee on Education.

The State Board of Elementary and Secondary Education also directed through its rule-making authority, that school districts assess **all first grade students and that a post assessment** be given to second and third graders in order to measure progress in reading over the year.

During the initial year of implementation (1997-98), school districts were allowed to select an appropriate means for measuring students' reading abilities. The SDE and BESE allowed local choice of assessment tools in the initial year due to the extremely short time frame for implementation of the legislative request. Basal reading tests, informal reading surveys, computerized reading inventories, and other measurements such as norm-referenced tests or criterion-referenced tests were among the methods used in assessment.

BESE, the SDE, and the Legislature were all cognizant of the need to establish a uniform method for measuring reading performance state-wide.

Assessing Students' Reading Ability -- *The Developmental Reading Assessment (DRA)*

In May the Board of Elementary and Secondary Education approved the *Developmental Reading Assessment*, published by Celebration Press, as **the uniform assessment instrument** to be implemented statewide in the fall of 1998. The *Developmental Reading Assessment* is an individually administered instrument that evaluates the two major aspects of reading: accuracy of oral reading and comprehension through reading and retelling of narrative stories. Both aspects of reading are critical to independence as a reader. The assessment consists of twenty stories that increase in difficulty. Factors which contribute to the gradient of difficulty of the stories include the number of words on a page, complexity of vocabulary, length of the stories, degree of support from the pictures, as well as complexity of sentence and story structure.

The *DRA* is appropriate for assessing grade-level reading ability and is also used for early detection of reading difficulties. The instrument helps teachers by focusing on specific problems of each child and by serving as a guide to classroom reading instruction, based on the individual needs of each child. Early diagnosis of specific reading difficulties, when matched with appropriate instruction, can help to ensure that students' progress in school and become successful lifelong learners.

With the uniform assessment in place, the Legislature, BESE, SDE and local school districts and schools will be provided with a more accurate and valid picture of the reading abilities of our students.

Results of the Fall 1998 *DRA* Assessment of Reading Performance

This report describes the reading abilities of second and third grade students during the first 30 days of the 1998-99 school year. **Caution should be used when comparing first year (1997-98) results with the following 1998-99 Fall data since a uniform assessment tool was not in**

place in 1997-98.

Students Assessed and Included in the Fall 1998 Survey

In determining which students were assessed, the Louisiana Department of Education used the following criteria:

- all regular education students who were enrolled as of October 1, 1998
- all special education students whose IEP designates that they are in a specially designed, regular instructional program;
- all Limited English Proficient (LEP) students who were enrolled in and completed at least two full consecutive academic years in an English-speaking school (including kindergarten);
- students in alternative programs or placement who are addressing regular curriculum standards;
- all disabled students according to Section 504.

Summary of Findings -- Fall 1998 Reading Assessment

Based on the analysis of the data provided by classroom teachers, the findings are noted as follows:

1. Of the 58,615 second graders assessed

- 56.36% were reading below grade level
- 29.53% were reading on grade level, and
- 14.11% were reading above grade level.

In summary, 43.64% of the second graders who were assessed are reading on or above grade level.

2. Of the 57,625 third graders assessed

- 34.48% were reading below grade level,
- 45.72% were reading on grade level, and
- 19.80% were reading above grade level.

In summary, 65.52% of the third graders who were assessed are reading on or above grade level.

3. Of the 116,240 second and third graders assessed

- 45.51% were reading below grade level,
- 37.55% were reading on grade level, and
- 16.94% were reading above grade level.

In summary, 54.49% of the second and third graders who were assessed are reading on or above grade level.
