ABSTRACT

The Alabama Public Library Service (APLS) is charged with improving library services throughout the state to ensure that all citizens have access to quality library and information services. The agency is responsible for receiving and administering federal and state funds for the more than 200 public libraries in Alabama. Information is reported under the following categories: the Alabama Virtual Library; networking, development and planning (E-Rate, training, summer library program, mini-grant program, the Book Viburum Foundation Project, and consulting); information services (circulation, reference, interlibrary loan and fax, net lending, and video department); evaluation and research; automated services; technical services (acquisitions/serials, cataloging, state databases, and government documents); Division for the Blind and Physically Handicapped (administration, circulation, audio duplication, volunteers, National Library Service, and public relations); and finances. State aid and Library Services and Technology Act (LSTA) totals for 1999 are provided, in alphabetic order by library. (AEF)

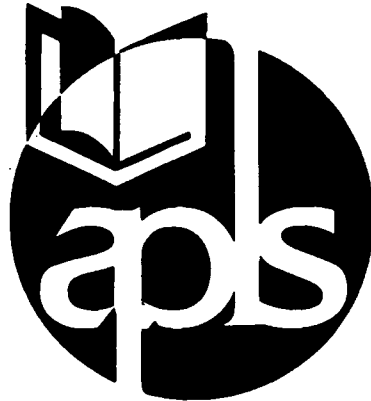

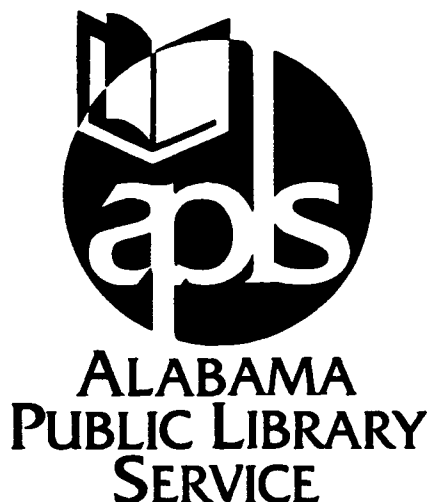

Annual Report 1999

The year ended on a very exciting note: the Alabama Virtual Library was funded for the upcoming year, and vendors agreed to make databases available for use during the last days of this fiscal year.

This allowed schools and libraries to be true partners in the educational process. We expect great things to come from this partnership in bringing databases to online patrons at their school, library, home or office.

The Alabama Public Library Service is providing library leadership throughout the state. We intend to continue this progress, expanding databases for the Alabama Virtual Library, and providing quality library services to all our patrons.

To the public libraries in the state of Alabama -- we are here for you. Let us know what we can do to help you. In the meantime, we will continue to pursue better and more efficient ways to serve you and your patrons.

The Alabama Virtual Library becomes a reality.

In June, Gov. Don Siegelman and the Alabama Legislature appropriated \$3,000,000 in the APLS FY2000 budget for database licensing for publicly supported school, public, academic, and community college libraries. Although no funds were available for implementation of the project during the 1999 fiscal year, the AVL dominated much of the year. The earlier months were spent helping librarians become more technically savvy and building interest in a statewide virtual library among citizens and librarians.

Constituent groups had made commitments to legislators that resources would be available to students when schools opened in the fall. Five state agencies and multiple volunteers throughout the library community worked together to get funding. The state agencies were the Alabama Public Library Service (APLS), the State Department of Education, the Alabama Commission on Higher Education of which the Network of Alabama Academic Libraries (NAAL) is a part, the Department of Post-Secondary Education, and the Alabama Supercomputer Authority. By early July, a 15-member council had been appointed and charged with implementing and managing the Alabama Virtual Library (AVL).

During the time that the library community had been lobbying for funding, volunteers had been reviewing databases. The volunteer steering committee that had been managing the lobbying effort had committed to having licensing in place initially for an encyclopedia, full-text periodicals and newspapers. By the time school started, the AVL had reached agreements with EBSCO, Electric Library and Britannica to provide free service until the start of the state fiscal year. Through these commitments students had available to them a major encyclopedia online and access to articles in more than 3,500 magazines, various reference books, newspaper, maps and television and radio transcripts.

Networking, Development and Planning

In August, staff began scheduling training sessions. In 20 training sessions around the state before October 1, EBSCO staff had trained more than 300 trainers to help others use EBSCOHost.

Also, as soon as funding was passed, APLS staff began collecting information about how public libraries reach the Internet. This information was sent to each vendor as soon as agreements were reached so the vendors could set up permanent authentication for the libraries.

All the participating agencies worked together to get information out to constituent groups and to inform library users. The Alabama Supercomputer Authority began work on a website. Still communication with school technology coordinators and media specialists has been difficult in many instances. APLS staff put together a flyer to try to reach them during the LAMP tour.

The AVL has been a true collaboration. APLS staff have been able to schedule training lab space in all kinds of libraries throughout the state. Librarians went from vendor training to train others within their geographic areas without consideration for what types of libraries were represented in training sessions.

E-RATE

By the end of the fiscal year, many public libraries were able to provide greatly improved Internet access with support from the universal service discount program, also known as the e-rate. APLS staff helped libraries complete their applications and work through all the paperwork of the first year of the e-rate program. Staff continued to consult on and certify the e-rate required technology plans.

Before the year ended \$850,686.93 in e-rate funds had been awarded to benefit 104 public libraries for the first year of the e-rate program.

TRAINING

Division staff ran a full workshop schedule with sessions provided by a variety of presenters in locations throughout the state. Sessions included ones done by division staff, other APLS staff, presenters from the Southeastern Library Network (SOLINET), the State Department of Education, and Alabama Virtual Library database publishers. This year, 1,165 library staff members attended 76 workshops. Workshops ran the gamut from staff-developed sessions on such topics as developing children's collections, cataloging in the small library, and weeding to technical training on teaching others to use databases.

There were several firsts during the year. For the first time APLS cosponsored a video teleconference recruiting sites for viewing and handling registrations for a SOLINET videoconference on filtering. APLS staff also planned and facilitated a two-day automation vendor showcase. This year APLS included staff from more non-public libraries in its continuing education program.

SUMMER LIBRARY PROGRAM

In the absence of a youth services consultant, staff pulled together to carry out a highly successful *Reading Road Trip*, the 1999 Summer Library Program. Staff published and distributed materials to public libraries. These materials included 128 large posters, 2,089 small posters, 128,670 bookmarks, 98,817 certificates, 120,925 stickers, and 554 manuals.

APLS hosted a kickoff program where more than 170 public librarians learned programming ideas. More than 56,700 Alabama youth read some 865,302 books during the summer. Libraries provided 3,619 program events attended by 158,178 young people.

MINI-GRANT PROGRAM

Another APLS first was a mini-grant program to support children-at-risk programming. Under this first-come, first-served program Alabama awarded up to two grants of up to \$150.00 each per public library to fund professional performs such as storytellers, drama groups and puppeteers to enrich children's programs to promote reading. Thirty-one public libraries had 56 programs which were attended by 3,894 children.

VIBURNUM

Staff worked with the Library of Congress Center for the Book Viburnum Foundation Project to recruit from among Alabama's public libraries applicants for family literacy project funding. Harrison Regional Library; B. B. Comer Memorial Library; Lewis Cooper, Jr. Memorial Library; Marion-Perry County Library; and Ashland-Clay County Public Library were awarded grants. A staff member attended the regional training session in Baton Rouge as a workshop facilitator.

CONSULTING

The division staff continued to consult with staff of public libraries throughout the state by phone, by e-mail and with personal visits. Staff supported program planning, technology planning and troubleshooting, space utilization planning, collection development and weeding, grant writing, staff levels and utilization, library standards, and e-rate applications.

Information Services

This year of the AVL and the INTERNET has been exciting for the Information Services Division. All departments are using the AVL and the Internet.

CIRCULATION

The circulation staff had a busy year. The number of new borrowers grew from 213 to 367, an increase of 72 percent over last year. Overall circulation showed a small drop of just 4 percent, from 14,488 to 13,893. Circulation increases occurred in the following patron categories: nonpublic libraries, out-of-state libraries, school/faculty (Montgomery Higher Education Consortium) and schools. The drops in circulation were with traditional APLS users: public libraries, state employees and staff. The number of electronic requests, those received either by email or by SIRSI, jumped from 166 to 526, an increase of 217 percent.

REFERENCE

The Reference staff handled 13,301 requests during the year, an eight percent drop from the previous year. However, the number of walk-in patrons grew from 1,458 to 1,890, a 30 percent increase. These patrons asked 23 percent more questions than last year's patrons. Pages copied from computers and microforms increased by 72 percent, from 2,730 to 4,700. The department now has three Internet terminals in Reference and Government Documents. Staff uses the Internet and the AVL to answer more and more reference questions. In addition to regular reference work, the staff also works with the public libraries and with state employees on a daily basis to show them how to find answers on the AVL and the Internet.

INTERLIBRARY LOAN AND FAX

APLS initiated 4,161 requests using the OCLC Subsystem. Of these 3,786 were sent directly to libraries, an increase of 22 percent from last year. Other libraries made 5,736 requests for APLS material, an eight percent rise over the number of requests from last year. The number of requests by fax grew from 5,860 to 6,813, a 16 percent increase. Requests filled by fax rose from 955 to 1,371.

NET LENDING

APLS and public libraries lent 13,127 items to satisfy patron needs during the year. Five public libraries were net lenders in FY99. These libraries lent 578 more items than they borrowed during the year. They were reimbursed \$7.50 for each loan. Houston-Love Memorial Library in Dothan, Birmingham Public, Gadsden-Etowah Public, Choctaw County and Tuscaloosa Public lent more than they borrowed. In FY99, NAAL libraries lent public libraries 3,997 items.

VIDEO DEPARTMENT

This year the video catalog went on-line. Libraries and state employees are able to search the catalog and make requests. A listing of the newest titles that have been circulated can also be viewed in the catalog. This year 5,462 videos were circulated, two more than last year. The Holiday List was sent out in July. For the first time ever, APLS had enough holiday videos for patrons to order as needed. A 1999 Supplement to the Video Catalog was mailed to patrons in the fall.

Evaluation and Research

During the 1999 fiscal year, the Library Research and Statistics Division completed editing and submitted the 1998 statistical data to the National Commission on Education Statistics as part of our responsibility to meet the requirements of the Federal State Cooperative Statistics program. The division began planning to convert the cumbersome paper survey process to data collection using an electronic format.

Working with Management Dynamics (now The Library Place) the company's BiblioStat products were adapted to meet the need of data collection in Alabama. The BiblioStat Collect program and the BiblioStat Connect program were introduced to Alabama library directors in April and training schedule introduced in July.

The "Connect" program containing the 1998 Alabama Statistics was mailed to all public libraries and its use demonstrated to library administrators.

In September a train-the-trainer session was held for system librarians and distribution of software for collecting the 1999 data began.

Automated Services

During the year, new personnel were added to the department. The division began utilizing databases on the Internet. A new Medianet server was purchased for the Audiovisual Department and placed in the computer room. New personal computers were purchased and placed on workstations around the building.

Much of the year was spent making sure all computers and technical equipment will be compatible for the new year, 2000. Cosmetic changes included adding cabinets and workspace and building storage areas in the department.

Technical Services

The APLS Collection Development Policy written in 1981 was revised by a committee. Suggestions from APLS professional staff during the revision process were also incorporated. The revision awaits discussion and approval from the director, the APLS Board (scheduled for presentation at the Dec. 1999 meeting), and a hearing before the revision is submitted to the Alabama Administrative Code.

During the year, the division cataloged 7,696 new titles and added 1,079 volumes to already cataloged titles. The division ordered 7,805 new titles and received 11,046 volumes including 240 gift books. The division spent \$673,276 on library materials, including \$563,190 for books and \$16,594 for Internet access.

ACQUISITIONS/SERIALS

Acquisitions ordered 2,630 fewer titles and received 756 fewer volumes than in FY98. Nearly \$125,000 less was spent on books.

CATALOGING

Cataloging workshops were held in several libraries around the state. The number of books and materials handled in Cataloging and Processing this fiscal year was 322 more than those handled during FY98. Staff assisted at least 17 small libraries by providing cataloging information for at least 83 titles and answering other more general questions.

STATE DATABASES

ALICAT: The 1999 ALICAT catalog, produced on six compact discs, consisted of 3,824,842 title entries in 9,078,381 locations. It also contained 88,558 AULS holdings input through Oct. 31, 1998.

AULS: The Nov. 1998 offline products of the Alabama Union List of Serials contained 33,590 unique titles to which 88,558 local data records were attached, representing the holdings of 118 libraries. A meeting of the Coalition for the Preservation of Alabama Newspapers (CPAN) was held in February 1999.

GOVERNMENT DOCUMENTS

Government Documents staff shifted and shelved almost the entire paper collection. Staff began to shift the government document microfiche to read from left to right and re-filed the fiche in new cabinets.

Division for the Blind and Physically Handicapped

The focus this year was on further implementation of the new KLAS circulation system in the areas of patron service and serials. The adaptive software, JAWS for Windows and ZoomText Plus, has enabled visually impaired staff members to continue their work and learn new areas.

ADMINISTRATION

New personnel were hired. The division completed the annual readership/circulation report for the National Library Service. Contact with NLS, network libraries and subregionals was maintained by phone, E-mail and in person. The division director made site visits to all five subregional libraries and sent follow-up reports to the librarians and their directors.

CIRCULATION

BPH circulated 139,048 special format volumes to its 4,093 active patrons. Average overall circulation was 11,587 volumes per month. The division gained 782 new patrons this year. There were 348 visits by patrons or their families who chose to pick up books or exchange machines in person rather than by mail.

AUDIO DUPLICATION

As requested by our patrons, 925 magazine copies from submasters produced in other states were duplicated and often circulated more than once.

VOLUNTEERS

During the year, 24 people volunteered at the library, donating 2,063 hours. BellSouth Pioneers had 10 volunteers who repaired cassette players and record players. The Junior League continued to work for BPH in magazine and book duplication.

NATIONAL LIBRARY SERVICE

Two NLS staff members visited BPH this year. Also, NLS decided to begin its "Take a Talking Book for Senior Adults" campaign for the next fiscal year. Orders were placed for the spring 2000 project.

PUBLIC RELATIONS

More than 200 people from 10 groups learned about blindness and library services from BPH staff. The BPH Consumer Advisory Committee continued its work. The committee was excited to learn about the Alabama Virtual Library and its impact on their lives. The quarterly newsletter, WhAT'S LINE, continued to inform patrons of NLS and BPH program changes and special services.

Finances

In 1999, the APLS Executive Board approved grants of Library Services and Technology Act (LSTA) funds to public libraries, library systems and state agencies.

For FY 99, the board approved \$1,590,834 in LSTA grants. Turn the page for a breakdown of LSTA totals.

A total of \$4,949,347 or \$1.15 per capita was awarded in State Aid for FY 99. Below is a breakdown of state aid totals.

In FY 99, APLS received \$7,617,364 from the state and \$2,896,610 from the federal government.

During FY 99, APLS made the following distributions: State Aid to Libraries, \$4,949,347; Agency Operations, \$2,668,017; Federal-Grants, \$1,590,834; and Federal - Agency Operations, \$1,088,663. Also appropriated in the APLS budget was \$25,000 to Athens Public Library and \$15,000 to Triana Public Library.

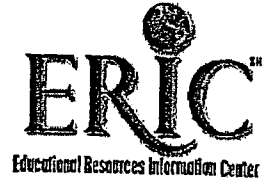
