ABSTRACT

This Critical Issue Bibliography (CRIB) Sheet focuses on the literature available on the internationalization of postsecondary education. The citations are grouped into these major categories: (1) Importance of International Education; (2) Curriculum; (3) Intercultural; (4) International Studies; (5) Language; (6) Professional Schools; (7) Administrative Structures; and (8) Assessment. Many articles stress the importance of international education, signaling that there is not a general acceptance of this goal. Much of the literature also relates to broader curriculum. The annotated bibliography describes 40 sources, all of which are in the ERIC database. (SLD)

**What is an ERIC CRIB Sheet?**

A Critical Issue Bibliography (CRIB) sheet is a selected bibliography on a topic of interest in the field of higher education. The majority of the literature cited in the bibliography is found in the ERIC Database, though some CRIB sheets also include other literature, such as selected Internet resources. CRIB sheets are updated annually.

Many of the issues discussed in one bibliography relate to another CRIB sheet topic. For example, the CRIB sheet on affirmative action is closely related to the CRIB sheet on creating a multicultural climate on campus. We have tried to note such connections in the bibliographies themselves; we encourage you not to see CRIB sheet topics as discrete and to explore several bibliographies on related topics.

**Critical Issue Bibliography (CRIB) Sheet:  
Internationalization of Postsecondary Education**

After World War II, an international component began to emerge in the United States' postsecondary institutions. The United States' new role as an international leader spawned international studies programs, new foreign language programs, and research and study exchange programs. Experts with an international perspective were critical in fostering our nation's new political role in world peace. Fulbright scholarships were born. In more recent years, due to the shrinking world economy and blurring of national boundaries, emphasis has shifted to infusing the general curriculum with an international perspective through study of other countries, their cultures, and their postsecondary education systems. Professional programs in business, social work, engineering, and teacher education have been the most active in embracing this new international perspective. Faculty and administrators from foreign countries have been recruited in an effort to diversify college campuses. What began as a narrow curricular innovation developed into an initiative that impacts the general curriculum and the human resources, administration, and mission of postsecondary education.

Terminology relating to the internationalization of postsecondary education has become confused. Some people discuss global education, others discuss international education, and still others emphasize intercultural, cross-cultural, and multicultural education. Each phrase has a distinct meaning, but all emphasize the importance of a greater appreciation of the diverse cultures of the world. Though internationalization is a buzzword on almost every campus, there is scant higher education research on the topic. Most ERIC literature on internationalization of postsecondary education has been collected from conferences. One new publication -- the *Journal of Studies in International Education* -- will help to fill this gap. The *Chronicle of Higher Education* is also a good resource for keeping informed about current events in international education and for obtaining an international perspective. In addition, the UNESCO/International Association of Universities fosters collaborations and partnerships in postsecondary education all over the world.

This CRIB sheet attempts to introduce the reader to the literature available on this topic. Citations are grouped in eight major categories: 1) Importance of International Education, 2) Curriculum, 3) Intercultural, 4) International Studies, 5) Language, 6) Professional Schools, 7) Administrative Structures, and 8) Assessment. Many articles stress the importance of international education, signaling that there is not general acceptance of this goal. Much of the literature also relates to broader curricular infusion. Articles listed in the curriculum category include those that stress the importance of international education within the areas of language development, intercultural competence and international studies. Leadership by professional schools is another theme. As international education became conceptualized as an overall campus learning goal rather

than as a specific disciplinary objective, *administrative structures*, e.g., international education or exchange centers and consortia, have emerged. Dilemmas and processes within these centers are the focus of this section. Lastly, *assessment* of internationalization of postsecondary education has begun to emerge to evaluate whether or not curricular modifications and new administrative structures are meeting the intended goals.

This report looks at a program at the University of Maryland designed to give first- and second- year students an opportunity at learning cross-cultural communication skills.

Koller, John M. (1995, January 31). *Globalizing education for engineering and science students: A FIPSE project model for cross-cultural studies of science and technology*. Troy, NY: Rensselaer Polytechnic Institute.

This report describes a project at Rensselaer Polytechnic Institute to develop a curriculum that focuses on the social construction and use of science and technology in diverse cultural contexts.

Discusses the intercultural effects on college faculty teaching abroad through an exploration of the experiences of two teaching academics working in Hong Kong with emphasis on issues of language and communication and social and cultural distance. Argues that the development of intercultural understandings must permeate the curricula, and be a shared goal and responsibility of both teachers and students.

Nunezz-Cronk, Brunilda, & Willoughby, Donna. (1993, November). *Golden West College intercultural center*. Paper presented at the Western Regional Conference of the Comparative and International Education Society.

A look at the development of an Intercultural Center at Golden West Community College to enhance campus-wide awareness of cultural diversity through services to immigrant and international students and the campus community.

Calvi, Licia, & Walter Geerts. (1995, April). *A multimedia program combining special purposes Italian with the study of the Italian economy*. Paper presented at the Annual Eastern Michigan University Conference on Languages and Communication for World Business and the Professions.

This paper describes the first phase of a project that applies multimedia and hypermedia technology to the study of modern languages. The approach differs from traditional ones in that language is not viewed from a conversational or grammatical perspective, but through scenarios imitating the contexts of natural language use.

Suarez, Jose I. (1993, December). *The language & international trade program at Clemson University*. Paper presented at the Modern Languages Association Convention. A look at an undergraduate program in Language and International Trade developed at Clemson University. The program is designed to train students to meet the needs of American firms doing business overseas.

This project, developed in three phases, called for the development of guidelines that could be used in the United States to internationalize undergraduate teacher preparation curricula.

This strategic plan addresses the internationalization of activities of American colleges and universities. Specifically, schools offering programs in food, agricultural, and natural resources disciplines.

This report takes the results of a survey of accredited colleges and universities, and examines the internationalization of the US higher education system.
