## ABSTRACT

This Critical Issue Bibliography (CRIB) Sheet is divided into sections designed to identify current trends and the changing roles in academic librarianship today. Items listed under State of Affairs identify trends throughout institutions, targeting specific situations from which both administrators and librarians can gain a new perspective about challenges facing colleges and universities today. Publications that discuss the academic librarian as a technologist, an educator, a faculty member and collaborator, and an Internet consultant are listed next. The citations conclude with a look at the issues confronting the management of college and university libraries and a list of associations to assist academic librarians in their profession. The annotated bibliography lists 46 references, all of which are in the ERIC database, and 3 Internet resources. (SLD)

### **What is an ERIC CRIB Sheet?**

A Critical Issue Bibliography (CRIB) sheet is a selected bibliography on a topic of interest in the field of higher education. The majority of the literature cited in the bibliography is found in the ERIC Database, though some CRIB sheets also include other literature, such as selected Internet resources. CRIB sheets are updated annually.

Many of the issues discussed in one bibliography relate to another CRIB sheet topic. For example, the CRIB sheet on affirmative action is closely related to the CRIB sheet on creating a multicultural climate on campus. We have tried to note such connections in the bibliographies themselves; we encourage you not to see CRIB sheet topics as discrete and to explore several bibliographies on related topics.

This CRIB sheet was updated in December 2001.

The report presents detailed tabulations for 1996 and historical comparisons with previous years.

Hardesty, L. (Ed.). (2000). *Books, bytes, and bridges: Libraries and computer centers in academic institutions*. Ten chapters discuss the relationship between computer centers and libraries at academic institutions.

Summey, T. P. (1997). Techno reference: Impact of the electronic resources on traditional reference services. *Reference Librarian*, 59, 103-11. This article deals with the effects of electronic resources on traditional reference services.

Leonard, B. G. (1993, Spring). The role of the systems librarian/administrator: A preliminary report. *Library Administration & Management*, 7, 2, 113-16. Discusses the role of systems librarians and the duties, responsibilities, and skills required.

Pierce, L. (1997). *BI with an attitude: Or attitudinal factors in bibliographic instruction*. Paper presented at the Annual Meeting of the Nebraska Library Association, Crete, NE. Discusses some of the pitfalls of the bibliographic instruction librarian.

Whitmire, E. (1998, May). Development of critical thinking skills: An analysis of academic library experiences and other measures. *College & Research Libraries*, 59, 2, 26-73.

A study suggesting that academic librarians should design library research skills courses to increase student-focused use of the library and its resources.

This article considers the expanding educational role of health science librarians in both academic centers and in hospitals as the result of new educational models and new technology.

The final report of a year-long study at Fontbonne College which examined ways in which the library's development could be centered in teaching and learning. More specifically, the task force was to determine how library and information services could be rooted in the college's curricula.

Examines the nature of faculty culture and how certain aspects of it impede bibliographic instruction efforts.
