## Profile of Degree/Certificate-Seeking Entering Undergraduate Students, By Control and Level of Institution

Student attendance patterns at postsecondary institutions have changed over the last several decades. In particular, the proportion of college students who both enroll in a single institution for their entire education and begin their education as a full-time student (i.e., full-time, first-time students) has declined. Today less than a quarter of undergraduates are full-time students who attend only one postsecondary institution (Peter and Cataldi 2005; Snyder, Dillow, and Hoffman 2009).

The Student Right to Know Act requires institutions that participate in any student financial assistance program under Title IV of the Higher Education Act of 1965 (as amended) to disclose graduation rates. To assist institutions in meeting this requirement, the National Center for Education Statistics (NCES) collects these rates as part of the Integrated Postsecondary Education Data System (IPEDS) in the Graduation Rates component (GRS). The

cohort for this rate comprises all full-time, first-time, degree- or certificate-seeking students. Students' inclusion in the GRS cohort is based on their attendance status and degree/ certificate-seeking status at the time they first enter the institution. Subsequent changes in attendance status and degree/certificate-seeking status does not change students' inclusion or exclusion from the GRS cohort.

Many students are not captured in the GRS cohort. For example, the cohort excludes students who started their first semester part time or who transferred from another postsecondary education institution. Additionally, because most GRS cohorts are based on fall enrollment, full-time students who enroll for the first time in the winter/spring semester are excluded.

These Web Tables compare enrollment information for entering students included in the GRS cohort (full-time, first-time degree- or certificate-seeking

students) to three other degree- or certificate-seeking entering student groups: (1) part-time, first-time students; (2) full-time, transfer-in students; and (3) part-time, transfer-in students. The Web Tables present the distribution of these four student groups across institutions possessing different characteristics and by the gender and race/ethnicity of the entering student population. Specifically, these Web Tables provide information on:

- The distribution of entering degree/certificate-seeking undergraduate students by attendance status and type of institution by select institutional characteristics (tables 1, 2, and 3).
- The distribution of entering degree/certificate-seeking undergraduate students by attendance status and type of institution by gender (table 4).
- The distribution of entering degree/certificate-seeking under-

graduate students by attendance status and type of institution by race/ethnicity (table 5).

## DATA

Data in these Web Tables were collected primarily through the IPEDS Enrollment component. The Enrollment component collects the number of students enrolled as of the fall census date by gender, race/ethnicity, student level of study, and attendance status. Undergraduate students are further classified by student enrollment type. The analysis included Title IV institutions that reported undergraduate

enrollment data for fall 2009. Title IV institutions are those eligible to participate in the Title IV federal financial aid programs (e.g., Pell Grants and Stafford Loans). The tables in this report present the number and percentage distribution of undergraduate students by first-time student status, disaggregated by several institutional and student characteristics.

IPEDS is the core postsecondary education data collection program for NCES. Institution-level data are collected from postsecondary institutions in the United States (50 states and the District of Columbia) and other jurisdictions.<sup>1</sup> For IPEDS, a postsecondary institution is defined as an organization open to the public that has as its primary mission the provision of postsecondary education. IPEDS defines postsecondary education as formal instructional programs with a curriculum designed primarily for students who are beyond the compulsory age for high school. This includes institutions that offer academic, vocational, and continuing professional education programs and excludes institutions that offer only avocational (leisure) and adult basic education programs. Data collected via IPEDS cover a variety of areas, including institutional prices, enrollments, graduation rates, program completions, student financial aid, institutional finance, and human resources.

Reporting data to IPEDS is mandatory for institutions participating in Title IV financial aid programs. Title IV participating institutions are accredited by an

agency or organization recognized by the Secretary of the U.S. Department of Education, have a program of more than 300 clock hours or 8 credit hours, have been in business for at least 2 years, and have a signed Program Participation Agreement with the Office of Postsecondary Education, U.S. Department of Education. Institutions that do not participate in Title IV programs may participate in the IPEDS data collection on a voluntary basis; however, analysis in this report was restricted to Title IV institutions in the United States.

## TECHNICAL NOTES

The data in these Web Tables come from the IPEDS Institutional Characteristics and Enrollment components

from the 2009–10 collection. Institutional Characteristics data used in this report are available for all institutions. The response rate for the Enrollment component for institutions located in the United States was high – 99.9 percent. To mitigate the impact of non-response on statistics calculated from the Enrollment data, imputations were conducted prior to the public release of the data. The analysis in this report was performed using both the reported and imputed Enrollment data.

### American Indian or Alaska Native enrollment count

### Asian, Native Hawaiian, or Other Pacific Islander enrollment count

DVEFAPT

The count of students enrolled that self identify as having origins in any of the original peoples of the Far East, Southeast Asia, or the Indian Subcontinent, including, for example, Cambodia, China, India, Japan, Korea, Malaysia, Pakistan, the Philippine Islands, Thailand, and Vietnam, or in any of the original peoples of Hawaii, Guam, Samoa, or other Pacific Islands.

### Black or African American enrollment count

DVEFBKT

The count of students enrolled that self identify as having origins in any of the black racial groups of Africa.

### Control of institution

CONTROL

A classification of whether an institution is operated by publicly elected or appointed officials or by privately elected or appointed officials and derives its major source of funds from private sources.
