# Executive Summary

As an association of state student grant agencies, NASSGAP is acutely aware of the need to make college more affordable, to ensure that all families are aware of the many financial aid programs available, and to streamline the financial aid process. While national efforts to promote college access and simplification continue, it is important to note the many creative and crucial activities that take place at the state level to help students and their families understand and navigate the financial aid process. States across the nation are reaching out to their residents and are helping millions of students take steps to fulfill their educational dreams. The data in this report demonstrate the continued commitment of states to ensuring postsecondary student financial aid is available, accessible, and responsibly administered. Information in this report is based on academic year 2005-2006 data from the 37<sup>th</sup> Annual National Association of State Student Grant and Aid Programs (NASSGAP) survey of state expenditures for student financial aid.

## Data Highlights

- In the 2005-2006 academic year, the states awarded about \$8.5 billion in total state funded student financial aid, an increase of about 7 percent in nominal terms from the \$7.9 billion in aid awarded in 2004-2005 and an increase of about 3 percent in constant dollar terms.
- The majority of state aid is in the form of grants. In 2005-2006, just under 3.6 million grant awards were made representing about \$7 billion in need and nonneed-based grant aid, an increase of about 5 percent from the \$6.7 billion in grants awarded in 2004-2005. Of the grant funds awarded in 2005-2006, 73 percent was need-based and 27 percent was nonneed-based, the same percentage as seen in 2004-2005.
- Funding for undergraduate need-based grant aid increased \$223 million nationwide from about \$4.7 billion in 2004-2005 to more than \$4.9 billion in 2005-2006, an increase of almost 5 percent.
- Seven states (California, Illinois, Indiana, New Jersey, New York, Pennsylvania, and Texas) collectively awarded more than \$3.3 billion in undergraduate need-based grant aid, accounting for about 65 percent of all aid of this type.
- States provided more than \$1.4 billion in nongrant student aid, including loans, loan assumptions, conditional grants, work-study, and tuition waivers. Loans and tuition waivers accounted for 69 percent of nongrant funds awarded.

Forty-six reporting entities identified state-funded undergraduate programs with awards based solely on need, while 31 identified programs with awards based only on merit. Exclusively need-based aid constituted 49 percent of all aid to undergraduates, exclusively merit-based aid accounted for 20 percent, with the rest, 32 percent, accounted for by other programs and by programs with both need and merit components. The amount of undergraduate aid awarded in 2005-2006 through programs with a merit component increased to about \$2.6 billion. This compares to \$3.6 billion awarded to undergraduates through programs based only on need.

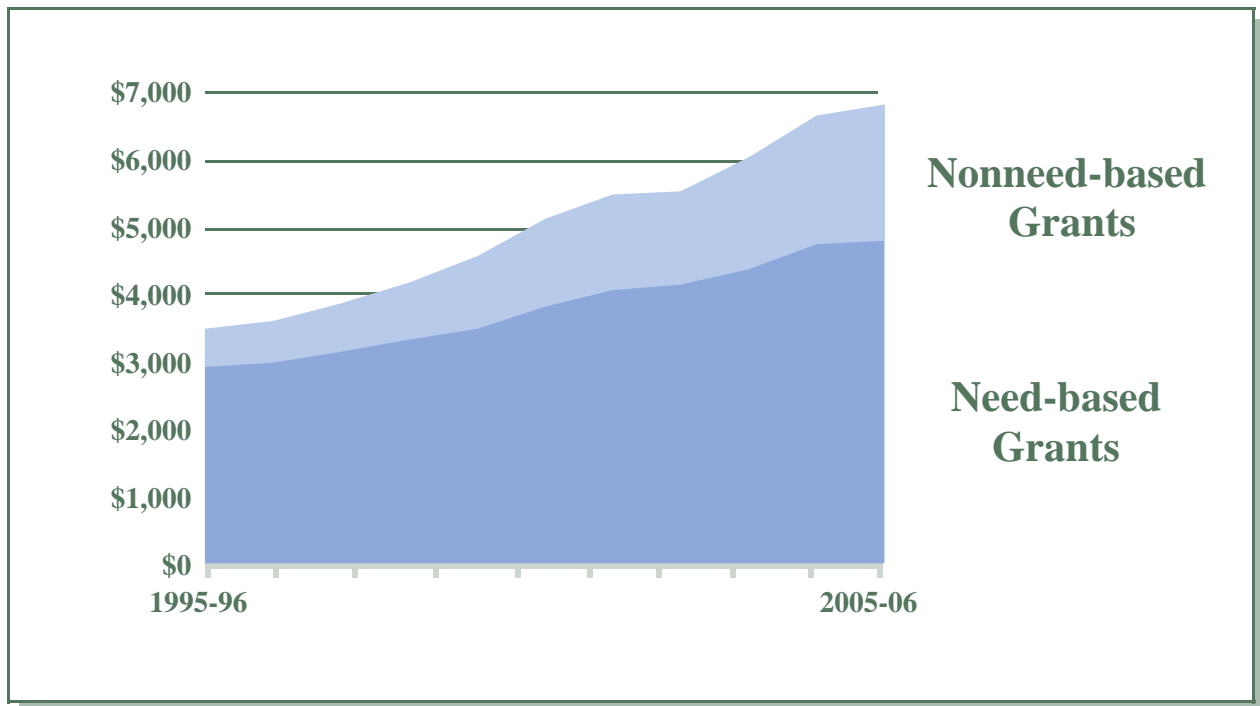
Washington DC, South Carolina, Georgia, New York, and Indiana, provided the greatest amount of grant aid on a per capita basis and the largest amount of aid per capita for the population between ages 18 and 24. South Carolina, Georgia, New York, Kentucky, and New Jersey provided the most undergraduate grant dollars compared to undergraduate full time equivalent enrollment. South Carolina, Vermont, Georgia, West Virginia and New York had the highest proportion of total expenditures for state-funded grants compared to appropriations for higher education operating expenditures.

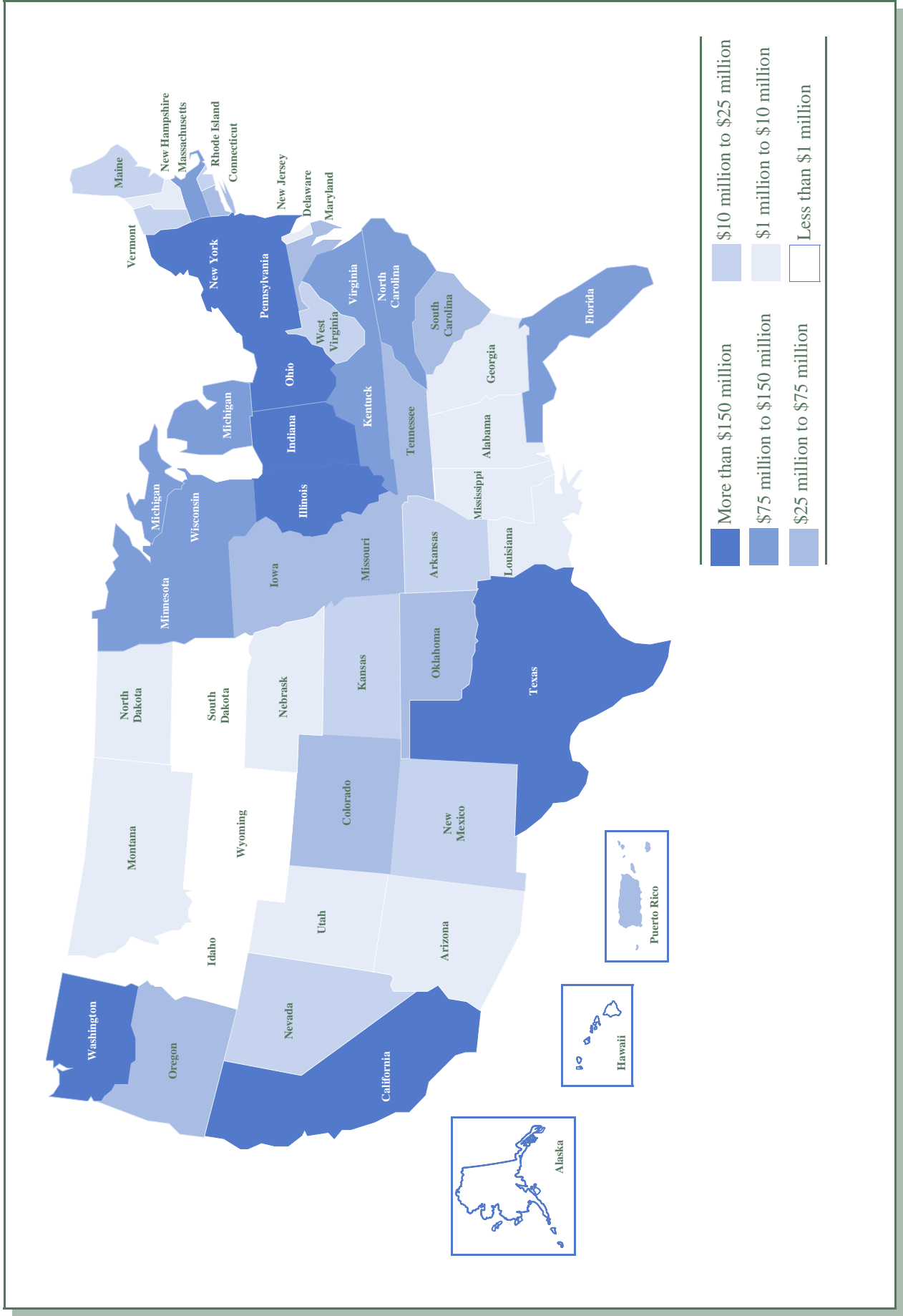

Constant dollars were calculated using the academic year correction of the Consumer Price Index, All Urban Consumers (CPI-U) from the U.S. Department of Labor, Bureau of Labor Statistics.

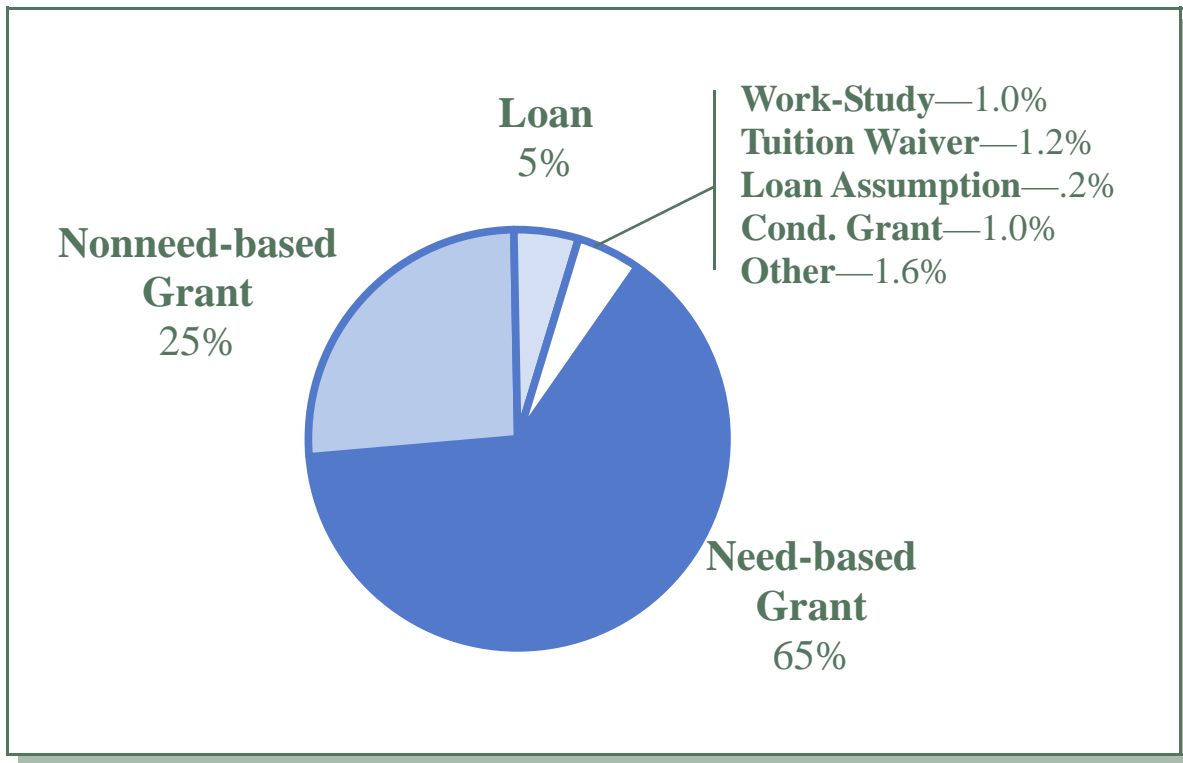

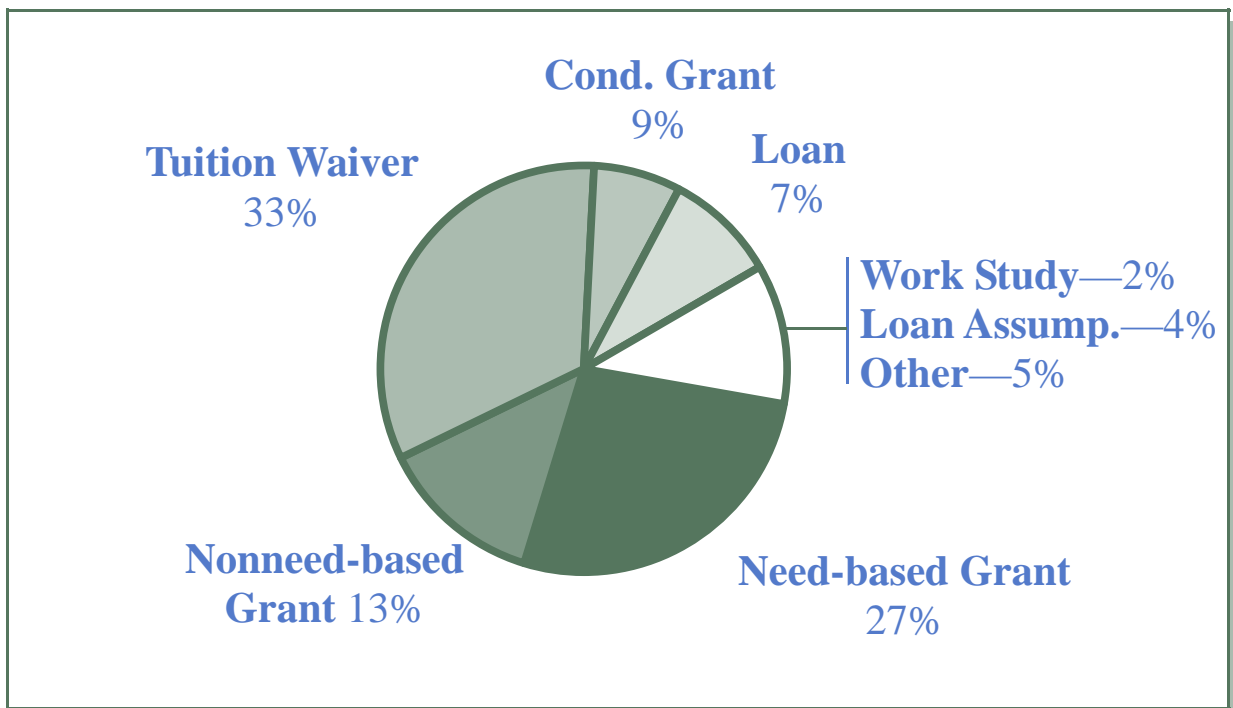

**Figure 1. Undergraduate Aid Dollars, by Type of Aid: 2005-06**

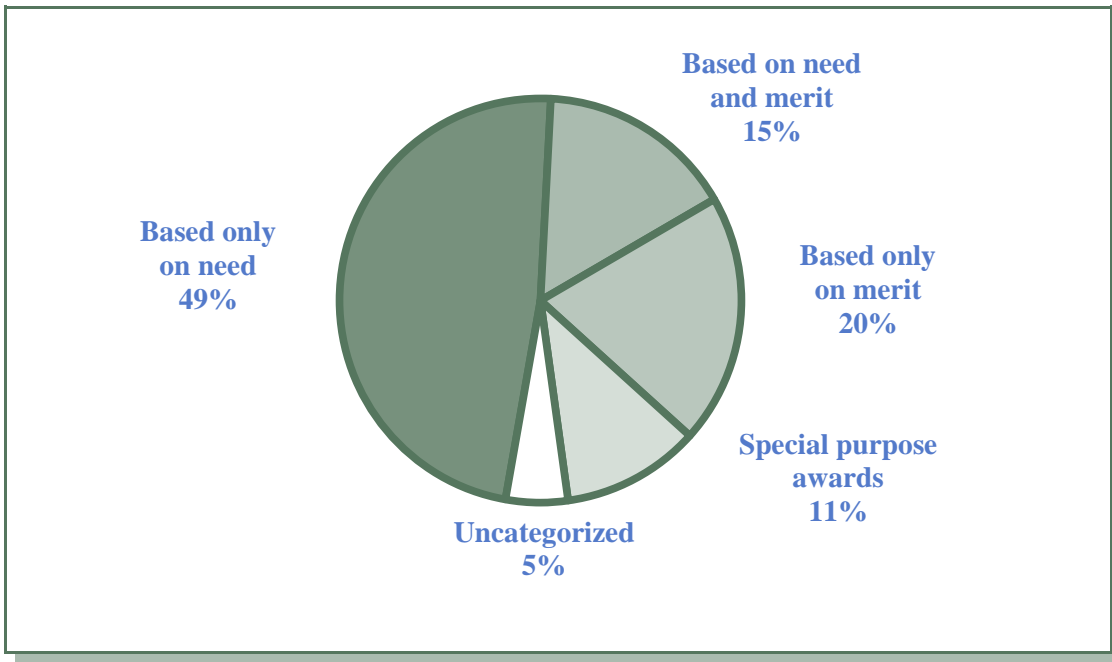


**Figure 2. Graduate Aid Dollars, by Type of Aid: 2005-06**

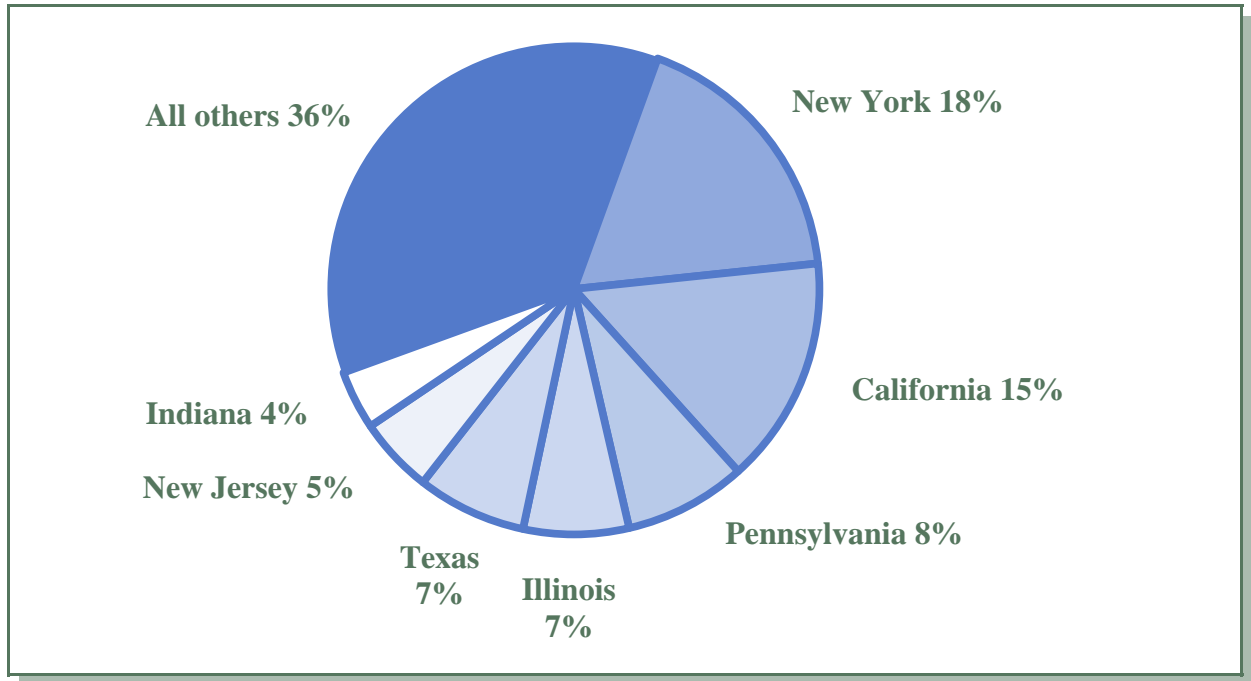

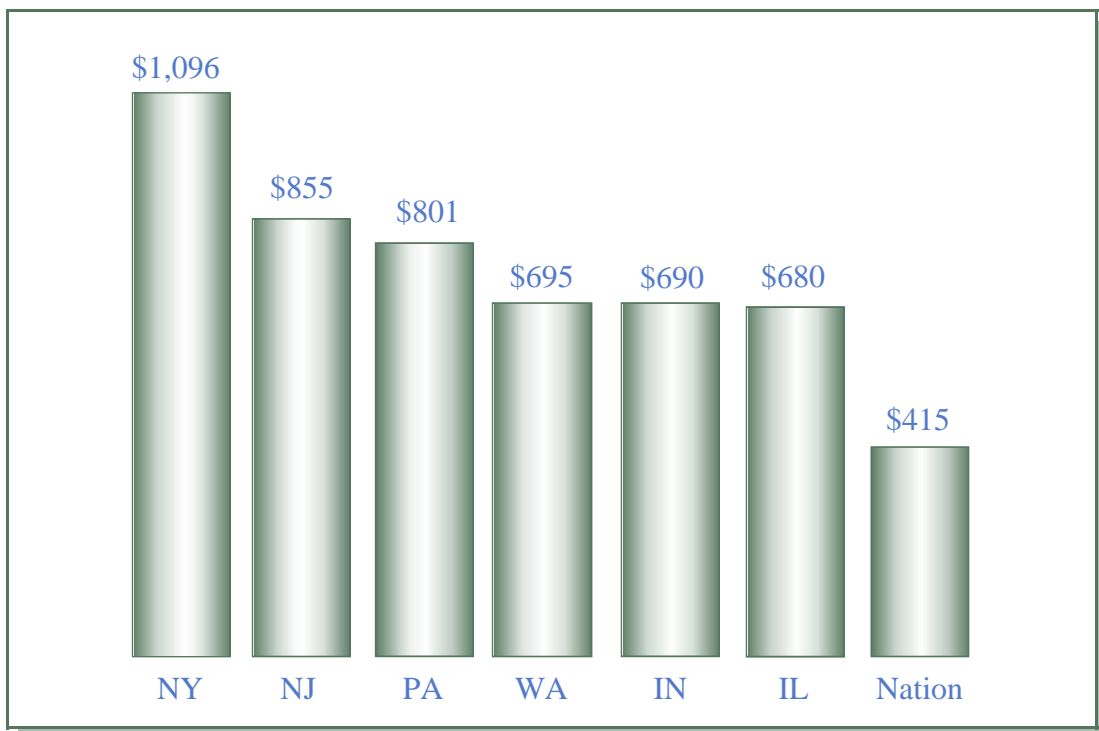

## About the Survey

The 37<sup>th</sup> Annual NASSGAP survey was completed by each state in Winter 2005-06. A PDF version of the survey instrument is available at [www.nassgap.org/survey/NASSGAP\\_Survey\\_Instrument\\_2005-06.pdf](http://www.nassgap.org/survey/NASSGAP_Survey_Instrument_2005-06.pdf). Terms used on the survey instrument include:

*Grant aid:* Includes grants, scholarships and other such gift aid.

*Need-based aid:* Recipients must meet some standard of need using such measures as EFC, remaining costs, or maximum income to be eligible for an award.

*Nonneed-based aid:* Recipients are not required to demonstrate financial need to be eligible for an award.

*Merit based aid:* Recipients are selected in whole or in part on the basis of test score, performance, class rank, grade point average, or other such criteria of achievement.

*Primary need-based grant program:* The flagship need-based grant program in a state. For some states (California, Colorado, Florida, South Carolina), the primary need-based grant program may be a combination of several individual programs.

*Tuition waiver program:* Program mandated or funded by a state in which all or a portion of a recipient's tuition at an eligible institution is not charged to the award recipient.

*Loan assumption or forgiveness program:* Program in which a recipient has the possibility of having a loan repaid or forgiven, in whole or in part, in exchange for fulfilling certain service obligations.

*Conditional grant or loan program:* Recipient receives an award, which will become a loan if certain obligations are not met.

*Special purpose program:* Program with specific objectives usually targeted to specific groups of students. Examples include workforce development programs in which recipients train for particular occupations, such as teachers and health and technical workers; retraining programs aimed at retraining unemployed workers; post-service programs offering benefits to veterans or National Guard members; and, parent or spouse service programs providing benefits to spouses or children of persons killed or disabled during service to the National Guard, police, fire fighters, military, corrections system, or other occupations.
