Profile of State College and Career Readiness Assessments (CCR) Policy

CCR assessment policy	South Carolina offers the PSAT or ACT's PLAN assessment to all tenth grade students as well as ACT's EXPLORE to all eighth grade students. However, the exams are not required for all students.
Purpose	According to the South Carolina Code of laws §59-18-340, "High schools shall offer state-funded PSAT or PLAN tests to each tenth grade student in order to assess and identify curricular areas that need to be strengthened and reinforced. Schools and districts shall use these assessments as diagnostic tools to provide academic assistance to students whose scores reflect the need for such assistance. Schools and districts shall use these assessments to provide guidance and direction for parents and students as they plan for postsecondary experiences."
	According to Proviso 1.27 in the 2011 General Appropriations Bill, "(SDE: PSAT/PLAN Reimbursement) Funds appropriated for assessment shall be used to pay for the administration of the PSAT, or PLAN, or WorkKeys test to tenth grade students to include the testing fee and report fee. The selection of the test for each student should be informed by the student's individual graduation plan (IGP) cluster selection, guidance counselor advisement and parent/legal guardian consent. SDE is authorized to carry forward into the current fiscal year, prior year state assessment funds for the purpose of paying for state assessment activities not completed by the end of the fiscal year including the scoring of the spring statewide accountability assessment."
	The South Carolina Department of Education also offers to all eighth graders the opportunity to take the EXPLORE test.
