
Reading 2013 Trial Urban District Snapshot Report

Overall Results


- In 2013, the average score of eighth-grade students in District of Columbia was 245. This was lower than the average score of 258 for public school students in large cities.
- The average score for students in District of Columbia in 2013 (245) was higher than their average score in 2011 (237) and in 2002 (240).
- The score gap between higher performing students in District of Columbia (those at the 75th percentile) and lower performing students (those at the 25th percentile) was 53 points in 2013. This performance gap was wider than that in 2002 (44 points).
- The percentage of students in District of Columbia who performed at or above the NAEP *Proficient* level was 18 percent in 2013. This percentage was not significantly different from that in 2011 (15 percent) and was greater than that in 2002 (10 percent).
- The percentage of students in District of Columbia who performed at or above the NAEP Basic level was 53 percent in 2013. This percentage was greater than that in 2011 (46 percent) and in 2002 (48 percent).





Score Gaps for Student Groups

- In 2013, Black students had an average score that was 64 points lower than White students. Data are not reported for White students in 2002, because reporting standards were not met.
- In 2013, Hispanic students had an average score that was 54 points lower than White students. Data are not reported for White students in 2002, because reporting standards were not met.
- In 2013, female students in District of Columbia had an average score that was higher than male students by 15 points.
- In 2013, students who were eligible for free/reduced-price school lunch, an indicator of low family income, had an average score that was 40 points lower than students who were not eligible. This performance gap was wider than that in 2002 (17 points).
