Subject: INFORMATION: Student Performance on the 2013 Assessment Program in Primary Reading (Kindergarten to Grade 2)

Between 2012 and 2013, the percentage of primary grade students who met or exceeded reading benchmarks on the Montgomery County Public Schools' (MCPS) Assessment Program in Primary Reading (AP-PR) remained above 90 percent for kindergarten students and showed a small decrease for Grade 1 students (84.9% to 81.9%) and Grade 2 students (74.1% to 72.6%) (Tables 1 and 2). The proportion of kindergartners who achieved proficiency at Text Level 6 decreased from 76.1 percent in 2012 to 73.6 percent in 2013. A small decrease in attaining Text Level 6 was found across all racial/ethnic groups except for kindergartners identified as two or more races; their percentage in attaining Text Level 6 increased by nearly 2 points. The largest decrease, 3.4 percentage points, was observed for Hispanic/Latino students.

In 2013, more than 90 percent of kindergarten students met or exceeded the grade-level benchmark at Text Level 4, which was consistent with percentages from the two previous years and showed an increase from 2006 of nearly 10 percentage points (Table 1). Between 2011 and 2013, the percentage of kindergarten students who met the benchmark remained steady for students identified as two or more races, but a slight decrease (less than 2 percentage points) was observed for all other racial/ethnic groups. With an increase of 17.3 percentage points from 2006, 73.6 percent of kindergarten students attained proficiency at Text Level 6 in 2013; there was a 2.7 percentage point decrease from 2011 to 2013. Across the three recent school years, a small decrease (2 percentage points or less) in the proportion of students attaining Text Level 6 was observed among kindergartners across racial/ethnic groups, except that the proportion remained similar for students reporting two or more races.

Approximately 82 percent of all Grade 1 students met or exceeded the grade-level benchmark of Text Level 16 in 2013, an increase of 6.3 percentage points from 2006; however, there was a decrease of 5.2 percentage points between 2011 and 2013 (Table 2). Across the three recent school years, the attainment of the Grade 1 benchmark remained the same for students identified as two or more races; the attainment decreased for all other racial/ethnic groups with a larger decrease for Hispanic/Latino and Black or African American students (decreased by 9.3 and 4.8 percentage points, respectively) than for Asian and White students (decreased by 1.8 and 1.6 percentage points, respectively).

More than 70 percent of all Grade 2 students met or exceeded the grade-level benchmark of Text Level M in 2013, an increase of 11.3 percentage points from 2006; however, there was a decrease of 1.6 percentage points between 2011 and 2013 (Table 2). Across the three recent school years, the attainment of the Grade 2 benchmark increased 2.8 percentage points for students identified as two or more races and decreased 3.4 percentage points for Hispanic/Latino students while remaining steady for other racial/ethnic groups (a change of 1 percentage point or less).
