Introduction

This document covers the data terms used in the VET in Schools 2016 summary publication and the Data slicer. The primary purpose of this document is to assist users to understand the specific data terms.

Terms that appear in the publication are listed in alphabetical order with the following information provided for each:

- definition: a brief explanation of the term
- classification categories: defined categories that apply to each term are listed, where applicable
- source: a description of the source of this information, including details of any calculations or derivations.

Unless stated otherwise, all data are sourced from the National VET in Schools Collection. The 2016 National VET in Schools Collection is governed by the Australian Vocational Education and Training Management Information Statistical Standard – AVETMISS VET Provider Collection Specifications: Release 7.0 (AVETMISS Release 7.0), which is available at <<http://www.ncver.edu.au>>. References to the applicable field definitions within AVETMISS Release 7.0, which further define the data collected, are provided in the Source column.

Terms that have a broader vocational education and training (VET) application have not been included in this document. Readers are referred to the *VET Glossary*, which is available at <<https://www.ncver.edu.au/support/support/glossary-of-vet>>.
