

The Roadmap of Need is an in-depth needs assessment for North Carolina youth, produced annually by the Public School Forum of North Carolina's Center for Afterschool Programs (NC CAP).

In 2010, NC CAP created the initial Roadmap, which included ten indicators related to afterschool programs, health care, job programs and other key initiatives for youth success. NC CAP expanded the Roadmap in 2013 to include 20 indicators of wellness across four domains: health, youth behavior and safety, education, and economic development. The revised Roadmap has been a key resource for afterschool providers communicating with policymakers, funders, and citizens about the importance of their services, and to target areas for increased investment. School administrators, central office staff, nonprofits, community leaders, and parent advocates also use the Roadmap to demonstrate to others the needs faced by their community. Public education advocates have brought Roadmap data to the attention of school board members, county commissioners, and members of the General Assembly, in order to inform their efforts to create state and local policies that address significant community needs.

This publication examines the 20 indicators of wellness in counties across North Carolina. These indicators contain relevant annual data demonstrating need across North Carolina, with each indicator being

used to identify where young people are most at risk of not succeeding, both in and out of school. All data points selected are updated annually, with the hope that this publication, along with future Roadmaps, can create a longitudinal dataset for county data on each indicator, the Roadmap provides rankings for each indicator and domain, as well as an overall ranking of all 100 counties that takes into account all of the data on all 20 indicators.

A note on NC CAP's methodology: all indicators are weighted equally in the calculations, but in reality some of these indicators may have a stronger influence on youth success than others. Additionally, it is important to recognize that other indicators could have been used. In order to come up with these indicators, NC CAP staff consulted with experts in each of the four domains, including those from the corresponding state agency for each domain, using their input to guide decisions about which data to include. Had different indicators been chosen, such as using the number of students that qualify for free and reduced priced lunch instead of median household income, the results would have varied slightly; however, the counties at the top and the bottom of the rankings would likely have remained the same.

Looking at the data, a troubling trend continues. Our state is becoming two North Carolinas - one populated by young

people living in areas that are attracting jobs and industry, and another populated by young people living in communities in a state of economic decline. At first glance, the Roadmap points to counties in eastern North Carolina as those most comparison. In addition to county-specific at risk. However, the nature of countywide indicators often masks the variation occurring within counties, particularly our most populous urban counties where neighborhoods that alone would fare well on the Roadmap indicators exist in close proximity to neighborhoods with many young people in need.

> The Public School Forum and NC CAP continue to advocate for public schools, afterschool programs and other expanded learning opportunities, and healthy, economically vital North Carolina communities. However, citizens and community organizations are in the best position to advocate for their schools and communities. The Forum hopes the Roadmap will serve as a resource as these individuals and groups meet with policymakers and local leaders, write grants, monitor programs, and seek resources for local communities. It is up to all of us. as North Carolina citizens, to use the data provided by the Roadmap to work thoughtfully and collaboratively to target resources most effectively to ensure that all North Carolina youth have the opportunity to succeed.

HOW THE CATEGORY RANKINGS WERE CALCULATED

In order to calculate the rankings, each county was given a rank of 1-100, either from lowest to highest or highest to lowest, depending on each indicator. For example, teen pregnancy rates were ordered lowest to highest, while physicians per 10,000 population numbers were ordered highest to lowest. Once we had rankings for all the indicators in the category, the indicator rankings were averaged for each county, giving an average of all health rankings. The counties were then ranked by this average, providing an Overall Health Ranking. This procedure was repeated for the categories of Youth Behavior & Safety, Education and Economic Development.



HOW THE OVERALL RANKINGS WERE CALCULATED

In order to calculate the overall rankings, we used a method very similar to the method used to calculate the category rankings. As for the category rankings, each county was given a rank of 1-100, either from lowest to highest or highest to lowest, depending on each indicator. For example, teen pregnancy rates were ordered lowest to highest, while physicians per 10,000 population numbers were ordered highest to lowest. Once we had rankings for all the indicators in the category, the indicator rankings were averaged for each county, giving an average of all twenty rankings. The counties were then ranked by this average, providing an Overall Ranking.

The map below depicts a disturbing trend. The illustration divides counties into four quartiles ranging from those that ranked highest on the Roadmap's needs assessment to those that ranked the lowest. Looking at the maps, the concern about two North Carolinas becomes apparent.




Quartile I (counties ranked 1-25)
