 Fall 2014 to Fall 2018

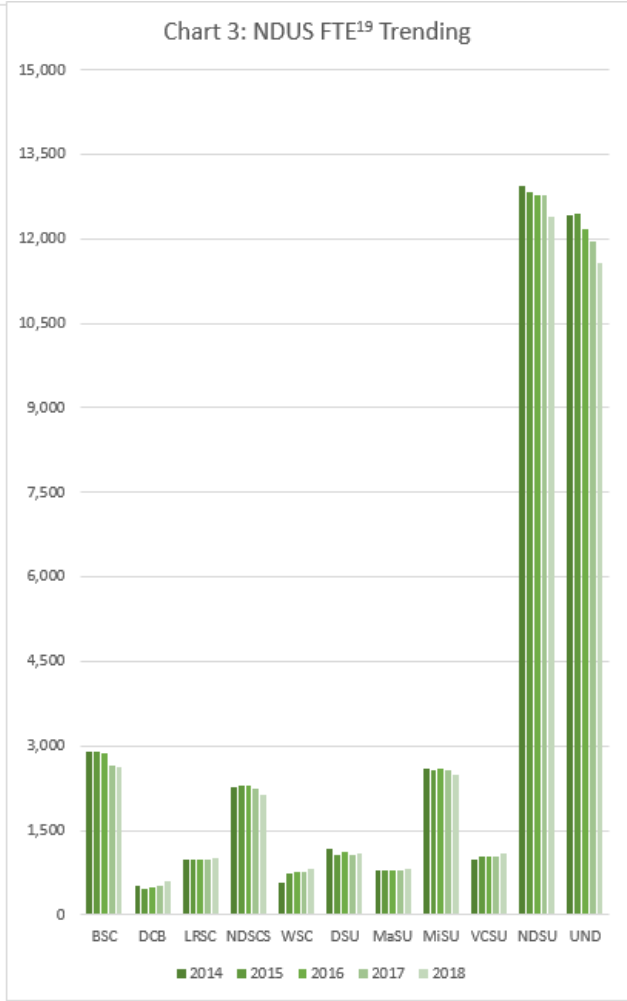
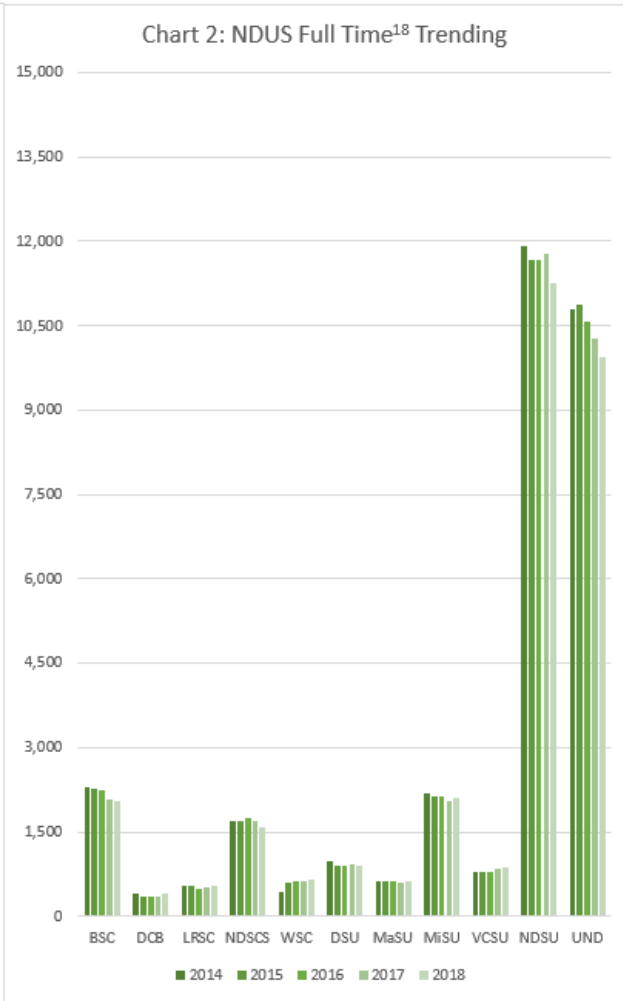
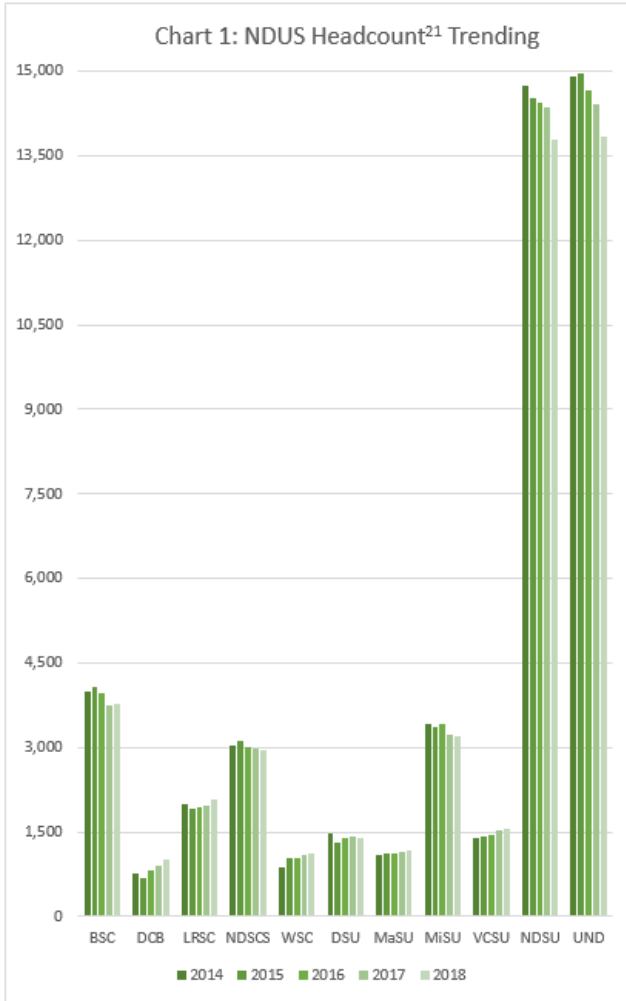

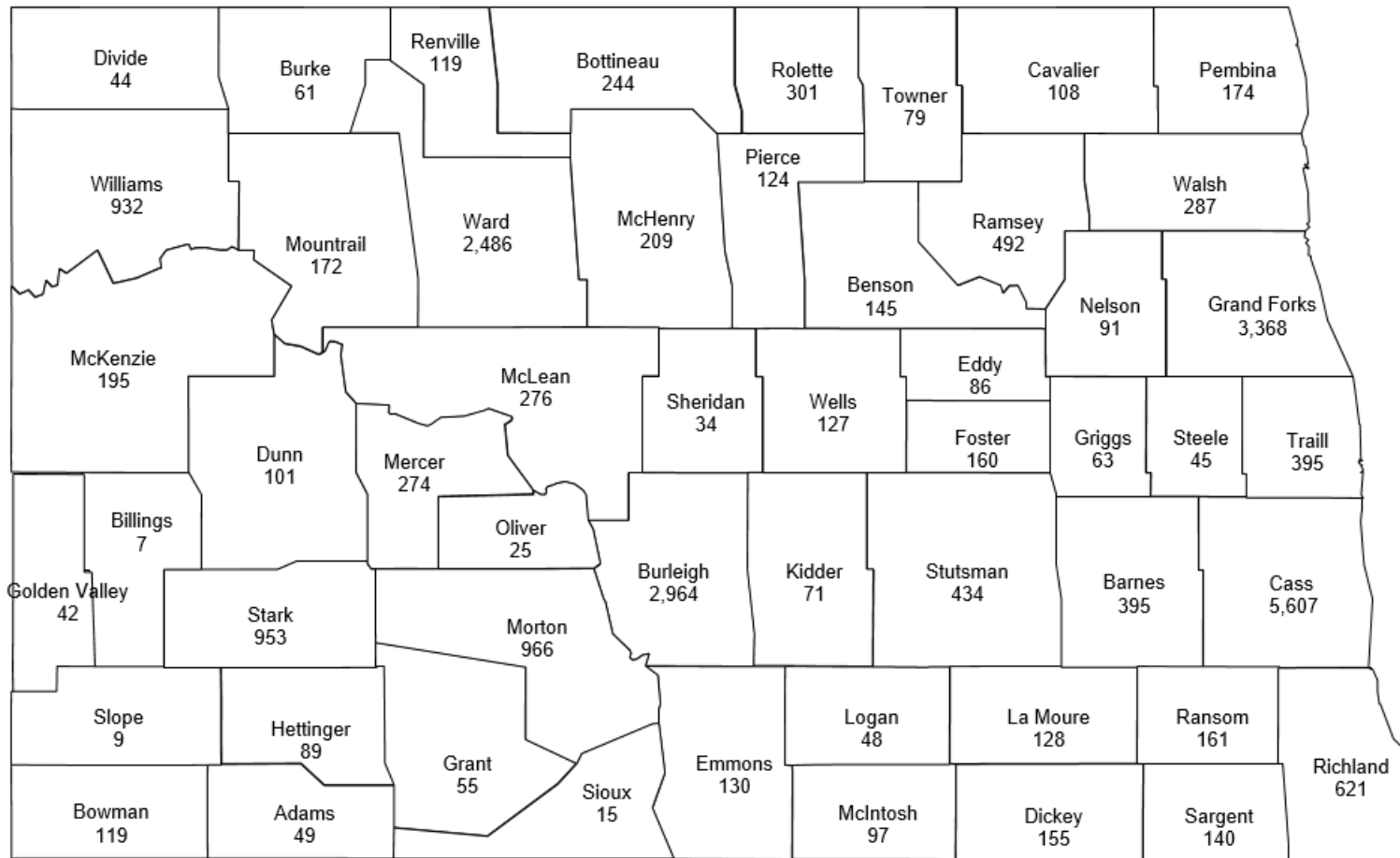

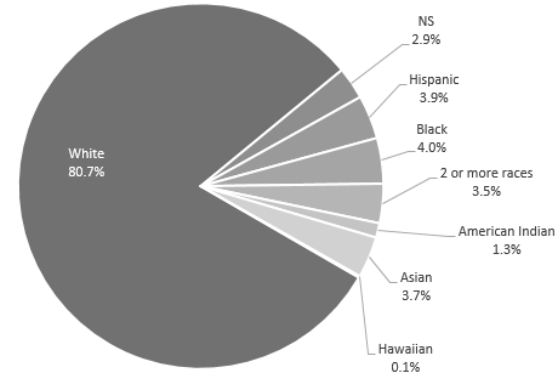

1	Age	Students' age is as of the 20th day of classes during the specified term. NDUS reporting truncates student age to whole year classification.
2	American Indian or Alaskan Native	Original peoples of North and South America (including Central America) who maintains cultural identification through tribal affiliation or community attachment.
3	APO AE/AP	A military post office address.
4	Asian	Having origin in the Far East, Southeast Asia, or the Indian Subcontinent, including, for example, Cambodia, China, India, Japan, Korea, Malaysia, Pakistan, the Philippine Islands, Thailand, and Vietnam.
5	Asynchronous Internet	Internet based class where instructor and students are not online at the same time.
6	Beginning Freshmen	Full-time/Part-time student attending any institution for the first time as a freshman. Since part-time students are included, this result is not the same as the IPEDS first-time full-time count.
7	Black or African American	A person having origins in any of the black racial groups of Africa.
8	Collaborative Enrollments	A student who enrolls in a course at a NDUS institution other than his/her home institution.
9	Combo	A course that uses a combination of both traditional face-to-face and e-learning.
10	Degree Credit	All institutional activities that can be applied toward college degree or credit based developmental or remedial courses taken by a degree-seeking student as reported to IPEDS.
11	Developmental Enrollments	Basic academic skills courses designed to prepare students to complete postsecondary academic degree-credit courses. Do not count as degree credit coursework.
12	Distance Education	Courses where a student is not located in a traditional face-to-face classroom on his/her home institution. Includes face-to-face off campus, correspondence, interactive video network, synchronous and asynchronous internet.
13	Duplicated	An enrollment count in which an individual student may be counted more than once because they are enrolled in more than one medium or more than one campus.

14	E-Learn/E-Learning	Instruction in an electronic format via the internet. Includes synchronous and asynchronous internet, and interactive video network (IVN).
15	Enrollments	A student counted as one enrollment in degree credit courses at each campus attending.
16	Face-to-face Off Campus	A classroom environment where the instructor and students are physically located in the same place in an off campus location.
17	FTE of Part Time	Full time equivalent enrollment of students enrolled in less than twelve credit hours as of the 20th day of classes.
18	Full Time (FT)	Undergraduate students enrolled in 12 or more credit hours or graduate and professional students enrolled in 9 or more credit hours (as of the 20th scheduled day of class).
19	Full Time Equivalent (FTE)	Student credit hours accumulated at the undergraduate level divided by 15 plus student credit hours accumulated at the graduate level divided by 12. Every professional student is counted as one FTE.
20	Graduate	A student who holds a bachelor's degree or first professional degree, or equivalent, and is enrolled in a graduate degree program.
21	Headcount Enrollment (HC)	A student counted as one enrollment in degree credit courses as of the 20th scheduled day of class.
22	High School Students Enrolled in College Courses	A high school student who enrolls in college courses. Includes both dual credit and early entry. Totals include only those students enrolled in college courses in the eleven NDUS institutions
23	Hispanic or Latino	Cuban, Mexican, Puerto Rican, South or Central American, or other Spanish culture or origin, regardless of race.
24	Independent Study	A correspondence course in which all communications between instructor and student is accomplished through the mail, email or fax.
25	Interactive Video (IVN)	Two way video system in which the participants can synchronously interact.
26	Midwest Higher Ed (MHEC)	A non-profit regional organization, established by compact statute, to assist Midwestern states in advancing higher education through interstate cooperation and resource sharing. Members are: Illinois, Indiana, Iowa, Kansas, Michigan, Minnesota, Missouri, Nebraska, North Dakota, Ohio, South Dakota, and Wisconsin.
27	Native Hawaiian or Pacific Islander	A person having origins in any of the original peoples of Hawaii, Guam, Samoa, or other Pacific Islands.

28	New Undergraduate Student Enrollments	Includes both incoming freshmen and undergraduate transfer, degree seeking students for the reporting term.
29	Non Resident Alien	A non-U.S. citizen or resident alien.
30	Not Specified	Student did not identify with a selected race.
31	Part Time	Undergraduate students enrolled in less than 12 credit hours or graduate and professional students enrolled in less than 9 credit hours (as of the 20th scheduled day of class).
32	Professional	A student who has completed a baccalaureate degree and is enrolled in a post-baccalaureate program leading to a professional degree in law, medicine, or pharmacy.
33	Race	Group or groups with which a person identifies or having origins as identified as valid values for IPEDS reporting.
34	Scheduled Credit Hours (SCH)	The sum of all course credit hours in which students are enrolled as of the 20th day of classes.
35	Synchronous Internet	Internet based class where instructor and students are online at the same time in order to interact.
36	Transfer	A student entering an institution for the first time but known to have previously attended a postsecondary institution at the same level. This student may transfer with or without credit.
37	Two or More Races	A person having more than one origin.
38	Unduplicated Headcount Enrollment	Removes duplicate enrollments of students across institutions or categories so they are only counted once. For instance, a student who is enrolled in two institutions at the same time would count as one student.
39	Western Exchange (WICHE)	A regional organization created by the Western Regional Education Compact and adopted in the 1950s by western states. WICHE was created to facilitate resources sharing among the higher education systems of the west. Members are: Alaska, Arizona, California, Colorado, Hawaii, Idaho, Montana, Nevada, New Mexico, North Dakota, Oregon, South Dakota, Utah, Washington, and Wyoming.
40	White	A person having origins in any of the original peoples of Europe, the Middle East, or North Africa.
