Annual Enrollment Executive Summary

The North Dakota University System (NDUS) Annual Enrollment Report is an effort to report system wide, unduplicated student headcounts for degree credit, non-degree credit, and non-credit enrollments across the eleven NDUS institutions for an entire academic year. The academic year is reported here as preceding summer, fall and spring terms.

The three credit types reported in this report are defined as follows:

- **Degree Credit** - instructional activities which result in the award of college credit that can be applied toward a college degree.
- **Non-Degree Credit** - instructional activities which result in the award of college credits, which typically cannot be applied toward a college degree. This includes remedial and continuing education coursework.
- **Non-Credit** - institutional activities, including Continuing Education Units (CEU) and TrainND activities, which do not result in award of college credit.

Table 1 provides the summative data for annual enrollment. Campus Solutions reporting has allowed identification of 65,962 unduplicated students enrolled across the eleven system institutions. Included in this are 7,405 first time degree seeking freshmen, 3,661 new transfer students, and 2,832 new post-baccalaureate (graduate) students, summarized in Tables 8, 9 and 10. Non-credit coursework reported by TrainND (Table 11) accounts for an unduplicated headcount of 16,008 across 1,830 participating businesses.

Totals are reported in the tables as **unduplicated**. Students are duplicated in institutional counts when they enroll in two or more separate institutions during the same term, i.e., they are counted at both institutions. Unduplicated system level totals counts students only once, regardless of whether students attend more than one NDUS institution. Likewise, students are duplicated in course delivery tables when they are enrolled in multiple courses with different delivery methods, i.e., they can be counted as both distance education and face to face, etc. Therefore in all report tables, unduplicated totals are not equal to the mathematical *sum of the row or column categories*.

Course Delivery Methods

Tables 2-5 provide a breakdown of enrollment by course delivery method. Delivery methods are the formats in which course content is conveyed from instructor to student. NDUS has seven delivery methods, shown in the hierarchy below in green. Blue boxes show delivery method categories.



NDUS SBHE Policy 440 (Enrollment Reporting) defines Full Time Equivalencies (FTE) as follows:

For fall and spring terms, FTE of undergraduates means total degree credit hours divided by 15; FTE of graduates means total degree credit hours divided by 12; every professional student is counted as 1 FTE. For summer terms, FTE of undergraduates means total degree credit hours divided by 12; FTE of graduates means total degree credit hours divided by 9; every professional student is counted as 1 FTE. On an annual basis, FTE of undergraduates means total annual degree credits divided by 30; FTE of graduates means total annual degree credits divided by 24; every professional student is counted as 1 FTE.

Early Entry students in their first term of taking college course are counted in Table 8B, along with other non-degree seeking, first term freshmen. When Early Entry students enter college after high school graduation, they are recategorized
