EDITORIAL

Preventive measures for avoidance of injury related to sport are to be encouraged and we received an excellent reminder of this in the Adolphe Abrahams memorial lecture by Professor Eriksson at the 1984 Congress. It is, however, important to evaluate preventive measures, particularly with respect to equipment where fashion rather than function may dictate the use of certain items. There is a considerable amount of literature to support the use of mouth guards to reduce dental trauma and to reduce concussion by dissipation of the force of a blow to the jaw. Thus, it is somewhat surprising to learn from the study by Professor Carstens and colleagues that in the rugby players studied by them, the use of mouth guards did not influence injuries. It is pointed out that much published work relates to American football, for which there is legislation requiring the use of mouth guards as is also the case for ice hockey in the United States. A recent study by Garon et al (JADA 1986 112: 663-665) studying a variety of sports suggested there was a role for the use of mouth guards. They found that no fractured teeth occurred in any of the sports considered other than American football when mouth protectors were used but did occur when mouth protectors were not used. They did not however study rugby football and perhaps the lack of benefit in the study reported in this journal relates to the particular group studied. It is also perhaps, as the author suggests, that adequate education of the players may

contribute to their findings. An alternative and additional factor may be the actual type of mouth guard used and this is not discussed. It reminds us that what is found for one sport may not apply to another and that in evaluating equipment not only is it necessary to be specific with regard to the particular equipment, but also to the group studied.

Assuming that the work of others supporting the value of mouth guards in sports other than rugby is correct, then mouth guards are more likely to be used when they are inexpensive and widely available. That described by Chandler and colleagues potentially provides such a mouth guard but as they point out it now requires evaluation with regards to its benefit.

Shortly Congress '87 will be upon us with reminders for abstracts and booking elsewhere in this journal. The annual Congress of the Association is a time when members can present their work, either in its preliminary stages or prior to publication. It also provides a forum for informal exchanges of ideas and meeting with colleagues with similar interests. The Adolphe Abrahams memorial lecture will be given by Professor Ernest Jokl, co-author of the well-known text on exercise at altitude. The title is still to be announced. It is hoped that as many members as possible will support this year's Congress which has what promises to be a most interesting programme.



SPORTING IMPLICATIONS OF PODAL DUPUYTRENS DISEASE

A sportsman with bilateral plantar masses which reached from the dome of a normal arch to the floor (Fig. 1), was referred for orthopaedic consultation owing to foot pain on exertion. Two years prior to his referral he had lacerated both feet while accidentally running barefoot over glass. At that time debridement and skin suture was carried out. These plantar masses had been present for about 2 years but wearing sports shoes had eleviated all pain. Foreign body granulomas were suspected although the X-rays

showed no glass. Under general anaesthesia with a great amount of difficulty part of one mass was excised. A histological diagnosis of Dupuytrens disease was made on the basis of fibroblastic proliferation, alternating with bands of hyaline representing early and established fibrous tissue (Fig. 2).

This case report highlights the trauma-mediated onset of the disease.

Palmar and plantar fibromatosis was first described by Dupuytren in 1832. Although the aetiology is unknown the disease has a familial inheritance with males being more commonly affected. The incidence of plantar disease alone is very rare and although Dupuytrens disease has been reported in the feet more than 50% have concomitant findings in the palms.

The disease often starts in the second decade of life. Its onset may be triggered off by trauma. With regard to treatment, little agreement can be found on this subject. The conservative view reflects the rate of recurrence after surgery and stresses the need to refrain from surgery while the aggressive surgical opinion insists that unless a total fasciectomy is carried out an unsatisfactory result will occur. Between these two extremes a subcutaneous fasciectomy was suggested by Luck and partial fasciectomy being another limited procedure.

Whether the decision is to operate or not is not the point of this communication. Once a diagnosis of Dupuytrens disease has been made and knowing that the onset of pathology is related to trauma it is necessary to reflect upon the type of sport such an individual is capable of.

The Rt. Hon. Lord Porritt of Wanganui and Hampstead, GCVO, GCMG, CBE, FRCP.

At the Annual General Meeting on 9th May, 1987 the Right Honourable Lord Porritt was elected as Patron of the British Association of Sports Medicine. We thank Lord Porritt for his continuing interest in the affairs of the Association. For the benefit of more recent members of the Association, we reprint below some biographical information originally published in 14: 2 & 3 on the occasion of Lord Porritt's retirement from the presidency of BASM. ARTHUR ESPIE PORRITT was born on 10th August, 1900 in Wanganui, New Zealand. From Wanganui Collegiate School he progressed to Otago University and thence, as a Rhodes Scholar, to Magdalen College, Oxford and St. Mary's Hospital, London. President of the Oxford University Athletic Club 1925-26, he held the track record for the 100 and 220 yards hurdles, together with the 100 yards record for the Oxford v Cambridge Match, with the more than creditable time of 9.9 secs. Competing in the 100 yards Olympic Final in Paris in 1924, he took the Bronze Medal. His appointment as Captain of the New Zealand Team in Paris in 1924 and again in Amsterdam in 1928 was followed by his selection as Manager in Berlin in 1936. His active interest in the administration of athletics has continued as a member of the International Olympic Committee and the British Olympic Committee.

His distinguished career as a surgeon included many appointments, culminating in his election as President of the Royal College of Surgeons 1960-1963, during which period (1961) he was elected an Honorary Fellow of Magdalen College. The British Medical Association awarded him the Gold Medal in 1964, and he was Sergeant Surgeon to Her Majesty the Queen. He gave further outstanding service as Governor General of New Zealand 1962-1967. A Baronet in his own right, he was made a Life Peer in 1973 and took the title of Lord Porritt of Wanganui and Hampstead. Together with a number of other forwardthinking individuals he founded the British Association of Sport and Medicine in 1953 and was elected the first Chairman. On the death of Sir Adolphe Abrahams in 1967 he succeeded to the Presidency. His outstanding ability as an administrator has guided the Association for twentyseven years. His gentle but firmly authoritative manner is a hallmark such as few men can carry. His advice has been eagerly sought and freely given. It is unlikely that many men will ever have such a beneficial effect in the cause of sport and medicine as Lord Porritt.

HON. TREASURER'S REPORT - FOR YEAR 1st JANUARY TO 31st DECEMBER, 1986

The end of 1986 also marked the end of the old unincorporated BASM and January 1987 heralded the opening of financial dealings of the new Limited Company with Charity recognition. This has led to a certain amount of confusion, not only within the membership of the Association but also with the bank. It has been necessary to open new accounts for the limited company whilst retaining the accounts of the old BASM until the final winding up can be completed. Sorting out early payments into the new Association received late in 1986 and late payments for the old Association received early in 1987 has been a difficult task and is not complete yet. As we have had to start 1987 as much as possible with a clean sheet several large credits and debits normally carried over to the next year have had to be attributed to the correct year and this has made the financial position appear much worse than it actually is.

Looking at the Income and Expenditure Account there is an apparent drop of over three thousand pounds in sales of the British Journal of Sports Medicine. Payments made in advance in 1985 for 1986 were included in the 1985 accounts but advance payments at the end of 1986 for 1987 which would normally have been dealt with in a similar manner were rightly credited to the new limited company. The thousand pound drop in advertising revenue was due to an agency failing to renew the contract for the four centre pages as the drug companies have had to reduce their advertising expenditure drastically.

Most of the items have changed little from the previous year; administration and wages have increased a little; the Hon. Secretary has had to purchase filing cabinets and we have acquired a display stand for use at Conferences; typewriters are showing overuse stresses and the business of winding up one body and starting another has meant more committee meetings and therefore more travelling expenses. The professional charges of £760 are mostly due to solicitors for drawing up the new Constitution and negotiating with the Charities Commission, Companies House and the Inland Revenue. The amount estimated for Tax on interest on the deposit account for 1986 has fallen as we have had to draw on the deposit account to offset losses. The nine and a half thousand pound deficit is ample explanation for the need to make such a large increase in the subscription rate but £35 a year compares very favourably with most similar membership associations publishing a quarterly journal which costs the association roughly £5,000 per issue.

On the Balance Sheet the increase in the amount of current liabilities is again due largely to the need to allow for the payment of the December issue of the journal in 1986 instead of carrying it forward to the next year as has been our previous practice. We therefore had to pay for five issues in 1986 instead of four. Negotiations are still in progress over our liabilities for back tax.

The Treasurer anticipates a much better financial state in 1987 as 50% of our members have transferred to the new association and we have over sixty new members.

He would like to express his gratitude to Mrs. Olga Harris who has done all the day-to-day invoicing, banking and keeping the accounts, and to Messrs Armitage and Norton, our accountants.

The unfortunate illness of our Hon. Secretary could have caused major disruption but he has continued to do as much work for the Association as he could, even from a hospital bed and has been helped by his secretaries, Mrs. Julie Oliver and Mrs. Kath Wilkes.

Several types of communications will be considered for publication by the Editorial Board.

- 1. ORIGINAL ARTICLES, reporting research, experimental work, innovations in therapeutic procedures, etc.
- REVIEW ARTICLES on special topics which should include an adequate, but not exhaustive, bibliography.
- ABSTRACTS of verbal communications given at scientific meetings.
- ANNOTATIONS, case reports, preliminary reports of research, and of pilot studies, usually not exceeding 400 words.
- 5. CORRESPONDENCE, 'letters to the Editor'. 6. CONFERENCE REPORTS from Area organisations of
- B.A.S.M., or of other meetings with direct relevance to the work and interests of B.A.S.M. members.
- NOTICES of forthcoming events relevant to Sports Medicine.
 OBITUARY NOTICES concerning B.A.S.M. members and
- OBITUARY NOTICES concerning B.A.S.M. members others distinguished in Sports Medicine.

SUBMISSION OF MANUSCRIPTS

These should be sent to the Joint Editor, Dr. A. E. HARDMAN, Department of Physical Education and Sports Science, University of Technology, LOUGHBOROUGH, Leics. LE11 3TU.

© The submission of a paper implies that it is unpublished, and has not been submitted for publication elsewhere. The copyright of articles is held jointly by the British Association of Sport and Medicine, who publishes the Journal, and by the author(s). No articles from this journal should be reprinted, in English or translation, without permission from both publisher and author(s), but no objection is made to a single photocopy being made for educational or research purposes.

Two copies of each manuscript should be submitted. They should be typewritten, double spaced, on one side of the paper only, in English, with conventional British spelling.

The title of the paper should be typed in capitals, with the name and principal qualifications of the author(s), e.g. "FRCS", "DipPE, PhD", "MSc(Psych)", "MB, BS, PhD" or "MCSP", then the appointment held, the department and the institution in which the work was carried out. If the author has moved since the work was performed, his present address should be added as a footnote.

In general, manuscripts should be prepared in accordance with the recommendations of the International Steering Committee of Medical Editors, the "Montreal Agreement". A booklet is obtainable from the Editor, British Medical Journal (50 pence), or Annals of Internal Medicine, 4200 Pine St., Philadelphia for U.S. authors.

AN ABSTRACT not exceeding 150 words should follow the heading of a long paper. This should include the chief points made in the paper, and the main conclusions drawn or suggested. On the advice of the Editorial Board, a communication may be published in abstract only. Following the Abstract, some three to six KEY WORDS should be inserted to assist with indexing.

NOMENCLATURE. Drugs should be specified by their official name, followed by the trade name and manufacturer's name in brackets if well known and widely prescribed under its trade name. Doses should be in metric measurements. S.I. units should be used, except for measurements of blood pressure, which should be in mm. Hg. Conversions from one system of measurements to another should be rounded off, and unnecessary demical places should be avoided. REFERENCES mentioned in the text should give the name of the author, or first author followed by 'et al' for multiauthor papers, with the date of publication in brackets, e.g. Wright et al (1976). In the reference section, the authors' names should be arranged in alphabetical order, followed by year of publication, title of paper, journal, volume number, and first and last pages, e.g. Wright, G., Clarke, J., Ninimaa, V. and Shephard, R. J. 1976 "Some reactions to a dry-land training programme for dinghy sailors" Br.J.Sports Med. 10: 4-10. For text-book references, the author, editor, year, title of chapter, title of book, edition number, publisher, and city of publication should be given. Our retention of the Harvard System of references is our only major deviation from the recommendations of the Montreal Agreement.

ILLUSTRATIONS should preferably be drawn on card in indian ink, with labelling lightly in pencil, or written or typed well clear of the actual drawing or graph. Good quality half-tone photographs may be used if suitable for reduction to fit the space allocated. Coloured photographs will only be reproduced in half-tone and X-ray plates and transparencies cannot be guaranteed to give adequate reproduction. If necessary, a second photograph with arrows or lettering should be included, as a guide to the block-maker. Figures are numbered in Arabic numbers.

Authors are reminded that they are responsible for clearing copyright on any figures, tables or other matter already published elsewhere, and the Editor may require written authorisation to the author from the copyright holder. He may also require signatures on the letter accompanying MSS from ALL the contributors of multi-author papers.

PROOFS:— It is the responsibility of the author/s to check proofs carefully and return them to the Editor without delay. Any extensive re-setting of type could be charged to the author.

REPRINTS

It is regretted that we cannot supply authors with free reprints. Orders for reprints should be made on submission of the manuscript, or when returning the proofs. The exact cost cannot be given until publication, but as a guide we are currently charging, for 100 copies,
