If you did express and interest and sign up, you will get notified the ballot is opened. You have to be an SA member or pay the ballot fee. Becoming an SA member entitles you to unlimited ballots.

Question: How does certification program intersect with standards development process? There is an intent to bring them together. Unusual ordering of doing things with the certification starting first. Leaders of expert groups last year were also either chairs or co-chairs of the related standards working group. Request to include as annex to standard a short piece describing ECPAIS bias certification activity – currently trying to figure out a good way of doing that, which would have to go to ballot for approval. There is also an intention to do a review of how well both of these activities have been aligning with each other, when 7003 gets towards the end, to identify any last tweaks we might want to do. And the certification will hopefully refer to 7003 which should be published by then.
