I. Presentation by Ali Hessami on EPCAIS

Ethics Certification Program for Autonomous Intelligent Systems. AIS Transparency, AIS accountability, are completed. Developing specialized criteria for different sectors. Working on translation of P7000 into SMART criteria that facilitates conformity assessment and linking between ECPAIS and standards. Consideration of P7001, 7002, 7003, 7010 for this transformation.

Question – What is the relationship to several ISO/IEC standards?

They mostly address issues other than ethics. Some materials from ECPAIS are to be published soon to allow us to compare. ECPAIS has more of a focus on how to

define a lack of bias rather than process to achieve it. ECPAIS criteria are going to be published as an "ontological specification" in the coming weeks to enable us to refer to them in our work. Suggestion that an appendix is added to P7003 that discusses the alignment. Discussion of the difference between the programs - P7xxx are more process, ECPAIS is to check on outcomes.
