Example of C_p given in which 'p' indicates the word 'pressure' not a variable, such that by the rules provided in 5, the 'p' is upright roman, not italicized. This is consistent with IEEE Std 280. Determined to change 'at constant pressure p' to 'at constant pressure' – omitting the 'p' which implies a variable.

- b) D15: 5 Alphabets and typography Corrected missing references by adding bibliographic entries for ISO 80000-2, and ISO 80000-13.
- c) D15: 6 Remarks concerning quantity symbols
 Deleted this section; 4.1 already directs reader to IEEE Std 280.
- d) D15: 7 Remarks concerning unit symbols
 Deleted this section; 4.2 already directs reader to IEEE Std 260.1.
- e) D15: 9 Reference documents Changed to 'Convergence of industry conventions.
