IEEE downloads site changed to a zip file until a folder with loose files. We have 17 standards with downloads. Would need corrigenda to amend the 17 standards if they don't change the site.

Creates a problem for folks that can't open or download zip files.

I&M and AES Society designated representative – haven't heard from Joe Stanco. Talking to IEEE to see if we can get a new liaison. Would be nice to know what those societies are doing since they are 2 of the 3 sponsors of this organization.

Attendance – IEEE is concerned that there aren't more people attending. Also concerned that people aren't buying the standards. IEEE's view is that DoD is not interested because they are not participating. Concerns

- Not buying standards
- Not attending meetings

What is chair going to do to fix this?

Is the download material being used? Is it being modified? Conversation with LMC about derived work. Is there more of this being done?

Website needs update. [Teresa] will volunteer to update the website

1671 Standards – would need 9 PARs to update all the standards and recommended practices. IEEE says you need a minimum of 10 people in the working group. This is not a viable option. Only address the base document one more time. Only non-breaking changes should be incorporated.

AI-ESTATE: no further action on 1232 standard

RFI: no further action on 1505 family of standards

Prognostics for ATS: working group will be formed in the April timeframe. Working group effort will be occurring over the next 4 years. P2848 will initially meet electronically.

Corrigenda for 1671.1 – working group will be formed. Mike would like this balloted in 2020. Didn't make the standards board meeting.

Corrigenda for 1636.1 – working group will be formed at this meeting.

1641 work being chaired by Chris. No plans to update the users guide. UK MoD is interested in Users guide – helps answer the question of how do I use the standard.

SCC20 and Working Group operations manuals need to be updated. Mike will see these through AudCom and Standards board. Annual Report – due January 24, 2020

E-mail from Val – wants to know how he can generate interest in what he is doing and how he can help.



Mike will chair for one more year and then transition to Malcolm. Mike will do the operating manuals.

Since the 19-1 Meeting in April

- **IEEE Std 1505.1-2019:** The Standard for the Common Test Interface Pin Map Configuration for High-Density, Single-Tier Electronics Test Requirements Utilizing IEEE Std 1505™
 - Published August 20, 2019.
- **PAR for P1671.1 Cor 1**
 - This was approved by Steering in April.
 - PAR is on the November 5-7 Standards Board Meeting Agenda.
- **PAR for P2848:** Standard for Prognostics and Health Management in Automatic Test Systems
 - Electronic Steering Meeting was held Sept 9-13.
 - PAR is on the November 5-7 Standards Board Meeting Agenda.

- **IEEE Download Site Discussions**
 - Every SCC20 Based Standard, that has download site associated material, contains a clause in the standard explaining the contents of the site.
 - The IEEE changed the download site contents to only contain a .ZIP file.
 - Every subject SCC20 standard (there are 17 standards with download site material) may need an amendment or corrigenda or revision.
- **IEEE I&M and AES Societies Designated Representative Discussions**
- **SCC20 & Working Groups Attendance**
 - Our Numbers are Typically Low; How am “I” Going to Get More People in Seats.
- **Modifications to Downloaded Material**



Upcoming Standards Activities

After this 19-2 Meeting

- **The SCC20 Web Site:**
- With the Exception of the Upcoming Meetings and Minutes; the site is approximately 4 years out of date.
 - I could use a volunteer to help maintain the site
- **All ATML Standards and Recommended Practices:**
- I Estimate 9 PARs and 15-20 volunteers to get them ready for a 'mass' ballot.
 - I don't see this as a viable option.
 - I suggest we only address the 1671 Base Document one more time.
 - If there are any changes, only non-breaking changes should be incorporated.
- **AI-ESTATE:** No further action on the 1232 Standard or Users Guide
- **RFI:** No further action on the 1505 based Standards

Upcoming Standards Activities

- **Prognostics for ATS:** WG will be being formed. WG efforts related to the subject will be occurring over the next 4 years.

- **Corrigenda for 1671.1:** WG will be being formed. I would like to see this in IEEE Sponsor Ballot in 2020.
- **Corrigenda for 1636.1:** WG will be formed at this meeting. I would like to see this in IEEE Sponsor Ballot in 2020.
- **STD Revision:** Complete 1641 WG efforts and move to Sponsor Ballot, Comment Resolution, and Publication
 - Before the PAR expires in December 2020.
 - STD Users Guide Revision? (1641.1)




