

Standards Activities since the 21-1 Report

- Revision of 1641.
 - Initial Sponsor ballot has been conducted.
 - Comment resolution group was formed.
 - Began work addressing comments the end of March.
 - There will be a recirculation ballot.
- Corrigenda for 1636.1.
 - The corrigenda is not ready to be submitted to SCC20 Steering for approval to move to MEC.
 - I suggest a meeting of the WG at the SCC20 22-2 meeting.
- Corrigenda for 1671.1.
 - The corrigenda is not ready to be submitted to SCC20 Steering for approval to move to MEC.
 - I suggest a meeting of the WG at the SCC20 22-2 meeting.
- P2848 Prognostics and Health Management for ATS.
 - Work commenced in 2021 through monthly WebEx meetings.



Standards Activities since the 21-1 Report

- Last fall we agreed to keep the ATML Standards active.
 - Both the Seven 1671 Standards and the Two 1871 Recommended Practices
 - Do we want to create and submit 9 PARs to SCC20 'steering' and NesCom "now"?

SMDCs are established by the IEEE SA Board of Governors (BOG) to address strategic focus areas that are necessary and critical for the IEEE SA to achieve long-term organizational objectives.



 IEEE S&SI Ad Hoc on Transitioning SCC's into S&SI SMDC. (2 of 4)

- Kickoff meeting was April 13, second meeting was May 4.
- Ad Hoc Scope:
 - "To guide the transition of former SASB SCCs [SCC14, SCC20, SCC21, SCC39] into Standards Committees reporting to the S&SI SMDC, including updating their operating procedures into the current Standards Committee baseline, and addressing issues such as appointment/election of officers, appeal procedures, default corrective action for dominance, and timing/methodology for reporting."

Note: the IEEE-SA Permits the SCCs to operate under their current P&Ps until December 31, 2022, or until acceptance by AudCom/SASB of updated P&Ps, whichever is sooner.
