5.1 P7011 – Standard for the Process of Identifying and Rating the Trustworthiness of News Sources

Slow progress is being made. Additional member has joined the working group. It is not clear what the timeline for completion is.

5.2 P7012 – Standard for Machine Readable Personal Privacy Terms

COVID-19 is making it difficult to progress. Progress has been made as activities are now focused on the essence of the PAR. Drafting is now the center of the work. Timeline for completion yet to be finalized, possibly early part of next year.

5.3 P7014 – Standard for Ethical considerations in Emulated Empathy in Autonomous and Intelligent Systems

Meeting are been held and progress is been made.

6 PARS FOR APPROVAL

The following PARs were put out for electronic vote. Returns due by 26th May. Actions 17/1 and 17/2 completed.

P2890: Recommended Practice for Provenance of Indigenous People's Date

P2895: Standard for Trading Human-Generated Data

Concern was expressed that the PAR definitions were too general. As the PARs are out for vote, the way forward will be determined after results are tallied.

7.1 Biometric Data for Identification
