# 8 OTHER BUSINESS

# 8.1 SC and WG Membership Inclusion and Diversity

At the last meeting, the SC considered the issues surrounding membership inclusion and diversity. A summary of the issues is given below.

- i) Is there a membership recruitment process that does not descend into tokenism?
- ii) Are their structural barriers, e.g. meeting times, technology, that inhibit membership diversity?
- iii) Does the issue require the dominate social group to reflect on their accepted norms?

- iv) Is data being collected to highlight the issues surrounding inclusion and diversity?
- v) What steps can SC, WG and SG members take to improve the inclusion and diversity of their respective committees?
- vi) Does the current WG leadership training include the issues of inclusion and diversity?
- vii) Should a SG be established to examine the issue?

It was agreed that better standards would be developed if there were greater inclusion and diversity on standard's SC, WG and SG. This is especially true if the standard under development will/could have a direct impact on a minority/disadvantaged groups.

To progress this issue there is a need to engage with decision makers. Additional work also needs to be undertaken to define the problem and how to improve outcomes. To progress this issue the Chair will have a discuss with John Havens, Executive Director of The IEEE Global Initiative (Action 20/1).

# 8.2 Ethical Design of Standards

Concern was raised that the development of standards may not follow best practice with respect to ethical design. The goals of Ethically Aligned Design Version II are encapsulated in the following general principles:

- Human Rights: Ensure they do not infringe on internationally recognized human rights.
- Well-being: Prioritize metrics of well-being in their design and use.
- Accountability: Ensure that their designers and operators are responsible and accountable.
- **Transparency:** Ensure they operate in a transparent manner.
- Awareness of misuse: Minimize the risks of their misuse.

It was not clear to those in attendance if the IEEE standards development process has been reviewed in light of the advances in ethically aligned design knowledge and principles.

It was agreed to leave this topic on the agenda of future meetings.
