The current plagiarism report is available a supplementary file in your author console under Microsoft CMT portal.

- B. All manuscripts declared under 'Major revision' / 'Minor revision' should be revised and submitted according to the following instructions:
- 1. All submissions must strictly follow IEEE Conference Template, available at <a href="https://www.ieee.org/conferences/publishing/templates.html">https://www.ieee.org/conferences/publishing/templates.html</a>. Please check the specifications of figure resolutions at the IEEE Template. Please note that registered papers not matching with IEEE Conference template will *not* be sent for uploading to the IEEEXplore Digital library.
- 2. The changes in the revised manuscript as per the review comments must be coloured with a different coloured font for easy identification. Do not indicate deletions, only new inclusions/alterations need to be marked.
- 3. The maximum manuscript length is 6 pages. If the length exceeds 6 pages to incorporate the revisions, the authors may judiciously adjust the lengths of sections / subsections keeping the spirit of the discussion intact. The revision file will be in PDF format only.
- 4. For manuscripts listed under 'Major Revision', the authors need to prepare an 'Author Compliance', where the authors must provide a response against each review comment and the revisions made in the manuscript in the following format:

- 9. All revisions must be submitted through the Microsoft CMT Portal. No email communication will be entertained for submitting the revised manuscript and author compliance.
- 10. All the revisions will be evaluated for plagiarism using Cross-Check (from i-Thenticate). The revisions exceeding 30% similarity score (excluding bibliography and references) will be rejected without further communication.
