

## IEEE Toledo Section, Davis-Besse Tour Event Registration:

**Our tour is confirmed for Thursday, November 7 starting at 5:30 pm.**

**Attached are the guidelines for the tour.** Attendees need to be aware that there is **considerable walking, including stairs**. Also, everyone does need to go through a security screening checkpoint, similar to an airport.

Regarding security and background checks:

- 1) Attendees **must** be a U.S. citizen to tour the plant. **No exceptions** allowed.
- 2) **RSVP By Thursday, October 17<sup>th</sup>**. We must provide a list of attendees in advance so the plant security can perform background checks. For each person, we must provide:
  - Full name (first, middle initial, last)
  - Social Security number
  - A copy of a state or federal government-issued identification (driver's license, passport, etc.).Note: attendees must still bring the original identification with them to the tour that night

## **GUIDELINES FOR DAVIS-BESSE NUCLEAR POWER STATION TOURS**

### **PRIOR TO VISTING:**

Send a copy of your state or federal government-issued identification (driver's license, passport, etc.) along with full Social Security Number (SSN) and country of citizenship to your Davis-Besse site contact. You must be a U.S. Citizen to tour Davis-Besse.

### **WHAT TO WEAR:**

#### Clothes:

- Dress business casual
- Long pants (jeans, khakis, or similar)
- NO shorts, sweatpants, or excessively baggy clothing
- Jewelry should not be worn in the plant

#### Shoes:

- Must be of sturdy construction
- Soles of rubber; uppers of leather, vinyl, or similar material
- NO sandals, high-heels, open-toed or open-backed shoes, athletic shoes with canvas uppers, etc.

#### Personal Protective Equipment (PPE)

- PPE will be provided by Davis-Besse
- PPE includes: hard hat, gloves, safety glasses, hearing protection
- Visitors are responsible for wearing the appropriate clothing to the site.

### **WHAT TO BRING:**

- The state or federal government-issued identification of which you previously sent a copy
- Your Social Security Number. You do not need to bring the SSN card, but you must know the number and be able to tell it to the Security Officer processing your visitor access.

## GUIDELINES FOR DAVIS-BESSE NUCLEAR POWER STATION TOURS

### **BEHAVIOR:**

- **Be professional!** Davis-Besse is an industrial facility with continuous work activities.
- **Be alert!** Hazards will be identified prior to the beginning of the tour, but this does not preclude changing work site conditions. Be aware of your surrounds to minimize the risk of injury.
- **Be respectful!** Employees of Davis-Besse have important jobs to do. Do not impede their ability to work. Listen to any instructions given by Davis-Besse personnel.
- **Be engaged!** The staff members that have organized the tour have done so on their own time outside of work. Show them your appreciation by asking questions, showing enthusiasm, and listening to instructions.
- **No pictures or cell phones!** In the plant areas. Cell phones could interfere with plant equipment. Pictures can only be taken with permission.

### **RESPONSIBILITIES:**

- Wear your visitor badge on the outermost garment above the waist
- The number side of the visitor badge shall face outward at all times
- Remain with your escort at all times
- If separated from your escort, IMMEDIATELY notify any badged individual and have that individual contact the Central Alarm Station (CAS)
