## **EDWARD D. CARL**

### **- A Retrospective**

#### **In Memory of A Colleague No Longer With Us**

For more than 30 years, Ed Carl had been a Systems Engineer specializing in technical, project and business management of computerized systems - from micros to mainframes. He spent the last 18 years as an Engineering Consultant.

Equally at home with both hardware and software, he had expertise in business, industrial, aerospace, and military systems working for such companies as Autonetics, Logicon, TRW, and Ford Aerospace.

Ed's ability to quickly grasp the "big picture" and then focus in on real problem areas made him a valuable consultant to such companies as Boeing, Honeywell, Hughes, Leach, Northrop, Rockwell, and many smaller companies.

In 1993, he co-founded the Orange County IEEE Consultants' Network (OCCN) as part of a nationwide initiative of the Institute of Electrical and Electronics Engineers (IEEE). Serving as Chair in 1997, his vision and leadership propelled the OCCN to become the largest and most active IEEE consultants' network in the country. The OCCN is open to consulting engineers and firms in ALL engineering fields. It is based on the principle that "networking, the sharing of ideas, experiences, referrals, resources, and extra workload, are all good for business".

The current members of OCCN hope to make the group itself a lasting legacy of Ed's tireless efforts. He recently started and led the Toastmasters Working Group, of OCCN, which has just begun to flourish.

Ed was 1998 Vice Chair of the OCCN, and was active in the Orange County IEEE Section, Orange County Engineering Council (OCEC), and Irvine Unified School District Science Alliance. He was also a Fellow of the Institute for the Advancement of Engineering. In addition to IEEE, he was also a member of the AIAA. Recently, he was honored with the President's Award by OCEC. He attended the University of California, Berkeley and Cal Poly, Pomona.

He died in his room November 17<sup>th</sup> of apparent heart failure. He was only 52. Ed is survived by his wife, Marilyn, and three children.

He will be sorely missed by them, and by all his friends and colleagues at OCCN and in IEEE. Undoubtedly there will not be another like Ed Carl.

I remember the time he shared his experience and life with me in the early stage of forming the TMWG, when there were only a handful of people attending a meeting. He constantly encouraged me to be persistent in whatever I wanted to pursue. He inspired me to dream of wonderful things. Indeed he was my teacher. I wish that he rests in peace. Although he has left us, his character, teaching and spirit should remain within our hearts and we should continue his mission.

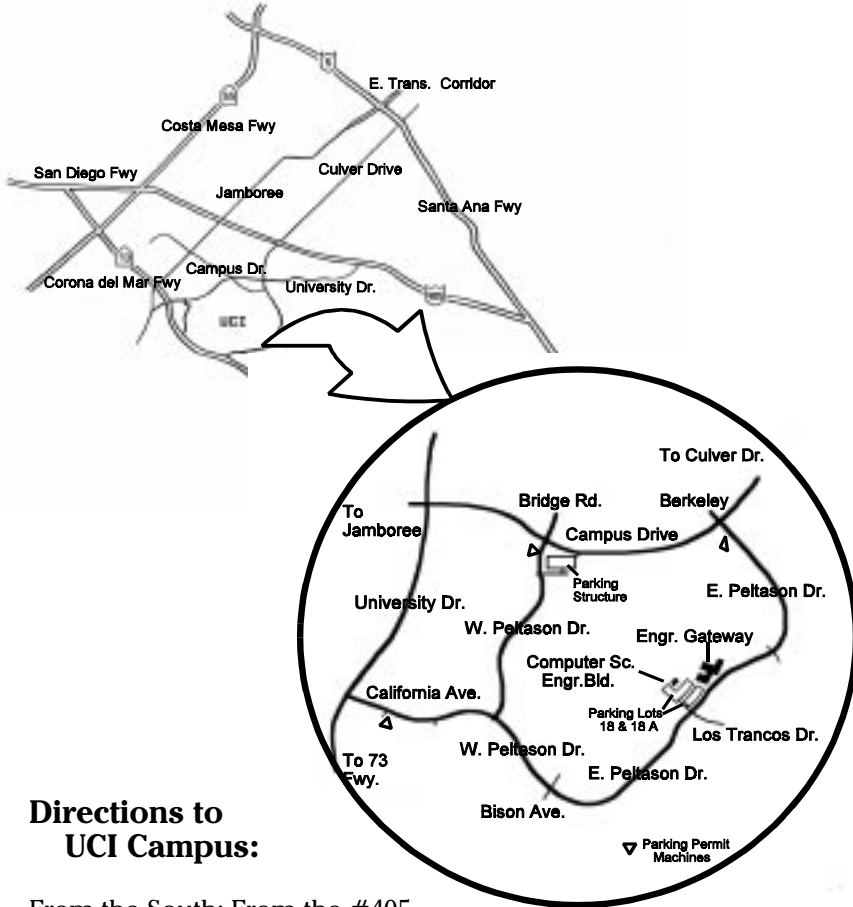

## “The Y2K Countdown - is ON”

### The Development and Implementation of Y2K Strategies

The panel of speakers will cover a range of Y2K technical and experiences of interest to those that need to deal with or be knowledgeable in these areas. An overview of the use of using a Logic Analyzer as a means of determining whether an embedded processor is functioning as intended. And will demonstrate methodology of a testing application using an analyzer for a specific chipset used in imbedded systems. Another will cover a technical presentation on “Year 2000 Problems in Embedded Systems”. Embedded microprocessors and Programmable Logic Controllers (PLCs) are found in valves, switches, control systems, security systems, etc. There are hundreds of millions of such “embedded systems”, and they represent a significant portion of the world’s Year 2000 problem. Systems analysis on large complex plants with thousands of embedded systems and experiences learned to date will be presented.

The Air Force has mandated every one of its systems to be Y2K-Certified. The Y2K Certification Process is embodied in the Air Force Certification Tracking Document which covers specific data collection parameters for each Y2K Phase (Awareness, Assessment, Renovation, Validation, and Implementation). The parameters are used to update the Air Force Automated Systems Inventory DataBase (AFASI) which in turn is used to report Y2K progress to the Air Force, OMB, GAO, Congress, and DoD. An overview briefing of this certification process and will emphasize the renovation and testing aspects. And the last speaker will give a technical overview of the risk analysis of dealing with systems failures and formulating a plan to act to protect your operations and business interest.

Murray will highlight learned failures from testing experienced to date, and some of the unexpected quarks that appeared after reviewing the test data and analysis procedure’s. This talk will highlight nuclear industry procedures and guidelines for Y2K activities. And as a final perspective, a review of risk properness strategies that should be developed as a proactive measure “after the failure occurs”, to have preparedness plus corrective action and response procedures in place. This plan may very well be the last response as your Y2K counter measure; its performance may save your company twice. And probably will be reviewed and gauged over and over again at the trial, or trails.

There will be a question and answer Q/A session at the end of the program to present your questions and experiences to the panel. ## A BRIEF LIST OF OCCN OFFICER DUTIES AND RESPONSIBILITIES

### CHAIR

Provides leadership of the network. Conducts general membership meetings and formal board meetings. Appoints committee and working group chairs as required. Represents OCCN at outside functions, or appoints appropriate representative. Solicits volunteers for supporting functions not assigned to Board members. Advises Board of all decisions affecting policy or assignments. IEEE membership is required.

### VICE CHAIR

May act for the chair, when the Chair is absent and not available. May represent the OCCN at outside functions. Takes on special assignments, such as making meeting arrangements. Greets new members at the meetings and help them make contacts within the membership to start the networking process. IEEE membership is required. Prepares for taking on the Chair position in the future.

### SECRETARY

Records all formal actions and votes taken at the main meeting and the executive board meetings. Handles

official correspondence. Provides follow-up of actions taken or assigned at previous meetings. Prepares and distributes agendas for general and Board meetings. Distributes meeting minutes in advance of next Board meeting. Monitors distribution of member badges at OCCN meetings. IEEE membership is required.

### TREASURER

Prepares the OCCN budget. Collects member fees and makes approved disbursements. Maintains membership records. Maintains appropriate financial records. Provides fiscal balance to Board activities. Periodically reports on financial status of OCCN. IEEE membership is required.

### EDITOR

You must have the following to qualify: a private practice consultancy with a formal business name, licenses, business-like phone and active e-mail address. If you don't qualify at that level, you can become an "Associate" member for \$45. You will not be listed in OCCN promotional materials but will be listed in our membership at the associate level, and will be able to participate in all other activities.

...(Dr. Koskinen) staff. They expect the Federal government to belatedly admit the seriousness of the Y2K problem, I mean opportunity. Some agencies expect to be ready for the 1 Jan 2000 change in about the year 2004 to 2008. There are no reports from the Electrical Power Grids (in the middle of deregulation disruptions and the consequent lack of responsibility for operations) nor from the computer controlled Trucking Systems that deliver food to the supermarkets. The bureaucrats are feeling guilty that they haven't warned people adequately.

Actually, I feel that the Y2K crisis is similar to Earthquake Preparedness, which we are all familiar with in Southern California. However, in this case we know WHEN the disruption will start, not how severe or how wide-spread the damage will be. Both cases endanger water, electricity and food supplies. Those who don't prepare must be thought of as victims, in the vernacular of the politically correct. They are victims of Consequence Deficit Disorder and many are beyond help. Like victims of gambling disorders (who feel they might win, so they really ought to play) the Y2K victims feel they might not be hurt, so they plan to wait and see if they are OK. The last Earthquake didn't hit THEM, so they will probably be all right

Our Engineering training would indicate that when we are faced with a real threat, a prudent engineering approach would be to protect from major damage by relatively low-cost, low disruption alternatives that would be beneficial in a variety of emergencies. In any emergency we need a little extra cash, a modest amount of food storage that doesn't need refrigeration, some home defense in case law and order breaks down for a while, and maybe some emergency electrical power. Many of us who are amateur radio operators have small gas driven generators for use in maintaining communications during emergencies and we hold emergency drills to keep these skills sharp. Power loss as a result of a Y2K disruption is just another example of the use of an emergency power generator and you could run a refrigerator for a few hours or days or run a fan to blow warm air around the house (Y2K hits in January, remember?) if you have a gas furnace.

You just have to look at the positive side of all opportunities to see the benefits of modest preparations for all kinds of emergencies. A good engineer that practices what he preaches should never be described as a person with Consequence Deficit Disorder.

Rick Nelson is rounding up some good candidates for our election of officers in December. Why don't you call him and offer to take one of the elected positions in your OCCN. The most important thing we can do in life is help others and one of these jobs is not as much work as it provides in rewards to you for giving some of your time to a worthy cause. ## A BRIEF LIST OF OCCN OFFICER DUTIES AND RESPONSIBILITIES

### CHAIR

Provides leadership of the network. Conducts general membership meetings and formal board meetings. Appoints committee and working group chairs as required. Represents OCCN at outside functions, or appoints appropriate representative. Solicits volunteers for supporting functions not assigned to Board members. Advises Board of all decisions affecting policy or assignments. IEEE membership is required.

### VICE CHAIR

May act for the chair, when the Chair is absent and not available. May represent the OCCN at outside functions. Takes on special assignments, such as making meeting arrangements. Greets new members at the meetings and help them make contacts within the membership to start the networking process. IEEE membership is required. Prepares for taking on the Chair position in the future.

### SECRETARY

Records all formal actions and votes taken at the main meeting and the executive board meetings. Handles official correspondence. Provides follow-up of actions taken or assigned at previous meetings. Prepares and distributes agendas for general and Board meetings. Distributes meeting minutes in advance of next Board meeting. Monitors distribution of member badges at OCCN meetings. IEEE membership is required.

### TREASURER

Prepares the OCCN budget. Collects member fees and makes approved disbursements. Maintains membership records. Maintains appropriate financial records. Provides fiscal balance to Board activities. Periodically reports on financial status of OCCN. IEEE membership is required.

### EDITOR

Responsible for content, publication and distribution of the monthly OCCN newsletter, and any special publication for wide distribution. Recruits and manages staff and vendors for publication. Newsletter delivery is to be approximately one week prior to the main meeting by primarily electronic means, and postal means where necessary. May solicit articles from the membership, or other responsible sources. Provides appropriate newsletter materials for OCCN Web page. Responsible to the Executive Board for newsletter format, budget, expenses, policy, and circulation. Reports expense history to Board periodically. Doesn't have to be a member of IEEE. However, membership is encouraged.

### REPRESENTATIVES-AT-LARGE (2)

This is a new office with no regular functional responsibilities. Expected to serve as advisory members of the board. May be responsible for special projects as required. Don't have to be a members of IEEE. However, membership is encouraged

### **“Teaming For Success”**

#### **Achieving The Advantages and Avoiding The Pitfalls**

Teaming, partnering, and strategic alliances can have a profound effect on the success of small companies. Successful teaming can quickly provide a sorely needed capability for short and long term needs such as: accommodation of larger markets and contracts, capitalization, marketplace and sales presence, technical capability, manufacturing capabilities, and an endless variety of reasons.

Mr. Allen will describe a process for going about this, and in a creative manner that promotes success while avoiding the pitfalls. ## WESCON TRAFFIC ALERT

(Reference: L.A. Times, O.C. Section, Sunday, August 30, 1998, pp B1-2)

If you are going to attend WESCON at the Anaheim Convention Center, you need to take into account that there is considerable construction (improvement?) underway in the vicinity of the Convention Center and Disneyland. Many Santa Ana Freeway (I-5) off-ramps in the area will be closed during the convention. These specifically include those at Katella Avenue, Anaheim Blvd., Harbor Blvd, West St., and maybe Euclid Street (the latter is supposed to be reopened 9/15/98). Also, for those of you using the Riverside/Artesia Freeway (SR-91), the off-ramps at Harbor and Lemon will be closed. Katella Ave. at the north edge of the Convention Center is a part of the construction zone. Since I was personally unsuccessful in a web search for viable and assured alternate routes, you need to work out your own routes carefully and allow extra time for getting to the Convention Center

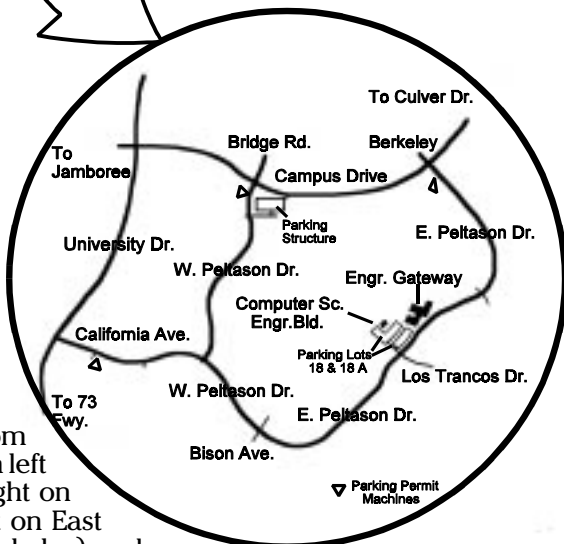
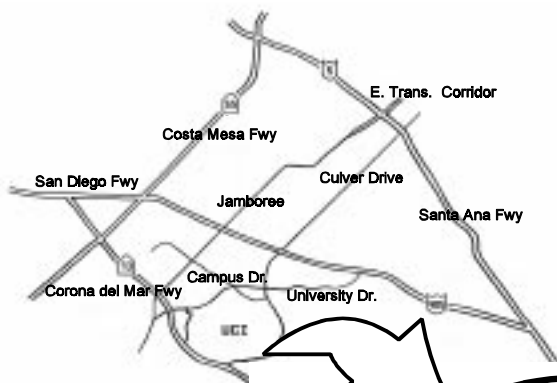
