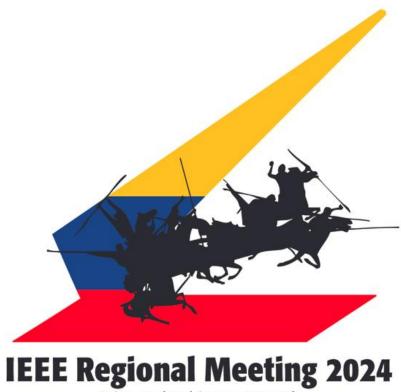

Robert Rules - Gerardo Barbosa

- The presentation covered meeting procedures based on Robert's Rules of Order, including making motions and seconding motions.
- It explained the process of adjourning a meeting, which requires a second, may be debated, and needs a majority vote.
- The concept of raising a point of order to address rules violations is highlighted, emphasizing the Chair's ruling.
- A meeting scenario is presented to illustrate the sequence of motions like amend, refer, postpone, adjourn, and recess.
- Proper meeting etiquette is emphasized, such as raising hands, stating motions clearly, and directing comments to the Chair during debates.

Code of ethics - Alberto Sánchez

- The speaker highlighted the importance of the IEEE Code of Ethics in guiding ethical behavior in the engineering and technology community.
- It emphasized the principles of fairness, respect, and integrity, including the prohibition of discrimination and harassment.
- The Code promotes public safety, ethical design practices, and the disclosure of factors that may endanger the public or the environment.
- It encourages members to support colleagues in upholding ethical standards and to report violations without fear of retaliation.
- The presentation concluded by stressing the responsibility of IEEE members to maintain the highest standards of ethical conduct in their professional activities.

- Finally, the expense reimbursement process for RM 2024 was presented.

Entrepreneurship Initiative – Susana Lau

- The 2024 IEEE Entrepreneurship Staff was presented.
- Various programs were highlighted, aimed at supporting entrepreneurs globally.
- The Entrepreneurship Women Tech Entrepreneurs Support Network offers a peer support network for women in tech entrepreneurship.
- Activities in Region 9 were highlighted, for example workshops.
- The Entrepreneurship Ambassador Program for 2024 seeks individuals to organize events leading to Entrepreneurship Week in the Latin America region.

SBRM Announcement – Yesica Giraldo

• The RSAC presented the next venue for the Students Branches Regional Meeting for 2024. The venue will be El Salvador.

Governance Training - Ronny Cabrera

- The main activities carried out by the IEEE R9 Governance Committee were presented.
- The presentation covered the IEEE and Regional governance documents, outlining their structure and importance in governing IEEE R9 activities.
- Detailed the approval and modification process for government documents, including timelines for motions, reviews, and regional committee notifications.
- Provided training and recommendations on constructing motions, emphasizing the importance of preparation, clarity, and adherence to governance document versions.

- Introduction to IEEE and Region 9 structure was presented.

 - Can an Operations Committee (OpCom) improve R9 operations?
- A working group will be formed for Region 9 Operations Alignment to seek compliance with the MGA Operations Guidelines.

EXECUTIVE SUMMARY:

The IEEE Region 9 Student Activities Committee is pleased to announce the guidelines for the prestigious **IEEE Section Exemplary Student Activities Committee Award**. This competition aims to recognize the Student Activities Committee (SAC) committee within IEEE Region 9 by their outstanding contributions and accomplishments to support the students.

This award not only aims to recognize the individual work of the SAC committee but also seeks to encourage active participation and the strengthening of the student activities committee across the region. The objective is to generate increased commitment and support for student branches in each section, thereby fortifying the support network and enriching the student experience in the technological realm within IEEE Region 9.

PROPOSED ACTION:

RESOLVED that the Region 9 Student Activities Committee, create, and promote the IEEE Section Exemplary Student Activities Committee Award, shall be, and is hereby, approved.

Only Student Activities Committee for IEEE Active R9 Sections can participate.

PROS:

- The regional award for Section Student Activities Committees (SSAC) will reflect a joint commitment between R9SAC and SACs in Region 9, which, in turn, provide support to student members of each student unit.
- Encourage the participation of SSACs participation in the Student Branches Regional Meeting.
- **Recognition of Excellence**: The IEEE **Section** Exemplary Student Activities Committee Award provides a platform to acknowledge and celebrate the exceptional efforts of Section Student leaders within Region 9.
- **Motivation for SSAC teams**: By recognizing outstanding contributions and accomplishments, the award serves as a powerful motivator for SSAC, inspiring them to continue their dedicated work in supporting students and fostering the development of technology in benefit of humanity.
- **Enhanced Networking Opportunities**: Winners of the award gain increased visibility within the IEEE community, leading to an expanded networking and collaborations with other professionals and organizations in the field.

CONS:

- **Resource Allocation**: Organizing and administering the award process requires dedicated resources, including time and human reviewing.
- It will involve transactions between the R9 account and Section's account.

FINANCIAL IMPLICATIONS:

- A **plaque** designated for the SSAC will be presented during the Regional Student Branch Meeting. Alternatively, if the SSAC representative is unable to attend the event, the Section Chair or a section lead delegate will receive the plaque.
- A **digital certificate** will be given to all members of the student activities committee receiving the award.

IMPLEMENTATION:

- The organization of this award will be executed with the other categories by the RSAC awards and recognition committee, the RSR and the RSAC.
- This award will be launched together with the others awards and contest defined in the **third week** of **May** and will end at the Regional Meeting of Student Branches in the second semester of the year.

BACKGROUND INFORMATION:

The current recognition system acknowledges outstanding student and professional organizational units, but lacks specific awards for section student activities committees at the regional level. In the Article III/Section 7 of the IEEE R9 Operations Manual, it is necessary to include the Finance Committee as one of the standing committees of the Region, since. the responsibilities of Finance Committee are continuous; moreover, its composition should be heterogenous, including representatives with knowledge about finances of Region 9, members of the Board and representative who aren't on the board.

PROPOSED ACTION:

Resolved that the Region 9 approves the changes of Article III, Sections 4, 5, 6 and 7 of the Operations Manual in the form presented, shall be, and is hereby, approved:

PROS:

- Since the responsibilities of this committee are continuous, it should be standing.
- It will include volunteers with background in the finances of Region 9, representatives of the board and people who aren't on the board.

CONS:

IMPLEMENTATION:

After the endorsement of the IEEE R9 Governance committee, and the approval of the IEEE R9 Regional Committee:

- IEEE Governance committee with update the manual of operations.
- The new manual will be uploaded in the website.

BACKGROUND INFORMATION:

Current version of the manual or operations: R9 Operations Manual V4

Article III. Responsibilities of the Regional Committee Members and the Regional Committees.

Regional Committee Members could participate with other volunteers in a Committee or Ad-Hoc Committee to perform some tasks and hence achieve the goals assigned.

4. The Region Director-Elect

The Region Director-Elect shall exercise those functions delegated by the Region Director and shall assume the functions and responsibilities of the Region Director in the event that he/she leaves office due to resignation, prolonged absence or disability. He/she will serve as an Ex-officio member of all the committees of the Region and will coordinate those entities delegated by the Region Director.

a. Functions of the Region Director-Elect

The Region Director-Elect becomes a Region Director upon expiration of the term for which the current Region Director was elected or appointed. Other Responsibilities includes:

- Assist the Region Director in the performance of his duties, being his main assistant.
- Ex officio member of the Strategic Planning Committee.
- Attend any meeting that is required as a function of the position.
- Maintain open channels of communication with the other members of the Regional Committee and ensure that the reports of the members of the Regional Committee are ready for presentation at the Regional Meeting in the manner provided by the Region Director or through statutes for this purpose.
- Shall be the chair of the Membership Development Committee at the Regional level.
- Shall represent the Region Director in the activities entrusted to him.
- Shall be a member of the Executive Committee and the Regional Committee with the right to voice and vote.
- Audit regional accounts when deemed necessary.
- Update the Regional Strategic Plan when taking office.
- Ex-officio member of the Regional Finance Committee.

5. The Region Secretary

The Region Secretary shall be appointed by the Region Director and shall serve for a term at the director's will, that has a maximum of two years. The Region Secretary shall have the functions of sending announcements, preparing the agendas for the meetings of the Executive Committee and of the Regional Committee and preparing the minutes of those meetings.

a. Functions of the Region Secretary

The Region Secretary is responsible for maintaining the archives of the Region in an organized manner. The Secretary will prepare all those reports that are required by IEEE or the Region and shall participate and follow up the action items made at the meetings. In addition, the Region Secretary has the following responsibilities:

- Coordinate the Regional Meeting together with the organizing section.
- Updating the specific website of the Meeting, by sending to the Web Master the information for it, such as, agenda, committee reports, data for the registration of participants and registration information for support staff and companions.
- Be a communication link between for Members, volunteers and other professional associations in the Region, making available the strategic plans and actions of the Region Directorate, seeking to serve the members of the Region equally, considering their own cultures and particular needs.
- Promote communication between the Sections, Societies, Councils and Student Branches by stimulating the formation of a communication network between the secretaries of these entities and facilitating their responsibility of maintaining this network active through meetings, projects, financial reports and other activities.
- Represent the Region Director in the activities entrusted to him.
- The secretary shall also act as Chair of the Governance Committee.
- Coordinate with the electronic voting with the Web Master, subject to the following procedure:
 - Review the document to be voted on and the additional comments.
 - Inform the deadline to receive suggestions for changes to the text. These comments must be sent by the proponents to the Region Secretary who will direct them to the corresponding persons.
 - For any vote that, due to its importance, cannot wait for the next Regional Meeting, the members with the right to vote will be informed of the electronic address for voting or another mechanism that will be indicated by the Region Secretary.
 - Inform the result of the vote.

- The Region Secretary is responsible for preparing the Regional Meeting Agenda, validating it with the Region Director and taking care of its proper development in a timely manner during the Regional Meeting.
- The Region Secretary being part of the Executive Committee participates in the meetings and is responsible of preparing and making available the unapproved minutes of the meeting.
- Ex-officio member of the Regional Finance Committee.

6. The Region Treasurer

The Region Treasurer will be appointed by the Region Director and will serve for a term at the director's will that has a maximum of two years.

a. Functions of the Region Treasurer

The Region Treasurer shall be responsible for the management of R9 funds, such as bank deposits and all payments that have been budgeted and have the endorsement of the Region Director, as well as the registration of all financial transactions made in the name of the Region. He/she shall only make those non-budgeted payments that have the endorsement of the Executive Committee.

- The Region Treasurer will prepare all the reports that are required by the MGA and Regional bylaws, as well as the ones that might be needed for the local governments where IEEE R9 has business.
- As Past Treasurer shall be member of the Strategic Planning Committee.
- The Region Treasurer will present a financial summary and regional budget projections at each Regional Meeting.
- The Region Treasurer shall be Chair the Regional Finance Committee.

7. The Standing Committees

The Region Director shall appoint the coordinators of the standing committees of the Region, who will chair the committees, except for those who hold this position by virtue of their office. All of them, with the exception of the Nominations Committee, will serve for a term of one to two years at the will of the Region Director. The Standing Committees are described below.

s. Finance Committee

The Finance Committee is a standing committee shall consist of the current Region Treasurer, who will chair the committee, the previous Region Treasurer, the Treasurer of the LATAM Transactions, one Section/Council chair appointed by

the Region Director, and the following non-voting members - the Region Directors (Director, immediate Past Director, and Elect Director), and the Region Secretary.

The Finance Committee shall:

- be responsible for the preparation of the Region budget.
- <u>supervise the progress of financial affairs in the region and continuously suggest recommendations to the Executive Committee midway through each operational year.</u>
- recommend to the Executive Committee about expenses or funding levels for regular activities and authorization levels for travel expenses.
- <u>evaluate and make recommendations to the Region Director on financial</u> business that he/she consults about.
- evaluate and make recommendations to the Executive Committee on requests for special funds for emergencies, special activities, or nonbudgeted events.
- maintain the funds of the Region in the IEEE bank account known as Concentration Banking.
- <u>recommend to the Executive Committee the appropriate levels for general reserve or special reserve regional accounts.</u>
- prepare and keep updated a short- and long-term financial plan consistent with the current Strategic Plan for the operations of the region.
- recommend to the Region Director about funds control mechanisms that he/she deems pertinent to be established in Region 9.
