April Meeting Minutes (Kim Parnell)

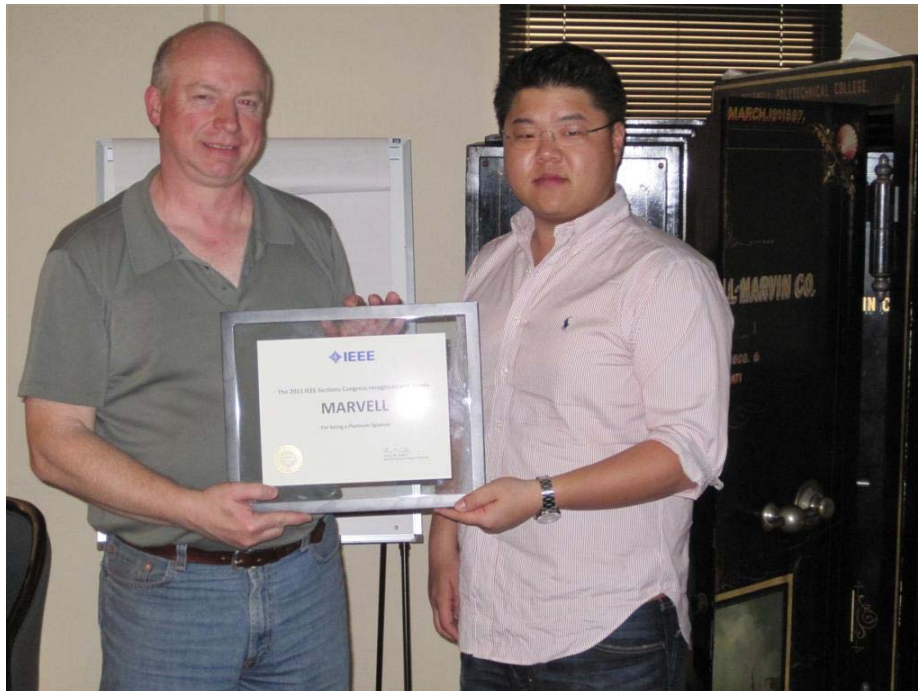
