Kim Parnell called the meeting to order at 6:01 pm.

**May Meeting Minutes (Kim Parnell)**

Kim asked if there were any objections to acceptance of the minutes from the 4 May 2011 meeting as circulated on the listserver. Hearing no objections, the minutes were accepted.

**June Meeting Agenda (Kim Parnell)**

Kim asked if there were any changes to the agenda that had been circulated prior to the meeting. Hearing no objections, the agenda was accepted.

**Chapter Report #1: Microwave Theory & Techniques (MTT) (Nima Shams, Chair)**

- Nima reviewed the current chapter officers
- Financials provided: \$13,756 in the bank
- Over 400 chapter members
- Up to 9 meetings are held each year, with meeting attendance of up to 52

**Chapter Report #2:SFBA Nanotechnology Council (Nano) (Allen Amaro, Chair)**

- Allen reviewed the current chapter officers
- Financials provided: \$13,966 in the bank
- Its listserver has 934 subscribers
- Typically ten seminars and two symposia are held annually

**Chapter Report #3: Monterey Bay Subsection (MBSS) (Weilian Su, Chair)**

- Weilian reviewed the current chapter officers
- Financials provided: \$7487 in the bank
- 833 active chapter members
- 8 meetings have been held so far this year, with another scheduled for later this month



**Chapter Report #4: Photonics Society (PHO) (Allen Earman, Treasurer)**

- Allen reviewed the current chapter officers
- Financials provided: \$9504 in the bank
- About 452 active chapter members
- 7 meetings were held during the last 12 months

**Officer Reports**

**Chair (Kim Parnell)**

- Kim made comments about the budget that would be presented by Ed Aoki this evening
- He also said that a better method for submitting funding requests needs to be established so that a request is not made known only just before the request is voted on.
- Kim also extended special thanks to Ed Aoki for all the time he has spent on the budget and other Treasurer's issues while Karl Mathia is out of the country.

**Vice Chair (Brian Berg)**

- Brian also extended his thanks for Ed Aoki for the tremendous amount of work he has done over the past few weeks.

**Treasurer (Ed Aoki, Interim Acting Treasurer)**

- Ed presented the Treasurer's Report, which included a summary of a budget that he proposed be passed tonight
- Ed then presented a detailed version of the budget, which included a \$37,500 deficit
- There was extensive discussion, during which time Ed noted the following:
  - An underscoring of Kim's comment that a better method for submitting funding requests needs to be established
  - Chapter Financial Reports must be submitted on-time as part of requirements to qualify for Annual Rebate or any other SCV financial support
  - Chapter Financial Reporting – infrastructure improvements to aid on-time filing

- Finally, Arthur Astrin made a MOTION to adopt the budget, and Brian Berg SECONDED the motion. After some further discussion, the motion PASSED by a vote of 18 yes, 0 no and 2 abstentions.

**Secretary (Ed Aoki)**

- Ed requested his notification of loss of Chapter Officers in a timely manner.
- He also said to let the Board know when you need help.
- Kim then chimed in and underscored these issues:
  - *All Chapters should plan on end of year financial filing to IEEE-SCV Treasurer to support **both** L-50 and expected Annual Audit of IEEE-SCV Finances*
  - *Chapter ExCom Meeting Minutes are required to document significant expenditures. ExCom Meetings with Minutes are a recommended best practice!*

**PACE (Kim Parnell, for Kiran Gunnam)**

- Kim noted that Kiran was not in attendance since he was about to become a father.
- The PACE webpage has been updated with upcoming events

#### SC2011 Committee Update (Tom Coughlin)

- Tom spoke via Skype
- Several hundred have registered so far, and about half are coming to the CHM event

- Dick noted that David Craven is working with the various student chapters to arrange for a Bay Area-wide gathering at the CHM
  - The general idea is to share best practices and what kinds of activities work well
  - The event will likely be scheduled a few weeks after the students get settled in for the fall.

- He will continue to work to support the chapters and the Section



**Senior Member Advancement Chair (Ed Aoki, for Jack Berg)**

- A Senior Member Elevation event will be held at Cogswell College on Monday, June 27, starting at about 5:30. Senior members and Fellows are encouraged to attend to help with candidates.

**GRID Editor (Paul Wesling)**

- Not present.

**GOLD (Jared Petrie for Sachin Desai)**

- Sachin was happy to participate at Maker Faire
- Another Cloud Computing event is planned for this fall, with CTO level speakers, to be held at Stanford

**Old Business**

**Neha Choksi Motion from April Meeting**

- A MOTION to take the April tabled motion re: funding \$5000 for Neha Choksi's request off the table was made by Dick Ahrons, and SECONDED by Brian Berg. This motion to untable PASSED with 5 yes, none opposed, and 3 abstentions.
- Ram suggested Neha ask SVEC for funding, and he noted that we could potentially match SVEC's funding.
- The original motion FAILED with none in favor, a large number of no votes, and 2 abstentions.
- Both Jeffrey Pawlan and Brian Berg noted the fact that Neha had presented a very interesting and unique proposal to get women involved in engineering.
- In recognition of this, Brian made a MOTION that the Section would like to hear more from Neha Choksi after she gets her 501(c)3 status. This was SECONDED by Larry Nagel, and PASSED by a vote of 12 yes, 2 no and 2 abstentions.

**Santa Clara University Formula Hybrid Motion from May Meeting**

- Kim gave some background of Santa Clara University's Formula Hybrid effort.
- A MOTION to take the May tabled motion re: funding \$1500 for the Santa Clara Univ. Formula Hybrid program off the table was made by Les Besser, and SECONDED by Brian Berg. This motion to untable PASSED with 16 yes, 1 no and 1 abstention.
- There was some further discussion.
- The original motion PASSED with 14 yes, 1 no and 2 abstentions.

**SJSU Student Branch Chapter of CPMT Motion from May Meeting**

- A MOTION to take the May tabled motion re: funding \$300 for a Laser Maze and \$180 for the Calif. Micromouse Competition off the table was made by Larry Nagel, and SECONDED by Allen Earman. The motion to untable PASSED unanimously.
- Brian noted that the Calif. Micromouse Competition had already happened
- Ed noted that CPMT would be able to provide funding to the Student Branch Chapter.
- The original motion FAILED with 0 yes, 14 no and 2 abstentions.



**New Business**

**Monterey Bay Subsection Funding Request (Weilian Su)**

- MBSS goal: reach out to members and non-members in Monterey Peninsula
  - Many events are happenkng; MBSS wants to co-sponsor science fairs in local schools
  - Estimated cost: \$3000; asking for \$1000
- Dick Ahrons made a MOTION to approve this grant, and Allen SECONDED the motion. The motion PASSED unanimously.

**MTT Short Course (Nima Shams)**

- Nima discussed a short course that the MTT chapter wants to hold
  - “The Fusion of RF and Digital Design” on Sat., Sept. 10 at Michael’s in Mountain View
  - Estimated attendee count: 84 (paid: 50, sponsored: 34)
  - Nima asked that the Section cover the cost of unemployed and student attendees (up to 34 at \$45/person) for a cost of up to \$1500. The money would be returned to the Section if the event is profitable.
- Fred Jones made a MOTION that the event be approved, and that \$1500 be allocated for this event. Lee Colby SECONDED the motion. It PASSED with 9 yes, 4 no and 0 abstentions.

**ISMICT Conference Moral Support (Arthur Astrin)**

- This is the 6<sup>th</sup> International Symposium on Medical Information and Communication Technology, which will be held in the U.S. in March 2012
- Art Astrin made a MOTION that the Section gives its moral support to this event. The motion was SECONDED by Allen Earman, and it PASSED unanimously.

**Information Theory Chapter is being resurrected (Arthur Astrin)**

- The 4<sup>th</sup> Wed. of the month looks to be the regular meeting date
  - A venue at Stanford Univ. will be the likely meeting venue

## SCV Treasurer's Report 2011

- o 2010: Income \$ 53,300  
Primary Expenses: \$ 56,400  
But \$10,032 in Chapter Rebates and \$900 in Chapter Support were cashed in 2011.

o 2011: Projected Income: \$ 58,500  
Primary Expenses: \$ 15,000 + \$ 10,000 + \$ 25,000 + Grants (Non-Chapter) + Grants (Chapter) + Grants (Student Branch/Chapter)... = \$ 95,000.

- o Deficit (2011) = \$ 37,500

## SCV Treasurer's Report 2011

As of May 2011, we spent \$ 26,000

As of June 2011, We have spent \$ 41,700.

Assume that STEM is reduced from \$ 5K to \$ 1 K.

Consequences for the rest of the year:

If we approve all of the STB/SBC requests from SCU, SJSU, SU, UCSC, we will have \$ 2 K left to spend on students.

If we approve all of the non-Chapter requests (EYH, STEM) we will have \$ 0 K for this category.

If we approve the GOLD winery tour, that will be \$ 4 K this year.

We cannot approve the funding of every good idea/project. Where possible, we should provide bridge-loans rather than grants.

Pay Rebates into CBRS accounts rather than by check.

One Time Expenses:

\$ 15 K for SC 2011

\$ 11 K for late checks ( rebate and Support )

5% of Beginning of Year (BOY) Cash  
Position = \$ 12 K

that the value of the LT investment does not decrease.

Requires that we CHOOSE the relative values of the requests  
and work with a fixed sum.
