advantage of it! There is an article elsewhere in this newsletter on the details of getting access to the database, and I have asked the Region 3 Employment Assistance Committee representative, Dick Riddle, to have business cards made up with those instructions.

The BBS has become a living creature - we have found that the more things we put on it, the more "obvious" things there are to put on it! It is open for business - please try it and let us know what you had hoped to find on it that isn't there - it is probably on the "things to do" list! One of the Councils has already started pulling information together for "their" page, and I would encourage any section that has an electronic version of their newsletter to send it to me on disk or upload it onto the BBS.

In addition to my "BBS" duties, I spend a lot of time on the Institute at the Board level. The most recent (and ongoing) exercise is a reorganization of the Institute - I will keep you posted on those developments.

We were quite honored at the first region meeting of 1995 in Birmingham - Wally Read, the 1995 President-Elect, came to visit! This was great timing, since we had the meeting in Birmingham so that we could "visit" the database at UAB, and so we could present a plaque of recognition and appreciation to the Student branch which did the work of implementing this database (having a student branch be such an integral part of such a major region project - another "first" for Region 3!) Thanks for coming, Wally!

The next set of Board meetings is March 1-6 in Calgary, Alberta, Canada. As a former Floridian (and current freezing Georgian), I am REALLY looking forward to THAT! This may be the only

time I am glad that the Board meetings are so tightly scheduled that we never leave the hotel until we go to the airport.

I hope that each section sends a representative to the Region Committee meeting and associated ExCom meetings, Leadership Development Workshop, etc. This is a wonderful opportunity to get together with other section representatives and discuss common problems and solutions, and get officer training, with the Region paying for it! ## VICE CHAIR'S REPORT

Looking ahead to the Region 3 meeting during Southeastcon '95, I would like to provide as much time for the sections to speak as possible. If the area/council chairs provide written reports only, and then lead their sections in the reporting process, all the sections will have sufficient time. To the section chairs please base your report on current activities, special projects, extraordinary needs and recommendations. Do not include officer lists and membership statistics, those are available from headquarters. A written one page report from each section is needed for the official minutes.

The same arrangement will apply for reports from the region's committees. In some cases the committee report may be longer due to necessary region action.

In the area of awards, it is important to recognize people for the work they do in furthering the IEEE and the profession of engineering. It is also necessary to prepare the nominations very carefully, following the requirements for the award. Timeliness is also important both from the submitter and the reviewer. Hopefully in the revised Region 3 Awards Manual we will update the lists of avail-

able awards. We plan to make note of the major Society awards. See you at SoutheastCon '95 in Raleigh.

## TREASURER'S REPORT

We had an interesting meeting of the Region 3 EXCOM in Birmingham in late January. Our preliminary budget figures for 1994 showed a surplus of income over expenses of just over \$16,000 due primarily to a total of \$32,000+ surplus from Southeastcon's '93 and '94 and Southcon '94. The EXCOM agreed to establish an escrow fund with this \$16,000 to partially fund Region 3 Section and Region representation to the Sections Congress '96 in Denver.

Sections and Councils are urged to provide similar escrow accounts to the extent possible in order to support one or two representatives to this important tri-annual event. RAB and Region 3 will be announcing as soon as possible how much will be supported for Section representative travel expenses.

The Region 3 EXCOM approved a budget for 1995 that projects a deficit of \$11,000 (Expenses over Income). Our reserves are adequate to support this deficit, and this budget permits the Region to support programs at about the same level as 1994 even though the income is not projected to be as large.

Several actions by Region 3 EXCOM affect our published Region 3 Travel Policy and are outlined below:

1) It has been several years since the daily meal allowances have been changed. The following wording was approved to replace the current wording of par c) to read as follows: c) Actual cost of meals, including tax and tips, not to exceed \$37.50. Where meals are provided by IEEE, this amount will be re-

duced by \$7.50 for Breakfast, \$10.00 for Lunch and \$20.00 for Dinner.

2) Change paragraph (d) to read as follows: d) Necessary taxi or ground transportation including airport parking (use long term parking where available) at cost.

3) Add paragraph (e) Telephone calls and incidental tips not to exceed \$15.00 per trip.

Recognizing that Region 3 expenditures for meetings and activities at SoutheastCon (EXCOM, Regional Committee and Student Conference) are by far our largest single budget impact of the year, it is critical that your EXCOM determine the true final cost of these activities as soon as possible. Therefore, in order to encourage early submittal of all travel expense vouchers, the following motion was approved by EXCOM:

All representatives, which includes Region, Section and Student Branches, must submit travel vouchers by 60 days after the conference in order to receive reimbursement by the Region.

IEEE Headquarters has announced the increase to \$0.30 per mile for approved personal auto travel. An updated Region 3 Travel Policy reflecting these changes will be available at Southeastcon in March. See you in Raleigh!

## PAST DIRECTOR'S REPORT

Over the past year, the Region 3 EXCOM has devoted significant attention to the issue of Region and Section fiscal responsibility. This matter will "come to a head" at the EXCOM meeting schedule in conjunction with SoutheastCon '95 in Raleigh. The purpose of this article is to give some background for this discussion and the reason why Region 3 and its Sections need to

demonstrate initiative in ensuring sound policies of fiscal responsibility on the part of the entities for which each area has oversight.

### *Background Information*

IEEE entity boards and committees of the Board of Directors are reviewed every five years with a special Review Committee being constituted for each group being evaluated. The responsibility of a Review Committee is (quoting from Institute Policy 9.13.C.) to “delve in depth into the effectiveness, continued need, policies, procedures, actions, composition, staff support, budgetary practices”. The Policy continues by saying that “the review should emphasize the examination of the results of the Total Quality Management approach to identify and improve service to the appropriate customers. This does not restrict the Review Committee from expanding the review in any other direction as they deem appropriate.” In other words, the Review Committee has the assignment to take a “hard look” at the way the group “does business” and make recommendations as to how operation can be improved for the benefit of the Institution.

Currently, two important reviews are underway relative to the activities of two committees of the Board of Directors: the Finance Committee and the Audit Committee. (This writer is serving as Chair of the Review Committee for the Finance Committee and as a member of the Review Committee for the Audit Committee.) One of the pivotal issues being faced by both committees, and especially the Review Committee for the Audit Committee, is the continuing complaint by IEEE Auditors that the IEEE Board of Directors (through its Audit Committee) is not exercising proper fiscal control over ALL Institute funds. Here is why.

Under the New York laws of incorporation that govern IEEE’s business conduct as a not-for-profit entity, all moneys held by the Institute, no matter at what level (i.e. Society, Region, Section, Council, or Chapter), belong to and are under the control of and jurisdiction of the Board of Directors. Further, IEEE ByLaws and IEEE Policies and Procedures dictate that (1) financial liability

for each Council and each Chapter rests with the Section(s) sponsoring the Council or Chapter, (2) financial liability for each Section rests with the Region, and (3) financial liability for Regions and Societies rests with the Institute. These Institute-level audits (in view of IEEE’s incorporation status and IEEE ByLaws and IEEE Policies and Procedures) have contained harsh words for the Audit Committee and the Board relative to its failure to assume oversight over the funds held at the Society, Region, Section, Council, and Chapter levels.

While the Board of Directors has determined that each level of the Institute’s hierarchy (i.e. Regions and Sections) must have in place a plan for ensuring that Institute entities reporting to it have no extraordinary financial risk or exposure that could adversely impact the financial operation of that hierarchical level, most Regions and Sections DO NOT have a plan in effect that ensures that “no extraordinary financial risk or exposure” is being presented by the Sections to their Region or by Chapters and Councils to the Section(s) sponsoring these entities. As a result, there is a high probability that the review process will result in Board-mandated controls for Regions and Sections that have not established their own control strategies.

### *The Region 3 Solution*

It is evident that Region 3 MUST adopt a policy that ensures that Sections within the Region are not exposing the Region to an adverse financial risk and that each Section within Region 3 must also develop a policy that, for its level of operation, ensures that Chapter(s) and Council (if it participates in a Council) is(are) not exposing the Section to adverse financial risk. Otherwise, Institute-level intervention may result in a less-palatable method of control. A procedure for establishing these controls has been proposed and will be again debated and “put to a vote” in March.

Elsewhere in this edition of the Newsletter, you will find information about the recommendation that the Region 3 Executive Committee will consider at its March Meeting. I commend the proposed policy to you for consideration and support.

### *On another issue:*

This year’s President-Elect election will involve two candidates nominated by the Board of Directors — Jan Brown and Joe Bordogna — and possibly one petition candidate — Charles Alexander. I solicit and encourage your support for Charles Alexander!

## **IEEE REGION 3 NEWSLETTER CELEBRATES 10 YEARS**

The following policy statement was recommended by the Conference Committee and approved by the Region 3 Executive Committee at its January meeting in Birmingham. It is the policy of

Region 3 that IEEE volunteers attending the Region 3 administrative meetings (Region Committee Meeting, Region Excom Meeting, PACE meetings, etc.) not pay registration fees to attend these administrative meetings even though they are held in conjunction with Southeastcon. It is understood that meal and meeting costs (audio-visual, etc. but not meeting rooms) will be paid directly from Region funds. Region 3 encourages all IEEE members to register and participate in SoutheastCon.

### *Southcon*

Region 3 has a major electro-technology show with technical sessions and product exhibitions which it sponsors with the Florida Council and Electronic Representatives Association. By the time you read this Southcon/95 will probably be over. It was held in the Ft. Lauderdale/Broward County Convention Center, March 7 through 9. If you did not attend you missed an opportunity to participate in a Careers Transition Workshop, several tutorials from "Introduction to Internet 'Information Superhighway,'" through UNIX, Multimedia Systems, C, Verilog, Programming in Perl, to CMOS VLSI Design. Additionally there were 18 technical sessions, plus a NAFTA Workshop, an Industry/University Partnership Roundtable, and a keynote address on "The Challenges of Low Power, High Performance Electronics" by Walter Davis, Corporate Vice President, Motorola, Inc. All of this technical program was in addition to the premier electronic components show in the southeast. IEEE is incorporated under the laws of New York. Recent audits have defined a need for each level of IEEE entities to have a plan to limit financial liability. To retain as much local control as possible, Region 3 is thus proposing measures to limit Section commitments, and each Section must also adopt measures to limit Chapter, SubSection, and Council commitments.

At the March 25 ExCom meeting in Raleigh, the SPC will thus put forth these two motions:

(a) That no Section in Region 3 may enter into a financial commitment, without prior approval of the Region 3 Finance Committee that will cause the Section to exceed its reserves, with reserves being defined as the Section's surplus as of January 1 of the current year plus the anticipated Section Rebate for the current year plus all anticipated accounts receivable for the current year minus all budgeted expenditures for the current year minus all encumbered, unspent expenditures for the current year and previous years.

(b) That the Director of Region 3 notify the Chair of each Section in Region 3 of this action and the background therefore, and the Section's responsibility to adopt a policy relative to the fiscal

operation of each Chapter, SubSection, and Council reporting to the section that will ensure that the Section is not exposed to an adverse financial risk.

Several special projects have been planned and initiated as part of the Region 3 Professional Activities Operation - Employment Assistance Subcommittee during 1994 and 1995. The goal of each project has been to provide employment assistance services to our Region 3 members in a variety of ways.

*Electro-Technology Industries Database*

In the last issue of our Region 3

Newsletter (Winter 1995) we saw several articles about our first project, known as the "Region 3 Electro-Technology Industries Database" which was started in 1993 and became operational in November 1994. The goal of the ETI database is to provide information about the more than 40,000 companies and organizations which employ technical professional people such as our IEEE members within the southeast. It lists the name and address of the company, name of the person to contact, number of technical employees, total number of employees, and the type of products that the company is involved with.

The database can be queried in a variety of ways: by company name or a part of the name, by city, state, Standard Industrial Code (SIC), and by telephone area code. See page 12 for detailed access information on the ETI DB.

Several enhancements are planned in 1995 for our ETI database. A major effort will be made to expand the information contained by adding new companies and updating the information on the existing entities.

### *Region 3 Bulletin Board System*

Our second project, known as the "Region 3 Bulletin Board System (BBS)" was started in the spring of 1995 and became operational during the winter of 1995. The intent of the R-3 BBS is to improve communications within our region by providing a central point to share information about the Institute, Region, Area/Council, Section, and most importantly the membership. A major reason for the existence of our BBS is to

provide employment assistance to our members by listing job opportunities. The R-3 BBS was demonstrated at the R-3 Excom meeting January 28-29, 1995, in Birmingham, AL.

### *Resource and Technology Initiative (RTI).*

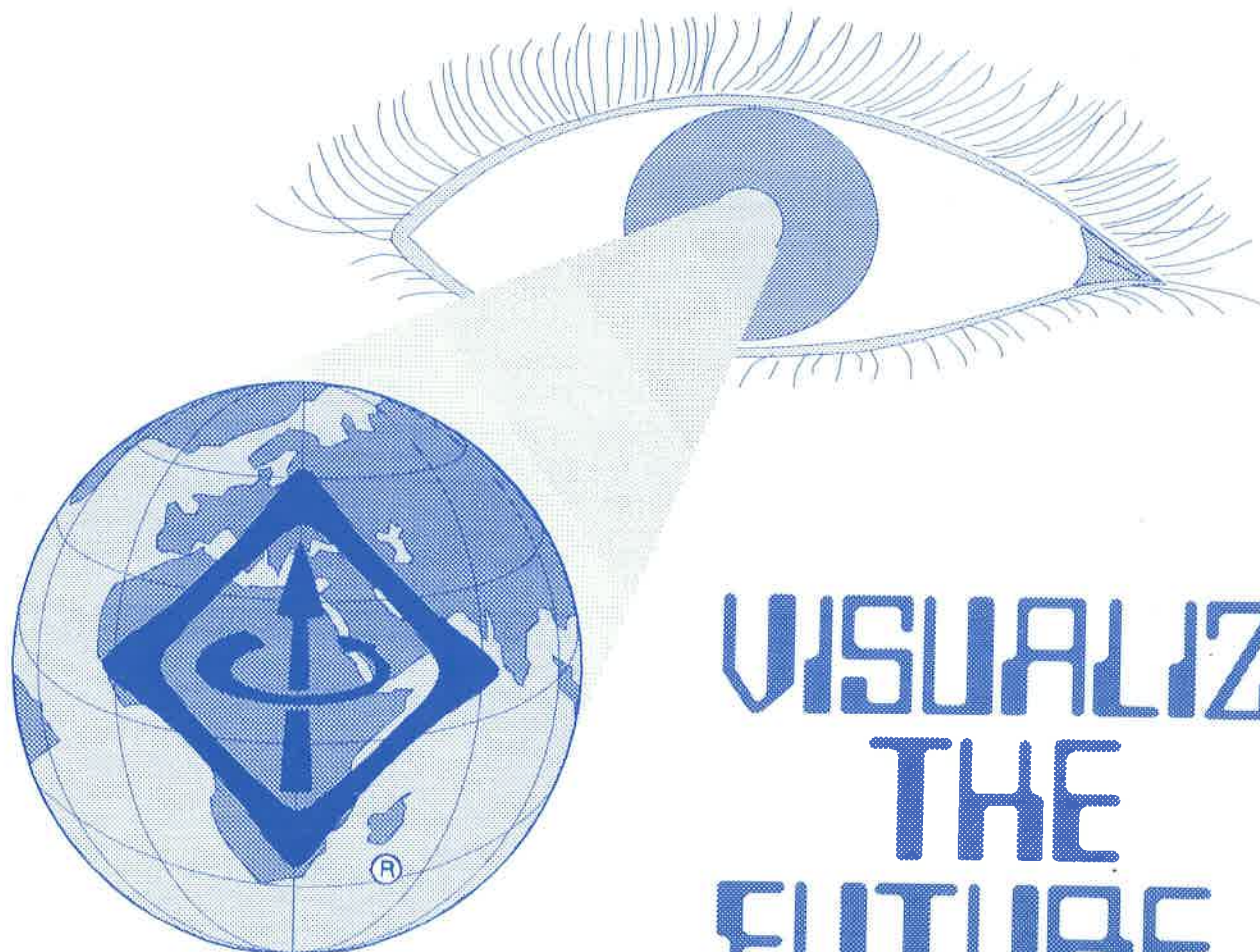

## ALVIN W. TRIVELPIECE, PH. D. TO RECEIVE OUTSTANDING ENGINEER AWARD



Alvin Trivelpiece is the Director of the Oak Ridge National Laboratory and Vice-President of Martin Marietta Energy Systems, Inc. An IEEE Fellow, Guggenheim Fellow, and Fulbright Scholar, he began a career in teaching after receiving his engineering degree from California Polytechnic State University in 1953. Dr. Trivelpiece joined the research efforts of the U.S. Atomic Energy Commission in 1973, followed by senior executive positions in private industry.

He returned to public service as Director of the Office of Energy Research in the U.S. Department of Energy in 1981. After a year as Executive Officer of the American Association for the Advancement of Science and publisher of Science magazine, he assumed his present positions. He is now responsible for the management of DOE's largest multiprogram, non-weapons laboratory, leading an organization of over 5,000 employees and 3,000 guest researchers and an annual operating budget of \$500 million.

Dr. Trivelpiece has received national recognition for his contributions as an educator, researcher, inventor, author, and manager of research in the fields of energy and physics. He holds five patents, authored two books on plasma physics, and is the author or co-author of 46 journal articles and papers.

Responsible for shepherding the SSC accelerator project through the government, Dr. Trivelpiece is credited with personally securing the approval of President Reagan. He was recently elected to membership in the National Academy of Engineering and is a recipient of the U.S. Secretary of Energy's Gold Medal Award.

A member of the Oak Ridge Section, Alvin Trivelpiece is being presented the Region 3 Outstanding Engineer Award for his outstanding achievements in plasma science, management, and engineering.



## DAVID G. GREEN TO RECEIVE OUTSTANDING SERVICE AWARD

David Green has served IEEE for almost twenty years. He has served the Region as Student Activities Chair, E-Mail Coordinator, Review Committee Member, Treasurer, and (presently) Conference Committee Chair. He has been active at the Institute level, including Chair of the Regional Activities Board's Student Activities Committee. He has continued to serve IEEE at the local level throughout this period in a wide variety of positions, including Section Chairman, Chapter Chairman, and Branch Counselor at the University of Alabama at both

Huntsville and Birmingham.

Mr. Green developed the Region 3 Student Conference Manual, and he originated the project — now at the Institute level — to include a card which explains the meaning of the IEEE logo along with every membership pin. His most recent accomplishment is coordinating the IEEE Region 3 Electro-Technology Database Project which has just recently come online.

Currently Instruction Assistant Professor at the University of Alabama at Birmingham and a member of the Alabama Section of IEEE, Mr. Green is receiving the Region 3 Outstanding Service Award for outstanding and dedicated service to IEEE Region 3.

**LEONARD L. GRIGSBY, PH.D. TO RECEIVE JOSEPH M. BIEDENBACH OUTSTANDING  
ENGINEERING EDUCATOR AWARD**



Leonard Grigsby is the Alabama Power Distinguished Professor at Auburn University. He has taught electrical engineering for 37 years, covering essentially every subject in the undergraduate program and concentrating on circuits, controls, and power systems at the graduate level. He has been the principal investigator for approximately \$2.4 million of research projects, has co-authored a textbook on network theory, and has 114 published technical papers to his credit.

Dr. Grigsby's long list of IEEE activities list includes the positions of ABET Program Evaluator, member of the Power Engineering Society Executive Board, representative to the IEEE Educational Activities Board, member of the IEEE Publications Board and the Technical Activities Board Periodicals Council, and Chair of the PES Engineering Education and Power Systems Engineering Committees. He was Associate Editor of the Electric Power Systems Research Journal and is currently the Publications Chair of the Power Engineering Society.

Dr. Grigsby is a Fellow of IEEE and is the recipient of an IEEE Centennial Medal and the Edison Electric Institute's Power Engineering Educator Award. He was the Auburn University Distinguished Graduate Faculty Lecturer and the first Tokyo Electric Power Company Endowed Distinguished Visiting Professor at the University of Tokyo. He has received four awards for teaching excellence and is a member of the Alabama Section.

Leonard Grigsby is being presented the Region 3 Joseph M. Biedenbach Outstanding Engineering Educator Award for his lifetime contributions to electrical engineering education.



**MAX DON TRUNDLE, P.E. TO RECEIVE PROFESSIONAL LEADERSHIP AWARD**

Don Trundle is an electrical engineer with Martin Marietta Energy Systems at the Oak Ridge National Laboratory, where he has specialized in power systems. A Senior Member of IEEE, he is a contributor to the Industry Applications Society's "Orange Book," Recommended Practice for Emergency and Standby Power Systems and is a member of the "Yellow Book" working group which is developing the IEEE Guide for Maintenance, Operation and Safety of Industrial and Commercial Power Systems. He is a member of the East Tennessee Section. Mr. Trundle has contributed to IEEE for over ten years in a variety of leadership positions, including Section Chair and, most recently, Chair of the Tennessee Council. He has been a tireless and successful promoter of the IEEE awards program and has a decade-long involvement with the local Annual National Engineers' Week Conference and with Tau Beta Pi. He has been a speaker at the National PACE Conference and organized the IEEE awards program at the 1988 International Science and Engineering Fair. Mr. Trundle also represented his fellow engineers in industry as part of the IEEE's congressional lobbying effort for pension reform and portability. Max Don Trundle is being presented the Region 3 Professional Leadership Award for outstanding leadership efforts in advancing the professional aims of IEEE.

## ELECTRO-TECHNOLOGY INDUSTRY DATABASE - 1995 PLANNED ACTIVITIES

To complete the ETI Database Project Phase 3 milestone, the Region 3 Professional Activities Operation, Employment Assistance Subcommittee will expand the database to include selected states outside Region 3. States of particular interest are those that are in economic recovery and are hiring electro-technology professionals. Another enhancement and 1995 goal for professional activities is to establish a procedure to permit Region entities (chapters, sections, area/councils) to support data entry for new entries and to further fill out the database.

## SECTIONS CONGRESS '96

SECTIONS CONGRESS '96 - Friday noon, November 1 to Monday noon, November 4. Three full days! If past experience holds true that means jam packed, crammed full! Saturday night after 5:30pm is unscheduled by the SC'96 committee to give yo'all a break midway through the Congress to catch your breath. Unless your Council or the Region decides to schedule activity at that time. The Congress Planning Committee purposely left this time period free to allow other meetings to be held during the Congress time frame without interfering with the Congress schedule or delaying anyone's departure. However, I recommend that additional meetings be held before or after the Congress to allow at least some time for informal relaxation during a very intense three day workshop and meeting.

To assist Section delegates to attend the fifth tri-annual Sections Congress the Region 3 Executive Committee approved putting \$16,000 in escrow. These funds will be made available to Sections in Region 3 to assist them in paying the travel and living expenses of their delegates. The algorithm to be used in allocating this money to the Sections is still under development. However, each Section is expected to provide a substantial portion of their delegate's support as well. If you have not budgeted for this expense you need to set money aside NOW and put it in next year's budget also. I recommend that each Section plan on total expenses of \$500 plus travel to Denver, for each delegate to be shared between the Section, Region 3, and Regional Activities. The registration cost of the Congress is covered entirely by Regional Activities.

I discussed the World Wide Web during the last issue of the newsletter. This is a continuation of that discussion. The general layout of the regional/regional sac servers is as follows: links to Branches and Chapters and Sections within the region, contact information of the various Branches, Chapters, and Sections, such as email address, the email coordinator, the region aliases, etc., allowing for students to register on-line for, say conferences, branch email address, etc., major student related projects in the Region (SPACs, Regional Training Initiatives, Regional Student Conferences), Region Awards information such as criteria, forms, deadlines, past winners, Regional guidebooks like the Region 3 Student Conference Planning Guide, Annual plans, reports, bylaws, etc. of all the branches in the region (this allows other Branches to look at them), Regional newsletters (or even Branch newsletters), Regional student awards, recipients, criteria, forms, etc., Logos, letterhead templates, whatever electronic resources that would be useful for each region, and more! ## **New Region 3 Member Service Available: Region 3 Electronic Bulletin Board System (1-800-555-REG3)**

The first IEEE Regional Bulletin Board System (BBS) was demonstrated at the Region 3 Executive Committee Meeting on January 28 in Birmingham, AL. The BBS includes region and institute reference materials (region history, calendar of events, directory, awards documents, the ETI database manual, the Region 3 Consultants Network, and the Region 3 Strategic Plan), as well as current committee and area/council/section activities (sections with electronic newsletters are welcome to load it on the BBS). Meeting notices for region meetings will be available; look up the details of the upcoming meeting at Southeastcon if you haven't already done so. Internal e-mail among BBS users, teleconference, and forums are other features currently being used. One of the most popular areas will probably be the job posting area, where companies can list their job openings for members to access.

The Region 3 BBS was conceived in the fall of 1994 as a vehicle for the region and the Institute to communicate with officers and members who may have access to modems, but not to e-mail services. The project was funded by the region ExCom in November, and the United States Activities Board (USAB) agreed to cosponsor the project later that month.
