PAR has been approved. As it is intended for this standard to be Dual Logo a New Work Item (IEC equivalent to PAR) will be applied for. Action: A Bosma.

Meanwhile the WG will continue to work on the document.

Designated Members have revued sections of the existing standard and proposed changes. This was circulated before the meeting to WG members (Revision 3) and these were discussed in the meeting and modified as necessary. Copies of most of the referenced standards have now been received. The WG has decided to remove all external references and incorporate the necessary term within the standard if possible. WG members will now review their assigned sections together with the references in order to do this, and propose changes.
