5. Working Group / Task Force Status Reports

a. C37.13: Standard for Low-Voltage AC Power Circuit Breakers Used in Enclosures

D. Edwards – Task Force created and submitted amendment PAR to update document to include voltage references to 1000V. PAR denied by NESCOM on basis of not allowing an amendment PAR to change the title and scope of a document. Several examples were

offered by Switchgear and other committees that the precedent for this type of change is acceptable. Task Force met this week and completed a draft of the revised document. LVSD reviewed the changes during the meeting. Motion was made, seconded, and passed to approve the draft 2 C37.13 document and to submit it with the PAR. Motion was made, seconded, and passed to move immediately to ballot for the draft 2 of C37.13 once PAR approval is received.

b. C37.13.1: Standard for Definite Purpose Switching Devices for Use in Metal-Enclosed Low-Voltage Power Circuit Breaker Switchgear

K. Flowers for R. Puckett – Document was approved on June 18, 2010. Motion was made, seconded, and approved to disband the Working Group for this standard.

c. C37.14.1: Standard for DC (1500V and below) General-Purpose Power Circuit Breakers Used in Enclosures Low Voltage; C37.14.2: Standard for DC (3200V and below) Traction Power Circuit Breakers Used in Enclosures

K. Flowers – There has been significant work to request input from Traction Power personnel to assist with the development of these documents. That input has not occurred. Task Force elected to not separate C37.14 into these additional documents. Work will start to update C37.14. No PARs were ever submitted for creating C37.14.1 and C37.14.2.

d. C37.16: Standard for Preferred Ratings, Related Requirements, and Application Recommendations for Low-Voltage AC (635V and Below) and DC (3200V and Below) Power Circuit Breakers

e. C37.17: Standard for Trip Systems for Low-Voltage (up to 635 V) AC and General Purpose Low Voltage (up to 600 V) DC Power Circuit Breakers

J. Mizener – Document currently in recirculation ballot. Working Group will apply for a PAR extension as work on the final document will not be able to be completed by PAR end date. Existing PAR has a link to the completion of C37.50. That will be removed as C37.17 needs to be published before work can be completed on C37.50. A revision PAR will also be submitted to allow an increase of voltage ratings to 1000V.
