7. Working Group / Task Force Status Reports

a. C37.13: Standard for Low-Voltage AC Power Circuit Breakers Used in Enclosures

D. Edwards – The task force met on Monday afternoon with 9 members and 15 guests present. The amendment for change in scope to cover voltages from 635 V ac to 1000 V ac was successfully balloted and approved by RevCom May 2. The amendment and the preferred ratings from C37.16 are incorporated into the new draft D1. The scope and purpose were updated to reflect addition of preferred ratings. There was discussion regarding the use of the terms "frame size" and "continuous current rating" and revisions were made to address the use of these two terms. Additional work to clean up the short-circuit current and short-time current preferred ratings tables copied from C37.16 will be completed in draft D1. A difference between overload and endurance reduction factor in C37.13 and C37.16 was discussed and resolved. Doug Edwards made a motion that a PAR be initiated on behalf of the task force. The motion carried.

b. C37.14: Standard for Low-Voltage DC Power Circuit Breakers Used in Enclosures

K. Flowers – The working group met on Monday morning with 9 members and 6 guests present. Tutorials were presented on rated peak current for traction power applications and short-circuit and short-time ratings for rectifier breakers as used in traction power applications. A guide for recommended practices for grounding in traction power applications was distributed. The topic of whether or not to include follow-up design verification testing in the document was discussed. Draft 5 was circulated for comments to be discussed at the Fall meeting.

C37.16: Standard for Preferred Ratings, Related Requirements, and Application Recommendations for Low-Voltage AC (1000V and Below) and DC (3200V and Below) Power Circuit Breakers

d. C37.17: Standard for Trip Systems for Low-Voltage (1000 V and below) AC and General Purpose General Purpose (1500 V and below) DC Power Circuit Breakers

J. Mizener – No working group meeting was conducted. Recirculation ballot was returned with 98% approval and RevCom reviewed at May 2 teleconference. There were some questions therefore it is on the agenda for the June 7 RevCom meeting.
