#### 7. Old Business

#### a. IEC activities

L. Farr: IEC 62271-1 is in revisions and first CD had ~400 comments. Second CD will go out in January 2013. Forecast to be CDV in spring of 2014. Then all documents will start revision for new IEC 62271-1.

IEC 62271-201 Insulated Switchgear – Maintenance Team meeting in Asheville in November 2012. Then document to go out for Final Document International Standard (FDIS).

IEC 17A and IEC 17C have plenary meetings scheduled for the Netherlands in April 2013.

#### b. ASC C37 – General update

T. Olsen: Must start up revision of C37.54 and C37.55 when C37.20.2 is completed. Must start up revision of C37.57 and C37.58 once C37.20.3 and C37.20.4 are completed.

Policies and Procedures work to be addressed. Possible meeting to be held (TBD) at spring 2013 at Galveston, Texas meeting.

# c. Task Force Report on Other Enclosure Finishes

C. Ball: Task Force work is completed. Text was included in C37.20.3. Once resolution of C37.20.3 ballot comments are completed, they will be made available to other working groups.

**d. ADSCOM** – Switchgear Committee Policies and Procedures for Standards Development J. Smith: C37.20.6 is currently shown as an ADSCOM document. This should be corrected.

Action: Request C37.20.6 be transitioned to be a SA document instead of ADSCOM document. Subsequent to SA S/C meeting, ADSCOM did approve moving control of C37.20.6 to SA S/C.

# 8. New Business

# a. Switchgear Standard 1 kV to 52 kV

E. Byron: Who should control and what number?

Recommendation is that a new standard should be created under Switchgear Assemblies and a new standard number (family of numbers) should be used.

Standards Boards requires that there be a primary sponsoring committee and its Policy and Procedures would govern.

Motion by E. Byron with 2<sup>nd</sup> by C. Ball: Switchgear Assemblies (as primary sponsor) with cosponsorship by Substation Committee to create a Standard with target name of C37.20.9 for Gas Insulated Switchgear rated 1kV through 52 kV.

For the circuit breaker (inside the GIS), the requirements are not covered by this S/C.

Action: E. Byron - Develop and present to Substation Committee details for co-sponsorship agreement. Target time is in April 28 – May 2 (concurrent with PES meetings in Galveston, Tx).

ADSCOM – Items for SA S/C chair to discuss at ADSCOM meeting
 J. Smith: Request transfer of control of C37.20.6 from ADSCOM to SA – See comment 7 d. above.
