- III Minutes from previous meeting of the WG were reviewed and approved.
 - a. Moved by Stan Billings, seconded by Xi Zhu; carried by voice vote.

a. PAR Expires Dec. 2013.

V New Business

- a. Recirculation #1 closed 13 Sept.
- b. 85% Response Rate, 97% Approval. Meets IEEE criteria for acceptance once negative comments are resolved. 2 Negative votes with 3 comments that must be resolved and two that are not mandatory to satidfy as shown below:
 - Clause 3 (h), Page 3, Line 22. Note following clause was incorrect. Comment was
 that resolution noted 'Accepted' where in fact it should have said 'revised' as the WG
 vote was to remove the note. Commenter proposed alternate wording which was not
 accepted by the WG.
 - Alternate wording was proposed in a motion made by D. Dufournet, 2nd by
 M. Aristizabal to alter clause h to only reference dielectric strength and strike the note which would now be superfluous

Discussion:

- Need to move "opening" to (g) from (h) as well as "interrupting" in (g) to cover end users (Ken Edwards)
- Added 'dielectric strength, opening or' to g)
- h) is deleted, as is its' note
- Question has passed unanimously...
- Auxiliary Switch comment dealing with number of aux contacts that may be possible to provide on retrofit breakers due to their construction was resolved by the chair and the commenter by adding C37.59 "IEEE Standard Requirements for Conversion of Power Switchgear Equipment". No objections made by WG.
- Comments list: One or more trip coils, the word 'simultaneous operation' was replaced by 'Operation of either one or...'.
 - Clause 5 (h): 'Operation of either one or...' was decided last meeting but erroneously failed to be included in D6.4.
- Non- "Must be Satisfied" Comments: Auxiliary Switches: 'extra' in figures left as is in explanatory text at bottom of drawing; change from "Extra" to "Additional" made on drawings and in text for required auxiliary switches made available for the user. A minor spelling error was also pointed out for correction.

c. Recirculation #2 submitted 16 September 2013 for 10 day recirculation.
