Minutes of Meeting - Fall 2014

This meeting was the first meeting since the first ballot of C37.100.2 at draft 4.1. The ballot did not pass with a final approval percentage of 73.0%. A total of 548 comments were submitted including 342 that were designated "must be satisfied". The vast majority of our time was spent in comment resolution.

Introductions

- **12 of 17 members** attended, thus a quorum was present.
- 17 guests attended.

The PAR was discussed and it was noted by the secretary that it expires at the end of the year. The deadline of October 20th for PAR extension application was acknowledged. Donnie will coordinate with Mike Wactor to ensure that the PAR extension application is completed on time.

Ted Burse suggested that the working group chair communicate with ADSCOM to discuss scope and possible document overlap with, for example, C37.09.

Ted Burse and John Webb stated that since the ballot was unsuccessful any and all changes are possible and not limited to the comments from balloters.

Cathryn Berger, IEEE editor, provided assistance to the working group for editorial and content matters. She offered her continued support if necessary.

Harry Hirz agreed to use the C37.66 session on Wednesday morning exclusively for the continuation of comment resolution on C37.100.2.

A total of 134 technical comments were addressed leaving 68 technical, 38 general, and 102 editorial comments that must be satisfied. The technical and general comments will be divided and assigned to sub-groups within the working group for resolution. Donnie Swing will address all of the editorial comments.

Commitments

Pete Meyer will work on section 4.3 in its entirety and have it ready by the end of the calendar year.

Frank DeCesaro will work on section 3 to make all of the changes to the definitions by October 31st.

Neil McCord will divide the remaining technical and general comments among the working group.

Donnie Swing will address all of the editorial comments by October 31st and, pending receipt of work from working group members, will compile the document by the end of January 2015.

Upon compilation of the document it will be sent out for a 10-day review by the working group members after which it will be sent out for its second ballot in February or March of 2015.
