The following is a high-level summary of the technical discussions from this meeting.

i. Title / Scope / Purpose

The Task Force reviewed and agreed to the title, scope, and purpose.

A motion was made by Allan Morse to request LVSD for permission to proceed with a PAR for the drafted title, scope, and purpose. Motion was seconded by Harry Josten. Motion passed unanimously.

ii. Draft 1 Comments

Comments to Draft 1 were submitted by three members prior to the face-to-face meeting. The task force reviewed, and resolved all of the comments. The comment matrix and the current draft version of the Guide will be circulated to the task force within two weeks.

iii. Instantaneous Peak Let-Through Current

The Task Force reviewed and discussed the voltage limit of 254 V, as used to calculate the instantaneous peak let-through current (described in 5.1.2 of Draft 1). Additional research on the history of this requirement will be done, and presented at a future meeting.
