Report of the Meeting held on April 29th 2015 in St-Pete Beach, FL, USA

Joint IEC/IEEE revision of IEEE C37.013 to be called: High-Voltage Switchgear and Controlgear - Part 37-013: Alternating-current generator circuit-breakers

IEC TC 17 / SC 17A / WG 52 IEEE P62271-37-013

The Working Group met on April 29th 2015 in St-Pete Beach, FL USA . The chair started the meeting with the introduction of all participants. The following people attended the meetings: see Annex A.

The chair summarized the present status of the development of this standard as follows:

- The IEC proposed FDIS was received from IEC on March 23rd. The IEEE-SA 10-day recirculation ballot of D13.4, was started on April 23, 2015.
- The IEEE Recirculation Ballot is scheduled to close on May 3rd 2015 to date one negative has been changed to affirmative, and there have been no new negatives and no comments.
- The main task of this meeting was to review the substantive changes made since the last (successful) IEEE ballot of D10.4. There were no questions after the discussions.

The chair sent members a list of 23 items that were considered to be possibly substantive, and the WG discussed these changes during the meeting. It was agreed that all changes were acceptable, and that the balloters should vote affirmative on the recirculation of D13.4

If the IEEE-SA recirculation ballot is successful then the IEEE can authorize IEC to begin circulation of the FDIS.

If the IEC vote is also to approve the FDIS, then the document can be printed and distributed.

With great thanks for a difficult task well-done, I believe that the working group members can then be excused. Since the stability date is 2020, and since the revisions to IEC 62271-1 and IEEE C37.100.1 are progressing, it is reasonable to assume that a joint maintenance team should be formed in 2016 to begin an amendment to realign this document according to the changes made in those revisions.
