IEC 60073 will be added to the Reference Section 2.

b) References: Minor issue was with UL 248-1. Comment i-92 was that UL 248-1 was only informative, not normative and thus should not be in the Reference Section 2. My position is that in Section 5.2 UL 248-1 is used in Normative manner.

Review is that the added definitions (listed below) are in C37.17. As these definitions are in C37.17, they are not needed here and are therefore deleted. This includes:

- d) 1200A Frame Size: Any issues? 1200A Frames are deleted through-out.

1200A Frame Size had been requested to be added into $\underline{C37.14C37.16}$ but when this was moved to C37.13 and based on negative ballot comments, the direction was to remove this as a Preferred Rating.

Agreement reached not to add (yes to delete) 1200A Frame Size at this time. This will be noted in the comments for future consideration.
